Because of that theory, the American state legislature as two houses. All reason for the division has vanished; vhat we have now is best described by Senator Norris, who alls the two-chamber legislature "as useless as a wogan vith five wheels.'

"You cannot have a two-house legislature," says the enator, "without in reality having three, for the confernce committees that must be set up to iron out differences etween House and Senate constitute a third body.

"Moreover, it transacts its business in an un-American nd undemocratic manner. Its meetings are held in secret; here is no such thing as a roll call, and there is no record f its proceedings.

"A bill once referred to a conference committee cannot become law unless it is agreed to by a majority of the conferees. Thus it is within the power of the conference committee, in secret and without a record vote, absolutely o prevent legislation and to kill or to modify at its pleasure iny proposed legislation within its jurisdiction."

The lever which this gives to special interests to block egislation designed for protection of all citizens is too obious to need comment; so, too, is the opening which it rives to all kinds of political chicanery and thimble-rigring.

Once the public awakens to the merits of the singlehamber plan, it is a safe bet that state after state will folow the lead of Nebraska.
