Bad Luck For Bovina, Mustangs Fall to 0-3

From September 5 to October 3, things looked good for the Bovina Mustangs. They ran over and through their first five opponents to enter district play at 5-0.

But last Friday night, the Mustangs suffered their third straight district defeat, losing to Hart 47-24 as Hart running back J. J. Finch scored six touchdowns.

Heading toward half time, the Mustangs lead 18-6 when Hart exploded for 19 points to lead at the break, 25-18.

In the third quarter, the Mustangs scored to pull within one point before the Longhorns rattled off four unanswered touchdowns, three by Finch.

Albert Larrea carried 21 times for 70 yards and 2 TDs. Tony Beauchamp added 79 yards on 6 carries

and passed for 158 yards and two touchdowns.

Senior receiver Luke Steelman grabbed 8 passes for 122 yards and a TD. Aden Perez also caught a pass for an 11-yard touchdown.

The Mustangs lost two fumbles and had two interceptions and a fair amount of sloppy officiating, according to coaches.

Coach Bobby Ortiz was penalized 15 yards once when a referee ran into him on the sideline, accusing him of being "on the field." Game films showed Ortiz was not on the field. The Mustangs were penalized 11 times for 93 yards.

"All I know is that we were leading by 18-6 when the penalty happened and in a little over three minutes, we were behind 25-18," said Coach Ortiz.

To make matters worse, two Mustangs abruptly quit the squad during the game. "They just walked off," said Ortiz. "They said they were not getting to play enough and were tired of people telling them what to do." It was said the two deserting Mustangs rode home on the band bus.

With two games left, Bovina could easily salvage a respectable 7-3 record.

Beware Of Roof Scam

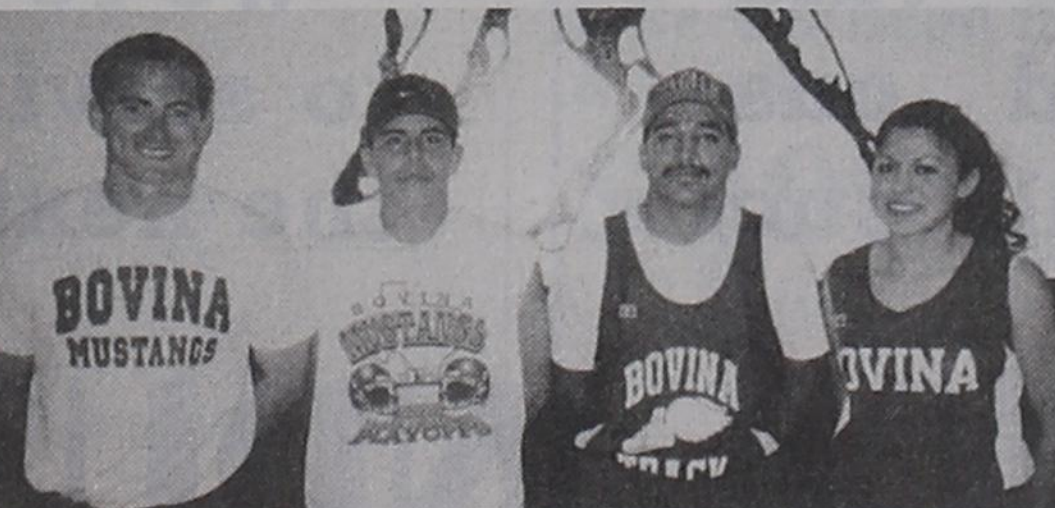
Last week, a man knocked on the door of a local 82-year-old lady and informed her that she had some roof damage.

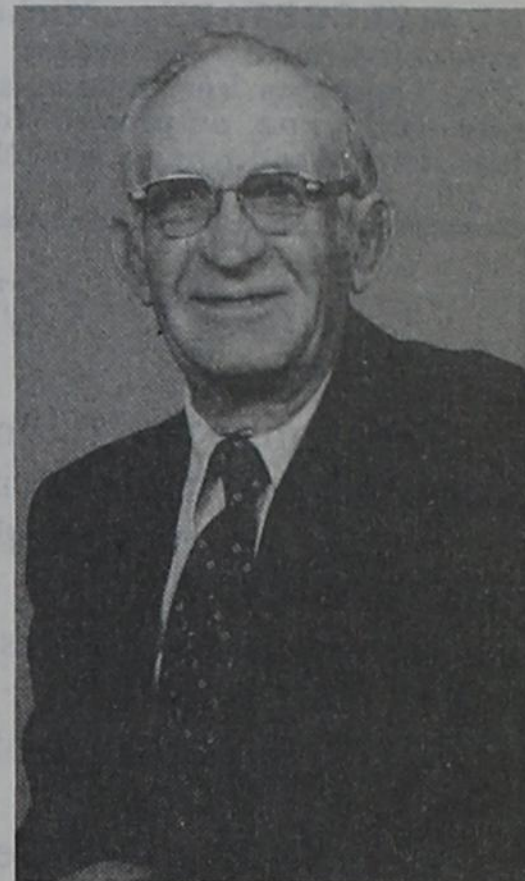

Fall Festival Rescheduled For Nov. 8

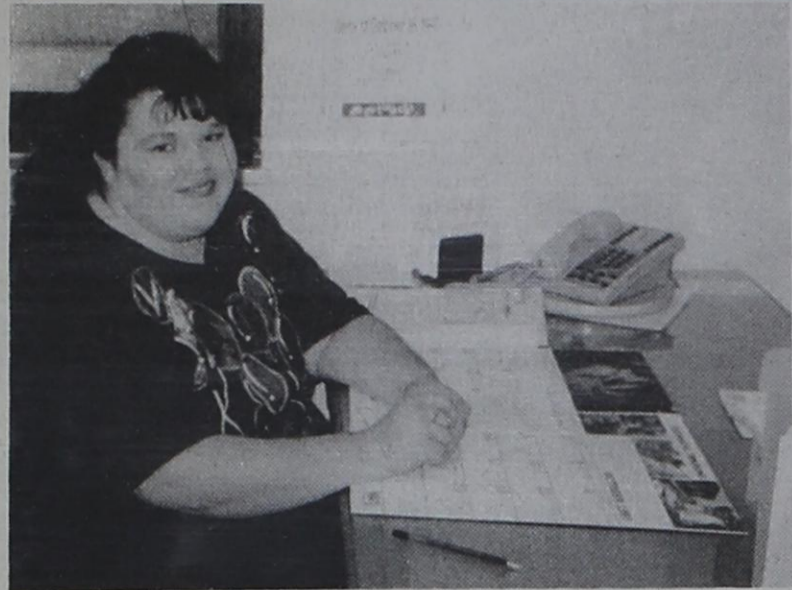

Villarreal Completes USMC Basic Training

Marine Pvt. Zeferino Villarreal, son of Zeferino Villarreal, of Bovina and Mary Villarreal of Hereford recently completed basic training at Marine Corps Recruit Depot, San Diego, California.

Villarreal successfully completed twelve weeks of training designed to challenge new Marine recruits both physically and mentally.

Villarreal and fellow recruits began their training at 5 a.m., by running three miles and performing calisthenics.

In addition to the physical conditioning program, Villarreal spent numerous hours in classroom and field assignments which included learning first aid, uniform regulations, combat water survival, marksman-ship, hand-to-hand combat and assorted weapons training. They performed close order drill and operated as a small infantry unit during field training.

Villarreal and other recruits also received instruction on the Marine Corps' core values-honor, courage and commitment, and what the words mean in guiding personal and professional conduct.

Out Here

"Alcoholics Anonymous is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism.

The only requirement for membership is a desire to stop drinking. There are no dues or fees for AA membership; we are self-supporting through our own contributions.

AA is not allied with any sect, denomination, politics, organization or institution; does not wish to engage in any controversy, neither endorses nor opposes any causes. Our primary purpose is to stay sober and help other alcoholics to achieve sobriety."

"Norman, I liked you better when you were drinking!" declared an old pal who was feeling no pain. "That makes us even," replied Norman, "when I was drinking, I liked you better too."

It is an old joke. One of many that are told in AA meeting halls around the world every day. AA members are big on humor.

The preamble at the top of the column is read by a group leader to open every AA meeting that is held anywhere in the world.

And they are held often. Morning, noon, and night. In non-stop cities like Las Vegas, there are many meetings held between 2 a.m. and 6 a.m. in the city that never sleeps.

Old timers in the AA program say that alcohol never sleeps either. It is described in the group's Big Book as "cunning, baffling, and powerful."

Tobacco's evils have been shouted about by self-appointed non-smoking zealots for some time now. State governments found a pot of gold at the end of a brown rainbow. The tobacco companies are ponying up large doses of cash under the guise of reimbursing states for medical costs caused by

smoking tobacco.

Yet you can find many people across America, from any walk of life, who will argue that alcohol does more damage, destroys more lives, careers, and families, and kills people in much more tragic ways than does smoke.

There are experts who claim that if alcohol was listed as the cause of death everytime it was involved, the number of alcohol-related deaths would surpass tobacco.

Think of the car accident victims, murder victims, drownings, boat accidents, plane crashes, and liver failures, just to name a few.

When an innocent victim is killed in a car crash by a drunken driver, alcohol is not listed on the death certificate as a cause of death.

A robbery victim killed for money died from a gunshot wound, not because of the alcohol short circuiting the killer's brain.

Some debates have flared up recently as to whether alcohol addiction can be cured without the 12-step AA program.

Maybe you remember a woman named Susan Powter. She burst on the scene a few years ago with the slogan "Stop The Insanity." It was a weight loss, exercise program.

Powter herself lost over 100 pounds, and capitalized on her short white haircut and screeching

delivery to sell weight loss products and video workout tapes.

She became a millionaire and then faded into bankruptcy. She says now that she was an alcoholic, is now a recovering alcoholic, and has developed some food supplements which help keep you from being an alcoholic.

See, she discovered that most alcoholics do not eat normally (which is true, but she didn't discover it) and if drunks and potential drunks will take 30-40 of her pills per day, they will become un-alcoholics.

She has been on TV talk shows and will probably sell enough of her pills to become a millionaire again. It is easy to take advantage of the weakness of overeaters and over-drinkers.

US News magazine had a long report on some new tests of a controlled drinking program, once again trying to figure out a way for alcoholics to drink like a normal person, without all the attendant problems that go along with being drunk every time.

Therein is the conflict which makes AA members smile as they share their experiences in countless meetings. The quest to drink like a normal person.

They call it denial, and recite Step One of the AA Program: "We realized that we were powerless over

alcohol and that our lives had become unmanageable."

Simply put, it is not possible for an alcoholic to drink in a controlled fashion. Indeed, a "good" alcoholic prefers uncontrolled drinking, and has no control of the consequences.

Alcoholism is a disease, they say. A disease for which there is no cure. No way has yet been discovered for an alcoholic to drink.

It is a progressive disease. They say that means even if you stop for some period of time, then start again, the results will be the same as though you had been drinking all along.

This too has been proven in millions of test cases. I've talked with many AA members about the AA program and their personal experiences.

Some of their stories are both tragic and funny. But all agree there is nothing funny about alcohol.

In the weeks ahead, I will be sharing some of their stories with you, as well as a look at the AA program and how it works.

It seems to be a simple program. As one member said, "We tell them (newcomers) if you don't drink you won't get drunk. And I had sure rather stay sober than try to get sober."

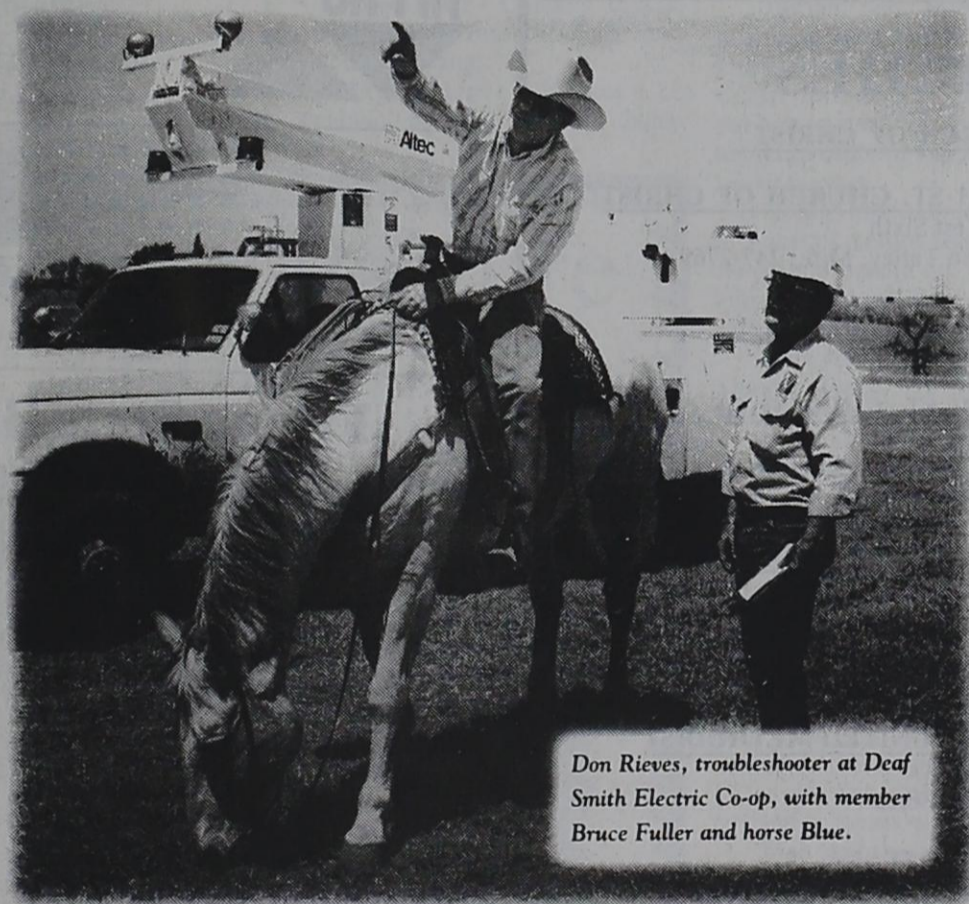

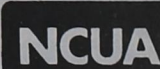
