

# **October-Breast Cancer Awareness Month**

Learning about breast cancer, knowing you're at risk and following an early detection program are important steps for every woman to take. Breast cancer is the most common form of cancer in women in the U.S. today, and every woman is at risk. Many women don't know the facts about breast cancer that although there is no certain way to prevent the disease, there are ways that each woman can protect her health. Learn about the steps you can take to protect yourself!

The first step is to follow an early detection program. When detected early often before it can be felt breast cancer can be treated successfully. About 97 percent of women treated for early-stage breast cancer are alive five years later, and most can be treated without losing a breast. Your early detection program should include:

Getting regular mammograms beginning at age 40, one every year as directed by your doctor. Mammography is safe, painless and highly accurate in finding breast cancer. Talk to your doctor about getting your next mammogram, or schedule one yourself.

Having a breast examination by a doctor or nurse each year, starting at age 20. Learning the normal feel of your breasts, and checking them yourself regularly. Many women have lumpy breasts, which are usually not a cause for worry. However, if you feel a change or a lump that is new, be sure to have it checked by a doctor or nurse right away.

There are other steps you can take for good breast health. Researchers are continuing to explore the effect that a healthy, active lifestyle can have on reducing breast cancer risk. A National Cancer Institute study has shown that adult women who are at a healthy to slim weight and those who lose excess weight have a lower incidence of breast cancer than women who are overweight, especially those age 40 and older.

A large study has shown that breast cancer risk increases as a woman gains weight during adulthood. While it is not yet known whether losing weight will reduce breast cancer risk, maintaining a lifelong healthy weight

is good for your breast health, for your heart and bones, and for your selfesteem. Results of breast cancer research also suggest that you should:

Maintain a diet low in fat, including fruits, vegetables and whole grains. Smith or Greg Jones. These low-calorie, high-fiber foods have proven health benefits. # No reason to go to war

The signals coming out of Washington about the impending war against Iraq are ominous. This is not only because it would be an unprovoked and undeclared war against a nation that has not attacked us, but also because of the new reasons being offered.

The Bush administration tried its best to pin 9/11 and the subsequent anthrax mailings on Iraq. The effort failed dismally. You can be sure that if there had been evidence, we'd have heard about

it. Then the ground shifted to weapons of mass destruction. The scary word "nuclear" has been dropped here and there, but, again, no one has produced any evidence.

Likewise f r chemical and biological agents. Saddam Hussein is not a nice man, and he may well be working on acquiring such weapons. But no one can say that he has them now. Scott Ritter, a former U.S. Marine who helped lead the UN inspection team in Iraq, is skeptical.

At any rate, he thinks the way to find out is to get the inspectors back in. Saddam has been reluctant to let them return because he wants leverage against the decade-old economic embargo that has imposed such hardships on the Iraqi people. He also hasn't forgotten that the U.S. government loaded the last inspection team with CIA

agents.

Now that President Bush is rattling his saber and has declared open season on Saddam personally, he might be unenthusiastic about inviting American spies back into the country. Dictators can be so unreasonable. So the grounds for war are weak. The

He's supposed to also abide by the Constitution.

I've read the brief Constitution, and I cannot find anything to suggest that a president may go to war on his own decision in order to keep from looking like a blustering paper tiger. Maybe that's where "living Constitution" thinking takes you, but I don't see it. It is clear that Mr. Bush has no intention of asking Congress for a formal declaration of war.

No president has asked for a declaration since FDR and World War II, but that hasn't stopped the United States from getting into several wars since then. To ask for a declaration now would set a precedent, and the last thing the powers that be want is a precedent limiting the unconstitutionally assumed war powers of the presidency. One thing Mr. Bush has going for him is that the public and most members of Congress don't care. (Do they even know that the war power is reserved to Congress?) If they did care, perhaps Mr. Bush would give them the same consideration he gives his friends who run other countries.

But don't worry. Mr. Bush at least thinks he'll owe the American people an explanation for why going to war is necessary. According to the Associated Press, he intends to give them one — right after he launches the attack.

"Trial, we don't need no stinkin' trial! He's guilty, string him up!" They knew that in a democracy, no one's rights are secure and that sooner or later the majority would find a way to sack the treasury and achieved the eighth- or ninth-grade levels. According to the Joint bleed it dry. That's why they formed a representative republic. In a republic form of government, which we are guaranteed by the national and state constitutions, there must be a limited franchise to vote. Voting in a republic is not a right, it is a privilege.

The American founders then went one step further, and insisted that voting privileges be determined by each state legislature, not the national or federal government. It worked quite well for more than 100 years ... then came "reconstruction" after the U.S. vs. CSA conflict in the 1860s. That's when the socialist move for a full democracy began.

It has flourished ever since, slowly but surely eroding the original guarantees of a republic form of government by planting ideas that every person has a "right to vote," simply ignoring constitutional restraints against such a notion.

Throughout our history there have been a variety of state rules about voting privileges. Requiring voters to own property was thought to be a sure fire way to keep the mob from raiding the treasury. Other state attempts to curb democracy included requiring the payment of poll taxes, being able to read and write in English and other similar rules. Only in the 20th century were these restrictions removed through federal court action, based on the notion that such voting restrictions were considered discriminatory.

Whenever government has the power to tax (steal from its citizens), there is an inherent danger in allowing full democracy. When there is universal voting, with little or no restriction, the mob votes for politicians who promise to steal the most for their constituents. It doesn't take long to figure out the end result, economic chaos and collapse, for the state and national treasuries are not endless supplies of funds, they exist only through the forced payment from productive citizens.

It becomes obvious that the only way to get elected in such a democratic system is to promise voters more from the public treasury. As our congressman found out when he visited Garza County recently, the number one questions were based around how much federal money he was going to secure for projects here. "It's our money, we might as well get some of it," is the common thinking of those who demand more government funding from political leaders. Therefore, the theft increases. Right now state political leaders are beginning their campaign to convince Texans that the only answer to solving state funding problems is to implement an income tax. That kind of talk is popular only with those who want to steal more money from someone else to pay for their favorite project. The end result can not be good, especially for those who believe in liberty and freedom.

If there were no government power to tax, perhaps full voting by everyone wouldn't be so destructive, but we must remember the famous words attributed to President George Washington, "The power to tax is the power to destroy."

You do not have the "right to vote," you have the right to life, liberty and the pursuit of happiness (ownership of property). You have a privilege to vote, an important privilege. Let's not get caught up in the national socialist plan to destroy this great nation through continued theft by the mob.

Besides, it's hard to miss the breaking of ranks. Mr. Bush took an oath to "preserve, protect, and defend" it, and that means more than ensuring that the National Archives building isn't attacked.







The Post Antelopes have an uphill battle on their hands toward their goal of a district championship, having lost to Shallowater last Friday. This week a strong Idalou football team comes to Post, with expectations running high for both Post and Idalou.

The Wildcats are undefeated, coming off a 21-7 win over Roosevelt last week. "They're a solid football team," Antelope head coach Richard Gorman observes, "but they aren't invincible." Gorman believes the Post Antelopes are also a good strong team, but had a bit of a let down last week at Shallowater.

"We've come back before," Gorman emphasized, "and I believe this team has what it takes to win."

In the loss at Shallowater, the Antelopes racked up 273 total yards offense, but had difficulty with the passing game. "We just didn't make the proper adjustments to their defense," Gorman added.

Mitchell Mills led the ground game wit 143 yards on 20 carries, with Jett Lott picking up 44 on 12 tries, Brody Robertson got 25 yards on seven attempts and Kris Hernandez got four yards on two tries.

Robertson connected on five passes of 18 attempts for 57 yards, four to Lott for 60 yards and one to Mills.

Bryan Looney connected on a field goal for the only Antelope points. Looney also punted five times for 188 yards, averaging 37.6 yards per punt. Jonathan Eilenberger led the defense with four tackles and six assists

quarterback Brody Robertson with 34 vards on seven carries.

Mills was the workhorse for the Antelopes, converting nine of the team's 13 first downs, with eight on 10-plus yard conversions in his 21 carries.

Post, on its 11 offensive series, went three punts, four turnovers on downs, one fumble, one interception, one time running out at halftime and one successful field goal.

Shallowater scored on the opening drive, frustrating the 'Lopes somewhat on an 85-yard, 10-play drive with a four-yard scoring pass to RB Edgar Martinez from Kiel Kitchens.

The Post Antelopes bounced back defensively during first half action to hold Shallowater to three punts and one lost fumble, with Shallowater also dominating, playholding Post to one Bryan Looney field goal in five Post series.

Brody Robertson threw a 43-yard Hail Mary pass with four seconds left to halftime to Lott, out jumping Jarrett Vickers and several Shallowater defenders as time ran out in the first half, with Lott hitting the ground on the Shallowater 7vard line.


points on a 70-yard punt return for a touchdown by Eric Morris at the 9:59 mark of the fourth quarter.

Antonio, Jack and Barney Fenoglio arrived in the US from Italy in 1872 and worked in coal mines in Illinois, Kansas and Oklahoma before saving enough money to come to Texas and buy land in Montague county. "They had a rough time," says Robert Fenoglio, a former

justice of the peace and now a city councilman in Nocona. "When they went into the town of Montague, they always went two at a time. They were not well received because they were Italian and Catholic, both rare species in Montague county at the time."

The Fenoglios couldn't speak English when they first arrived in America. "My grandfather quit school in the third grade," says Robert. "His name was Andrew Jackson Fenoglio. He quit school because one of the teachers

The Fenoglios farmed, bought more land, got into the oil business and now there are about 200 Fenoglios in Montague county involved in all facets of the community. Several hold political office both locally and statewide. Some made names for themselves on football teams in high school and college.

Robert's father married a red haired Irish lady who was vivacious and well loved. "That kind of broke the ice between the Italians and the rest of the community. We're very well accepted now and we're proud of our heritage."

Robert demonstrates the Italian lawn game of Bocci at fairs and festivals around the state. He says Bocci is now played mostly in back yards.

Robert likens the Fenoglios to Johnson grass. "They tried to kill us out, but we persevered and now we're here to stay."

The people of Montague are known for their tenacity. "My uncle Tony, the ex-state representative, says you could build a twelve foot fence around

Montague county and not let anybody else in and the people would survive better than any place on earth."

The Fenoglios left Italy because of poor living conditions. "In 1860 all of northern Italy was controlled by Austria. They had a civil war and won their independence. Then they had a depression. My grandfather told me about his father's family sleeping five in a bed sideways and no job and no land to buy. So they decided to come to the new country."

One brother stayed in Italy and lives in a small town at the base of the Alps near the Swiss and French borders. Robert went over there in 1997 and says it's the most beautiful place in the world.

"My great grandfather died when he was fifty-eight years old. When I came back from Italy I told my dad that I thought I understood why his grandfather died at such an early age. After he came to Texas from that beautiful place in Italy, he must have thought he was in hell and he

just couldn't stand it any longer."

The Companions work 20 hours per week and serve one to four clients in a week's time. The SCP has 17 male and 58 female Companions ranging in age from 60 to 90. They cover an eight-county, 8,000-square-mile area, including Bailey, Cochran, Garza, Hockley, Lamb, Lynn, Terry and Yoakum counties.

Garza County Companions include Emilia Cervantez, Alyne Clanton, Richard Collins, Angelita Raymundo, Margarita Romero and Lupe Ybarra.

There are an additional 20 volunteers that assist the Companions with struck again Monday night at time sheets, work schedules and transportation.

During December, a recognition luncheon is held and gifts are given to the Arcade, spreading chocolate syrup volunteers. Like most non-profit organizations, the SCP is short of funds. 


