Directors of the Garza County Hospital District were split last week when deciding the district's financial plan for the next fiscal year.

The board voted 3-2, with newcomers Fred Howell and Kenda Bartlett casting the dissenting votes, in favor of accepting the health care district's proposed budget for the next fiscal year.

Howell led the charge against acceptance of the budget, which stands at less than \$1 million and is smaller

According to figures provided by the district, the average taxpayer with property valued at \$50,000 in the new fiscal year will pay an additional \$4.20 under the plan, or about 35 cents per month. With property valued at \$90,000, the tax bill will climb \$7.55, or 63 cents per month. Bartlett said the district's conser-

vative clinic revenue projections could easily enable the board to make the bulk of the cuts necessary to drop the tax rate as per Howell's suggestion. "If there's a way that we can do this, then I think we need to do it," she

said.

Following a lengthy discussion, Howell made a motion to postpone action on the budget and schedule another budget work session. Bartlett seconded the motion; however, the two were outvoted by the remaining board members.



Drug task force future

uncertain

A recent announcement by the Lubbock Police Department has left the Garza County Sheriff's Department in a law enforcement limbo of sorts. After the Lubbock agency announced last week it would no longer serve as the administrating agency for grant monies that fund the South Plains Regional Narcotics Task Force, Garza County lawmen, as well as those representing 17 other area counties, were left to wonder whether they can continue drug enforcement activities at the same level.

Garza County Sheriff Kenny Ratke said that most area law enforcement agencies "operate on a shoestring" budget, and the loss of the regional narcotics task force is "just an added resource we can't afford to let go of out here."

The local sheriff's department and the task force have enjoyed a longterm drug enforcement partnership, the sheriff said. The task force has assisting in breaking down drug labs following drug busts, saving the county thousands of dollars per incident, and provided undercover agents to help work drug cases.

Highway traffic collections enrich county and state funds by \$25,392.06 in July

Garza County Justice of the Peace Courts collected a total of \$25,392.06 during July for highway travel fines issued here, according to official reports. The fund raising program, operated by Garzy County in coordination with the State of Texas, took advantage of travelers who were accused of violating State Transportation Codes.

In one of their most successful partnerships, the Garza County Sheriff's Department and the task force used a local informant to help Lubbock authorities file 26 heroin-related cases, most of them federal court cases, the sheriff said.

The term "Transportation" was not defined in the Texas Code. According to the United States Transportation Code and Black's Law Dictionary, the term "Transportation" was defined as transportation by a carrier for hire.

Use of the roads and highways for the purpose of "transportation for hire by carriers" was what fell under the scope of the Code. Even to this day, the Code protects the traveling public by regulating vehicles using the roads for the purpose of "Transportation."

Registration requirement falls within the limited scope of the Transportation Code. The only automobiles that are required by law to be registered with the State are those that use the roads for the purpose of transporting for hire: for example, busses, cabs, freight carriers, etc.

The simple question remains: will the county courts dismiss all cases where peace officers attempt to enforce the Transportation Code upon automobiles that do not fall within the limited scope of the Code?
