Donley County Fair

Plans for the Donley County Fair are coming along fine says County Agent H. M. Breedlove. The fair this year will be held in the McMurtry Building in Clarendon on September 17 and 18.

Most of the setting up of the exhibits will be done on the 16th so they will be ready for the opening day. All agriculture exhibits from the communities in the county will be set up on the 16th and will be judged on the 17th at 10 AM. The three schools in the county will have home economic exhibits and Miss Ruth Richerson will have charge of them. They will be set up on the 16th and judged on the 17th. All poultry should be in on the 16th and will be judged on the 17th. The flower show entries will close at 10:00 AM of the 17th, and all cakes for the cake department will close at the same time. The merchants' displays should be set up on the 16th and ready for the 17th.

The horse show, which is now approved by the American Quarter Horse Association will be held on the morning of the 18th at 10:00 AM at the rodeo grounds, and Breedlove says that entries will be taken right up to the time for the showing. The races will be held at 2:00 PM on the 18th at the rodeo grounds and are under the supervision of the Outdoor Entertainment Ass'n.

All swine and sheep in the boys livestock department will be on display both days of the show and will be judged on the morning of the 18th.

Breedlove says that next week the fair building will be cleaned and preparations will be made for space and setting up display tables. Everyone is urged to start to work now on your displays and help to make this fair one of the largest in years.

The fair catalog is ready for distribution and is being mailed all over the county to be distributed to those who will take part in the fair. The premium money will total about \$850.00 and was made possible by the ads bought by merchants in this catalog.

Remember the dates, Sept. 17 and 18, and make plans to bring the family and attend the "Biggest Little Fair in the World."

1956 Tentative Date For Salt Fork Dam

The tentative date set for the construction of the Dam across Salt Fork of Red River, to keep Texas water in Texas for Texas users, is 1956—not a year and a half away, according to a report from R. A. Underwood and Co., of Dallas, investment bankers.

Several steps must be taken by the towns in the water district, who are Hedley, Clarendon, Wellington, Paducah, Memphis, Childress and Quanah. The first will be an election to confirm the action of the legislature in creating the water district. The date has not been set but will be in the near future. The persons who can vote in this election are tax paying residents (either personal or real estate) who live in the city limits of Hedley and have paid their poll tax.

The dam site selected is just below the junction of White Fish and Salt Fork, about 9 miles from Hedley. It is the only location discovered in the Greenbelt district where a large body of good water can be impounded. The lake will impound 100,000 acre feet of water or about four times as much as Lake Worth. It will furnish to users 25 million gallons of water a day. The present consumption of the seven cities is only about 13% of this. Three major established industries within the area will be users, one of which uses one million gallons a day. Other industries have been urged to come into this territory. The estimated cost of the dam and system is 8,100,000.00 to be financed by a long time revenue bond. When the bond is retired the lake and system will be the property of the water district.

Information on the project will be prepared in question and answer form and will be printed in a series of articles in the Informer each week.

First Cotton Ginned

Photographic flashbulbs popped and a radio tape recorder buzzed to publicize the first bale of cotton for 1954 at the West Texas Gin last Friday afternoon.

Woodrow Farris, farmer 6 miles northeast of Hedley, drove onto the cotton scales at 6:00 PM to launch the 1954 Cotton Harvest. Cotton Festival officials were on hand to photograph the event and a tape recording was made publicizing the Cotton Festival, October 8th and 9th.

On the radio show, emceed by Bob Harris for Cotton John of KGNC, W. B. "Nooky" Wiggins prophesied between 2500 and 3000 bales for his Gin alone this year. Throughout the area old timers were optimistic in their views that the 1954 crop would beat the 10 year past average. In over 60 years, Hedley has never had an outright cotton crop failure! Some years like the past 4 have been small, but the prospect of a bumper harvest this fall has made everyone feel like celebrating. An opportunity to do so will be given everyone in the High Plains on October 8th and 9th at the Third Annual Hedley Cotton Festival.

The Hedley Booster Club purchased the Woodrow Farris 510 pound bale for 40¢ a pound. The bale will be given away during the Festival.

The second bale was picked for Walter Moss by a group of friends Monday. It weighed 530 lbs. and was bought by the Legion post at 40¢. It was ginned at the Paymaster Gin.




