

THE FORBIS PAMPHLET

Mr. Forbis and the Childress Political Clique are distributing pamphlets throughout the District in an effort to defeat Allen Harp.

- * In the pamphlet Mr. Forbis sets out the boxes that he carried in the primary in an effort to show that his character is better and his ability superior to that of Allen Harp. He does not give the results in those boxes where he received practically no votes at all.
 - * In the pamphlet Mr. Forbis says that Allen Harp has served four terms.
- -The truth is that Allen Harp became District Attorney January 1, 1950. You can figure that for yourself.
- * The pamphlet further states that Forbis has had six and one-half years active criminal and civil practice.
- —The truth is that the Williams, Broughton and Forbis law firm does not practice criminal law at all Mr. Forbis has not had any criminal practice (The District Attorney's office is concerned only with criminal law). In fact Mr. Forbis has had practically no court room experience even in civil law.

A CHARACTER ASSASSINATION CAMPAIGN

Never in the annals of local politics has there been a character assassination campaign comparable to the one that is being waged against me. The Childress Political Clique which has sought to control Childress through the years has always tried to defeat me because I have prosecuted the high and the mighty on the same basis as those of low estate and have not submitted to any control from any person or group of persons. The enmity created in nearly every county through prosecutions has added its weight on the side of the Childress Political Clique. The members of the clique are fanning out into the other counties carrying Forbis literature and false stories about me.

I have been married but one time. My wife and I have been married and living together as man and wife for more than twenty-one years. We have never lived apart from each other except for a part of the time that I was in the Service during World War II. We have a boy 15 years of age and a girl 12 years of age. We have attended Church regularly, although I did not start preaching when I started running for District Attorney. My wife and I are attempting to rear our children in a good home. You will note that I use the word "good" instead of "Christian". The term "Christian" has been so prostituted by political demagoguery as to become, in the words of the Apostle Paul, "as sounding brass or, a tinkling cymbal" when used in connection with a campaign such as this. I have been guilty of no offense of any nature of which my opponent has not been guilty. I have not attacked the character of my opponent either directly or indirectly. I have sought reelection purely on my qualifications with the sincere belief that a majority of the people want to elect the best qualified person for public office, especially an office with the responsibility of the District Attorney's office. It is on this basis that I submit to you my plea for reelection. I will certainly appreciate your vote on August 25th.

HEED THE WARNING!!

In the City of Childress a general telephone rate raise was granted effective September 10, 1951. The ordinance passed on that date included two rate raises both of which are now in effect and amount to an increase to the residential telephone user from \$2.50 per month to \$4.75 per month. The raise granted almost doubled the rate. Mr. Forbis, a junior member of Williams, Broughton, and Forbis, was City Attorney during the time the hearing was held before the City Council. Mr. Broughton, a senior member of Williams, Broughton & Forbis, represented the Southwestern Bell Telephone Company at the rate raise hearing. You can be the judge of who won the case. At the time of these hearings the City Attorney's salary was made payable to Williams, Broughton & Forbis. As a matter of fact, the salary was so paid until January 31, 1956, when the salary payment was changed and made payable to John T. Forbis. (They must think the public is really gullible.) This law firm is not content with its hold on the City of Childress and Childress County but now seeks to elect its junior member District Attorney.

Do you want the District Court operated in the manner of the City of Childress? Forbis has stated in open court on several occasions, a couple of years ago, that he had no interest in criminal law; that he didn't want anything to do with criminal law and that the District Attorney's job was one job he wouldn't have under any circumstance. WHO caused him to change his mind and WHY? Of course, the additional revenue and other advantages of the office appeal to the law firm of Williams, Broughton & Forbis. On the other hand there is the Childress Political Clique which has attempted to control Childress through the years and are now attempting to grasp power in the District Court. We believe that the people of Donley County will defeat them in this effort by defeating their favorite candidate for District Attorney.

HARP'S OPPONENT

The law firm of Williams, Broughton & Forbis does only civil practice and does not do criminal practice. You say, what is the difference? The difference is this — take two doctors, one is a dentist and the other a medical doctor. There is as much difference between criminal and civil law. The District Attorney handles fhe more serious criminal offenses for which a person may be sent to the penitentiary. It is an office of purely criminal law. Mr. Forbis has never tried a criminal case. According to officials of our District Court he has never had the full responsibility for trying any contested civil case in the District and very limited courtroom experience of any nature.

ALLEN HARP

... does not represent any corporation or any other interest that might conflict with his duties as District Attorney.

... served Childress County for two years and three months as County Attorney before becoming District Attorney.

... has served this District well as District Attorney for about six and a half years.

... has performed as District Attorney over and beyond the call of duty. He has appeared in county and justice court cases when requested to do so by the grand juries or the County Attorney.

... has been District Attorney. He has not permitted any person or group of persons to dictate to him. The Childress political clique has not been able to control him but he has had the courage and integrity to prosecute all persons on an equal basis regardless of the pressure brought on him and the political consequences.

It appears to us that all citizens interested in the District Attorney's office being free from control by pressure groups — those who believe in justice and fair play and those interested in the protection of their life, liberty and property; would rally to the support of Allen Harp and give him an overwhelming majority vote on August 25th.




