## Notice of Election

The State of Texas County of Travis Board of Water Engineers

To the Qualified voters of the Green Belt Municipal and Industrial Water Authority comprising the cities of Childress, Clarendon Wellington, Hedley, Memphis, Paducah and Quanah:

Take Notice that an election will be held in each of the cities above named on August 31, 1957 on the question and at the places more particularly set forth in the order of the Board of Water Engineers of the State of Texas, which order is as follows:

An Order

Calling Confirmation Election In The Green Belt Municipal And

Industrial Water Authority Be it ordered by The Board of Water Engineers of The State of Texas:

1 An election shall be held in the Green Belt Municipal and Industrial Water Authority on the 31st day of August, 1957, at which election the following proposition shall be submitted:

"Whether or not the establishment of the Green Belt Municipal and Industrial Water Authority shall be confirmed to include each of the following cities in which the majority vote favors confirmation: Childress, Clarendon, Wellington, Hedley, Memphis, Paducah, and Quanah."

2. (a) The election held in the City of Childress shall be at the City Hall in said City and Mr. Bill King is hereby appointed Presiding Judge of said election.

(b) The election held in the City of Clarendon shall be at the City Hall in said City and E. J. Chenault is hereby appointed Presiding Judge of said election.

(c) The election held in the City of Wellington shall be at the City Hall in said City and F. A. Hatch is hereby appointed Presiding Judge of said election.

(d) The election held in the City of Hedley shall be at the City Hall High School building Wednesday of said election.

(g) The election held in the City of Quanah shall be at the City Hall in said City and E. G. Givens is hereby appointed Presiding Judge of said election.

3 Each of the presiding judges above named shall appoint two judges and two clerks to assist him in holding the election in his voting place.

4. Said election shall be held under the provisions of House Bill 88 enacted by the 53rd Legislature, first called session, and the General Election Laws of the State. Only qualified voters who reside in each of the Cities above named shall be qualified to vote in said election held in such Cities.

5. The ballots for said election shall have written or printed thereon the following:

> "For Confirmation" "Against Confirmation"

6. A substantial copy of this order shall constitute proper and sufficient notice of said election Such notice shall be published in

a newspaper published in each of the Cities above named once each week for two weeks, the first notice shall be at least fourteen days prior to the date set for the elec tion.

"The election on August 31s will merely create a legal representative body," Dr S. H. Town send of Childress stated today 'The law is very specific in limiting the power of the Authority once it is created, to levy taxes of issue bonds. Only the qualified tax payers of each community can authorize a tax for the authority or give permission to issue bonds the authority's real purpose will be to study the feasibility of building a dam for water storage, to authorize studies of water quality which will be obtained from such a dam and to make any studies of cost o delivering the water to the seven cities which may vote themselves into the autority," Townsend concluded.

The Salt Fork of the Red Rive has been proclaimed the last avail able source of water for this area and progress must be made toward using the water available from this source if the area is not to lose its water rights to other cities downstream who have been already studying means of capturing this water for their own use.

Election judges and the place of voting in each community has been set. Absentee balloting start ed on Monday, August 12, and will continue through midnight, August 27. Absentee ballots can be obtained from City Secretary O'neill Weatherly.





PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 5, 1957.

HOUSE JOINT RESOLUTION NO. HOUSE JOINT RESOLUTION NO. 3 proposing an amendment to the Constitution of Texas adding a section to be known as Section 49-c of Article III, providing for the issuance and sale of bonds of the State of Texas to create the Texas Water Development Fund to provide financial assistance to certain political subdivisions or bodies politic and corporate of the State of Texas in the conservation and development of the water resources of the State; providing for the payment of such bonds; creating an agency to state; providing for the payment of such bonds; creating an agency to administer said Fund and to perform other duties prescribed by law; limiting the period during which financial assistance may be granted; and providing for the calling of an election and the publication and issuance of the proclamation therefor.

RE IT PESOLVED BY THE LEG.

BE IT RESOLVED BY THE LEG-ISLATURE OF THE STATE OF

Section 1. That Article III of the Constitution of Texas be amended by adding a new section thereto to be known as Section 49-c, as follows:

"Section 49-c. There is hereby created as an agency of the State of Texas the Texas Water Development Record to exercise such powers as necessarily services and powers as necessarily services."

Board to exercise such powers as nec-essary under this provision together with such other duties and restrictions

essary under this provision together with such other duties and restrictions as may be prescribed by law. The qualifications, compensation, and number of members of said Board shall be determined by law. They shall be appointed by the Governor with the advice and consent of the Senate in the manner and for such terms as may be prescribed by law.

"The Texas Water Development Board shall have the authority to provide for, issue and sell general obligation bonds of the State of Texas in an amount not to exceed One Hundred Million Dollars (\$100,000,000). The Legislature of Texas, upon two-thirds (2/3) vote of the elected Members of each House, may authorize the Board to issue additional bonds in an amount not exceeding One Hundred Million Dollars (\$100,000,000). The bonds authorized herein or permitted to be authorized by the Legislature shall be called "Texas Water Development Bonds," shall be executed in such form, denominations and upon such terms as may be prescribed by law, provided, however, that the bonds shall not bear more than four per cent (4%) interest per annum: they may be issued in such installments as the Board finds feasible and practical in accomplishing the purpose set forth herein.

"All moneys received from the sale of State bonds shall be deposited in a

"All moneys received from the sale of State bonds shall be deposited in a fund hereby created in the State Treasury to be known as the Texas Water Development Fund to be administered without furthern to be administered." (without further appropriation) by the Texas Water Development Board in such manner as prescribed by law. "Such fund shall be used only for the purpose of aiding or making funds

available upon such terms and conditions as the Legislature may prescribe, to the various political subdivisions or bodies politic and corporate of the State of Texas including river of the State of Texas including river authorities, conservation and reclamation districts and districts created or organized or authorized to be created or organized or authorized to be created or organized under Article XVI, Section 59 or Article III, Section 52, of this Constitution, interstate compact commissions to which the State of Texas is a party and municipal corporations, in the conservation and development of the water resources of this State, including the control, storing and preservation of its storm and flood waters and the waters of its rivers and streams, for all useful and lawful purposes by the acquisition, improvement, extension, or construction of dams, reservoirs and other water storage projects, including any system necessary for the transportation of water from storage to points of treatment and/or distribution, including facilities for transporting water therefrom to wholesale purchasers or for

ment and/or distribution, including fa-cilities for transporting water there-from to wholesale purchasers, or for any one or more of such purposes or methods.

"Any or all financial assistance as provided herein shall be repaid with interest upon such terms, conditions and manner of repayment as may be provided by law.

"While are of the heads authorized

"While any of the bonds authorized by this provision or while any of the bonds that may be authorized by the bonds that may be authorized by the Legislature under this provision, or any interest on any of such bonds, is outstanding and unpaid, there is hereby appropriated out of the first moneys coming into the Treasury in each fiscal year, not otherwise appropriated by this Constitution, an amount which is sufficient to pay the principal and interest on such bonds that mature or become due during such fiscal year, less the amount in the sinking fund at the close of the prior fiscal year.

"The Legislature may provide for the investment of moneys available in the Texas Water Development Fund, and the interest and sinking funds established for the payment of bonds issued by the Texas Water Development Board. Income from such investment shall be used for the purposes prescribed by the Legislature. The Legislature may also make appropriations from the General Revenue Fund for paying administrative expenses of the Board.

"From the moneys received by the Texas Water Development Board as repayment of principal for financial assistance or as interest thereen, there shall be deposited in the interest and sinking fund for the bonds authorized by this Section sufficient moneys to pay the interest and principal to become due during the ensuing year and sufficient to establish and maintain a reserve in said fund equal to the reserve in said fund equal to the average annual principal and interest requirements on all outstanding bonds issued under this Section. If any year prior to December 31, 1982 moneys are received in excess of the foregoing requirements then such excess shall be deposited to the Texas Water De-

thereafter received as repayment of principal for financial assistance or as interest thereon shall be deposited in the interest and sinking fund for the administrative expenses of the Board may be annually set aside; and provided, that after all State bonds have been fully paid with interest, or after there are on deposit in the interest and sinking fund sufficient moneys to yay all future maturities of principal and interest, additional moneys so received shall be deposited to the General Revenue Fund.

"All bonds issued hereunder shall after approval by the Attorney General, registration by the Comptroller of Public Accounts of the State of Texas, and delivery to the purchasers, be incontestable and shall constitute general obligations of the State of Texas under the Constitution of Texas.

"Should the Legislature enact enabling laws in anticipation of the adoption of this amendment, such acts shall not be void by reason of their anticipatory nature."

Sec. 2. The foregoing amendment to the Constitution shall be submitted to a vote of the qualified electors of this State at an election to be held on the 6th day of November, 1957, same being the 1st Tuesday after the 1st Monday in said November, 1957, at which election each ballot shall have printed thereon, the following words:
