

prairie in slabs about 2 feet wide by 3 in length, and on the side of the knoll, where an excavation had been made in its side, these slabs were placed one on top of the other until the required height was reached. It was arduous work, and I remember what a lot of excitement there was when my father and my brother Lem started off early one morning to go after the ridge pole and rafters that were to support the roof. Washington, D C., April 7 .- A oill which is claimed meets in a large part the objections stated by President Cleveland to the Bland seigniorage bill was to-day introduced by Representative Meyer (Bem) of Louisiana. It provides for the coinage of standard silver dollars and for the issue of new bonds in lieu of bond : heretofore authorized. The bill repeals such portions of the resumption act of 1875 as authorized the issue of 4, 4 1-2 and 5 per cent bonds. In lieu of these the Secretary of the Treasury is authorized Imqure Blood, Bolls, Car- to sell bonds of \$20 and multiples thereof, payable in coin, after five years bearing interest not exceeding 3 per cent. Provision is made
