Over 250 Names Deemed Ineligible to Vote

The regular meeting of Commissioners Court was held Monday, April 10, at 9:00 a.m. The agenda follows:

Senior Citizen Seminar

Agnes Vondy approached the Court asking for \$462.42 to cover the cost of attending a Senior Citizen's Seminar in Austin. County Attorney Tully Shahan informed the Court that he could not find a law that would give them authority to finance this seminar.

Commissioner Bizzell asked if it would be legal for him to transfer his unused seminar funds into the Nutrition Center budget so Ms. Vondy and another representative of the Nutrition Center could attend

this seminar. Shahan said that he couldn't find anything illegal with that. Commissioners Slubar, Garza and Fuentes also offered money from their seminar funds in the amount of \$150 each, making a total of \$600, allowing enough money to also cover food expenses on the trip.

Blue Cross Blue Shield Denies Payment

County Treasurer Carlotta De La Rosa informed the Court that she had received a letter from Blue Cross Blue Shield stating that although the Commissioners Court of 1986 had adopted the policy on the understanding that it was to cover life insurance for retired employees, that in effect was not a policy for that type of coverage and sent checks back in refund to all persons that had been paying for that coverage.

The family of Albert Postell refused to accept the refund check and stated their intent to De La Rosa to take this matter to trial.

Robert White Case

Upon Attorney Shahan's advise, Judge Tommy Seargeant recused himself from trying the case of Robert White, due to Tommy being disabled to handle the case. Judge Jimmy Simmons was appointed as presiding Judge over charge filed on Robert White, seeming displeased with this decision stated, "Let it be known that it is 'his' - referring to Shahan - 'friend' - referring to Judge Simmons - that he wanted all along."

250 to 300 Names Taken Off

Voters Registration List Tax Assessor collector Tim Ward reported to Commissioners Court that 250 to 300 names would be removed from the voters registration list because they are not eligible to vote in Kinney County. (A list of Pct.

3 names that have been removed can be found on page 4.

Roof Repair

Approved was the accepting of bids on Civic Center roof repair and Courthouse roof and gutter repairs.

Kinney County Budget Review

County Auditor Betty Deason informed the Court that they were operating in a deficit budget of \$43,100. This does not mean that the county is broke. The county to date has \$736,437.81 in the bank.

According to Commissioner Bill Bizzell, at the end of the fiscal year if spending proceeds as it has - they should have close to \$400,000 left.

The deficit in the budget occurred during the first six months of operation. The budget was emergency ammended on the following dates:



4-H Highway Clean-up Scheduled

The Kinney County 4-H Club will be having their annual Hiway Clean-up this Saturday morning at 8:30 a.m. They will be cleaning 2 miles of Highway 90 West.



The new Kinney County Grand Jury was sworn in for the new term to serve from April until October 1989. Their first line of business was to hear a case involving a local man charged with a 3rd Degree Felony offense of Carrying a Prohibited Firearm on Licensed Premises.

Ruben Manzano Reyes, a 53 year old Mexican National who recently applied for citizenship in the U.S., was arrested on February 12, 1989, after reports were recieved at the Sheriff's Office of his having pulled a pistol on a local barowner. Reyes was arrested approximately 15 minutes after the report was received by Chief Deputy David Luna and Chief of Police Johnny Fritter as he walked along James Street near the Methodist Church.

A "patdown" of the suspect at the scene turned up a small semiautomatic pistol tucked behind the suspect's belt and concealed by his shirt. Reyes was arrested without incident, transported to the county jail and booked on the felony offense. He was magistrated by Justice of the Peace Alvin Hall and has remained in the county jail in lieu of \$5,000 bond since his arrest.

Reyes was indicted by the Grand Jury Friday, April 7, and his arraignment has been set for April 17, 1989. It is anticipated that an attorney will be appointed to represent him at subsequent hearings or trial.

a group of illegal aliens from Mexico broke into a rural residence located approximately 15 miles west of Brackettville on Sunday, April 9. They were apprehended a short time later by U.S. Border Patrol agents on patrol in the area. Entry to the residence was gained by force through a front window of the residence and various foodstuffs were taken by the burglars. Prosecution of the Mexican Nationals was declined after it was determined by investigation that one of the group was the brother of a previously apprehended illegal alien who was diagnosed as having infectious hepatitis.

It was feared that the whole group might be infectious and would spread the disease to law enforcement officers and other prisoners should they be held in the county jail. Consideration was given to the fact that only approximately \$25 worth of food was taken and the costly expense of holding the culprits for several months, appointing them individual attorneys, and then trying them. After the victim homeowners declined prosecution, they were quickly processed and deported back to Mexico.

Another burglary was reported by the owner of a hunting camp in north Kinney County on Monday, April 10. The victim did not know exactly when the crime took place but estimated sometime within the past 3 or 4 weeks. Several items were taken including various tools, beer, knives, .22 caliber ammo, and a 100 ft. extension cord. Due to the varied assortment of stolen items, it is believed the crime was committed by someone other than illegal aliens. We have been plagued by hunting

camp burglaries over the past 3 or 4 years. In some cases, large items such as stoves, refrigerators, and air conditioners have been taken. We have a slim lead in the cases but at this time no solid evidence has been turned up that will allow an arrest. Some of the cases are believed to have been committed by the same person or persons.



Heat jelly until melted, stir in KIRSCH, arrange strawberries on top of cheesecake, spoon jelly mixture over strawberries. Chill before serving. My what a treat!



Gypsies have been with us for a very long time. The ancestry of the . modern gypsy began in northwestern India. A thousand years ago, they left India and roamed through the Middle East into Europe and Central

Because of lack of unity in politics and military affairs, the gypsy came to be oppressed. For several hundred years, the gypsy were enslaved in central Europe. Many came to America with the Spanish and Portuguese. Because their masters abused the gypsy women, gypsies are mostly of European descent.

In 1856, Gypsy slavery was repealed, it still continues in many localities. During the second World War, half a million gypsies perished in Hitler's gas chambers. To enter America, a gypsy must get their passports as a citizen of the country they came from. That's why there is no official count of them in the United States.

The different groups, or clans, are very particular and strict about accepting a new member. In the southwest, the largest groups are Machwaya and Kalderasha. Other groups travel over Mexico. Others travel South America, but the groups do not mix. Most everyone in the group are related by marriage, which only further weakens the clans. Most of the time the sons work with their fathers doing contract labor and the daughters stay at home to learn from their mothers.

The first job contracted in the beginning of the new year indicates what the rest of the year will bring, so the gypsy, or "Rom", as he prefers to be called, makes an effort to control the type of job he likes.

Gatherings and celebrations are usually attended only by the group.

There are so many taboos, it is easier to have their good times within their own group.

Gypsy music is especially exciting and soul stirring. They stay longer in one location now a days. Even for settled "Rom", traveling has not been given up entirely, especially to a wedding, which is very expensive and lasts a long time. Because of the extensive traveling, parts of other languages have been mixed in with their own and passed down from generation to generation.

Because they wish to lead an exclusive clannish life, they are mistrusted. Sometimes they change their surname and claim to be Greek or Italian, which can be believable because of their dark complexion.

The gypsies used to come to our town when I was a child. They came in gaily decorated wagons with flower boxes under the windows. Probably you could consider them the forerunner of the travel trailer set. Their horses were beautiful Arabians. They camped down on the river and around their campfires at night, they played their haunting gypy music, and danced, and the women told fortunes.

Against our parents wishes, we would slip down to the river, and staying hidden, we watched and listened. It was like a fairyland to us. The music was like the Flamenco you hear today. It can never be forgotten, and once you are under its spell, you are hooked on that kind of music.

We were told to stay away from these strange people because they stole little children and took them away in their wagons. I never heard of such a kidnapping happening. I think we were told that because our parents didn't understand their culture and were afraid of something they didn't know about.





Would you really like to enjoy birds in your yard? You can have them with a little effort. Simply to hang a bird feeder will bring in some birds. There are better ways, however.

A small concrete slab (6'x6') can be utilized effectively located near trees is best. A bird feeder above it is helpful, but not necessary. Wild bird seed is available and when bought in quantity (25 to 50 lbs) is not really all that expensive.

Spread some feed early in the morning or in the late afternoon and birds can be drawn to it. They will form the habit of coming at a given time. If you sit absolutely quiet, you will not disturb them, but if you so

much as move a hand or arm, they

If this is too much a problem, simply hang a feeder with seed under a tree and enjoy watching. Do not hang the feeder over a flower bed. If you do, you will have a continuous fight with unwanted plants and grasses. Seed falling from the feeder will germinate and make a mess in the flower bed.

It is truly fascinating to watch birds come to feed. You will be agreeably surprised at the number and types of birds you attract. Just be patient, when they know the feed is there and are comfortable regarding their safety, they will entertain you.







One Hundred Years Ago, in a Wide and Raw Land......

One hundred years ago, in the wide and raw land that is now Uvalde, Medina, Bandera, Kerr, Real, Edwards, Kinney and Val Verde Counties, Fort Clark's Lt. John L. Bullis rode with four woolly privates of the Ninth Cavalry in advance of a main company of soldiers. In a land raked and burned by Indian violence. they rode in search of warriors. In the afternoon, they discovered three Indians driving a large herd of stolen

Bullis and the scouts attacked at once, capturing the herd and scattering the Indians. But the Indians returned, now a force of 28 braves, driving a second herd of cattle. Bullis and his scouts turned, attacked again and battled for half an hour, until the Indians were chased into hiding. Quickly gathering both herds of stolen cattle, they returned to their company.

Lt. Bullis inspired the famed Seminole Negro Indian Scouts to their most daring deeds by leading the charge. Huddled around their fires at night, the Indians spoke of Bullis as "The Whirlwind" who struck fear and disaster without

When the Texas frontier between San Antonio and Brackettville's Fort Clark had been deemed safe from further Indian attacks, the Army transferred Lt. Bullis on to the hostile country of Indian Territory, Arizona.

Widely regarded as the man who brought peace to the Texas frontier, the people of the area were shocked and saddened to hear of Bullis' transfer. The newspapers of 1882 fully expressed the wide-felt regret at Bullis' departure. It was the "Quill" of Castroville that proposed raising a fund to present First Lt. Bullis with a sword, as testament of the people's gratitude. Other newspapers, the Bandera "Bugle", the Uvalde "Hesperian", the San Antonio "Express" and the "Fort Clark News" soon joined the drive, raising money and esteem for Bullis.

Constructed in Boston, word soon spread of the sword's beauty. A continuous battle charge of soldiers and Indians was being etched lengthwise down the golden blade, with etches of the Goddess of Liberty, the American Eagle, a camp scene in the Chenati Mountains and a portrait of Bullis also planned. It would read: "Bullis, the Friend of the Frontier" and "He Protected Our Homes - Our Homes Are Open to Him. Presented to Jonn L. Bullis by the people of Western Texas."

Not to be outdone, the citizens of Kinney County, home to Bullis during his dozen years at Ft. Clark, raised funds to present the legendary soldier with an additional sword. Shortly after completion of the first sword, it was joined by a second of scarcely less beauty. Silver, with a seed pearl hilt, it said: "Presented by the People of Kinney County as a token of their undying gratitude."

After Gen. Bullis' death on May 26, 1911, the swords continued to hang in his magnificent San Antonio home. Later, as his daughters grew older, they gave the swords to the Witte Museum. In the shuffle during the passing years, the Witte Museum grew into what is now the San Antonio Museum Association. The Bullis swords were eventually placed in a box, and stored in the basement of the Witte Museum.

Charles G. Downing of Fort Clark Springs is obsessed with western history. J. Lee Ballantyne of Brackettville, and her brother, Paul Hill of Castroville, grew up in the area, and remembered the legends. All had asked to see the Bullis sabers as the years passed, and each was denied. The Bullis blades were in a box, and no exhibition was planned.

Upon hearing that the swords were in storage, the Fort Clark Springs Member's Association requested a temporary loan for a display in the Fort's Old Guardhouse Museum during the annual cavalry trooper's reunion on April 21-23. The museum association denied the request, saying the old post jail wasn't proper facility for the Bullis swords.

A March 1, San Antonio "Express-News" story saying "SAMA, Fort Clark locked in duel," and "Bullis swords spark turf fight," set phones ringing in the museum association's office, and officials singing a different tune.

As a result of the controversy, the famed swords of West Texas legend Gen. John L. Bullis will be on display for one day only, April 22, 1989, at the Old Guardhouse Museum at Fort Clark Springs in Brackettville. The display, underwritten by Sterling C. Evans of Castroville, will run from 9:00 a.m. to 5:00 p.m. on Saturday only.

The Bullis swords display will be a special addition to the Ft. Clark Trooper's Reunion and Commanding Officer's Quarters historic marker dedication ceremony, also planned for April 22. Former Gov. Dolph Briscoe of Uvalde, will


