Kinney County and the City of Brackettville receives \$3000

Last week Police Chief Alonzo announced at the regular monthly City Council meeting that they had received a \$3,000 grant.

The grant is for the enforcement laws in Kinney County and was received from the State of Texas Comptrollers office.

In June of last year both the County and the City approved the application submitted by Kinney County Constable Cordelia Mendeke and Police Chief Arnulfo Alonzo for this grant.

The monies granted must be applied as follows: 40% for stings, 25% for compliance inspections, 25% community compliance/education, 10% required reporting.

According to Chief Alonzo the first step is to educate local merchants, parents and our students, about the law on minors and tobacco products.

"We must begin with our merchants, as they are the key to stopping any sale to minors or

to an adult they suspect of giving the tobacco product to a minor," said Chief Alonzo.

"We would work with other counties in other areas, like Del Rio, Eagle Pass, and Uvalde.

Our kids that are helping us with this project would help them.

They would go into their stores, places of business, and try to buy tobacco products.

It would be a sting basically and we would bring in unknown kids to this area to conduct stings," said Constable Mendeke

Any store or vendor in violation during a sting or inspection would be reported to the State Comptrollers office, in addition to a local citation.

"We as a community must unite together to work with and for our minors," Alonzo added.

Meetings are planned to explain the law and the responsibility of all parties involved.

Information on the meetings will be posted in the very near future as well as public notice through the newspaper.

Man dies attempting to cross West Prong

Billy Joe Howton, 74, of Houston, drowned in the Nueces River last Friday night.

Howton was traveling with his, 48 year old, son to their deer lease in Kinney County.

They were headed west towards Brackettville on Ranch Road 334.

At approximately 8:30 p.m. they attempted to cross the West Prong of the Nueces River and were swept from the roadway.

Their '89 Dodge Van came to rest upright about 75 yards downstream.

Not knowing they had made it over halfway across; the men exited the vehicle and swam towards the east side of the river.


Howton's son made it across but lost sight of his father in the

process. It was around 1:30 a.m. Saturday before another car arrived and Howton's son was able to call for help.

Search and rescue workers arrived at the scene at approximately 2:15 a.m.

Kinney County Sheriffs Office, Kinney County Emergency Medical Service, Kinney County Volunteer Fire Department, Department of Public Safety Troopers, Uvalde County Sheriffs Office, Uvalde County EMS, Uvalde County Fire Department and United States Border Patrol were all involved in the search.

Howton's body was found shortly after 9 a.m. one half mile downstream.

County terminates CiviGenics agreement

Kinney County Commissioners terminated a Lease/Purchase Agreement with CiviGenics last Monday afternoon.

The 1998 agreement for a 500 bed detention facility was cancelled due to failure to obtain financing.

"I really regret that it has gotten to this point but I certainly understand. We haven't done what we agreed to do," said Bob Prince of CiviGenics.

Herb Bristow, an attorney representing Kinney County, explained to commissioners that on four separate occasions financing on the transaction had been setup.

"There were a lot of things that were really related to timing in the market place. Different issues that really were beyond our control. We worked through each one of those and they would get to the table and then something would happen," Bristow said.

The most recent financing problem occurred 6 months ago.

"Our end of the deal was suppose to close on Wednesday but there was a glitch in the paperwork. They decided to meet the following Tuesday and let the

attorneys work it out. On Thursday night is when two of the three principals were killed in a plane crash," Prince told the court.

"That is how frustratingly close we have been during this time," Prince added.

Bristow advised the court that to be clear, on where they stood, they should consider a formal motion to cancel the transaction.

"It is probably in the county's best interest to sever ties with the past RFP (request for proposal). We understand that; we are embarrassed that its gotten to this point," said Prince.

The court unanimously agreed to terminate the agreement.

The court also agreed, by unanimous decision, to cancel the agreement for Architectural Consulting Services for the detention center.

Commissioners unanimously approved the preparation and publication of Requests for Proposal for the design, financing, construction and operation of a 300 bed detention facility. These RFPs are based on the previously selected site, currently owned by CiviGenics.

Alien found dead near Mud Creek

Carlos Lazaro Diaz, 41 from Durango, Mexico died on the Rio Springs Ranch sometime Tuesday morning.

The ranch is located approximately 15 miles west of Brackettville on Mud Creek road.

Diaz, an illegal alien, was

traveling with 3 other men. Diaz told his companions, Monday afternoon, he could travel no further.

The four men made camp on the banks of Mud Creek approximately three and one half miles north of Highway 90.

They woke the following morning to discover Diaz had died during the night. Two of the men then flagged down Border Patrolmen to ask for assistance.

EMS Public Hearing

EMS Update

Let's dive right into the subject this time! December 31, 2001, at midnight, our Texas Department of Health temporary personnel variance expires. There is a chance it can be renewed but we must first do our part. The first part is to let the citizens of this county know exactly what this variance is all about.

Our Public Hearing to address this matter is on Thursday, December 6, 2001 at 9:00 a.m. at the EMS Station.

According to TDH rules, all EMS units must be staffed with a minimum crew of two EMS certified (ECA, EMT Basic, EMT Intermediate, and/or Paramedic) personnel on board. As of November 1, 2001, we do not have certified people available on a 24-hour basis to man two or more units. If we did, it would require at least 4 EMS

certified crew members at all times.

A temporary personnel variance allows us to function as required for the first EMS unit committed to a call; since we cannot guarantee that we have two full crews at all times, the variance allows us to use non-certified drivers with one certified EMS attendant.

If this request for variance is approved, this will be our fourth year requesting a variance (made since 1997). The personnel variance is designed to assist rural EMS to develop a plan to compensate for the lack of personnel available to make EMS calls in the area. During 2001, Kinney County has run a total of 25 calls where two or more ambulances and crews were needed. The majority of these calls occurred when our primary unit was committed to a call and another EMS call came in.

Local Lions host 12th annual Health Fair

The local Lions Club hosted its 12th annual Health Fair last Thursday.

With over 380 people signed in, the event was well attended. Eye exams, hearing test, blood pressure and blood sugar tests were free of charge. Flu and pneumonia shot were also available for a nominal fee.

Members of the Texas Department of Health were on hand to administer the Flu and pneumonia shots.

The Lions Sight Research Foundation had their Mobile Eye Screening Unit (MESU) giving visual acuity and inter ocular eye pressure (Glaucoma) test.

The research foundation was formed in 1982 by the Lions Club of Texas District 2-A2. Fund raising for the MESU began in 1995. Through the help of the Lions of the District 2-A2, H.E.B., state funding, numerous private and University benefactors the MESU became a reality in the spring of 1996.

The foundation also created the Lions Sight Research Center at the University of Texas Health Center in San Antonio in 1991.

Middle Rio Grande Development Council was at the fair updating 911 addresses and information for rural residents of Kinney County. Addresses are assigned according to distance from the nearest intersecting highway. Addresses in the hundreds represent tenths of a mile; one thousands represent miles. For example an address of 5400 Ranch Road 674 would be 5.4

miles north of Brackettville.

Anyone in Kinney County, who has not received a 911 address should contact Forrest Anderson at 888-945-3940. Those in rural areas should have the address posted on the nearest paved road. This will help EMS, the fire department or sheriff's office find your home during an emergency.

Life Line Screening, a mobile

medical screening company, does testing to provide early detection and prevention related to Stroke, Vascular Diseases and Osteoporosis.

The three vascular screening tests are Carotid Vascular, Abdominal Aortic Aneurysm and Ankle Brachial Index.

The Carotid Vascular test visualizes the buildup of fatty deposits in the arteries which can lead to stroke. The test is non-invasive and painless.

The Abdominal Aortic Aneurysm test checks for the existence of an aneurysm or enlargement in the abdominal aorta that could lead to a rupture. This test is also painless.

The Ankle Brachial Index test screens for peripheral arterial disease in the lower extremities. Studies suggest an abnormal ABI may indicate peripheral arterial disease as well as a high risk of coronary artery disease. The procedure consists of placing a blood pressure cuff and Doppler ultrasound probe on the arms and ankles.

The company also does Osteoporosis testing on women over the age of 45 to screen for abnormal bone mass density.

The test is performed with an ultrasound unit and is painless.

Life Line was giving away free chances for a Stroke Screening. Their mobile unit did screenings at Frontier Baptist Church last Tuesday morning.

Community Council of Southwest Texas had a booth for its Southwest Transit Operations Program (STOP). It is a rural public transportation service that is funded by both the state and the federal government. Local representative Beverly Wright gave out route schedules and explained how the program worked.

The program covers nine counties; Dimmit, Edwards, Kinney, La Salle, Maverick, Real, Uvalde, Val Verde and Zavala. The three primary routes from Brackettville are to San Antonio, Del Rio, and Uvalde. Trips to Brackettville are also available for rural residents of Kinney County.

Medical transportation is also available for Medicaid eligible clients. Their transportation fees are covered by funding from the Texas Department of Health.

The fare to San Antonio is



Bonilla's District Stays Intact

Washington D.C. - The court battle over redistricting is likely over and Congressman Henry Bonilla's 23rd district remains almost completely intact. "I've become very attached to the people of the 23rd district. We work well together and have supported one another for the past nine years. I'm thrilled that I'll continue representing them, hopefully for many years to come," said Mr. Bonilla.

A three-judge federal district panel issued an order today adopting new congressional districts for Texas. After close review, Mr. Bonilla's district looks largely the same. He will keep his portion of Bexar County (San Antonio) and retain almost all 800 miles of his border region, which includes Laredo, Eagle Pass, Del Rio and parts of El Paso County. According to the new map, the 23rd district will also gain Real County.

"I feel very fortunate to have kept such a large portion of my district. When you look at the big picture, things look pretty familiar," said Mr. Bonilla. "The people of the 23rd district should expect great things. I look forward to being a part of their continued success."

"I also understand that I've gained an additional county. I look forward to getting out to Real County as soon as possible and meeting my new constituents. I welcome them to the 23rd district - it's a great place to be" said Mr. Bonilla.

Unfortunately, due to population growth in the 23rd district, Mr. Bonilla was forced to lose more than 111,000 constituents. These losses were seen specifically in Loving, Winkler, Ector, Midland, Ward and Crane Counties.

"I fought hard to keep all my constituents, but when it came down to drawing the final lines, the court was forced to make a few changes," said Mr. Bonilla in response to losing six of his counties. "I have great pride in the state and federal court system, but I sure will miss the people in and around Midland and Odessa. We've been through some good times and I can only hope I've added something to their communities and their lives."

Representative Henry Bonilla has been serving the people of the 23rd district since his first election in 1992. The 23rd district is the largest in the state of Texas. It spans two time zones, three climates and covers almost 800 miles of the Texas/Mexico border.

The office of homeland security

Capitol Comment

Recently, we celebrated Veterans Day — a day that honors our nation's many military veterans. It is on this day that we as a nation are to reflect upon the personal sacrifice and courage of those involved over the years in the struggle to protect our liberty. Over the years, the willingness of these brave men and women to risk their lives have meant we remain free, proud and protected.

This year though, in an all-too sad coincidence, Veterans Day also was the two-month mark of the heinous attack against us. Unlike years past, when our military men and women fought wars on foreign shores, this attack brought the front lines here, to our soil. We are all now called to do battle and to defend our hard-won principles.

Our first line of defense is the Office of Homeland Security. A few weeks ago the President created this office by executive order to show Americans that every possible step is being taken

to ensure their security.

The mission of the office is to coordinate federal, state, and local counter-terrorism efforts to strengthen protections against terrorist threats or attacks. It is critical that we have an organized and comprehensive national strategy to help protect the United States — that is, one of force that not only looks for future attacks, but defends us from them and, finally, helps us to rebound after them.

President Bush appointed former Pennsylvania Governor Tom Ridge, a decorated combat veteran, to head the office. Governor Ridge, who will report directly to the President, has the strength, experience, personal commitment, and authority to take on this challenging assignment. In this time of crisis, your leaders in Washington are taking a variety of steps to ensure our security and punish those responsible. For example, we passed a new antiterrorism law to give our law enforcement agencies better capability to respond to the new technologies, such as allowing, with a court order, wire tapping of a

person instead of a phone number.

In addition, we are moving to secure our airports now and in the future, our public health officials responded quickly against the anthrax threat, and already the Coast Guard and the National Guard have expanded their duties both to protect our shores and ports and to provide increased surveillance at our borders. At the same time, our brave men and women in the military are on foreign lands tracking down the evildoers.

All of us have responsibilities though, in this new war — we must refuse to give terrorists the power they are seeking, the power of fear. As the President said recently, "There is a difference between being alert and being intimidated, and this great nation will never be intimidated."

We must go about our daily lives, and at the same time we must remember to focus on what truly matters — we must treasure the awakened appreciation for our nation, our values, our neighbors and our families. Make a commitment to this emotion — in dedication of the

memory of what happened on September 11 — and find a way to offer service in your community. Defy the terrorists by showing how strong our spirit and good will are — how strong our American values are.

Our good fortune in never having had our shores violated by international terrorism is both a blessing and a curse. It means that we have, unfortunately, a learning curve. I assure you though, we are responding rapidly, forcefully and appropriately. It is the character of our nation and our people — we can quickly adapt to circumstances and always have. Sam Houston once said, "Texas has yet to learn submission to any oppression." Houston, who spoke during the quest for freedom for Texas from Mexico, was thinking of the character of our people — of our conviction, determination, and, admittedly, our bullheadedness! Today we are fighting for freedom from terrorists, and his thought is apt today: America will never learn submission to any oppression.

We are the best. We have a just cause. And we will prevail.

The Kinney County Arts Council's "Annual Christmas Homes Tour" is scheduled December 2nd from 2:00 to 5:00 p.m. All homes to be displayed are located on Ft. Clark in Brackettville, Texas. The tickets are \$5.00 and the project is a major contributor in bringing cultural events to the school children of Kinney County, funds are also matched by the Texas Commission on Arts.

One of the new homes to be toured is owned by Mr. and Mrs. William Cronin, which is located toward the east end of Fairway Circle. The dwelling was built in 1997 out of cedar and Austin stone, with three dormer style windows. Trim throughout is natural pine, and a beautiful balcony overlooks the living room. There are 3 bedrooms, 2 1/2 baths and a large "secret room," as the children call it located above the carport.

Exquisite Christmas decorations will be displayed throughout the home from Barbara Voss's collection of Christmas Around the World open invitation from the House of Lloyd.

Christmas at the Alan and Xyan McWilliams home reflects elegance and a graceful display of vintage furnishings. It is located at 3105 Bowlegs and is an

example of an excellent use of space. The dwelling was built about six years ago and was designed to create a spacious feeling with all rooms open to each other without utilizing hallways.

Megan 16, has a pretty room decorated with cheerful flowers and her collection of Barbie dolls and Beanie Babies. Her personal Christmas tree is white and decorated with angels and pieces special to her.

Mason 14, has a typical Southwest style boy's room and a Christmas tree decorated with red and western decor. Each child's room has an adjoining bath.

The living room will be dominated by an enormous green tree with white lights and covered with old fashioned gigantic elaborate gold and crystal drops. The ornaments vary with hearts, gold crosses, stars, hunter green Christmas balls, and many, many rich colored ribbons. In Christmas seasons past, people stopped by to view the tree. The McWilliams family is generous in sharing their home with the annual Kinney County Arts Council Christmas Tour of Homes.

Along with the Cronin and McWilliams homes, other historical and contemporary homes to be toured give an overview of a "Now to a Back Then" theme.

The Daughters of the Republic of Texas Library Committee and Library Staff once again put together a successful and very informative forum relating to Texas History, Chapter members and guests from around the state gathered at Alamo Hall situated on the grounds of the Alamo for a slightly different type forum.

This one pertained solely to contributions of women in the early days of San Antonio.

Maria Watson Pfeiffer, who received her master's degree in urban studies from Trinity University, told the story of the Ursuline academy as it reflected the intricacies of San Antonio at its best-from construction and operation of the school, to the survival of its building, to the founding and flourishing of the Southwest School of Art and Craft.

It was a story that had three themes-education, historic preservation, and love of artistic invention-that merged to produce and preserve this unique place.

The second speaker, Gerianne Schaad, reported on her investigation of the collections of the San Antonio Woman's Club, the Tuesday

Musical Club and the Pan American Roundtable in helping to define the motives and impact of some strong and influential San Antonio women.

These were women who saw needs in their community and addressed them, according to Ms. Schaad, who received her master's degree in library and information science from the University of South Florida and is currently a certified archivist with the University of Texas-San Antonio.

A native San Antonian and long time board member of the San Antonio Conservation Society, Sally Buchanan was eminently qualified to discuss that organization's beginnings in her topic "Emily Edwards and Rena Maverick Green: The Establishment of the San Antonio Conservation Society."

Educated at Mills College with a degree in art history, Sally serves as a Bexar County director of the San Antonio River Authority and is a member of San Antonio's Downtown Advisory Board and the Downtown Alliance.

Nationally respected speaker Dr. Judith Sobre, professor of art history at UT-SA, explored

how the Battle of Flowers parade evolved into a festival institution in San Antonio-which was, and still is, the only parade of this nature run entirely by women. Dr. Sobre received her Ph.D. from Harvard University and her latest book Celebrating in the City, Six Festivals in San Antonio, Texas 1866-1900 is to soon be published by Texas A & M Press.

Following the program a luncheon was held at the Menger Hotel to allow members to visit

with the presenters. DRT members from Uvalde's Caddell-Smith Chapter in attendance were Vice-president Fran Brookshire and Registrar Pat McKelvy, as well as former chapter member Jane Knapik.

The next Texas History Forum is scheduled for Friday, February 15, 2002 and will pertain to Native Americans.



County EMS requires personnel variance

Part of the plan to recruit and train EMS personnel is to partner with South West Texas Junior College, using distance learning resources in the area to carry on EMS training throughout the region. It is hoped that through contact with other area EMS providers by training their personnel, we will obtain additional qualified EMS certified people.

Since starting the Kinney County EMS Training Program and offering courses here, we have gained a total of 5 new volunteers. Progress has been made but not to the extent where we have full coverage without outside assistance. We currently have 9 TDH certified people who make the majority of the runs.

Without the variance Kinney County EMS would require staffing we do not have locally, as proven in the last two years by hosting three EMS courses and gaining 8 new members but retaining only 5. These members help out most often on weekends. For everyone's information, in the report issued to TDH for this renewal, after recruiting outside the area for volunteers and part time paid people, plus the new members trained by Kinney County EMS, we added 13 new names to the roster; however a total of 8 personnel are no longer with this county for a variety of reasons. One new member is unable to "run" with us because of injury and will not be available until after January 2002.

One of the ramifications the variance carries with it is reduced revenue. When an ambulance has

less than two EMS (certified) caregivers on board, EMS cannot legally charge insurance, Medicaid, or the patient him or herself the "going" rate for services and skills. Example: the first unit is on the way to the hospital with its crew and patient; the second unit is called in. As an example, on board the second responding unit, there is a non-EMS certified driver and may be (minimum training level is ECA) an advanced attendant (Intermediate or Paramedic). Because of the advanced level of skill on board, the certified EMTI or P must treat at that higher level of care, if needed (intravenous lines, heart monitor, certain drug interventions). EMS is unable to charge for those skills and supplies, which effects the overall revenue. If there are as many as 20 calls per year where the variance is used as in the example, this could mean as much as \$5,000 to \$6,000 (\$250 to \$300

less per call) revenue.

One point to keep very clear is that we maintain the highest level of staffing we can provide. In all cases there will be at least one EMS certified attendant with our patient. That EMT will give our patient the highest quality of care possible. Mutual aid is available in any direction we travel to augment our system in the event of disaster. Crews may call for "intercepts" from our mutual aid EMS brothers and sisters for added help when higher level of care is needed.

As taxpayers in Kinney County it is your right to be informed. Please show up for the Public Hearing on this variance.

Home Oxygen and Medical Equipment from Del Rio also had a booth. They had a variety of medical supplies they sell on display. They also sell oxygen equipment, hospital beds and wheel chairs. Delivery is available to patients with Medicare or Medicaid.

370 people received flu shots, 82 people received eye test and 40 people received hearing test. Many individuals also had blood sugar and blood pressure checks.
