Candidates debate city issues

The 2004 Brackettville city election has turned out to be one of the most controversial in recent times, with mudslinging and the vandalism of political signs.

But there were little fireworks Monday when close to 100 citizens turned out to meet the candidates and to ask questions concerning local government.

The forum, held at the Brackett ISD Auditorium, was organized by Beverly Garcia and Elizabeth Goebel. Neil Simmons served as the moderator for the event.

"This is a first," said Joe

Garza, mayoral candidate.

J.J. Guidry, also seeking the mayor's post, added: "I am so glad that we have this opportunity to discuss the issues with you this evening. I'm thankful that you chose to come out and spend some time with us to get to know us better."

The forum began with the mayoral and council candidates discussing their platforms.

Garza, Guidry and Ponce Padron are all vying for mayor.

Garza said he is running for mayor because of the turmoil facing city government.

"I'm very familiar with this community," he said. "We're not a rich community. Our tax base is not as healthy as I would like for it to be. But I believe that I can take this community in a positive direction."

Garza, a native of Brackettville, has 29 years of experience in education.

"I feel very strongly about my qualifications and credentials," he said. "I feel like I have something to offer this community. I have extensive knowledge, extensive experiences in many areas, budgetary as well

as administrative.

"The role of the superintendent is a very complex role, and I served in that capacity for eight years. You have to be prepared for everything. It is very politically oriented, but the rewards are great."

Guidry, also a Brackettville native, served a two-year term on the City Council.

"During that time the city was very prosperous," he said. "We had over \$500,000 in the bank. We never raised taxes while I was on the council and

Miller joins water board Shahan considers taking GM's post

Dub Miller of Fort Clark Springs was appointed to the Kinney County Groundwater Conservation District Board of Directors by the Commissioners Court Monday morning during a special meeting.

Miller is filling the vacancy for an at-large position for Fort Clark following the resignation of Bob Young.

The motion to appoint Miller as a director was made by Pat Melancon, commissioner of Precinct 4, which includes part of Fort Clark Springs.

"In talking to Tom Saylor, the president of the Fort Clark board, he only had one name. He recommended Dub Miller, who has a geology background and is willing to serve. I think he helped some on the development of the master plan," Melancon said.

Terrazas asked if the position had been advertised.

"We don't have to (advertise)," County Judge Herb Senne said. "We can if you want to."

Terrazas replied: "I just wanted to know how they went about it and how many people knew about this."

In previous appointments, the court advertised the openings and then interviewed the appli-

cants.

"I didn't have anyone else indicate an interest to me," Senne said. "I didn't advertise, but the action of the groundwater board was publicized. I would assume that if there are folks interested in the appointment, we would have heard from them."

"We don't have to pull the trigger now," Melancon said. "The position is up for election in November."

Senne replied: "I'm ready to make the appointment, but if y'all are hesitant to do so, we can wait."

Melancon added: "I don't know that you can find anybody willing to jump into this fire."

Senne said the court may soon be faced with appointing another director, "if the groundwater board wants to fill it between now and the election."

Darlene Shahan is expected to resign her position from the board to become the general manager. She was offered the job earlier this month. Shahan had previously served as the interim general manager.

"I think there was some sort of verbal announcement that she made at their last meeting when she was appointed general manager," the county judge said.

Couple arrested for drugs

A Del Rio couple was arrested Sunday evening after a routine traffic stop resulted in the seizure of over 54 pounds of marijuana.

Jesse Martinez, 18, and Vanessa Briones, 22, were both arrested by DPS Trooper Tully Welch on a second-degree felony charge of possession of marijuana. Martinez was booked into the Kinney County Jail and Briones was transported to the Wackenhut Correctional Facility in Del Rio. Both were still in custody at press-time.

Welch was on routine patrol when he stopped a black Pontiac for illegal window tint on Highway 90, about 8 miles east of Brackettville.

The driver and the passenger of the vehicle gave conflicting stories about their trip. The driver gave consent to search the vehicle and 35 bundles of marijuana was found in the spare tire well of the trunk. A subsequent

search the following day revealed an additional 15 bundles located in the left rear of the fender.

The Kinney County Sheriff's Office assisted in the investigation.

Local Emergency Planning Committee meets

The Kinney County Local Emergency Planning Committee (LEPC) met Monday at the EMS building with chairman James Reesman presiding.

Among those present were County Judge Herb Senne, the county chairman of LEPC; Steve Burch, the Brackettville Committee Coordinator; County Commissioners Pat Melancon and Joe Montalvo, Commissioner-elect Marvin Davis and Brackett ISD Superintendent Bobby Templeton, as well as various other key personnel from local organizations, and interested community members.

This all-volunteer committee, as mandated by state and federal law, meets on a monthly basis to determine and implement a county-wide response to emergency situations, such as widespread flooding, hazardous material spills on the highway or railway, or other such natural or man-made disasters that might

pose a threat to life or property in our community.

The recent flooding in Crystal City and the floods here and in Uvalde in past years are prime examples of situations that require prompt and accurate response to minimize loss of life and property damage.

This committee is responsible for coordinating activities during a time of emergency, including recruiting and directing volunteers, the acquisition of emergency equipment such as generators, gas masks, water, medical supplies, and shelter as well as being responsible for working with the American Red Cross, FEMA and other governmental agencies to provide basic and on-going services in such an emergency.

The Kinney County LEPC plan, written in 2001, has been recognized state-wide as a model for other counties. This plan sets out specific duties and respon-

sibility for each agency or individual in case of an emergency situation. Procedures for providing appropriate warning, shelter, search and rescue, food service, transportation and appropriate routes in case of evacuation, legal support, and law enforcement are just a few of the areas addressed in this comprehensive plan.

"Having an active and well-trained LEPC and volunteer force ready to act in times of community emergency is similar to having an insurance policy in effect in case of a personal emergency," Susanna Lowery said. "Even though you never know if or when you might need it — and you hope you don't — it is mandatory and comforting, to have it in place should the situation call for it."

The next meeting of the LEPC will be Monday, May 24, at 6:30 p.m. at the EMS Building. Meetings are open to the public.

Downsizing can be healthy

They say everything's bigger in Texas. Unfortunately, according to the latest obesity study by *Men's Health* magazine, so are the people in Texas. Five of the 10 fattest cities in America are located in Texas. This is one contest no city is proud to win — obesity is not a laughing matter.

Poor diet and physical inactivity are becoming a leading preventable cause of death in the United States. The U.S. surgeon general has even gone so far as to call obesity an epidemic.

One-third of adults in the U.S. are overweight and another third can be classified as obese. These statistics mean that fewer than half of America's adults are living at a healthy weight.

The costs associated with excess pounds and obesity are enormous. Diabetes, high blood pressure, heart attacks and cancer are just a few of the health risks more prevalent in overweight individuals. Health care costs are at an all time high, not to mention the economic costs due to lost productivity, which recently totaled \$117 billion.

Why are so many Texans overweight? The answer can be summed up in one word — lifestyle. In general, people spend more time sitting in front of computer and television screens than they did 30 years ago. Suburban sprawl has not helped our declining level of inactivity either.

Today we spend more hours in our cars because there are fewer places within walking dis-

of death among Americans. Tobacco is the No. 1 cause of preventable deaths, but the growing obesity epidemic will soon claim as many as 500,000 American lives each year. That's an astounding number of people dying before their time.

There are several things you can easily alter in your daily routine to help you and the ones you love live a more healthy lifestyle. I have a rule that I always take stairs at the Capitol, rarely using the elevator.

At work, walk over to your coworkers' desks periodically instead of using e-mail or the telephone. You might try parking toward the rear of a parking lot and slightly increasing the distance you walk to get to wherever you're headed.

Establish a regular program of physical activity three or more times per week, but take it slow. Start with one day a week and go from there. Also, make sure to check with your physician before making any drastic changes in your exercise routine.

For further motivation, sign up to participate in a walk or race for a charity or non-profit organization. To help children stay physically fit, enroll them in activities that get them off the couch and on the move, and encourage schools to increase physical education requirements.

The growing number of people who are overweight and obese is alarming. Fortunately, it's a problem we can work together to address.







we never raised water rates, gas rates or waste collection rates. The city was very sound fiscally."

Guidry said he is seeking office to "make our town better."

"I stand confident behind my voting record while on the council," he said. "Every decision I made I felt was for the benefit of the whole community, and I say this wholeheartedly. I'm not a person to make a decision to benefit me or my neighbor — it'll always be for the betterment of the whole community."

"I want to improve life for everybody. That means keeping your taxes down, keeping the money that you work hard to earn in your pockets, and to make your tax dollars work for you."

Padron moved to Brackettville in 1997. His wife, Martha, is the county tax assessor-collector.

"I have never been involved in any kind of politics and I thought I would give it a go," he told those attending the forum.

Padron said he has "over 25 years of excellent leadership and interpersonal skills, beginning in 1974 when I began my career in public relations."

"I was pretty much involved in the selection of hiring, training and executing a lot of the daily procedures that are involved with that," he said. "As I continued, I got into a lot of budgeting and scheduling."

Padron said he wants to help improve the city's financial status.

"I started attending meetings when we were in debt," he said. "We had a lot of problems. Today, because of the City Council and because of people getting involved, we are pretty much level and we want to continue this. I think I got the experience to handle it, and the leadership skills."

Camilo Cruz Jr., incumbent Place 1 councilman, was not in attendance at the forum, but his two challengers, Richard Guajardo and Tully Welch, were.

Cruz was appointed to the council last year to fill a vacancy left by Bonnie Wardlaw, the current city secretary.

The Place 1 position will have one year remaining following this year's election. The mayor's post and other council positions all have two-year terms.

Guajardo was born and raised in Brackettville. He has a background in construction, and said this was his first time to enter the political arena.

"I'm very concerned with the problems in Brackettville," he said. "I would like to see it grow and prosper. I feel that I can give valuable opinions on many issues concerning the growth of Brackettville, such as maintenance, the upkeep of city parks and streets, and resolving the issue of abandoned houses or lots."

"I feel I can do a good job, try to keep people honest, and

try to work with the other council members and mayor to do the best I can.

"If elected, I promise to listen to the peoples' opinions and try to get issues resolved in a timely manner. I promise to be a voice for the citizens of Brackettville."

Welch is a Uvalde native. He has lived here for two years and has worked for the Texas Department of Public Safety for the last four years. He has also worked in education as a high school science teacher.


"A lot of people have come up to me and voiced concerns about the city of Brackettville and Kinney County," he said. "There are several reasons that I decided to run. In the two years that I've lived here, I have not had a single elected official ask me my opinion on any political or public matter. I think we need people in public offices that are concerned about the well-being of the public, their constituency. That is my goal as a city council person, if elected, to represent the people that put me in office."

Welch said he wanted to revitalize the city's defuncted police department.

Place 2 candidates Matt Bland and Mary Flores attended the forum, while Ramon "Dido" Garcia and Stephanie "B'Ann" Gomez were absent.

Flores, originally from Uvalde, has served 12 years on the council.

Currently, employed with

Guajardo Family Investment and Mortuary Services, Flores said she has "extensive accounting and management experience."

"When we had problems last year, the city was very much in need of revenue, and that's why we took action," she said.

"Those of you that went to the meetings know that we were about to lose everything. The doors of City Hall were about to be closed. The council and I got ourselves out of that. We have paid all the accounts in arrears. The city is out of debt."

"If re-elected, I want to work on the streets, city police and the fire department," she added.

Bland, who described himself as a "hometown boy" is the former owner of the Brackett Service Center and has worked

in sales and security for Fort Clark Springs.

"I bring 15 years of business management experience and about 20 years of public relations experience," he said.

Bland said he is running for office to "try to establish a tax base in order to ease the tax burden on the citizens."

"Over the past 15 or 20 years, the city has lost a host of businesses," he said. "Only a handful of these businesses have been replaced by other businesses. This is one of the reasons why we have a very high unemployment rate and increasing taxes."

"We need to have people on the City Council that have the initiative to solve some of our economic problems. We have two major sources of income, one

being tourism and the other being hunting. We need to help these two major resources grow."

Incumbent Johnny Samaniego and Lydia Tipps, Place 5 candidates, did not attend the event.

Simmons read a letter from Tipps, who said she was absent because her husband, Jeff, was recovering from brain surgery.

"I want to encourage all of you, regardless of who you vote into office, to attend not just the council meetings, but the school board and Commissioners' Court meetings as well," she said in her letter. "You and I, the voters, have the power to bring change in our community, but we must attend meetings to be informed, to voice our opinions, and we must vote."


Roy Jay Harris


