We had another family suffer the loss of their home due to fire early Wednesday morning.




Lillian Burnell "Bea" Welch, 85, of Sarasota, formerly of Ft. Clark Springs, died June 26, 2011.


Bea was born in Luka, IL on May 12 1926 to Charles and Eva Baley. She married her high school sweetheart twice, James D. Welch who precedes her in death.
