NUMBER BALES GUNED UP TO SEPT. 1st, 191,416.

Report of Census Bureau and Crop Reporting Board are Both Bullish

Washington, D. C., Sept. 9 .- The census bureau today issued is first bulletin on the cotton crop for the season, as shown by the returns from ginners, showing a total of 191,416 bales ginned up to September 1 as compared with 407,551 bales up to the same period last year. In this state ment round bales are counted as half bales. The great falling off is attributed to the lateness of the crop.

The reports show that there were only 4,067 ginneries in operation Sept. 1 this year as compared with 6,037 in

The output by States for the present year is as follows: Alabama, 7,345; Arkansas, 85; Florida, 34; Georgia, 1,207; Indian Territory, 3; Louisiana, 112; Mississippi, 1,128; North Carolina, 43; Oklahoma, 5; South Carolina, 3; Texas, 145,101. Last year Texas had ginned 328,686 bales before Sept. 1st.

FIRE LOSS AT ALVORD

INCENDIARIES BLAMED FOR \$60, 000 BLAZE-STARTED IN LUM-BER YARD.

BUILDINGS BURNER

Entire North Side of Principal Business Block in Wise County Town Reduced to Ashes.

Alvord, Tex., Sept. 8.—Originating in Thomas Brothers' lumber yard at 1:30 o'clock this morning, fire, believed to have been of an incendiary origin, destroyed property of an estimated value of \$50,000, about two-thirds of which is covered by insurance.

Of the cash \$692,612 belongs to the general revenue fund and \$246,-797 to the permanent school fund. SHERIFF DAVIS LANDS FUGITIVE

COMPLAINT IS FILED

Billy Schmidt Charged With Selling Liquor on Election Day-Conviction Will Mean Forfeiture of License.

From Monday's Daily.

A complaint was filed this morning by Sheriff Davis against Billy Schmidt, who conducts a beer saloon on Ohio avenue, charging him with selling liquor on election day in violation of the State laws.

This morning Sheriff Davis saw M C. Neal leaving the saloon with a suspicious object under his coat. The sheriff gave pursuit and Neal fled to a nearby wagon yard where he was overhauled and two pint bottles of Budweiser were found under his coat. Neal was taken before County Attorney Greenwood, where he admitted to the purchase of the beer in Schmidt's saloon this morning.

Under the new Baskin-McGregor liquor law a conviction on this charge will forfeit Schmidt's license to do

This is the first complaint of the kind that has been filed in Wichita one man. county since the new law went into effect. The case will be heard before Judge Yeager in the county court.

THE COMMISSION WANTS NEWS

Order Directs Roads Must Report by Telegraph as to Wrecks.

Austin, Tex., Sept. 7 .- The railroad officials of the State who have always tempted to withhold from the pr and the public information regarding wrecks, will be somewhat discomfited by the order issued today by the railroad commission.

The order requires that when wreck occurs, either freight or passenger, the company shall make promt telegraphic report to the commission, stating the cause of same and the ap proximate number of persons killed and injured, and when full information has been received shall make full written report. This order has been issued because of the action of the railroads in withholding information which should be given to the public.

For some reason the railroads have seen fit to keep from the newspapers the facts in such cases and then complain because the papers make mistakes in picturing the catastrophe. The newspapers have never understood upon what grounds the railroads have stood with regard to the giving out of information about wrecks.





HOLD COTTON

n Spite of the Price Now Offered They are Storing Crop as Fast as Gathered.

Houston, Tex., Sept. 6.-Ex-President Calvin of the Farmers' Union. has returned to Houston after a tour of the central and southwestern cotton belt, and discussing crop conditions with a Record reporter today stated that from his viewpoint it looked as though there would be less than one half of last year's crop in Texas, or less than 2,000,000 bales.

"There are a few scattering places in the State where the crop is as good as last year," he said, "but in other places, and for that matter, in most places, cotton conditions are deplor able. They are worse than I had any idea they were. I have been through the central portion of the State and through the southwestern portion and the southern portion. Out in the Brownwood and Coleman sections conditions are very bad. It requires about eight to ten acres to the bale and down in the San Angelo country conditions are worse. If there will be as much as half that was produced last year, I do not know where it is to come from."

The farmers for the most part, stated Mr. Calvin, are storing their cotton, notwithstanding that the price is 131/4 cents in the interior or 14 cents in Houston. He believes that it will be wise for the farmers to hold it for 15 3 miles from Wichita Falls, on cents, feeling sure that the price will reach that figure and beyond. The Farmers' Union Warehouse and Compress Company, of which Mr. Calvin is the manager, is receiving some cotton already, which is being stored and a certain percentage of its value loaned on it. The company has not renewed its lease on the Inman press and ware house, but has secured storing room and the Cleveland press.

The insect is small and looks to be armless and innocent, but it has been caught on the bolls, getting in its dead-

Some farmers say their crop will be cut off considerably on account of the ravages of this insect.

Persons here who have seen the Texas boll weevil declare this insect resembles it closly, and that they are one and the same.

SHORTAGE GENERAL

BEEF STUFF SHORT OVER THE ENTIRE COUNTRY.

Colonel Ike Pryor Says Cattlemen Will Establish One Only as a Protection.

There is a shortage of beef cattle all over the country and many sections are extremely short on big steers, according to Colonel Ike T. Pryor, president of the Cattle Raisers Association of Texas. This condition is certain to be prolonged and intensified for several years, and the natural consequence will be higher prices, says Col.

"In South and Southwest Texas there are fewer big steers than in many years," he said. "Owing to the good prices that have predominated, the shipment of steers to the markets has been unusually heavy and the movement to territory ranges has also figured in lessening the number on Texas ranges. This year has witnessed the fullest season of good prices within my recollection, and the cattlemen of the State are generally satisfied with the situation.

"Conditions continue dry in South Texas, but nothing is suffering. Water has been well distributed as a result of improved and wiser management, and cattle are in good shape, taking everything into consideration."

Speaking of the reputed movement of Texas cattlemen to establish an independent packing plant in Ft. Worth, Colonel Pryor said that the agitation had subsided since the Big Five packeries rescinded the obnoxious postmortem inspection order.

"Cattlemen of Texas do not really want to establish an independent plant," said Colonel Pryor, "and they will not do so except as a protectionary measure. So long as the present packeries treat them fairly, there will be no independent movement, but they stand ready and able to put in a plant in the event they are not given a square deal."-Fort Worth Record.
