COTTON REPORT LEAKAGE CASE.

Witnesses Tell How the Reports Were
Prepared.

Washington, D. C., June 11.—Amery

Worthington, representing Edwin S.

Hokes, Jr., in the trial of the latter

concerning the methods of preparing

the cotton crop report on which she

had for several years been employed.

She said that in 1904 and the first

part of 1905 the reports from the field

agents were generally handed to her

by Mr. Holmes, with whom she fre-

quently held conversations concern-

ing the work, at times assisting in trans-

lating the crop reports, which always

came in "code."

It is Alleged That Makers of Umbrellas
Have Fixed Prices.

Philadelphia, Pa., June 11.—Acting

on instructions from Washington United

States District Attorney Thompson

RECEIVERSHIP GRANTED.

R. J. Eckhardt of Taylor is Named as
Receiver for Waters-Pierce Oil Co.

Austin, Tex., June 11.—After hear-

ing the arguments of the defense on

the application of the state for the ap-

pointment of a receiver for the Waters

Pierce Oil Company in Texas, and de-

clining to listen to the argument of the

state, Judge Brooks announced today

that he would grant the request and

appoint a receiver, not because it was

necessary to insure the collection of

the penalties according to the verdict

brought in by the jury, but because it

was evident that the defendant pro-

posed to continue to conduct its busi-

ness pending the determination of the

appeal in the matter and by the same

means as had been found by the jury

to be in violation of the laws of the

state of Texas.

At a conference to which the court

invited the lawyers for the state and

defense, the court stated that he con-

templated appointing Robert J. Eck-

hardt, cashier of the First National

Bank of Taylor, Texas, to be the re-

ceiver of the Waters Pierce Oil Com-

pany, and that it was possible he

would appoint a joint receiver. The

appointment of receivers will probably

be made today.

EASILY WALLOPED

BOWIEITES FALL A PREY TO COLLIER'S SLANTS AND LOSE.

SEASON'S OPENING GAME

Proves an Easy Victory For Locals Second Game of the Series Today.

Wichita walloped the boys from Bowie yesterday in the initial game of the series to the tune of 8 to 3. The trick was turned so neatly and easily that the lads from down the Denver were never once in sight of the money, and the game was too one-sided to be intensely interesting.

Collier handled the horse-hide for Wichita and did the stunt in such a stylish manner that the Bowieites never found the locality of his slants to any damaging extent only in one inning. On the other hand Minor, the slab artist for the visitors, was found at several stages of the game and his offerings were tumbled out into the tall grass with a frequency that brought delight to the hearts of the home fans, of whom a considerable number were out to witness the inaugural number. Then, too, Minor was generous with his complimentaries to the first sack and several times with men on the stations, his team-mates gave exhibitions which entitled them to consideration for an aeronautic prize.

Wichita started in with her run getting in the first session. F. Smith drew a pass and was sent in home by clean drives by Carrol Smith and Huff. In this inning, Bowie executed the first of her three double plays. Collier sent a feeble fly to Minor, who nabbed it and shot the ball to Stallings before Smith could get back to the canvas.

The Bowieites got one bingling hit in the first and then were retired in order through four hitless innings.

In the sixth inning the laddies from down the Denver road became very familiar with Prof. Collier's hitherto elusive slants and rapped out four screaming hits in close succession, which in conjunction with an air flight on the part of the locals, netted them three scores. This was destined to be the extent of Bowie's scoring, and not because they needed it, but just to show the visitors what they could do if necessary. Wichita added another to her score of seven in the eighth and closed the score making.

Carrol Smith's work with the willow was one of the bright features of the game. In four times at bat he slashed out two rollicking singles and a screaming two-sacker. The last time at bat, however, he made three futile sweeps through the atmosphere and then ingloriously retired.

For the visitors, the work of Donald, who presided in the middle garden, was especially pleasing.

The two teams are playing again this afternoon. Bowie has made some changes in her line-up and has her crack slabman in the box, and if intentions have anything to do with the results, Bowie will have a different story to send home tonight.

METHODIST REVIVAL CLOSES.

Meetings Result in Thirty Conversions and Much Good That Cannot be Calculated.

Rev. Barton's text from the last chapter of Revelations last night was, "The Spirit and the bride say come, let him that heareth say come, let him that is athirst come, and whosoever will let him take of the water of life freely." He showed that the spirit was the Holy Ghost and that it called men in various ways to come to God, sometimes by a sermon or by sickness, death, or maybe a storm. He gave as an illustration an instance of which a man had told him. There was a church lady who was very sick and the doctors had told her she would have to die. She prayed God to save her life that she might raise her little children and promised that if she should get well she would work her very best for the Lord. She was restored, and true to her promise started a prayer meeting in her home and invited all others to meet with and help her. As a result of her efforts two churches were built in that community, two persons were called to preach and one offered to go to the foreign mission field. He emphasized the great need of men paying their vows to God and making greater efforts to serve Him.

He drew a word picture that it is hoped may be realized in a few years. He said that on a beautiful lot in the central part of the town he could see a magnificent Greek church, the prettiest in the world. The upper story of this church was a great auditorium, seating 1000 people or more, while in the lower story or basement there were great reading and rest rooms for those who were in town and had a few hours leisure. Here also the railroad men and the clerks could find a pleasant place to rest. He contrasted such a place with the

present lack of it and said that the saloon was about all the place the man was looking for rest and something to interest him had to satisfy his desire. He never thought God should live in the best house in town. God never gave plans and specifications for but one house on this earth and it was the finest the world has ever seen.

The meeting closed last night. There have been about 30 conversions and ten presented themselves last night for membership in the Methodist church. Two of them were baptized. The result of the meeting as a whole are not to be measured by the number of conversions alone. It is claimed that it is in a great measure responsible for the recent acts of the grand jury in certain matters and also influenced our officers and gave them courage to undertake the great things for our town that they are going to do.

Attorneys for the Waters Pierce Oil Company are complaining that the fines imposed on the company by the State in the recent ouster suits are excessive and amount to confiscation. Let's see. At the ouster the State asked for the sum of \$5,000,000 in fines and penalties. The attorneys for the defendant company thought that \$50 per day for every day their clients had violated the anti-trust law would have been punishment sufficient. Had the jury before whom the case was tried viewed the matter in that light, this "terrible" punishment would have amounted to just ten cents per day—on the supposition that the company has 500 agencies in the State, and that every one of them had violated the law. The verdict, as rendered by the Travis County jury, is more of a compromise verdict than anything else, and the fines and penalties are low enough. The proper thing to do now is to collect these fines and penalties, and this Attorney General Davidson seems determined to do. If he makes good, the people of the State will owe him a debt of gratitude which they will discharge at the first opportunity which may present itself.

There has been much written of late about the rendering of property for taxation at full value, and many are under the impression that the law requiring this to be done was enacted by the Thirtieth legislature. This is a wrong impression. The law is an old one, but heretofore has not been enforced. The attempt to enforce this law is the work of State Revenue Agent McDonald. If he succeeds, property owners will not be required to pay more taxes than heretofore, for the simple reason that when the state finds that the tax levy is greater than

is required to meet current expenses it will be lowered. The object of the law a good one and has for its purpose to require the man who has the property to pay his just share of the taxes. As is well known, most property holders, large and small, have been in the habit of rendering their property for only about 65 per cent. of its real value. Under a strict enforcement of the law, this cannot be done, but all property will have to be rendered for tax purposes at its full value.

Should Schmitz go on the stand it may be necessary for the prosecution to play its trump card and call Abe Ruef to testify. Ruef is all that is needed, it is said, to clinch the case against Schmitz, but there are other prosecutions to be considered and it might be considered poor strategy to spring a climax in the first case. The grand jury intended to bring an investigation yesterday upon the arrival of shipments of dynamite to San Francisco. Col. Williams of the Twenty-first infantry sent word to the Judge Advocate of the Department of Colorado to go to Castle Rock and take charge of the prosecution for the government.

Feeling among the soldiers who were at target practice at Parker is still so high that Lambert has been placed under an armed guard and a guard has also been placed in charge of Lambert's saloon to prevent its destruction by fire. Private Salmon and musician J. Ennenda, the two men who were shot, are seriously injured.

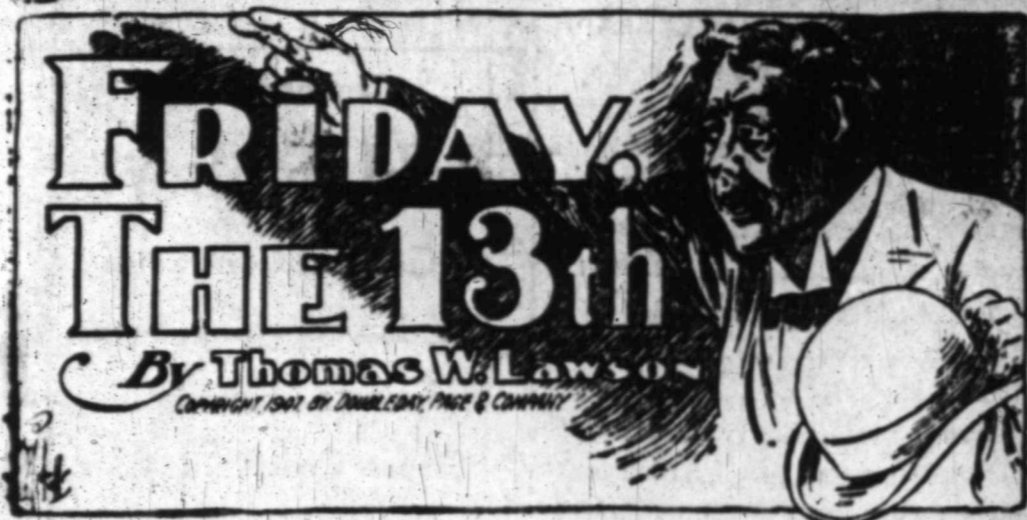

THE HAYWOOD TRIAL

(Continued from First Page.)

Speculation is rife over the testimony which Adams will give. He was the associate of Orchard for years, according to the testimony of the latter Adams helped to pull the wire which caused the Independence explosion, killing fourteen men. He stood beside Orchard when the latter shot Lyte Gregory. He lay in wait with Orchard to assassinate Governor Peabody, and he is declared to be the man who shot Arthur Collins through a window while surrounded by his family. Of the two men Adams is said to have more human blood on his hands than Orchard has confessed to.

Adams Confessed in Boise Jail.

While in jail at Boise last year, Adams made a confession which, the prosecution declares, corroborates the one made by Orchard in every detail. This confession he afterwards repudiated, and the attorneys for the defense feel sure that he will do the same when he is placed on the witness stand. Adams made a confession in 1903, 1904 and 1905. In some of these he said there had been changes in the facts which were made without authority. The reports were some- times mailed to the office and at others to a claim agent, Mr. Hyde, then in the confession referring to Tyler was introduced. The defense does not know what the rest of the alleged confession contains, except in a general way.

If he repudiates the confession, it will probably permit the prosecution to introduce the document in evidence. If it is introduced another story of murder and assassination will be unfolded which will equal that told by Orchard. It is not certain, however, that Adams will repudiate the confession. He is in a position where, it is stated, he will surely hang unless he is offered immunity by turning State's evidence.

While the trial of Adams at Wallace resulted in a disagreement, the jury dividing strictly on class lines it is stated that even were he acquitted in this State he would be taken to Colorado and hanged for the murders he is charged with having committed in that State. In that position, he may decide to save his neck by turning State's evidence, although the lawyers for the defense assert that he would rather hang.

Orchard and Adams of Different Make-Up.
While Orchard and Adams are said to have been associated in crime, the men are on an entirely different temperament. Adams is human, and in making his confession, he declared that the industrial strife in the mining regions of the west was class war, in which he felt justified in taking human life. He declared that every murder he committed, he did it in the hope that it would further the interests of the Western Federation of Miners. He has always been intensely interested in the affairs of this union, and willing to go to any extreme in his blind devotion to a cause. He is of a high emotional nature, a streak of emotional insanity running in his family, which is of Kentucky origin. It is easily understood how such a man might have committed the murders he is said to have confessed to.

Shows Increase of Over One Hundred Over Last Year.

The scholastic census of the Wichita Independent school district recently completed by W. E. Frieze of the school board, shows a decided increase in the number of children between the ages of 7 and 17 over last year's report.

The total number of children between those ages of both sexes and colors this year is 898, while last

year's census gave 748. This is an increase of one hundred and fifty within a year and gives some idea of our increase in population. Of the number 853 are white and there are 438 boys and 415 girls.

The colored population numbers of whom 28 are males and 17 females.
