suits are some different to the ones used last year. They are a brown gray, known as a Yale gray. The stockings, caps, belt and letter N on the shirts, will be maroon, altogether making a very pretty, neat and attractive uniform. Only the very best timber possibly obtainable will be signed, and while some of the personnel of the team has already been decided on, no names are to be given out yet. Mr. Blount, assisted by some other enthusiasts, is endeavoring to get a subscription of \$200 per month to supplement the gate receipts and aid in paying the team. So far about \$125 has been signed for. It is stated that the majority of games will be played on the local diamond, insuring at least two games each week. During the elapse of time while the uniforms are being made, practice will go on, getting in shape for a series of games to be played here about the middle or last of this month.

Stow has supposedly been dead for two or more years. Whether he sent the report out, or was the cause of it being sent out, or whether the news came here was an unintentional error, is not known but no disposition of the charge was made during his reported "demise." According to statements Stow was a reckless kind of a fellow, and enjoyed the card table very much, indulging in his water considerably. In some trouble with a negro, the latter was killed. The Grand Jury indicted Stow, and he was released on bond. The following term of District court, the case was called for trial, but Stow failed to show up. The report came from the Louisiana line that he, with lots of others, was quarantined on account of small pox, and for that reason the

case was continued. Later the news came that Tom Stow died of small pox. The belief existed with some however that he was still alive, and hatched the report to thwart trial. On this belief the search for Stow continued, and finally with the result of his being captured. A telegram was received this morning at the sheriff's office stating that Stow was in jail in Alexandria. A return message was sent to the Louisiana officer, asking if Stow would come to Nacogdoches without requisition papers. If he will Sheriff Spradley, or a deputy will go at once for him, if not, the officers will await the proper papers from Governor Campbell.

GEORGE W. PARTIN DEAD.

Another Pioneer of This County Passes Away at His Home in This City This Morning—Burial This Afternoon.

From Thursday's Daily:
George W. Partin, another one of the old timers, and who has been a citizen of this city and section for more than half a century, died this morning at four o'clock at his home on North Street. For several days Mr. Partin has been quite sick, and from the very beginning it was feared serious. Tuesday he became unconscious, remaining that way until the end. He is survived by a widow, two sons and a daughter, the latter, Mrs. Robert Jordan, who resides in this city, and the sons away from here. One of them lives at San Antonio and one at Oklahoma City. They have both been notified.

George W. Partin was born in Grundy county, Tennessee, August 10, 1842. In 1854 he came to Texas, settling in this county and where he has continually resided since. He was an old Confederate soldier, being a member of Company A, 17th Texas Cavalry, known as Captain Sebe Nobles command. There were 132 who joined this command from this city, and out of the original number only eleven are today living. After the re-organization, the company was dismantled and later made an infantry. Mr. Partin, on account of a wound, was not able to go with the new command, and exchanged with another party, getting again into the cavalry. Mr. Partin was well and favorably known over this county, and East Texas, and his death removes from the midst one of the best citizens and distinctly one of the pioneers. He leaves a host of relatives, of which the families of Burrows and King are included. The burial will take place this afternoon at four o'clock at the City Cemetery.

Proposed Amendment to the State Constitution Authorizing Cities and Towns with a Population in Excess of 5,000 to be Incorporated by Special Act.

SENATE JOINT RESOLUTION No. 6.

Joint Resolution to amend Article 11, Sections 4 and 5, of the Constitution of the State, authorizing cities and towns within the State of Texas to be incorporated by special act where the population exceeds five thousand inhabitants.

Be it Resolved by the Legislature of the State of Texas: Section 1. That Article 11, Sections 4 and 5, be amended so that the same shall hereafter read and be as follows:

Sec. 4. Cities and towns having a population of five thousand or less may be chartered alone by general law. They may levy, assess and collect an annual tax to defray the current expenses of their local government, but such tax shall never exceed for any one year one-fourth of one per cent, and shall be collectible only in current money, and all licenses and occupation taxes levied and all fines, forfeitures, penalties and other dues accruing to cities and towns shall be collectible only in current money.

Sec. 5. Cities having more than five thousand inhabitants may have their charters granted or amended by special act of the Legislature and may levy, assess and collect such taxes as may be authorized by law, but no tax for any purposes shall ever be lawful for any one year which shall exceed two and one-half per cent of the taxable property of such city; and no debt shall ever be created by any city or town, unless at the same time provision be made to assess and collect annually a sufficient sum to pay the interest thereon and create a sinking fund of at least two per cent thereon.

Sec. 2. That the above and foregoing proposed amendment shall [be] duly published once a week for four weeks commencing at least three months before a special election to be held for the purpose of voting upon such proposed amendment on the first Tuesday in August, 1909, in one weekly newspaper of each county in the State of Texas in which such a newspaper may be published, and the Governor be, and he is hereby directed to issue the necessary proclamation for the submission of this proposed amendment to the qualified electors for members of the Legislature.

At such election all persons favoring such amendment shall have written or printed on their ballots the words "For the amendment to Article 11, Sections 4 and 5, of the Constitution," and those opposed thereto shall have written or printed on their ballots the words "Against the amendment to Article 11, Sections 4 and 5, of the Constitution."

Sec. 3. That \$5000, or as much thereof as may be necessary, be and the same is hereby appropriated out of any money in the Treasury not otherwise appropriated, to defray the expenses of advertising and holding the election provided for above. W. B. Townsend, Secretary of State.

Proposed Amendment to the State Constitution Validating School Districts and Their Bonded Indebtedness and Authorizing Levy and Collection of Taxes to Pay Such Indebtedness.

HOUSE JOINT RESOLUTION No. 5.

House Joint Resolution to amend Article 7 of the Constitution of the State of Texas by adding thereto Section 3a, validating school districts and the bonded indebtedness of such districts and authorizing the levy and collection of taxes to pay such indebtedness.

Be it Resolved by the Legislature of the State of Texas: Section 1. That Article 7 of the Constitution of the State of Texas be amended by adding thereto a new section, to be known as Section 3a, which shall read and be as follows:

Sec. 3a. Every school district heretofore formed, whether formed under the general law or by special act, and whether the territory embraced within its boundaries lies wholly within a single county or partly in two or more counties, is hereby declared to be, and from its formation to have been, a valid and lawful district.

All bonds heretofore issued by any such districts which have been approved by the Attorney General and registered by the

Comptroller are hereby declared to be, and at the time of their issuance to have been, issued in conformity with the Constitution and laws of this State, and any and all such bonds are hereby in all things validated and declared to be valid and binding obligations upon the district or districts issuing the same.

Each such district is hereby authorized to, and shall, annually levy and collect an ad valorem tax sufficient to pay the interest on all such bonds and to provide a sinking fund sufficient to redeem the same at maturity, not to exceed such a rate as may be provided by law under other provisions of this Constitution. And all trustees heretofore elected in districts made up from more than one county are hereby declared to have been duly elected, and shall be and are hereby named as trustees of their respective districts, with power to levy the taxes herein authorized until their successors shall be duly elected and qualified as is or may be provided by law.

Sec. 2. That the above and foregoing proposed amendment shall be duly published once a week for four weeks commencing at least three months before a special election to be held for the purpose of voting upon such proposed amendment on the first Tuesday in August, 1909, in one weekly newspaper of each county in the State of Texas in which such a newspaper may be published. And the Governor be, and he is hereby directed to issue the necessary proclamation for the submission of this proposed amendment to the qualified electors for members of the Legislature. At such election all persons favoring such amendment shall have written or printed on their ballots the words, "For the amendment to Article 7 of the Constitution validating school districts and school district bonds," and those opposed thereto shall have written or printed on their ballots the words, "Against the amendment to Article 7 of the Constitution validating school districts and school district bonds."

Sec. 3. That \$5000, or as much thereof as may be necessary, be and the same is hereby appropriated out of any money in the Treasury not otherwise appropriated, to defray the expenses of advertising and holding the election provided for above. W. B. Townsend, Secretary of State.

Proposed Amendment to the State Constitution in Regard to Formation and Taxing Power of School Districts.

HOUSE JOINT RESOLUTION No. 6.

House Joint Resolution to amend Section 3 of Article 7 of the Constitution of the State of Texas, in regard to the formation and taxing power of school districts.

Be it Resolved by the Legislature of the State of Texas: Section 1. That Section 3 of Article 7 of the Constitution of the State of Texas be so amended as to hereafter read as follows:

Sec. 3. One-fourth of the revenue derived from the State occupation taxes and a poll tax of \$1 on every male inhabitant of this State between the ages of 21 and 60 years shall be set apart annually for the benefit of the public free school, and in addition thereto there shall be levied and collected an annual ad valorem State tax of such an amount, not to exceed 20 cents on the \$100 valuation, as with the available school fund arising from all other sources, will be sufficient to maintain and support the public free schools of this State for a period of not less than six months in each year, and the Legislature may also provide for the formation of school districts by general or special law, without the local notice required in other cases of special legislation, and all such school districts, whether created by special law, may embrace parts of two or more counties. And the Legislature shall be authorized to pass laws for the assessment and collection of taxes in all said districts and for the management and control of the public school or schools of such districts, whether such districts are composed of territory wholly within a county or in parts of two or more counties. And the Legislature may authorize an additional ad valorem tax to be levied and collected within all school districts, heretofore formed or hereafter formed, for the further maintenance of public free schools, and the erection and equipment of school buildings

therein, provided that a majority of the qualified property taxpaying voters of the district, voting at an election to be held for that purpose, shall vote such tax, not to exceed in any one year 50 cents on the \$100 valuation of the property subject to taxation in such district, but the limitation upon the amount of school district tax herein authorized shall not apply to incorporated cities or towns constituting separate and independent school districts.

Sec. 2. That the above and foregoing proposed amendment shall be duly published once a week for four weeks commencing at least three (3) months before a special election to be held for the purpose of voting upon such proposed amendment on the first Tuesday in August, 1909, in one weekly newspaper of each county in the State of Texas in which such newspaper may be published. And the Governor shall and he is hereby directed to issue the necessary proclamation for the submission of this proposed amendment to the qualified electors for members of the Legislature. At such election all persons favoring such amendment shall have written or printed on their ballots the words, "For the amendment to Section 3 of Article 7 of the Constitution in regard to the formation and taxing power of school districts," and those opposed thereto shall have written or printed on their ballots the words, "Against the amendment to Section 3 of Article 7 of the Constitution in regard to the formation and taxing power of school districts."

Sec. 3. That \$5000 of as much thereof as may be necessary, be and the same is hereby appropriated out of any money in the Treasury, not otherwise appropriated, to defray the expenses of advertising and holding the election provided for above. W. B. Townsend, Secretary of State.

It is brimful of good reading matter, stuff of splendid importance concerning the far west and has a fine ad patronage. The Texan has a fine appearance and indicates prosperity in abundance. Of course the Texan really doesn't expect the Colonel to aspire,—he's too busy banking,—but the talk is fine publicity for the Panhandle. Keep the ball rolling and whoop up a county fair.

NACOGDOCHES TO GET HELP

Objections Offered to the Term, "Experiment," With Reference to the Tobacco Industry in East Texas.

San Augustine Tribune.

Through the efforts of the Nacogdoches County Tobacco Growers Association a bill was recently passed by the Texas legislature appropriating \$1000 a year for two years to assist the national government in carrying on the tobacco experiments in that county.

Texas has done no more than it should in this matter, as the placing of East Texas tobacco on the world's markets will bring fame to the State and money to an ever increasing body of citizens.

Nacogdoches county this season will plant about 250 acres in cigar tobacco, San Augustine 100 acres, and the other counties to the west of these will probably bring up the amount to 500 acres or more. Nacogdoches is so situated that its neighboring counties can receive the benefits of its progress in this line, and San Augustine county is pleased that the efforts of the association were successful.

We beg to offer the suggestion, however, that it might have a better effect on the industry if all persons in the tobacco belt would drop the term "experiment," for in view of the progress made in tobacco growing the term is misleading, and possibly detrimental to development.

To our certain knowledge these experiments commenced about six years ago and have been continued each year since in one section or another, always with the same general result of proving that a high grade tobacco could be grown. And as it is being grown successfully by scores of people, who when once started, uniformly continue its culture. What is there left to determine by further "experiment" more than in other crops?

The idea probably is to find out certain details of the business that will bear further investigation, ascertain best methods of handling, the most successful varieties, etc., but this class of work ought not to be called experimenting in the sense that the term has formerly been used with reference to this particular industry. Rather should it be like what is going on with crops of cotton, corn, grasses and other things that everyone knows will grow, although each farmer should investigate, demonstrate or, if you please, experiment to learn how to obtain the best returns from his labor.

Consider the suggestion, neighbors, and let us all drop this misleading term, and bend our energies towards showing prospective settlers and others that tobacco is a standard crop of East Texas—and no longer an experiment.

THE talk about another extra-session of the Texas Legislature is getting too intense to be comfortable. Texas has had her share of calamities this year, without a repetition of the "blustery bunch" down Austinway.

CITY "DADS" IN SESSION.

Department Heads And Committees For Ensuing Year Appointed, Telephone Matters Discussed, and Many Other Things Receive Attention.

The city guardians now meet in the afternoon,—first Tuesday in each month. Yesterday's coming together was the first meeting under this arrangement since the new members have donned the official harness, and as a consequence a number of visitors were on hand—to watch the wheels of the city legislative body go round. A volume of business was disposed of, routine and otherwise, including the appointment of department heads and naming the standing committees for the ensuing year. J. F. Floyd was succeeded by Guy A. Blount as Street Commissioner, but Mr. Floyd succeeds himself as water superintendent. Both men are continued as the committee on street and bridge work. The past year Mr. Floyd was active street man, with the salary and the other gentleman the honor. The affair is merely reversed in order to divide honors. Fire and building committee, J. R. McKinney and I. L. Sturdevant. Sanitary committee, J. C. Harris and J. G. Orton. Finance committee, J. C. Harris and Frank Sharpe, Jr. Light Committee J. C. Harris and J. R. McKinney. Water committee, J. F. Floyd and G. A. Blount. Mayor W. U. Perkins is also a member of all committees. Among the things to come up was a petition to council to name the streets and number the houses, or authorize such to be done. But little time was given this matter however, as there seems to be no occasion for such till the people want mail delivery. At this stage the point was made that Nacogdoches needs side-walks before she can get mail delivery,—and then the numbering process. The new ordinances, just off the press, were inspected and accepted, being understood that a few pages are to be added, and caused by the recently adopted city laws in reference to wiring houses, etc. A report on the telephone matter was made by J. C. Harris, chairman of the committee appointed at the last meeting for the purpose of investigating. The inference is that the South Texas Telephone Company has no franchise here. The mayor was instructed to employ counsel to further investigate and recommend to the city body what action to take. At this juncture several verbal petitions were heard, one from the committee recently appointed to look after the Sanitarium furnishings. No definite action was taken in reference to any of them, all being left open till some future time. The appointment of a tax assessor and collector was postponed until next meeting, City Marshal A. Y. Matthews being instructed to complete this year's rolls and John Dorsey given in charge the delinquent list. There are two applicants for the

position of assessor and collector. The several reports were made, including mayors, marshal's, city attorney's and water superintendents. The former showed \$122.75 paid into the city treasury; next \$55.62 delinquent taxes collected during April; the next \$18.50 in fines collected, and Mr. Floyd's report showing \$778.60 collected. Balance on hand April 1st was \$595.50, in the surplus fund. The amount paid out in April is \$146.65, leaving \$631.95 to be distributed among the three funds. An equalization board for the year was appointed as follows: Charles Hodges, R. D. Whitaker and J. G. Orton.

They will meet as soon as the tax rolls are completed. The entire meeting of the council was one of the busiest ever held, and while a great amount of business was transacted, among other things too, Mayor Perkins instructed the marshal to look after sanitary matters some and report any and all infractions of the city ordinances, stating that he would fine the limit. This was in reference to weeds, back alleys and other rubbish and waste that some folks allow to accumulate. There was also a little discussion concerning the putting in of another main feed pipe at the city reservoir, but no action was decided on. A special session of the council will be held to consider the telephone situation, as soon as counsel investigates a few

points in connection with the "no franchise" feature. The following officials were present at the meeting: Mayor W. U. Perkins; Alderman, J. F. Floyd, Guy A. Blount, J. C. Harris, J. R. McKinney and J. G. Orton; City Marshal, A. Y. Matthews and City Attorney G. B. Layton.

MURDER THEORY EXPLODED.

Belief Today That George Blakey Burned to Death and That Odie Hillen Was Killed by Train—Officers Visit Scene.

"The theory held for several days that George Blakey and Odie Hillen were the victims of foul play, is exploded, according to the reports of officers. Neither of the parties were murdered, and neither circumstance had any connection with the other. Blakey burned to death, after having been robbed, and Hillen died as the result of fatal injuries received by a passenger train, early Saturday morning, after having been with Blakey, and possibly knowing something of the cremated man being "rolled" for his purse. These are concisely the conclusions reached by officers, after having gone to the scenes of the two accidents. A thorough investigation was made yesterday by Sheriff Spradley, in reference to the grounds, and a number of folks in the section of Angilina were questioned.

There was no pool of blood at or near where Blakey was found, nor was the skull crushed. The face was bruised slightly, but not to the extent calculated to injure. The ground, trees, bushes, etc., indicate that Blakey built a fire and lay down by it. Being in a drunken stupor he rushed in to a clump of bushes when he awoke, into the midst of the blaze, his oily clothes catching and enveloping him in flames. The ground shows that he made a terrible struggle to get out of the fire, as also do the grasses and leaves around the place indicate that he rolled and wallowed in his effort to extinguish it. This happened about eleven o'clock. The man's watch was found near the scene, and had stopped at twenty minutes past twelve. The time piece however, is known to have been one hour and twenty minutes fast. Investigation shows that Hillen was with him a few minutes before he was burned to death. Hillen went from that place to the saloon, got several drinks, and then went by the side of the railroad and also built a fire. He fell into a stupor and sat down on the end of a railroad tie to wait for the train, believing it was almost time for it. Indicating too, that he had seen Blakey's watch not long since, and being more than an hour fast, leading Hillen to think the passenger was soon due. A number of times the fire at the railroad was replenished, according to parties who live there and heard Hillen hunting wood, boxes, etc. He was sitting on the tie when the train struck him, and for that reason, and other things connected, his death is credited as the result of injuries received there and then. There is but little question that Blakey was robbed, if circumstances be correct, but by whom is yet to be worked out. The silver and mill checks was found in Hillen's pocket, but the ten dollar bill has not yet been located. Blakey's

We would not attempt to prohibit people from using it—the habit is theirs, not ours—but what we object to is the misapplication of our money—and for such a purpose!—Gordon Courier.

To oppose developing the industry in Texas is wrong. Let us develop the resources of Texas and as far as possible keep Texas money—even tobacco money—in Texas.—Fort Worth Record.

EDITOR'S WRONG REASONING.

The present Legislature appropriated \$2000 to assist the tobacco growers in Nacogdoches county to grow tobacco. Next Legislature ought to be asked to appropriate a few thousand dollars to help the people of Rusk county grow tomatoes. The principle is about the same so far as we can see it. We have always been taught that the people should support the government and not the government support the people. That the government should not do

anything for the people that the people can do for themselves. This is a correct principle. It teaches the people self-reliance, and not to look to the government as a child would look to his daddy for victuals and clothes. Now don't say that we are opposed to experimental stations, for we are not opposed to them. An experiment station is established on State land, and the benefits derived in the way of information, how to cultivate different crops, best

seed to plant, etc., is given free to all people. Experiment stations are proper and useful to the people, but we do not understand the Nacogdoches appropriation to be an experiment station proposition.—Mt. Enterprise Herald

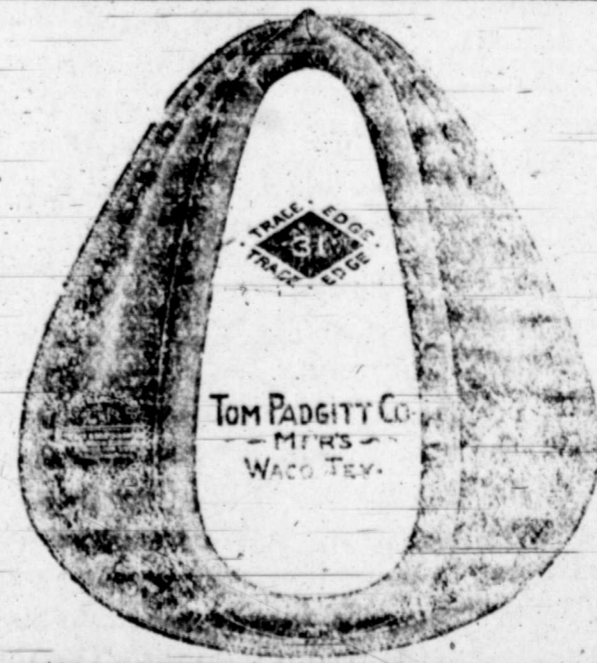
