

For those of us who thrive on the Big Band Sound, this is it. Since the formation of the band in 1985, its members have discovered the appeal of this music is timeless. They present swing and jazz with authenticity and respect for the style and class of the period. It's a group of volunteer musicians from many professions who are dedicated to the preservation and performance of the great American music of the golden age of jazz and swing. The band performs in support of activities of the Fine Arts and Speech Dept. at Tarleton State, Stephenvile.

Retired Kansas State Band Director Hewett is known for drums.

Under Phil's leadership, the band provides the wild jazz improvisations and rich precision ensemble sounds that made the music of Glen Miller, Tommy Dorsey, Benny Goodman, Duke El-Count Basie, Harry James lington, and others popular with all generations in the 1930s, 40s and 50s. Only a truly big band can perform this music, so the instrumentation includes five trumpets, five trombones, five saxophones, plano, string bass, guitar, drums and a complement of vocalists. All volunteers, the musicians' actual professions include an optometrist, a funeral director, an insurance agent, a professional photographer, a speech professor, an art instructor, a minister, a journalst, an entrepreneur, several school band and music teachers and directors more. Jury Deals 99 Years In Drug Conviction

In a jury trial in 91st District Court last week Richard Gaeta, formerly of Eastland, was sentenced to 99 years in the Texas Department of Corrections on a drug delivery charge. In addition, he was assessed a \$10,000 fine.

Visiting Judge Pete Perez of Fort Worth presided over the trial. Eastland County District Attorney Mike Siebert prosecuted the case, assisted by Attorney Bill Dowell.

Also assisting the prosecution at the trial was West Central Texas Drug Task Force officers Frank Cleveland and Adrian Huddleston, DPS Narcotics Division, Sgt. Jim Greenlee, Texas Ranger Gene Kea, and Eastland Police Dept. officer Don Walls. The Court appointed Attorney for the Defense was Jim Parker of Comanche.

Kidnapping Charges To Go To Grand Jury

A Carrollton woman was released from the Eastland County jail Monday, pending a Grand Jury consideration of kidnapping charges against her.

Julia Ann Moore, 34, allegedly removed her grandmother, age 72, from the Eastland Health Care Center Sunday afternoon.

Staff members at the nursing home notified officers about 7:10 p.m. that a patient had been taken without permis-

sion.

Her grandmother was taken to Eastland Memorial Hospital, then later returned to the nursing home.

On behalf of the Eastland Police Department, Chief Funderburgh asked Justice of the Peace Jack Graham Monday to drop bond charges on Moore. The charges were lowered to a personal recognizance bond of \$10,000, which she will forfeit if she doesn't come back to a

If you think that spirit is dead, you need to stop by 112 N. Lamar in Eastland and watch Mike and Anne Zoellick restore a building which holds their future home and business -The Eastland Bed and Breakfast Hotel.

This vintage brick three story structure has been a part of Eastland history since its construction in 1918. Now it will have a brand new history -that of a Bed and Breakfast place exclud-

ing a homey charm. Known over the years as The Princess Theatre, The Stanley Hotel, The Maverick, the Johnson and the Rawson Building, the building was purchased in 1990 by the Eastland Fine Arts Association, whose members saw a potential in the location.

The hope was to turn the building into a community center and use it with the Majestic Theatre, which shares a common wall.

Some improvements were made, but the project went into kind of a holding pattern. Perhaps the old Hotel need ed someone with the vision, and energy to resurrect it.

Agricultural Valuation Available

The following information is provided to property owners within Eastland county in compliance with publication requirements of the Texas Property Tax Code.

If you are the owner of land that is being currently used for some type of agricultural use or activity; you may qualify your land for a special use valuation for ad valorem tax purposes.

Landowners must file for special use valuation with the appraisal district

by May 1, 1995. The Texas Constitution provides for two (2) types of agricultural productivity appraisal. Article 8, Sec. 1d-1 allows what is known as Open Space Land appraisal. Article 8, Sec. 1-d allows Agricultural Use appraisal. The requirements for applying and qualifying both the land and the owner are different for each of the two types.

Most property owners for 1-d-1 or Open Space appraisal. This special

appraisal requires that the land's use in a qualifying agricultural purpose meets the degree of intensity generally accepted in the area. The owner must show that the land's use is devoted principally to agricultural use for at least five (5) of the proc-

essing seven (7) years. Land owners should be aware that the law does require a rollback to be incurred when the quali-

fied land is taken out of agricultural use. The rollback tax includes the difference between the taxes paid under agricultural

appraisal and the taxes that would have been paid if the land had been on the tax roll at market

value. The law also requires that the rollback tax include interest charges.

The application must be submitted on a form prescribed by the Property Tax Division of the State Comptrollers office. The application must contain the information necessary to determine the validity of the application.

To apply for the "Open Space Land" valuation for which you may be eligible; please contact the Eastland County Appraisal District.



### **1995 Exemption And Special Valuation Applications Are Available Through May 1**

Eastland County property owners wishing to sign up for 1995 property tax exemptions and/or special use valuations may obtain the necessary applications at the office of the Eastland County Appraisal District. The office is located on the second floor of the Eastland County Courthouse, Eastland, Texas. The necessary applications may be requested by telephone. The number to call is 629-8597.

The completed application must be filed with the Eastland County Appraisal District by May 1, 1995 if it is to be considered timely filed for the 1995 tax year.

There are numerous property tax exemptions and/or special valuations through the Texas Property Tax Code. A partial list of those available is given at the end of this article. If a property owner has a question as to his or hereligibility; they should contact the Eastland County Appraisal District for assistance. Homeowners can take

advantage of the partial homestead exemptions available. The exemption application must be filed by May 1, 1995. It does not have to re-applied for each year. If the residential homestead owner resides in the same house for 1995 that he or she lived in for 1994; and they received a homestead exemption for 1994; they do not need to re-apply for 1995. An exemption to this would be a person who received the exemption last year (1994); but has turned sixty-five (65)

years of age during the 1994 year. This person would need to re-apply as he or she would now be eligible for an additional or increased exemption in an amount available to those over sixty-five (65) years of age.

If you have a question as to whether you are receiving a homestead exemption or as to your eligibility for one of the available exemptions or special valuations; please contact the Eastland **County Appraisal District** for information and assis-
