diana state legislature was deadlocked for five ballots in picking a U. S. Senator-Senators then being elected by state legislatures rather than by popular vote. A Whig seemed likely to win. But on the sixth ballot Marsh's vote elected Democrat Edward A. Hannegan, 76 to 75. Early in 1845 Congress was

voting on admitting Texas into the Union. The House was for it, but the Senate split down the middle. Senator Hannegan's vote for annexation avoided a tie. Thus Texas be-came a state in December.


