The Sonora Chamber of Commerce office opened for business here Monday in the building just east of the La Vista Theater. According to Manager H. V. Stocken, a telephone has been installed and files are being set up. The office, given by Gay Copeland, will be used until a suitable permanent location is found.

Dues to the organization are payable as of November 1 and Pat Lyles was the first member to send in his dues.

Applications for the position are being taken now by Stokes. Listings of hunting leases are being handled by the office as well as listings of rent property. The C of C office telephone number is 26151.

A general membership meeting is expected to be called shortly by the directors for the purpose of general program planning and for formulation of working committees.

Sutton County voters went to the polls Tuesday, November 4, to join with the national trend of casting votes for Democratic Party candidates. In the race for Governor, Edwin S. Mayer, Sutton County Republican candidate, polled 219 votes as compared to Democrat Price Daniel's 307.

A total of 565 citizens cast ballots at four polling places with eight of the number voting absentee. In the contested races, local voters cast a majority of their ballots for Daniel, Lt. Gov. Ben Ramsey, Attorney General Will Wilson, U. S. Senator Ralph W. Yarborough, Agriculture Commissioner John C. White, Land Office Commissioner Bill Allcorn, State Treasurer Jesse James, Railroad Commissioner Olin Culberson, Comptroller Robert S. Calvert, Associate Justice Robert W. Hamilton, Criminal Appeals Judge Kenneth K. Woodley.

In a write-in campaign Bill E. Cartwright failed to unseat incumbent Alfred Cooper. Cartwright received 155 votes to Cooper's 266. Cartwright also received 39 votes for Constable, Precinct 1 an office for which there was no candidate.

For Constable, Precinct 3, Mrs. Stanton (Mack) Bundy received one write-in vote.

Local voters approved only three of the nine proposed constitutional amendments. Balloting on the amendments was as follows:

1. Annual session of Legislature: 103 for, 316 against;
2. Pensions for county officials: 142 for, 279 against.
3. Filling local office vacancies: 260 for, 160 against.
4. Limiting officeholders from running for another office: 221 for, 198 against.
5. Four-year terms for city offices: for 145, against 259.
6. Range pensions: 180 for, 249 against.
7. State advertising: 229 for, 197 against.
8. Permitting certain medical payments: 195 for, 231 against.
9. Permitting certain hospital districts: 182 for, 227 against.

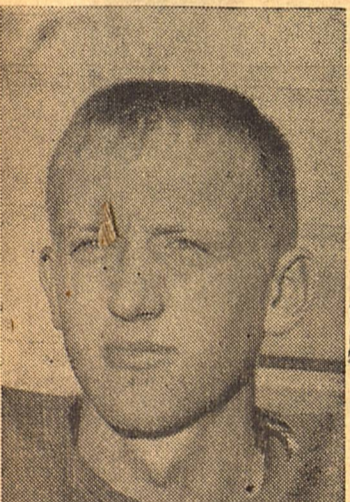

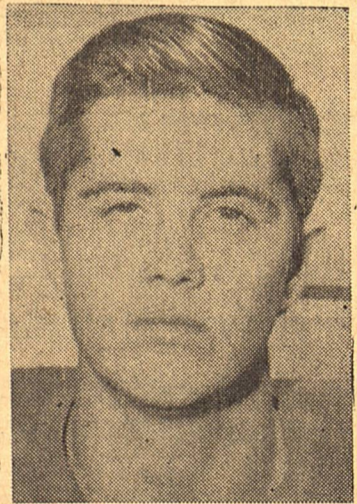

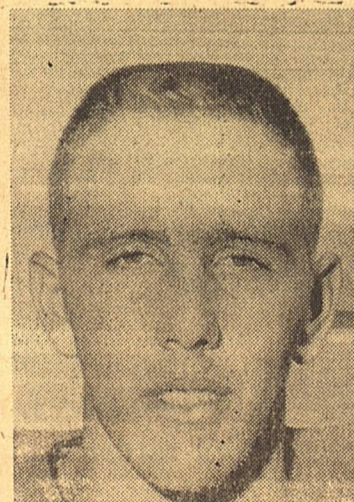

run. Alfred Sykes set the pace which was followed by Eddie Sosa on a 47-yard run across the goal line.

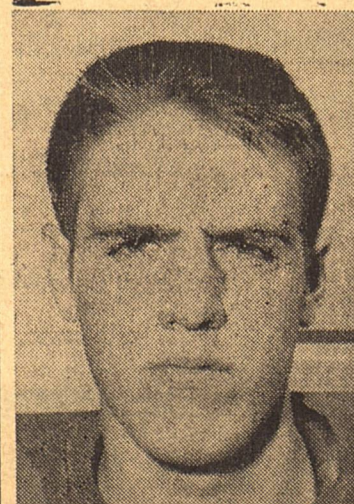

**Devil's River Philosopher Baffled
 Over How Anybody Could Inject
 Foreign Policy Into Politics**

Editor's Note: The Devil's River Philosopher on his bitter-weed ranch on Devil's River discusses foreign policy this week, which is out of his field.

Dear editor:
 All during the Congressional campaigns throughout the past few weeks I've been reading indignant statements by different people saying

we ought to keep our foreign policy out of politics, and I wish to say that if foreign policy has been injected into politics, I didn't even know what our foreign policy is.

For example, I know we must have some policy toward say Formosa, but how can you expect me to know what it is when nobody in Washington does either?

However, I'm not sure there's anything wrong with injecting foreign policy into politics, lots of candidates inject honesty into politics and some of them don't know what that is either. If you're going to limit politics to what a man knows, I know some candidates whose campaign wouldn't last longer than five or ten minutes. I figure mine, if I

was running, would last one or two.

Speaking of foreign policy, I read the other day where a man in Washington said the United States now has fewer friends in the world than ever before. This is the sort of statement that intrigues me.

In the first place, I don't even know how many friends I had abroad before, not to mention now. Foreign friends added up by somebody else are somehow different from friends in your own neighborhood. With the latter, you can find out for yourself, but with the former, you have to take somebody else's word for it, and as a result you never know which side they're going to turn up on when the chips are down. Some of our best friends in the first world war were our worst enemies in the second, and some of our allies in the second are our worst enemies now. You get the feeling that foreign friends frequently are like your welcome in some stores. You're welcome only as long as you're spending money there.

If you catch any politician injecting our foreign policy into politics, I wish you'd let me know about it. I'd like to corner him and ask him what it is.



completed harvesting of grass seed on 140 acres of former cropland this week in the largest seed harvesting operation ever staged in this area.

Half of the acreage was covered with a thick stand of sideoats grama, while the remainder of the field supported a mixture of sideoats and blue grama, KR bluestem, blue panic and buffelgrass, and some Johnson grass. The seed yield is expected to total over 7,000 pounds of sideoats grama seed, and approximately 8,000 pounds of mixed grass seed.

Two self-propelled 14-foot combines, operated by C. C. Smith of Uvalde, harvested the

seed. The seed was sacked loosely in wool bags, allowing room for turning to aid drying. The dry seed will be reclaimed at a Uvalde cleaning plant operated by the Nueces-Frio-Sabinal soil conservation district.

Landowners and many range technicians who saw the field prior to harvesting were amazed at the excellent growth and heavy production of seed. The fields were drilled to grass in 1957, at the rate of approximately three pounds of seed per acre. Weeds were mowed in 1957, and were controlled by poisoning in 1958.

The fields, with normal moisture, should produce good crops of grass seed for many years.

Before entering the Navy, he graduated from Reagan County High School, Big Lake, Texas.

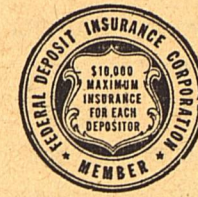
