## Services Held Monday For Col. James Adamson

Services for Col. James M. Adamson (U.S.A. Retd.) were held Monday morning, March 2, in Main Post Chapel, Fort Sam Houston, with the Rev. Alanson Brown officiating. Burial was in Fort Sam Houston National Cemetery with full military honors.

Born December 29, 1894, in Ottawa, Canada, Col. Adamson was reared in Montana and Canada before joining the Army in 1914. In 1916 he served with Gen. Pershing in the Mexican Revolution. He served as a Fifth Cavalry officer and with the re-mount service.

During World War II Col. Adamson was the supply officer with Gen. Patton's Third Army during the invasion of Sicily and in other European theater sectors. Col. Adamson also served with the Marshall Mission in China before his retirement in 1948.

Col. Adamson received awards including the Legion of Merit, the Bronze Star and Army Commendation Ribbon. He was a member of St. John's Episcopal Church.

Col. Adamson died early Thursday, February 26, at his ranch home 35 miles southeast of here.

He is survived by his wife; two daughters, Carol and Sandra Adamson of Sonora; a son, Major James B. Adamson, U. S. Army; a brother, Robert M. Adamson, San Francisco, Calif.;

## Special Stamps To Be Issued

The Postoffice Department will issue a special four-cent stamp through the Washington, D. C., post office on April 4. The stamp honors the tenth anniversary of the signing of the North Atlantic Treaty and will be 0.85 by 0.98 of an inch in dimension and will be issued in sheets of 70. An initial printing of 120 million has been authorized.

Collectors desiring first-day cancellations of the four-cent NATO commemorative stamp may send addressed envelopes, together with remittance to cover the cost of the stamps to be affixed, to the Postmaster, Washington 13, D. C.

Trophy cups will be awarded winners in both boys' and girls' divisions of debate and a trophy will also be presented the winners of the limited one-act play contest.

The one act play division will consist of only three entries. Sonora high school will present "The Case of the Crushed Petunias"; Alice High School will do the recognition scene from "Anastasia"; and Denton High School will present a cutting of "Moor Born".

Individual speaker medals will

be presented to first place winners in each of the following divisions for both boys and girls: Debate, oratorical declamation, humorous declamation, extemporaneous speaking, senior and junior poetry reading, original oratory, dramatic interpretation, duet acting, after dinner speaking, Bible reading, ready writing, number sense, spelling and typing.

# RAINS MEASURE 30 TO 1.50 INCHES

Light rains fell over most of the Sonora area last Thursday, bringing the heaviest moisture since October 1958. Rains were very spotty, varying from about .30 to 1.5 inches.

Rains were generally lighter west of Sonora, increasing gradually as clouds moved east. The Dee Word ranch received .30, while Thomas Morris recorded 1.50. Rainfall occurred in two showers, one early Thursday morning and another in the afternoon.

With increasing warm weather, the light rains were very beneficial to the heavy winter weed growth on rangeland. The heavier moisture will also start grass growth. Rainfall since October has totaled about 2.00 inches, compared to the long time average of 4.16 inches for the period.

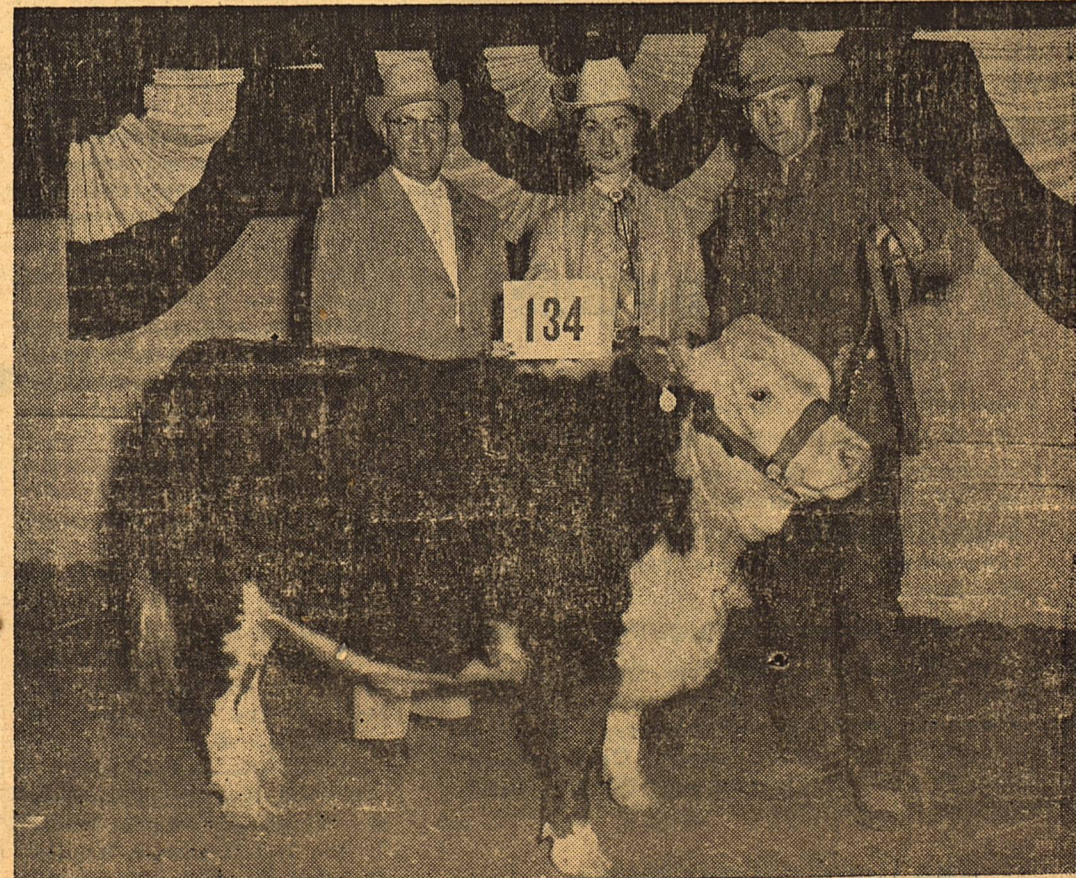
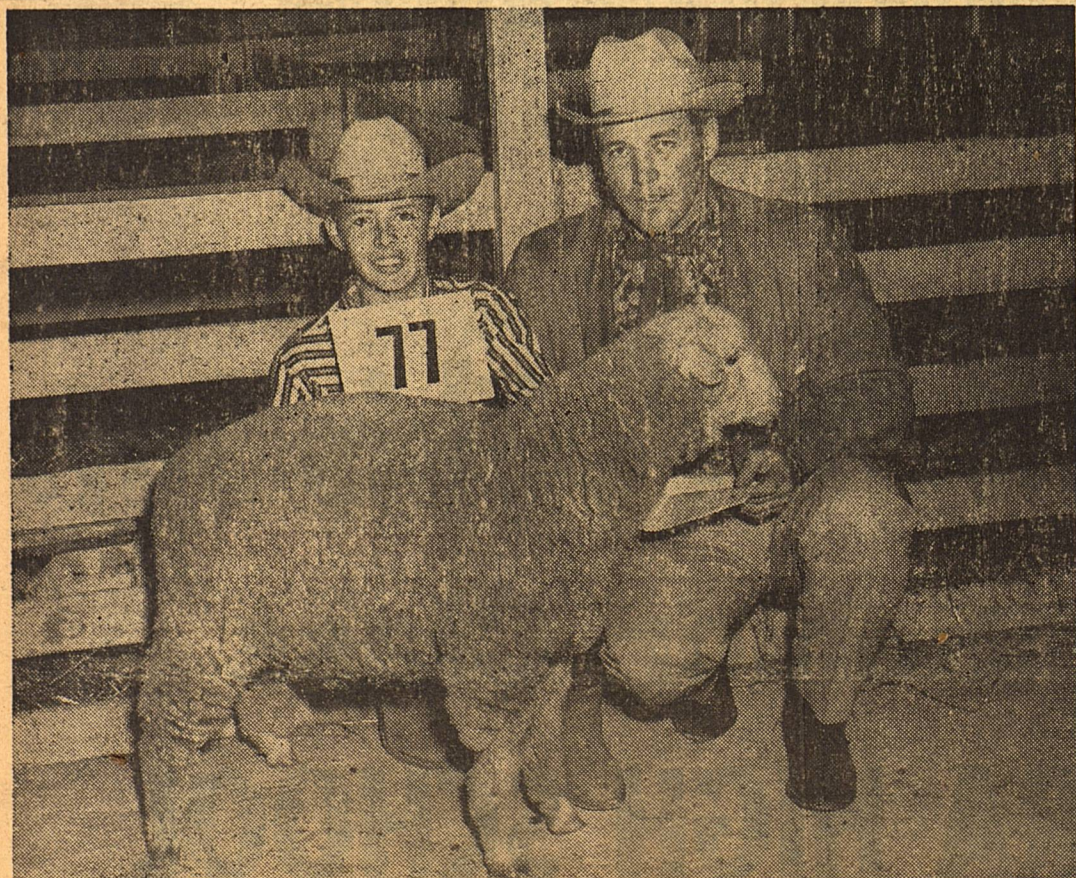
SONORAN'S COUSIN AUTHOR OF "MAN OF THE WEST"

## YOUR MINISTER SAYS

**TWO MEN-BOTH SINNED.** The Bible tells us about both. One chose the road to the left. It led to a tree in the valley, death by his own hand, the condemnation of all generations, and hell without end. The other took the road to the right. It led to a confession of sin, forgiveness, and life eternal.

The first was Judas. He was born just like you and me. He even had a religious name. Judas means "praise of God." Judas betrayed Jesus for 30 pieces of silver (about \$20 in our money). He tried to make amends by attempting to return the money to the chief priests with whom he made the deal. But what did they care? Judas found no sympathy among the worldly. He received no forgiveness. Not because God would not forgive, for Judas never went to God. Judas saw only a black future without hope. He thought his sin was too great.

Peter was the other. He denied His Lord. In the courtyard he swore and cursed that he never

knew Christ. Peter turned to the Lord after his sin. Like the Prodigal Son he went to his father and confessed his sin. Peter found forgiveness.

You, like Judas and Peter, betray and deny your Lord. Perhaps not in such a way as Judas did by making a deal with the ungodly to betray Him, nor by openly swearing you never were a follower of Christ as Peter did, however, you can deny and betray God with your life as well as your tongue. A life of sin is the same thing. You do sin. You need God's pardon. Christ died for you, no matter how great the sin. What shall it be? Shall you be like Judas, praise of God, who chose the tree in the valley, and will never sing again? Or shall it be like Peter, repentance, confession to a merciful God, and you shall sing again?

Remember Judas, his life will never be an inspiration to you but must always be a powerful warning. Remember Peter, he found the forgiveness God wants to give to you. **TWO MEN-ONE SAVED, ONE LOST!**

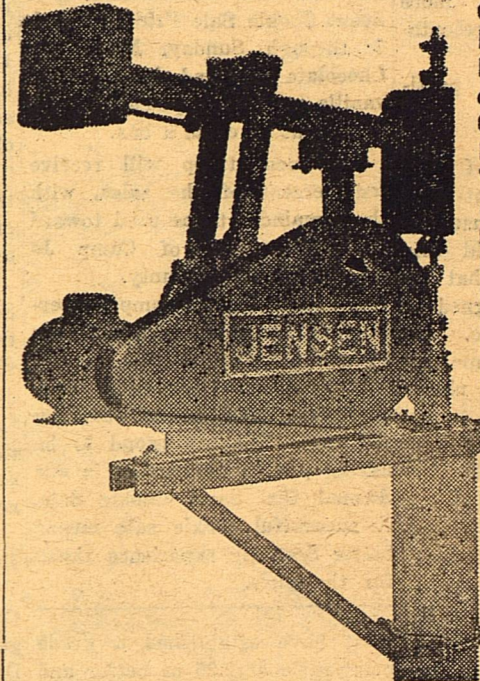

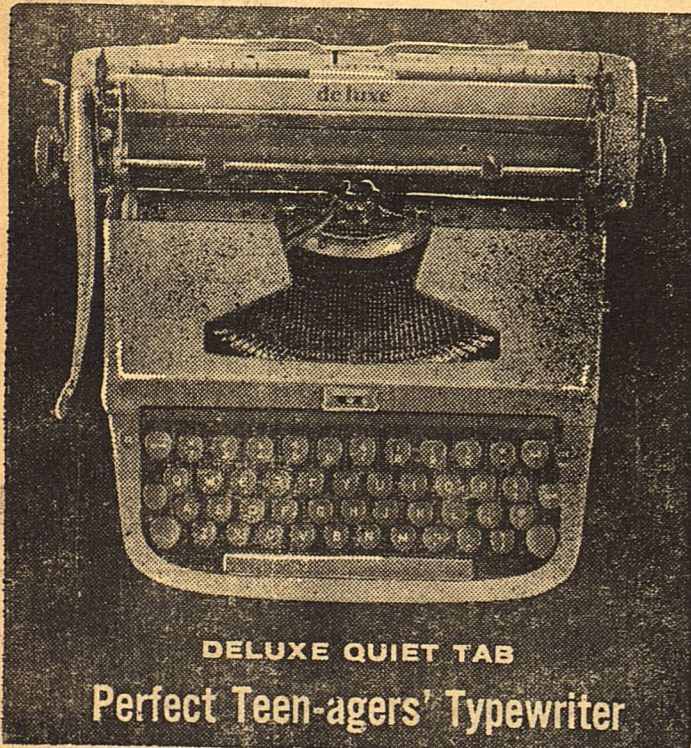

## The Devil's River Philosopher Finds Out At Last How Some Phonograph Records Got Played Over The Air

I couldn't figure out how such a record ever got played, not to mention how anybody could claim it was zooming.

Well, this has been cleared up. According to a newspaper I read last night, the Senate Rackets Investigating Committee has turned up some evidence that juke box owners to buy phonograph records have been forcing

graph records.

I knew somebody must have been holding a gun on somebody else to get such music played. But it'll never succeed. I mean, while maybe the racketeers can force records distributors to buy their records, it's going to take a lot of mobsters to hold enough guns on enough people to make them listen.

On the other hand, I've heard some records that weren't forced on anybody, they're played night and day, on radio, TV, juke boxes and kids' portable record-players, and I'll tell you it's going to take an expert to tell which record was forced on the public by racketeers and which one by teenagers. I'm glad I'm not on the Senate Investigating Committee when this problem comes up. Turn that music down and let me read. Where's my copy of The Devil's River News? Or something. Anything will do.

## Fishing Booms; Buy License Before Going

Fresh water fishing definitely is on the upgrade in Texas with an apparent break in winter weather, according to Captain E. M. Sprott, director of law enforcement of the Texas Game and Fish Commission.

"Wardens are reporting increased activities on every lake and stream in the state," Capt. Sprott said. "Some exceptionally large crappie are being taken in lakes in East Texas. Bass fishermen also are reporting catching some six to eight pounders in most of the lakes. This is especially true in Falcon, on the Rio Grande south of Laredo."

There is an unconfirmed report of an 11-pounder being caught in Falcon last week. Eight pounders, however, have been frequent.

White bass are still running at the upper end of all major lakes. Some fantastic catches also have been reported below the dams.

"This is a good time to warn fishermen they must have a license if they fish outside of

their home counties or use a rod and reel," he said. This applies to all persons between the ages of 7 and 65. Texas has a universal license fee of \$2.15 which permits fishing in both fresh and salt water. It applies to both residents and non-residents.

## Fence Jumpers Head List Of Game Charges

Trespassing continues to be the principal violation committed by hunters, according to the monthly arrest report of the director of law enforcement of the Game and Fish Commission. During December 1958 there were 129 hunters who "crawled over the fence" to hunt on private property.

Night hunters, however, came a close second, with 124 arrests. The night hunting arrests were heaviest because of deer hunters who insisted on getting their venison with the use of headlights.

Next in line of violations were hunters and fishermen who failed to get their licenses. There were 103 such violations, with 58 hunters involved.

Most of the other hunting violations involved deer. There were 23 persons fined for killing spike bucks; 15 for killing doe deer; 13 killing deer in closed season. Numerous other minor violations also were recorded.

The 715 persons arrested by game wardens during December paid fines totaling \$20,925.78 and court costs \$1,280 for a total of \$22,205.78.

Among the cases made by the wardens, there were 15 dismissals and 15 who served jail sentences. In two cases fines were suspended. Three defendants were found not guilty.

**8th U.S. Army Corps  
To Be Reorganized**

Lt. Col. John Sponenburgh, commanding the San Angelo area of the North Texas Sector, announced the receipt of orders today from the Commanding General of the VIII U.S. Army Corps (Reserve), Major Gen. R. G. Gard, for the immediate reorganization of the U. S. Army Reserve in the VIII Corps area which includes Texas and New Mexico.

Under this reorganization, Army Reserve units will be re-modeled to conform to the new Pentomic concept which has been in force in the regular Army for some time, and some units no longer required by joint war plans will be eliminated. The overall result of the reorganization will be a more effective Reserve.

In announcing the changeover, General Gard emphasized that there would be no reduction in the size of the Army Reserve. "However, there will be many changes in the size, types of units, and even geographical location of some of them," he added. Continuing, the General said,

"The number of paid drill spaces in the VIII Corps area, in fact over the entire United States, will not be reduced.

The local Sonora unit affected by the reorganization is Company B, 830th Engineer Battalion, U. S. Army Reserve, commanded by Lt. Bob Burkart. This unit has been redesignated Detachment, Troop B, Reconnaissance Squadron, 90th Infantry Division. There will be a slight reduction in number of officer personnel. There will be a slight reduction in the number of presently assigned enlisted personnel.

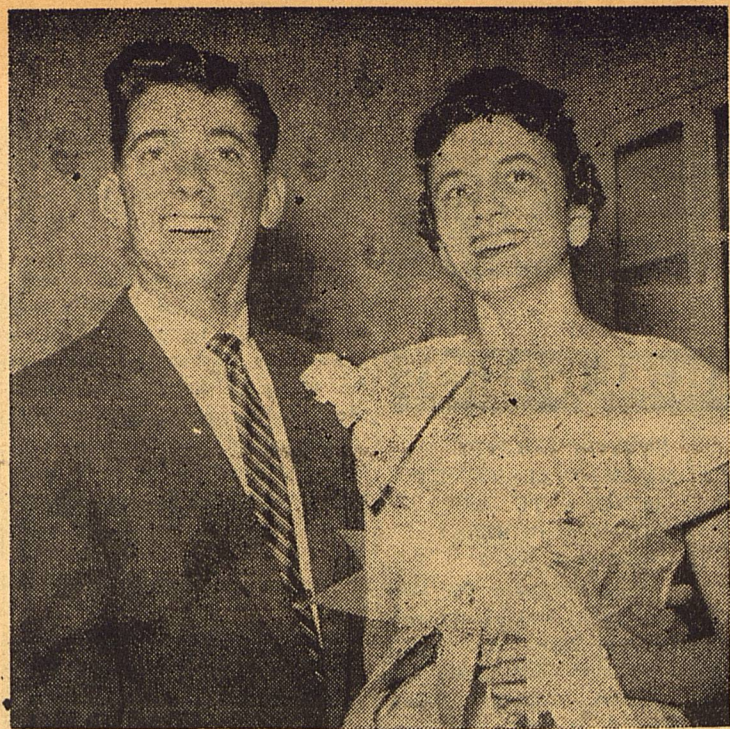

**High Lights And Sidelights  
From The State Capitol**

AUSTIN, TEX.—56th Legislature is moving like a snowplow with the snow still falling and the snowballs flying.

Taxing and spending committees are pushing doggedly through their hearing schedules. But new bills are still swirling into their path, and, in whatever direction they move, they're constantly pelted with objections.

With the 120-day session nearing the halfway point, each passing day increases the possibility that they'll come to the May 12 quitting deadline still "snowed under."

**OVERHAUL PLAN** — Rep. Frates Seelingson is pushing his take-some, add-some tax plan as a long-needed updating of Texas' tax structure.

Seelingson (of San Antonio) told the House Revenue and Taxation Committee that many taxes still on the books (such as those on clock peddlers, waxworks, medicine shows, etc.) are no longer useful. Others, such as the chain store tax, he called inequitable.

Seelingson's bill would repeal some 38 such taxes and increase levies in other areas—auto sales, cigarettes, liquor, beer, corporation franchises. His plan also would include two ideas backed by Gov. Price Daniels—to take over abandoned property for the state and to make a bookkeeping transfer of \$18,000,000.

But unlike the governor, Seelingson is frankly pulling for a general sales tax.

Other new tax ideas are to increase the levy on beer from \$4.30 to \$10 a barrel, by Rep. Leon Thurman of Anson.

Rep. W. T. Oliver of Port Arthur has introduced a five per cent gross receipts tax on hotels, motels, rooming house rentals and airline passenger business. Oliver also proposed a five-cent-a-gallon tax on soft drink syrup and a three per cent levy on pop sales.

**GALS AT IT AGAIN**—That hardy repeater from many past sessions, the women's equal rights amendment, is back again.

Sen George Parkhouse of Dallas is sponsor of the proposed constitutional amendment which would remove legal restriction on women.

Representatives of the Federated Business and Professional Women told the Senate Committee that some Texas laws classify women with "infants, imbeciles and lunatics." They pointed to the statute that prevents a married woman's selling, without her husband's permission, property she acquired on her own hook.

As usual, no one opposed the women. But the proposal was packed off to the attorney general for a "full appraisal of what effect it would have."

**OF CHURCH AND STATE**—Religion and politics got mixed with explosive results when four legislators announced they'd heard "atheism was being taught in state colleges.
