But the Devil would never lift his nose to snob such goings on. Rain in this area is a miracle any way and any time it comes.


In fact, The Devil would be glad to handle the kitty in case some Sutton County people want to pay for a little overflow to the south of San Angelo.

 NO. 1 proposing an amendment to Sections 2 and 4 of Article VI of the Constitution of the State of Texas so as to repeal the provision making payment of the poll tax a requir-ment for voting and so as to author-ize the Legislature to provide for the registration of all voters.
 BE IT RESOLVED BY THE LEG-ISLATURE OF THE STATE OF TEXAS:
 Section 1. That Sections 2 and 4

TEXAS: Section 1. That Sections 2 and 4 of Article VI of the Constitution of the State of Texas be amended to read, respectively, as follows: "Section 2. Every person subject to none of the foregoing disquali-fications who shall have attained the are of twentycone years and who

age of twenty-one years and who shall be a citizen of the United States and who shall have resided in States and who shall have resided in this state one year next preceding an election and the last six months within the district or county in which such person offers to vote, shall be deemed a qualified elector; provided that any member of the Armed Forces of the United States or com-ponent herenches thereof, or in the Forces of the United States or com-ponent branches thereof, or in the military service of the United States, may vote only in the county in which he or she resided at the time of en-tering such service so long as he or she is a member of the Armed Forces; and provided further, that hefore offering to vote at an elec-tion a voter shall have registered if required by law to do so. The Legis-lature may authorize absentee vot-ing. This Amendment shall take ef-fect on December 1, 1963.
