

"THE MAKING OF A SURGEON"

Anyone who wonders why the output of doctors from medical schools has lagged behind the explosive growth in health care demands should read the book, "The Making of a Surgeon," by villiam A. Nolen, M.D., as it was condensed in The Reader's Digest.

To begin with, the layman may be shocked to earn that graduating from medical school is out the first step in the life of a surgeon. It requires five years to turn an inexperienced doctor, ust out of medical school, into a practicing urgeon.

In a brief introduction, The Reader's Digest says, "They are exhausting years, filled with tension and crisis-plus, fortunately, occasional moments of comic relief." The author of the book takes the reader through years of internship during which textbook studies and medical theory become stark reality in the life and death arena of the operating room.

Dear Editor:

Many Sonorans possibly do not know that the proposed revision of the Texas Penal Code contains several ideas directly opposed to customs in this part of Texas.

Chapter 9 makes it illegal for a person to defend his property with deadly force, which means that a citizen could no longer shoot at a robber.

Chapter 46 deals with "weapons" and severely restricts a citizen's right to bear arms. Among other things, it says that a weapon carried in a vehicle must not only be unloaded, it must be "broken down in a non-functioning condition and could not be readily assembled". This would in-clude any firearm whether rifle, shotgun or pistol; and, naturally, the restriction would apply to every rancher or farmer who carries a rifle in his pickup.

If you are alarmed at this prospect, please write to your State Legislator and State Senator and oppose these measures. By all means hurry because the liberal majority in the Legislature are pressing for its quick passage.

Lee Spencer sent us a book entitled "Speedy Golf" by the National Golf Foundation. The book emphasizes the need of all golfers to move along at a faster pace, always conscious that others are playing the course. Listed below are a few quotes to help 'speed up' the game.

-After hitting the ball, move promptly off the tee box and proceed down the fairway.

-Allow speedy golfers to play through when observing the 5 minute rule while looking for a lost ball.

-As an ethical golfer, never stand in the position that interferes with a putt, shot or concentration of a fellow golfer.

-Approach the green and get behind your ball ready to putt. -The club house is the place to tell stories and entertain your friends-not on the greens. -Stay away from the green with golf cars and golf carts.

Do not park them in front of the greens. -Think about the next shot as you approach the ballmake club selection enroute, step up and hit the ball without delay. "Speed-read" your putts.

"Sight-in" and follow the trajectory of every shot you hit, establish reference markers and go straight to ball.

TO THE CITIZENS OF SONORA

Your City Council has, after many months of deliberation and serious consideration, decided to ask your support on a 1% City Sales Tax. This Sales Tax will be put to the qualified voters of Sonora on February 27, 1971.

It is the estimate of the Texas Municipal League that approximately 85% of the people in Texas live in cities, towns and villages, and about 75% of the people of Texas live in cities which have adopted the City Sales Tax. It is the sincere pledge of your City Council that if this tax proposal is carried on February 27, the three above reasons will be carried out.
