



gulfing this nation we can roll with the punches-and suffer no major changes in Sutton County way of life. The chips are on the table-let's see how the game goes. Where are we standing now?

My impressions of our school are not palatable. Looking at every facet I could, the impression is very strong that teaching in that environment is highly improbable more nearly bordering on impossible. Why do I think this?

First, the text books, in mathematics at least, could have more profitably been shipped to the back country of Arkansas, where they might have been substituted for last years edition of Sears Roebuck. It is not that they are poorly

written, they are high quality, masterfully written, absolutely beautiful books, but they are insidiously conducive to rote learning techniques. They do not, in a healthy learning environment present an obstacle of any significance, but in an atmosphere of disturbance they become living examples of that old adage, "A university lecture is a mechanical process by which the notes of the professor get into the notebooks of the students without passing through or disturbing the minds of either.

My next observations must be recognized certainly as nonuniversal generalizations, because there are many exceptions. Like they say in Hemphill-Wells, or the Florsheim Stores, "If

the shoes fit wear them." Student behavior patterns leave no alternative to the conclusion that our school bus drivers must be given more rigid examinations for visual acuity. Obviously they are hauling in rancher's livestock and leaving the students standing in the pasture, of course some of the livestock walks in or drives. After having worked in maxi-mum security area for most of my career, the requirement for a student to have a hall pass to go to his locker, makes me look out of the comers of my eyes for the armed guards. Divided Highways Pavement Marks Color Change Due

Inside line pavement markings on divided highways will take on a new color soon, the Texas Highway Department has announced.

Soon the inside edge line will be yellow to conform to changes in the Manual of Uniform Traffic Control Devices issued by the U.S. Department of Transportation. Previously both the inside

and outside edge lines were painted white. Painting the inside edgeline yellow will correspond with the solid yellow center line on undivided highways, which denotes a registration against passing. Thus, the yellow edgeline will serve as a reminder to avoid crossing the median into opposing lanes of traffic.


