Farris Sentenced For

William Streeter Shooting

A 30-year sentence was handed down to Shawn Farris, 20, of California for his part in the brutal shooting of William Duane' Streeter of Flordia last November.

The sentencing was done in the 216th Judicial District Court on Thursday, according to District Attorney Joe Grady Tuck. A co-defendent, Michael Edward Ryan was earlier given a 99-year

sentence upon his conviction. Sutton County Sheriff Bill Webster, who headed the investigation indicated Ryan had actually shot the motorist after leading him to an isolated spot off IH 10, while Farris remained behind in the car: Streeter made his way back to the highway three days later where he was spotted by two passersby. Streeter was left partially paralyzed from the incident.

With Contractor on CVEA Building **School Reaches Agreement**

The Board of Trustees of the Sonora Independent School District set Sept. 5 as the "substantial completion date" for the new vocational building, the principal action of their meeting yesterday. Representatives of Burk Con-

struction Company, contractors for the building, met with the school board to discuss this and several other items.

The board was in doubt as to whether this date could be set until several problems with the building had been corrected.

The major obstacle concerned the hail damage sustained by the roof and whether it should be replaced or simply repaired.

Other problems included a drinking fountain which only worked when certain lights were turned on, hail damage on the overhead door, no electrical outlet for the drill press.

Also, water leaks around an exhaust fan, water leaks around two doors, one of which was also rusting, water leaks around an office, low mirrors in the restrooms, unfinished painting on the outside.

Also, breaker switches in one room which keep tripping, the weather stripping on a door which had been torn off, the lack of a proper clearance on a classroom door which caused the door to hang, and specks of paint and paint smudges on doors.

Tom Gregg, attorney for Burk Construction, suggested the alternative of accepting appearance damage money on the roof and overhead door instead of having the roof replaced.

The board went into executive session, deciding to replace the roof since the contractor's insurance would cover the damage done.

The "substantial completion date" was also set in the executive meeting.

John David Burk asked the board to reconsider the issue since delivery time on the roof would be about four months and this would

leave the roof open during January when the weather would be bad.

The board explained they desired to have a new roof put on so if problems arose at a later date, ther problems arose at a later date, there would be no questions as to why the board did not replace it.

The board also advised the company that an additional \$20,000 would be held in retainance until the roof was completed.

In other action the board

approved the payment of bills. Included in this was a bill for \$10,000 to Alamo Tools.

Superintendent Dr. Joe Andrews explained this was for new tools in the vocational building, and of this the State had approved \$7,700 in reimbursement for the school district.

The board approved the bus drivers for the school year. These are Jacque Baker, Ed Caldwell, Clara Brooks and Grady Tumlinson.

Lewis Ferguson was also elected for the new Eldorado route to be started soon.

Demo McMinn was elected as a teacher's aide in junior high.

Members agreed to leave the pay for substitutes at \$20 a day, although a new escalating salary policy has been added for those who must substitute in the same class on a continuous period.


"If for some reason one of us doesn't contact you...or hasn't contacted you by now," Burnett emphasizes, "please call us so we can get your item in the auction."

The amendment grants an exemption from public school property taxes of \$5.000 of the market value of the residence homestead. In the Champlin case, Examiner Johnson summed up a U.S. Supreme Court decision relating to the subject of the classification of a gas utility as his basis for finding Champlin to be a gas utility.

Only "the production gathering on one's own gas exempts company from being a gas utility," said Johnson as to the meaning of the high court's ruling. Johnson said his study of the records indicated Champlin operates natural gas processing plants in Panola and Montgomery the In Counties. operation, Montgomery said Johnson, Champlin buys gas from others and transports it over several public roads to its processing plant.



In Panola County, Johnson explained, Champlin is a co-owner and sole operator of a gas processing plant which transports gas through pipelines for others over public roads, and delivers it to purchasers in exchange for a portion of the liquid products extracted during processing.

Johnson added that the fact Champlin owns and operates a pipeline and transports natural gas over public roads is another legally defined characteristic of a gas utility.

As with Gulf, the order signed by the Commission declaring the two oil companies as gas utilities directs Champlin to pay the state natural gas gross receipts tax dating back to March 17, 1977.

That is the date the Gas Utilities Division Director Joseph J. Piotrowski Jr., informed the two companies that they had been found to be operating as gas utilities.

The grazing management research on the Rio Grande Plains Experimental Ranch near Spofford, Texas is providing some very useful information for producers.
