

ODG hosts story telling fest

"We salute the pioneers of Sutton County and Sonora. We take off our hats to the hardy men and women who came to a rugged country with their children and their stock to make homes. It's a long way from an open range to a fenced and developed county. It's a long way from several tents, a few frame homes on newly purchased town lots, and a half dozen businesses to a modern town with a history of 75 years of progress. Sutton County and Sonora

pioneers must have loved their town and their county. They worked for them, sacrificed for their growth, and supplied the needs for education, religious worship, law enforcement, and business opportunity....."

So read a "Tribute to Foundation Builders" which appeared in the 75th Year Souvenir Edition of The Devil's River News published on Thursday, August 19, 1965 in celebration of 75 years of history-1890 to 1965. What this means to us today is that in only 3 years

(36 months) we must be prepared to celebrate 100 years of Sonora's history.

If you pick up that edition of the newspaper and read it you quickly discover that they really celebrated the Diamond Jubilee of our county and city. The weight alone of the issue (1 lb.) is an indication of the time and effort that was put into their celebration.

How should we begin the planning and development of a Centennial Celebration, a celebration worthy of the people who "loved their town and their county, who worked for them, sacrificed for their growth, and supplied the needs for education, religious worship, law enforcement and business opportunity" during the past 100 years? What can we do that will adequately portray what this century of living and dying has cost? **IT IS MANDATORY THAT WE BEGIN NOW!**

One small effort in the direction of 1990's celebration is being made by THE OUTDOOR DRAMA GROUP on Sunday, April 26th in connection with the "Dinner on the Grounds" at The Church of the Good Shepherd (Presbyterian Church). Following the dinner those attending are being asked to remain for an hour, divide into small groups, with a leader in each, to tell stories about the past. You don't have to be a story teller or a historian to participate. This is just for "us folks" to sit and reminisce about the people we remember or stories we know. It should be a fun time and will be, for the drama group, an initial attempt in the collection of both written and oral history of Sutton County, Sonora and the people who have made them what they are today. Following this event the drama group plans to schedule visits with as many of Sonora's Oldtimers as possible to record their stories for use in planning our celebration and for the preservation of our valuable history.

It is hoped that you will plan to attend this event-Sunday, April 26, Presbyterian Church, 12 noon. Come for a free barbeque lunch and bring a friend.

couple of weeks. Let me start at the beginning, or should I say at the end of last year and catch you all up on the scoop.

Last year was incredible. I look back at it now with nothing but fond memories and occasional tears. We ended up going to 22 states in the U.S., Canada, Germany, Switzerland, Italy and Denmark. I had a grand total of 78 host families for the year. And I had advance promotion work four times... Sonora, Texas; Farmington, Pennsylvania; Lubbecke, Germany; and Mannheim, Germany. What a year!

Some of the highlights that come to mind (they change every day) are helping the victims of a twin tornado in Sweetwater, Texas; Hands Across America in Longview, Texas; Memphis in May Festival in Memphis, Tennessee; Whitewater rafting in Farmington, Pennsylvania; St.

Patrick's Day in Chicago, Illinois; Thanksgiving on an American Army Base in Germany and at Dachau, the first concentration camp in WWII. I tried to think of the families that were highlights, and ended up with 74 families in the top 10. It's impossible to tell you how very special all of you were. My most precious memories come from my host family book. I carry it wherever I go, and whenever I am feeling homesick I simply open it up and start reading. Memories come rushing back as I feel as though I just saw you all yesterday.

Right now, I am back with UWP. I have been hired as a Promotions Representative. I was only home 2 weeks at Christmas and it was back to Tucson, Arizona, to start a whole new year with a brand new cast and show. What an awkward feeling it was to begin all over again. But it has proved to be such a rewarding job. I love it.

The new show I feel is the best UWP has ever put on. It doesn't even have a title yet. The cast is dressed in very contemporary costumes, much like you would see in any high school classroom. Everyone is in a different color, but in bright, bold colors. The stage looks different. Its center is still where the band is, but it is high and creates a triangle look. The music is exceptionally good. It starts out slower than Beat of the Future, but has an equal if not better impact. Lots of international songs, including pop hits from Japan, Russia and an umbrella dance from China. We have a long do-wop 50's medley at the beginning of the second half that is hot. The final song is called An Unfinished World, and creates such an impact. The cast is from 18 different countries and looks totally international on stage. This is a 50% international enrollment in this Cast E. We are all pleased about that. And for the first time, we have a deaf student traveling with us. He is one-of-a-kind talented guy, and is featured in a sign language song in God's Skin.

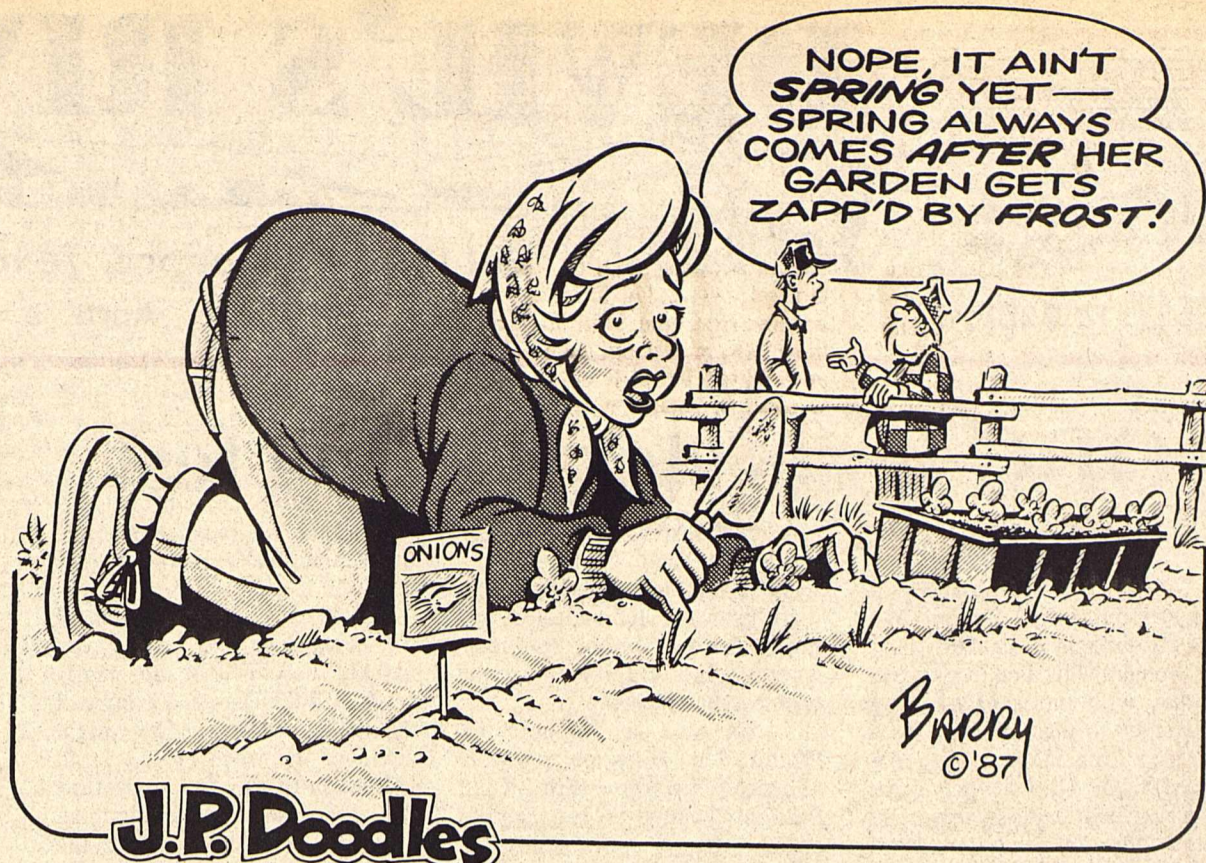
The tour of this Cast E is centered mainly in the western part of the U.S. We are doing state tours of Arizona, Wyoming, Montana, and traveling alot through Idaho, Oregon, Utah, California, and Washington. We don't know where we are going in Europe yet. We have received a invitation to visit the Soviet Union in September of this year. That means that this cast will go if all the details are worked out. So, depending on the outcome of the talks, we could be in Russia for awhile. We are all keeping our fingers crossed.

I wish it were possible for me to visit all of you again and at length. My year in UWP went by much too fast. I only hope that you enjoyed your brief contact with UWP as much as I enjoyed it.

Take good care of yourselves and drop me a line whenever you can find a spare moment. I will try to be a better letter writer, too.

Ivan is doing P.R. but in Europe. He sends his best. I hope to be in Sonora again. It still ranks as my favorite city! Take Care.

ONE MAN'S OPINION

It is amazing what we have done with the Christian fundamental teachings. The ten commandments of Moses as modified and clarified by the parables of Jesus are virtually lost in the complexity of rules of modern sects, faiths, and derived beliefs.

The fundamental beauty and serene clarity of the original teachings were impressed on all that could read them. Interpretation was not difficult. Unfortunately these writings were not available to the man on the street, in his language for a thousand years. More unfortunately, their custody resided almost entirely in the hands of the people who had most to gain from vastly increased complexity as well as a thousand years to build a tradition in that complexity.

Once language of the street came to the doctrine-protestantism and reformation came along with a period of extreme pain for humanity beginning with the Albigenian Crusade in 1235 and ending with the auto da fe in Seville in 1810. A period that could have been avoided had the

simple doctrine of Moses and Jesus been stripped of man's abhorrence of simplicity. More critically the thousand year delay allowed the building of the traditional concept that passage into heaven must be purchased.

How far we have come from our fundamental religion has been highlighted by the recent "divine comedy" of the T.V. Evangelists. One is left confused. Is it really a prayer tower, or a tower of Babel? Is there a reasonable length to which an intelligent populace will permit fund raisers to go? Can we, steeped in our deficit, allow the non-charity portions of these hundreds of millions of dollars incomes to go untaxed?

Time is here, it would seem, to go back to the teachings of Moses and Jesus--a religion of love with prohibitions that are understandable. Local churches, with priests and reverends you know, and a simple creed you can carry out on the street seems to be the only sound approach. Theory is nice, but in a nuclear, capitalistic, greedy world application is not easy.

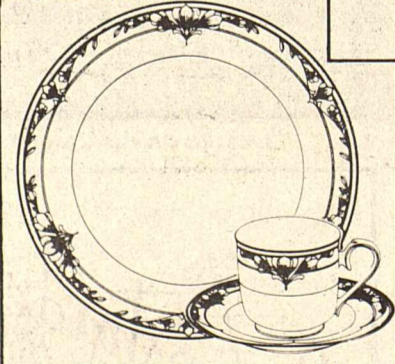

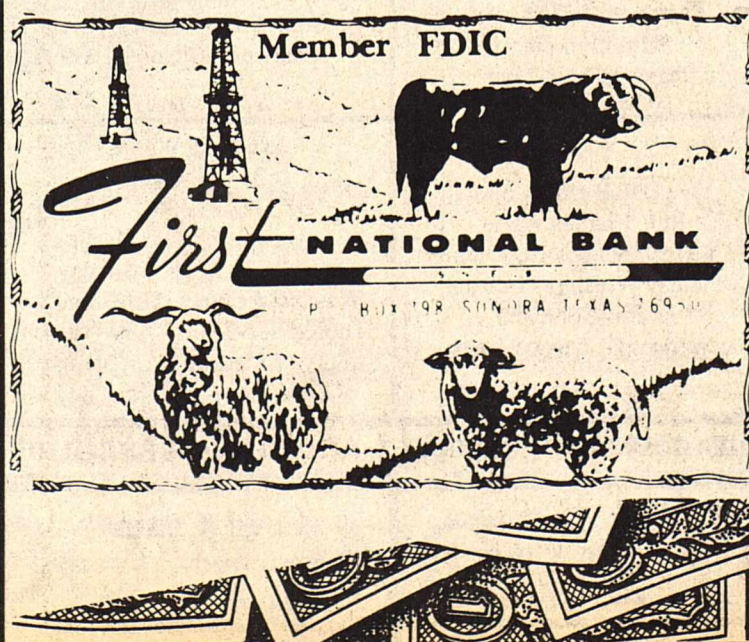

April 26 proclaimed John and Mildred Cauthorn Day

Some remember her as the owner of Labenske's Style Shop on Main Street in Sonora, some remember her as the wife of rancher, John Cauthorn, some remember her as the lady who loved and cared for cats, some remember her as a charter member of the Church of the Good Shepherd (Presbyterian Church) in Sonora, some remember her for the car loads of dresses she sent each year just before inventory to the Itasca Children's Home, but all of us in Sonora will remember her for a long time to come as the Christian lady who gave everything she had to her church and to her adopted city.

Mildred Cauthorn, born Mildred Labenske in 1905 to Lee and Annie Acklen Labenske, moved to Sonora with her parents in 1930 when her mother took over the dress shop which Mildred still owned at her death in 1984. Mildred gave to others all her life, dresses to the girls who live in the Presbyterian Children's Home in Itasca, glasses to countless people who couldn't afford a pair, education to numbers of young

people, food to bereaved families in both the Anglo and Hispanic communities. She loved cats, too, and she bought food for not only the neighborhood cats where she lived in town, but also for the cats which populated the ranch. During the years when the Presbyterian Church in Sonora was newly established, as well as later years when the membership was small, she contributed untold amounts of money and material things. Of course, that love for her church was instilled in her from birth by staunch Presbyterian parents who drove to Eldorado for church from the time they moved to Sonora until the Presbyterian church was built in Sonora in 1957 and then they donated the land (30 years ago) for the building of it. Mildred and her parents were all three charter members of the Sonora church, with John Cauthorn becoming a member of the church later in life.

John Cauthorn was born in 1900 in Sutton County to pioneer ranchers A.R. and Louella Seales Cauthorn. He was raised on the ranch his parents established in 1890, and in 1923 John acquired the ranch he and Mildred lived on

and operated until their deaths. John lived all of his life in Sonora and built an outstanding reputation for his fine livestock, both cattle and Angora goats. He was 42 years old when he married Mildred Labenske and they had no children, but he like Mildred, contributed more than will ever be known to the welfare and education of young people in the County. John made outstanding contributions to his church, but the love of his life was his ranch and the out-doors. He is remembered as being a very quiet man who went about his own business and was often thought of as shy and even unsociable because unless you went to the ranch you just hardly ever saw him. Even when he and Mildred moved to town to care for her parents, he went early each day to the ranch and returned late. His sense of fairness was expressed to this writer by one of John's proteges, who remembers that he went to see Mr. Cauthorn as a young man looking for ways to earn a living for his family and to begin his own ranching business. He made a deal with Mr. Cauthorn to find hunters to lease the

Cauthorn land which had an abundant supply of deer not being hunted. After the deal was struck and they shook hands on it, the young entrepreneur inquired as to how they would split the income and Mr. Cauthorn replied in his typical fashion, "Why, I don't know any way to split it except 50/50," which is the way it worked except that he was so trusting and so unconcerned with his portion that Mr. Cauthorn often had to be forced to take his share. Many who dealt with John Cauthorn have never forgotten the lessons in humans kindness taught them by this gentle man. John Cauthorn died with his "boots on" in 1969, found dead on his ranch.

Mr. Cauthorn died without a will and the property which he had inherited was disposed of according to the law. The portion of the ranch which remained Mildreds was disposed of at her death according to the will she had written following her husband's death. This will reflected her great love for both her church and her community as the entire estate is divided between the two. She named friends, neighbors, fellow churchmen and fellow citizens as the trustees of her estate which has already benefitted the local Presbyterian Church as well as the Presbyterian Children's Home and Service Agency and will continue for many years to come to benefit these two entities as well as the city she loved.

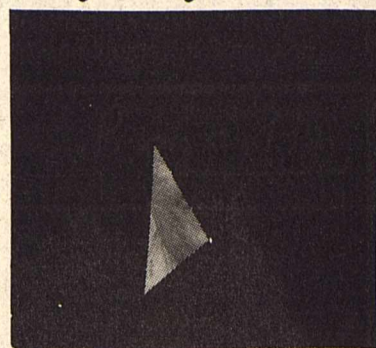
The idea of a John and Mildred Cauthorn Day grew out of a desire on the part of The Church of the Good Shepherd and the Itasca group to express their appreciation to the Cauthorns and to celebrate the impact of Mildred's gift on their life. In light of that desire the mayor was asked to sign a

proclamation naming April 26th, 1987, JOHN and MILDRED CAUTHORN DAY so that the entire community could be made aware of her attitude toward her Christian life and what it has meant to the church and to the community both during her lifetime and for future generations in Sonora.

The entire community of Sonora is invited to participate in this celebration to be held on the grounds of The Church of the Good Shepherd, 319 NE Mulberry, Sonora. Old friends and former members of the church are being invited to attend worship in the morning at 10:00 a.m. The old-fashioned Dinner on the Grounds will begin at 12:00 noon following worship in the community's churches. A barbeque meal is being furnished by the church. Tables and chairs are being set up on the lawn and

the public is invited to come for dinner. Following dinner there will be a very brief service of thanksgiving and dedication of the church's new education facility on the hill which is now called "Cauthorn House." Plenty of time is being allowed for old friends to visit and everyone is encouraged to remain after dinner for a COMMUNITY STORY TELLING FEST.

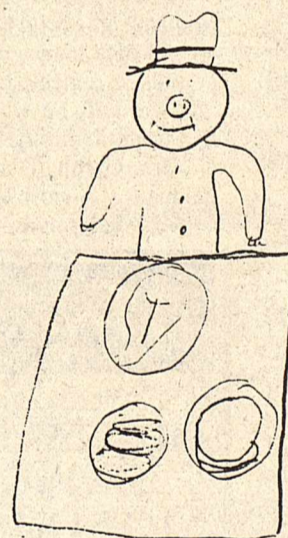

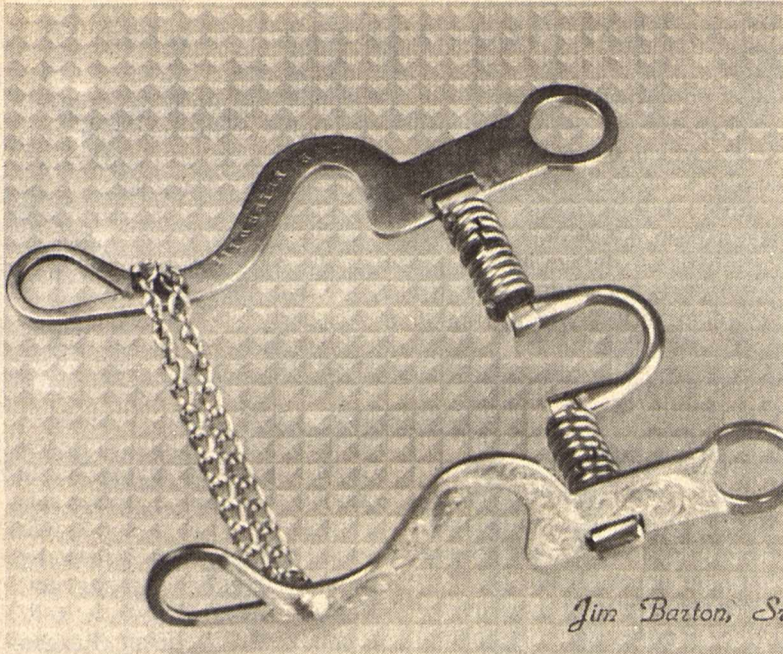

Texas spur maker strives to be best

Lee Friend, III hopes to be one of the top bit and spur makers in the United States someday!

Friend, the son of Benny Friend of Ozona and Carol Crews of Big Lake, was born in San Angelo in 1959. He is the grandson of Wilma and Batts Friend of Sonora.

While attending college, Lee worked part time as an apprentice welder. He started his own welding business in 1980, selling it in 1984 to go back into ranching.

It was at this time that Friend started making bits and spurs, working on them of an evening after the ranching chores were done. "Making bits and spurs was something I had always wanted to do." Friend says. By 1986, orders were coming from more than just the neighbors and Friend began his business in earnest.

Noticing that there were no bit and spur makers in Texas using the inlay method, Friend spent a

month with Elmer Miller in Nampa, Idaho. Miller, a forty year veteran to the trade, is the only bit and spur maker to have his works on display in the Smithsonian Institute.

Miller taught Friend the proper procedure to inlay bits and spurs. In this procedure the steel is chiseled out, the silver, copper or brass inlaid and made flush with the steel.

The inlay is a less popular method because it involves more hand work and time. It takes approximately twelve hours to complete an overlay spur and about forth-eight hours for an inlay spur. To the best of Friend's knowledge, he is the only bit and spur maker in Texas to use the inlay method.

Friend says that at least seventy percent of the work that goes into making bits and spurs is done by hand. "Machines do speed up the work," Friend states, "but they can not possibly replace the hand work that goes into each item."

The creative talent of Friend makes each pair of bits or spurs unique and Friend's motto is to strive to make each customer happy with the item he or she orders.

Friend, his wife, Patricia and fourteen month old daughter, Cheyenne live on the family ranch fourteen miles north of Big Lake.
