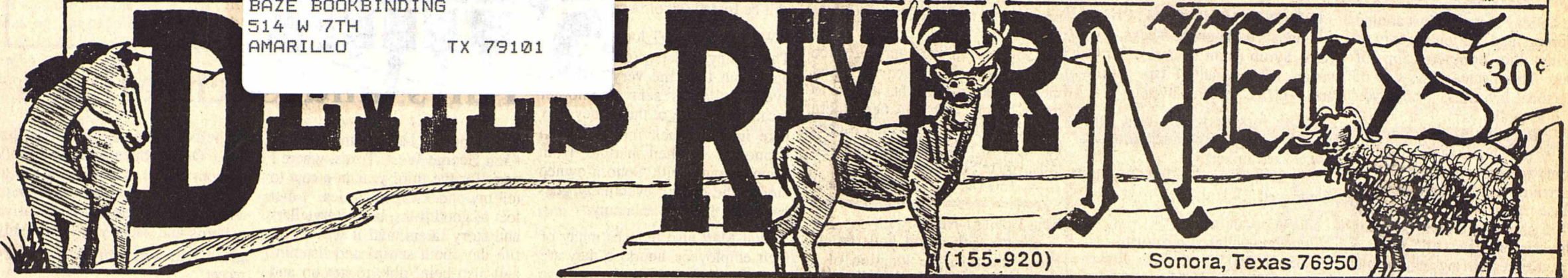

## Broncos subdue Rangers

Everything seemed to fall into place nicely for the Sonora Broncos last Friday night against Midland Greenwood--but not until the second quarter began.

It was in the second period that the Broncos erupted for 21 points en route to a crucial 34-14 win over the Rangers at Bronco Stadium. Sonora goes to 7-2 on the season and 3-1 in district. The Broncos now face a must-win situation in Crane Friday night. (See related story.)

Greenwood jumped out to a quick 7-0 first-quarter lead when Eric Clutter ran one yard for a TD and Joe Kilgore kicked the point after.

"In the first quarter, we had trouble picking up what they (the Rangers) were doing. They were lining up in different gaps and stunting differently than what we'd worked on," senior lineman Robert Gallion said.

"On the first couple of Greenwood's plays we were worried. We weren't sure what was happening to us," Sonora Head Coach Bob Bellard said.

"As it turned out, we just weren't taking care of responsibilities. Once we did that, we were okay," Bellard added.

He also said that many times it's difficult for a defense to pick up what a wishbone offense, such as Greenwood's, is doing. "It takes a little time to adjust," Bellard said.

The first quarter behind them, the Broncos came on strong, scoring three touchdowns in the second period.

"Our line blocked really well, and holes started opening up after the first quarter," senior Larry Chalk said. Chalk had a fumble recovery and an interception in the game. "We just started to move them off the ball," Gallion added.

The Broncos' first score came with 9:43 remaining in the half when Danny Mata scampered 18 yards for the touchdown. Armando Robles kicked the extra point. Mata finished with 103 yards on 17 carries.

The leading ball corner for Sonora, however, was Adam Youngblood, who scored the next three TDs. Youngblood finished the night with 178 yards on 21 carries. Youngblood's first score came with 2:57 left in the first half on a 60-yard run. Robles again added the point.

On Greenwood's possession just after Youngblood's first touchdown, the Rangers fumbled, and Sonora's Sam Taylor recovered, setting up Youngblood's second score, a 15-yard run with 1:01 left before halftime. Robles added the PAT to make it 21-14.

Earlier in the quarter, Greenwood had put another touchdown on the board when Clutter caught a 65-yard pass from quarterback Irvin Welch. Kilgore again kicked the point.

The defense came on big in the second half, holding Greenwood to no points.

"Shane Keller made a lot of plays. Michael Escalera, with two interceptions, played very well, too," Bellard said. He also singled out Ricky Gandar, Joe Buitron, and David Kemp for outstanding defensive efforts.

Youngblood's last TD of the night came with 8:02 left in the third period on a one-yard plunge. Robles kicked the point to put the Broncos up 28-14.

Mata scored the final TD of the night on a 15-yard jaunt with 6:04 left in the game. Robles missed the PAT, and the Broncos' 34-14 lead stood as the eventual final score.

Bellard cited the play of several Broncos who have really come on strong as the season has progressed.

Tight end David Kemp "has been blocking really well and catching the football." Chris Perez has been "improving steadily, as has Shane Keller." Bellard also said Michael Escalera has been playing "to the level we expect of him."

## Broncos tied for district crown

The Sonora Broncos took a major step forward in their quest for a playoff berth last Friday night by downing Midland Greenwood.

As a result of last Friday's games, four teams in District 6-AAA have a shot at the two playoff spots. Greenwood was eliminated from a post season position by virtue of Sonora's victory.

Reagan County and Sonora sit atop the district pack with 3-1 loop records, but the owls have the advantage over the Broncos because of the Owl's 14-13 victory the second week of district play. Kermit's record (2-1-1) is good for third place. Crane (2-2), Greenwood (1-3), and Colorado City (0-3-1) are in the bottom half.

In this week's district games, Sonora is at Crane, Kermit is at Reagan County, and Colorado City is at Greenwood.

The Broncos can be district champions if they defeat Crane and Kermit upsets Reagan County. The Broncos, however, must win - or possibly tie - for a playoff spot of any kind. If Sonora wins and RC wins, the Owls would be district champions and the Broncos would get the runner-up berth.

Kickoff in Crane Friday night is 7:30 p. m.

"It's going to be a tough, hard-nosed football game," senior receiver Larry Chalk said of the Crane matchup.

Bronco Head Coach Bob Bellard seconds that.

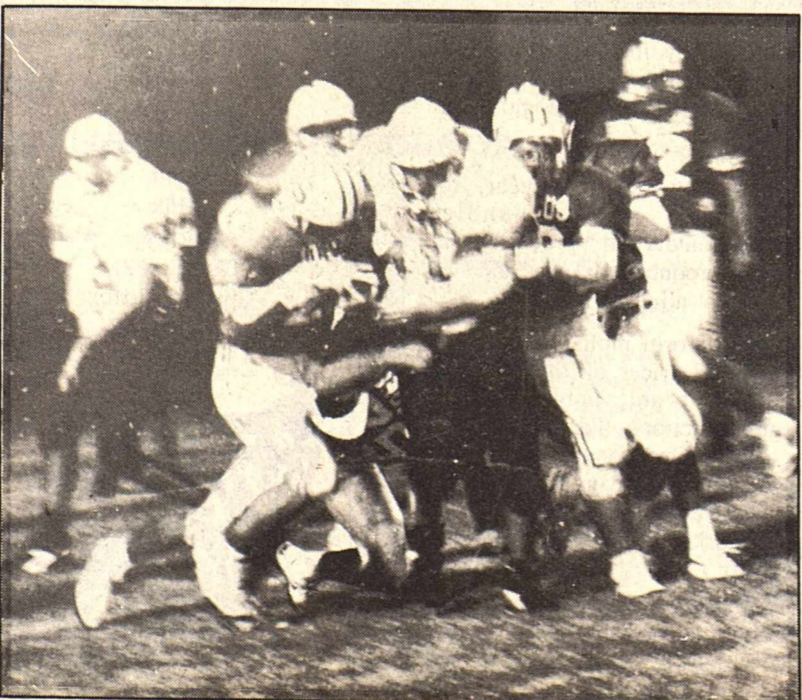
"Crane is very big," Bellard said. "They have two fine running backs who look healthy and ready to go for this game."

According to Bellard, "Defensively, Crane is very aggressive. They come after you hard. They've got great size inside and good speed in the secondary."

Crane won last year's contest 21-7 in Sonora that gave the Cranes the district crown.



**HALLOWEEN TREAT** - McGruff the Crime Dog brought a message of safety to these Sonora Primary students last Thursday.

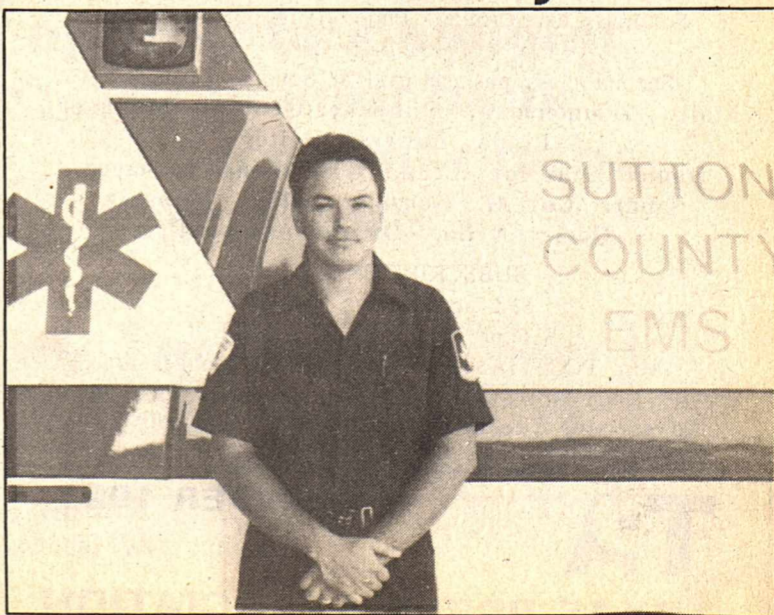


**FAST ACTION** - Sonora's defense was tough on Greenwood allowing very little yardage on the ground.

## My favorite pecan pie recipe

The holiday season is just around the corner, and Sutton County is enjoying the bumper crop of pecans. This pecan pie is one of my personal favorites. I hope you enjoy it as well.

### PIE PASTRY

For 9" pie shell, single crust. 1 C. flour, 1/2 tsp. salt, 1/3 C. + 1 T. shortening and 2 T. cold water.

Place flour and salt in bowl. "Cut" in shortening until particles are the size of peas. Add water a little at a time, stirring with a fork until dough clings together.

Turn out on flour board. Roll dough 1/8" thick. Cut as desired. DO NOT STRETCH DOUGH INTO PANS!

**GRANNY'S PECAN PIE**  
1 unbaked pie crust, 3 eggs, 1 C. Karo Syrup (light or dark), 2/3 C. sugar, 1/8 tsp. salt, 1 tsp. vanilla and 1-11/2 C. pecan halves.

With fork or whisk, beat eggs until thoroughly blended (do not use electric mixer). Add syrup, sugar, salt & vanilla. Blend well.

Stir in pecan halves. Pour into unbaked pie crust. Bake at 350 for 10 min. Lower heat to 300 - cook 45 minutes or until set.

(Should not look liquid when removed from oven.)

Dear Devil's River News,

I read with alarm your article about the possible location of a Wal-Mart in Sonora. I live in a small town about the size of Sonora with several other small towns within a 40 mile radius. Several years ago we were so excited to learn that Wal-Mart was planning to locate six miles away in Kenedy, Texas. It would provide so many jobs and boost the economy in a lot of different ways.

The first year that Wal-Mart was here, the local hardware store's business fell 75%. EVERY small

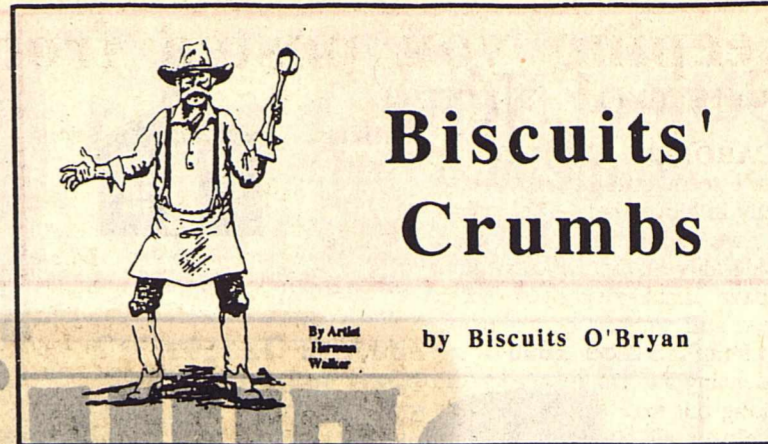
business in Kenedy, Karnes City, Runge, Nixon and Poth have seen their businesses drop by at least 50%. With the location of Wal-Mart in Sonora, every local business that sells gifts, drugs, prescriptions, groceries, hardware, clothing, material, linens, or toys will suffer -- and suffer a lot. Many will be forced out of business.

Wal-Mart is NOT locally owned. The money is deposited in a local bank, but then the very next day every dollar is sent to another location. NONE of the money they take in goes back into the local economy. When people from Sonora's trade with Sonora-owned stores, the money eventually goes back into Sonora's economy.

Wal-Mart also reduces many of their employees' hours so they are considered "part-time" and are therefore ineligible to receive pension and insurance benefits.

Please consider the advice of someone who loves and cares about Sonora and the people who live there: Don't make the mistake of supporting a wonderful discount chain, but at the same time crippling your local economy.

## Fairs and such affairs

I just come back from Storyfest #3 at George West, Texas, where I went for the third year in a row to tell my chuckwagon stories. I met lots of good folks, both storytellers and story likers, and it was a real fun day, both settin' and listenin' and also bein' able to get up and talk awhile. One of the most interestin' groups I met was a bunch of black cowhands from South Texas whose families had been workin' cattle for four generations in that part of the world. They was really fascinatin', since their experiences in South Texas are lots different from mine in West Texas. From now on, anytime I get to thinkin' the mesquite and cedar's thick around here, I'll just recall some of the tales they told of real brush country and thank my lucky stars I live where I can pretty much see where I'm headed most of the time.

Besides the stories and music, I reckon the thing I like best about Storyfest is that they have a whole passel of food booths, and I get to spend the day samplin' the wares. There was chili (which wasn't real spicy and made with hamburger, so I didn't eat but one bowl), taquitos, rice and beans, turkey legs, sausage, and lots of sweet stuff I didn't bother with, preferrin' to fill up on real food. But they did have one kinda sweet item that I really like and am beginnin' to see more and more, and that's funnel cakes. The main problem I find with people fixin' funnel cakes at fairs and such is that they really don't have the right kind of cookin' gear to keep up with the demand, so lines to get 'em are pretty long. But they're really worth the wait if they're done right.

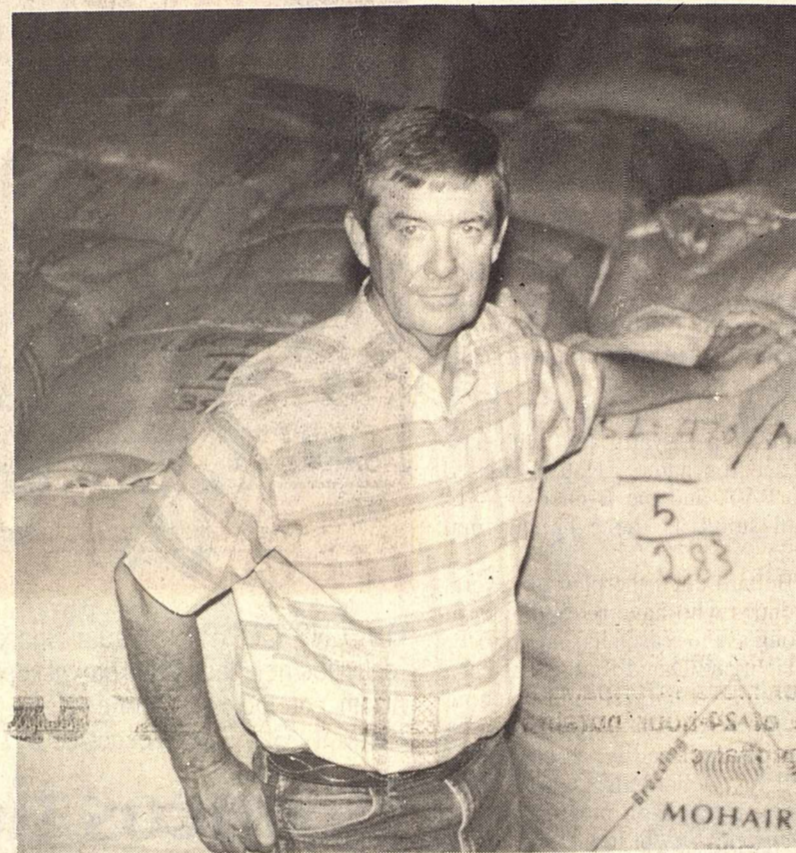
You can fix 'em at home, but if you're one o' them types that can't stand to get kind of messy, well funnel cakes probably aren't for you. On the other hand (probably on both hands), if you really like to get a feel for what you're cookin' and enjoy makin' real creative patterns and such, you'll probably get a real kick out of tryin this reacet.

### FUNNEL CAKES

In a large mixin' bowl, stir together: 2-1/2 cups self-risin' flour, 1/4 cup sugar, 1-1/2 cups milk, 2 beaten eggs. Heat up a dutch oven or deep skillet. Pour in about 1 to 1-1/2 inches cookin' oil, wash all the gas and oil off your funnel, hold your finger over the end (that's the small end, silly) and pour in about 1/2 cup of batter. Hold the funnel over the hot oil, bein' real careful not to stick your finger in it, and let the batter pour out, makin circular and do-dad patterns with the batter. When the edges begin to turn brown, turn the cake over and fry til golden brown. Drain on paper towels, sprinkle on powdered sugar, and eat while it's hot. Be sure to make the cakes a couple of inches smaller than the skillet so's you'll have room to turn 'em over. Also, it helps to have a fork and a spatula when turnin', so's the cakes won't splash hot grease all over the place. This reacet'll make probably 6 or 8 cakes, so adjust the reacet to be sure you have plenty.

Funnel cakes are pretty much like doughnuts, and they sure go over big on cold evenin's like we've been havin', so why not get the stuff together and whip up a batch for dessert tonight. Shoot, before you know it, you might decided to start followin the fairs and craft shows as a professional funnel cake cake maker. Or at least you can whip 'em up for your family ever now and then. Ya'll keep on cookin'.

## Pooling their product--mohair marketing of a new variety

On April 30, the first-ever mohair auction in the United States took place in a hotel in San Angelo.

The same day, world mohair prices jumped 20 center per pound.

A coincidence? Not according to members of the U. S. Mohair Marketing Board, which organized the sale. While the setting was low-key, the event marked the first time the dozen or so mohair processors in the world openly competed against each other.

Until 1990, producers had little choice but to deal one-on-one with buyers from England, Europe and South Africa. Because the U. S. Wool Act requires mohair to be sold by December 31 to qualify for federal deficiency payment, buyer and seller would wait each other out until nearly year-end, each wanting a better price. Then, like clockwork, prices would rise again in January.

But the start-up last year of the mohair marketing board--patterned after Plains Cotton Cooperative--gave producers an alternative. Besides organizing special sales like the April auction, the board offered to purchase mohair at a guaranteed price. Participants in the pool received an initial advance payment of 50 cents per pound upon delivery, a mid-season payment and a final payment when the mohair was sold.

The result? The 300 or so participants in the pool realized an average of \$1.10 per pound on 2 million pounds, while the national average for mohair was approximately 94 cents. "Without our program the average probably would have been about 80 cents," says Fred Campbell of Eden, who operates South Western Wool and Mohair, one of eight warehouses that handle mohair for the pool.

"We were able to stop a 'fire sale' at the end of the year," adds Gary Leonard of Del Rio, vice-chairman of the board.

One major reason for this was the board's decision to sell adult mohair

for no less than 70 cents per pound, based on mid-autumn mohair prices, according to Campbell. By late January, when mohair was scarce, buyers were willing to increase their prices.

However, it is not the marketing board's intention to continue buying and selling mohair year after year. Rather, the cooperative American Wool and Mohair Association established the mohair board in the winter of 1989-90 with two stated purposes--to stabilize U. S. mohair prices and to encourage producers to improve the preparation and quality of their products.

"Right now," Leonard notes, "a lot of producers just throw all their mohair in one bag without sorting or grading it first. Buyers will pay a higher price if they're getting a uniform product."

"I think the pool definitely kept the price from going down in December and caused it to come back up more quickly in January," says Glen Fisher of Sonora, who is sales manager for the mohair board. After producers see how cooperative marketing can reduce their vulnerability in the very volatile mohair marketplace, more goat raisers will join the pool, he believes.

During the past year, the marketing pool handled approximately 20 percent of the mohair produced in Texas and 12.5 percent of all U. S. mohair.

With world mohair production down and prices on their way up again, the board wants to establish regular auctions, like the one held in April. One special mohair sale was held September 10 and others may be held this fall, depending on the market conditions, in San Angelo.

"Marketing mohair through a pool at an auction sale is giving everybody a chance to buy, and fostering competition is a good thing," says Campbell. "The sales also will save buyers a lot in buying expense."

## Lopez completes recruit training

Marine Pvt. Ramiro Luna Lopez, son of Santiago and Julia Luna of Sonora, recently completed recruit training.

During the training cycle at Marine Corps Recruit Depot, San Diego, recruits are taught the basics of battlefield survival, introduced to typical military daily routine, and personal and professional standards.

All recruits participate in an active physical conditioning program and gain proficiency in a variety of military skills including first aid, rifle marksmanship and close-order drill. Teamwork and self-discipline are emphasized throughout the cycle.

The 1991 graduate of Sonora High School joined the Marine Corps in June 1991.

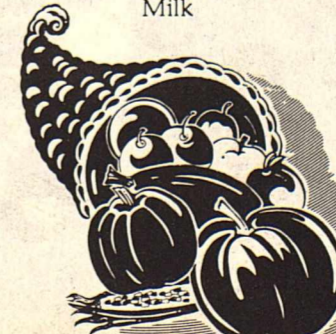

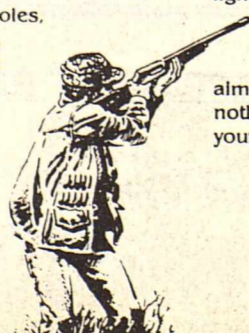
Hunting season is a much anticipated time for many Texans — but often a dreaded time for electric co-op linemen.

And the danger doesn't stop there. Loss of service to a home with life-support equipment can quickly create a life-threatening situation. An outage can also affect traffic signals and security lighting.

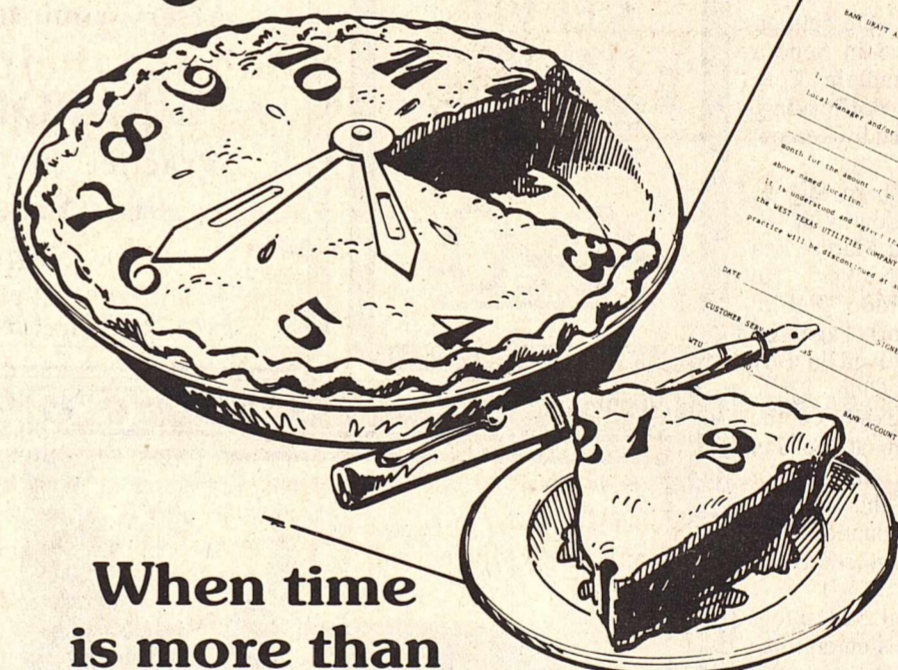

**Retiring next year? Find out about social security now**

If you're thinking about signing up for Social Security sometime in 1992, you should get in touch with Social Security now about your plans. You and your family may be due benefits for months you are still working. But, to get those benefits, you must file your application early.

It may be to your advantage to have your Social Security benefits start in January, even if you don't

plan to retire until later in the year. Under current rules that affect how much a beneficiary can earn, called the Social Security "retirement test" many people can receive more benefits with an application that is effective in January.

A 1990 legislative change that eliminated retroactivity in most retirement claims has increased the importance of contacting Social Security before retiring. The rules

are complicated, so the Social Security Administration urges prospective retirees to find out in advance if choosing to start their benefits in January would be advantageous.

Retirement claims that go into effect in January can be filed any time from October 1 through January 31. To file an application for retirement benefits, call Social Security at 949-4608.

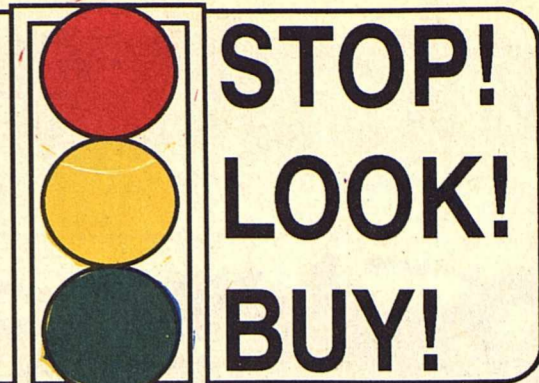

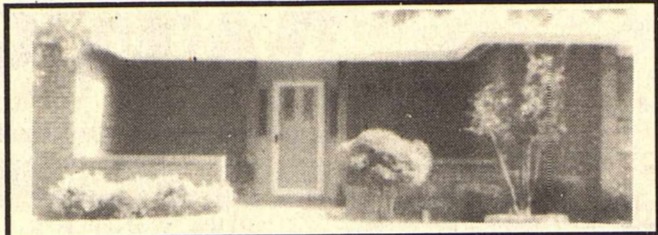
