

## Focus on Education Site based decision making

was passed requiring "site based decision making." This section of the law is an extension of the move toward decentralization that was begun in Senate Bill 1. Site based decision making is a process for decentralizing decisions to improve the educational outcomes at every school campus through a collaborative effort. Principals, teachers, parents, and community representatives assess educational outcomes of all students, determine goals and strategies, and ensure that strategies are implemented and adjusted to improve student. achievement.

The message to local school districts dictated by legislation is that decision making will be decentralized. The characteristics implied by the definition are as follows:


1. A simple concept of moving the decision as close to the recipient as possible.

2. A campus committee that reaches agreement through consensus.

3. Those who make decisions help implement the decisions.

4. There is a substantive change in the traditional structure of authority.

To date, the Sonora ISD Board of Trustees has approved a policy creating a District Committee ("Breakfast Club") composed of two teachers from each building. The



Also, a policy has been approved that creates a committee at each of the campuses. These Campus Committees are composed of teachers, parents, community members, and the principal. The primary purpose of the Campus Committee is to establish performance objectives for each academic excellence indicator (attendance, TAAS Test, dropout rate, etc.).

The next step in the site based decision making process for our school is the creation of the District Based Decision Making Plan which will be utilized to assist the district in decentralizing decision in five specific areas of concern: goal setting, curriculum, budgeting, staffing patterns, and school organization. Five members of the 'Breakfast Club" together with a parent representative from each of the campuses, 2 community members, and a high school student will work toward the development of the Site Based Decision Making Plan that must be submitted before September 1 to the Texas Eduction Agency.

The celebration was given to them by their children Trudy Schreiber and Gary and Cheri Jones of Houston.



The Colt 45's hosted Paint Rock Sunday in a double header.





The City of Sonora will undertake the project described above with Community Development funds from the Texas Department of Housing and Community Affairs under Title I of the Housing and Community Development Act of 1974. The City of Sonora is certifying to TDHCA that the City of Sonora and Lemuel Lopez, in his official capacity as Mayor, consent to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to environmental assessments, decision making and action; and that these responsibilities have been satisfied.
