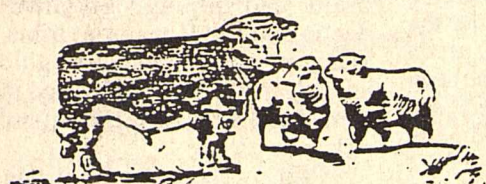

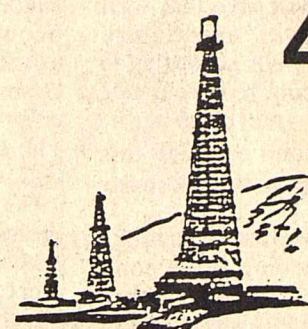

## State Champs

The high school One-Act Play, "The Marriage of Bette and Boo", came home with the state championship Friday. The play was under the direction of Paula "Miss" Rodriguez.

During the Competition, the cast faced some technical difficulties and gracefully recovered to perform, what is thought by the cast, to be their best performance yet.

"The audience participated and laughed and cried, we loved it," said sophomore Casey Thorp.

Eighteen total individual awards were given; of which Sonora received three of eight honorable mention all-star cast. They went to Roy Ivy, Matt Hazelton and Matthew Hunt.

Sonora also received one of eight All-Star cast awards. That award went to Michele Pruitt.

Ms. Rodriguez, her second year as a teacher, broke a 20 year streak, winning for the first time since 1973. "It's like a dream come true," said Rodriguez.

As an actress in high school she watched the directors she admired and look forward to the day it would be her on that stage, she said.

"I didn't feel intimidated, but realized we can hold our own," Ms. Rodriguez stated, "I feel proud to be the best."

When Ms. Rodriguez committed to "The Marriage of Bette and Boo" she expected a negative reaction.

Said Rodriguez, "I was delightfully surprised at the support of the community."

All people have their own opinion, she said. "Sometimes people go to a movie to cry. That's the kind of play we performed."

She said she felt skeptical about doing a play so challenging and demanding with such a young cast, but after the first level of competition she knew it was worthy of the state level.

"I felt very, very small receiving the first play trophy."

And about next year... "more of the same. More shows and more representation at state."

Ms. Rodriguez had a great tradition of success to fill in this department and in her first two years she has earned a third and first place at state, "It was the icing on the cake," said Rodriguez.

## Mayor Proclaims Police Week

The week of May 9 - 15 has been proclaimed as "Police Week" in Sonora by Mayor Lemuel Lopez. Mayor Lopez formally issued the proclamation at City Hall last Friday.

The Proclamation also calls upon all citizens to observe Friday, May 14 as "Police Officers Memorial Day" in honor of all peace officers, past and present, who have lost their lives or become disabled in the performance of their duty.

In signing the Proclamation,

Mayor Lopez noted the vital role law enforcement officers play in keeping Sonora a safe and secure community in which to live. He also recognized the spirit of cooperation that exists between all of the various police agencies that serve Sutton County.

"We want the officers of the Sonora Police Department, Sutton County Sheriff's Department, Texas Department of Public Safety, and all other law enforcement agencies to know that their loyalty and

dedication is not unnoticed," Lopez said. "I hope everyone will take the time to let them know how much they are appreciated in Sonora."

The date of registration of a non-exempt well will give that well precedence over any future registration of wells according to the rules (spacing requirements, number of wells/section, gals/min/section, etc.) of this District as they pertain to non-exempt wells.

## Spring '93 Fashion News

- Color -- Several themes influence color choices for Spring 1993. The sea with its ocean blue and greens, the natural colors of the ecology from desert sands to the greens of the rain forest, ethnic brights and the worn, weathered shades of the American West all play a part this season. From under the water come tones of coral, green and turquoise, which can be seen in sarong skirts, wrapped slip dresses or collarless cardigans worn over loose trousers.

- Sun-bleached colors like rose orchid and iris are important for dress country florals but also for stripes and checks. Whitened pastels can be combined or blended with other colors in silky fabrics, light wool blends

and linen. Dusty peach and natural are neutrals that can stand on their own, be paired with other natural tints or be used as a neutral with other colors.

The season's few darks are derived from ethnic themes. Black accents brights from colorful cultures. Blue and olive also become basic colors and are excellent when used for the new menswear looks with relaxed tailoring.

- Trims -- Look for trims associated with the western look-pearl snaps, rick rack, soutache braid and piping, gingham, denim and bandanna print trims. When it comes to metallic, gold and silver will be widely used in trims such as braids, piping and rick rack.

- Prints - Nature has a strong influence on prints for Spring. Shells, starfish, tropical designs, florals, garlands and bouquets are popular designs. Animal prints continue; look for reptile skins to emerge.

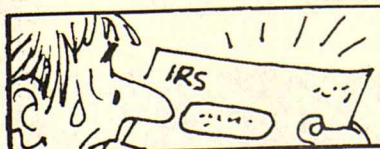

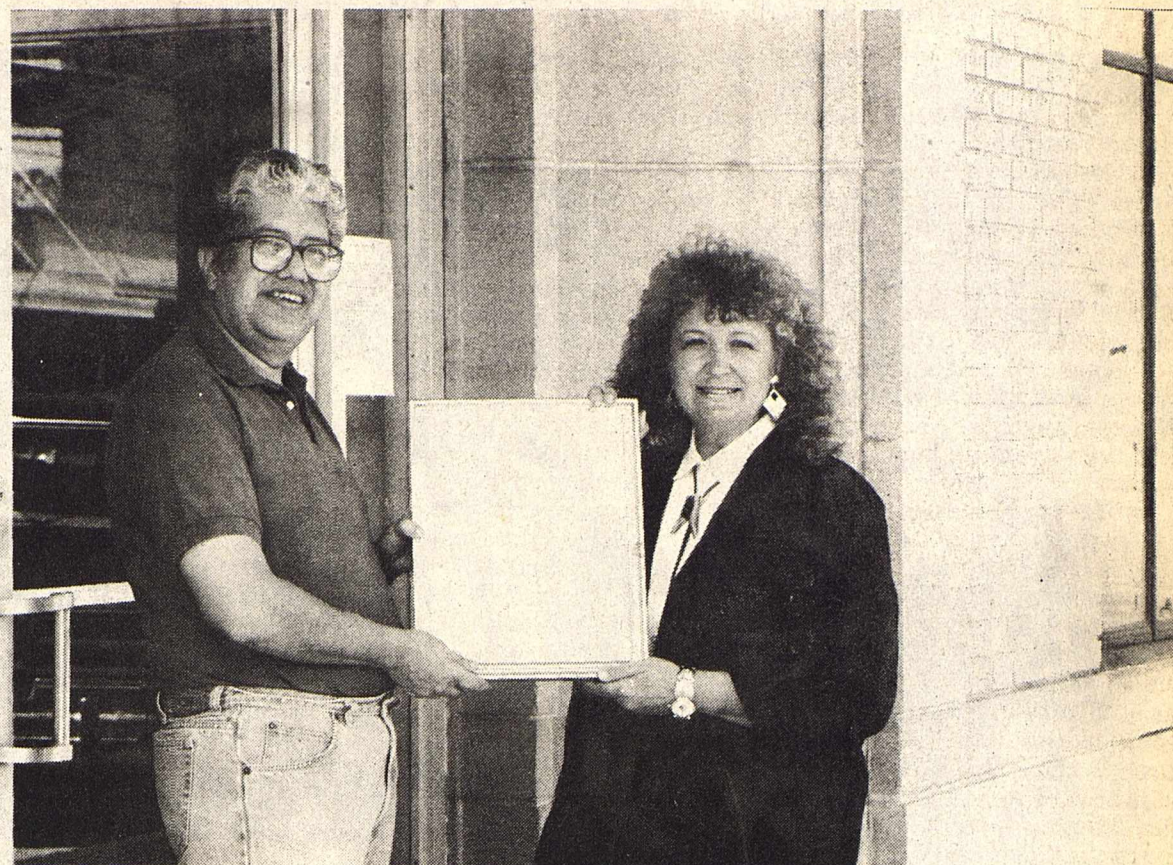

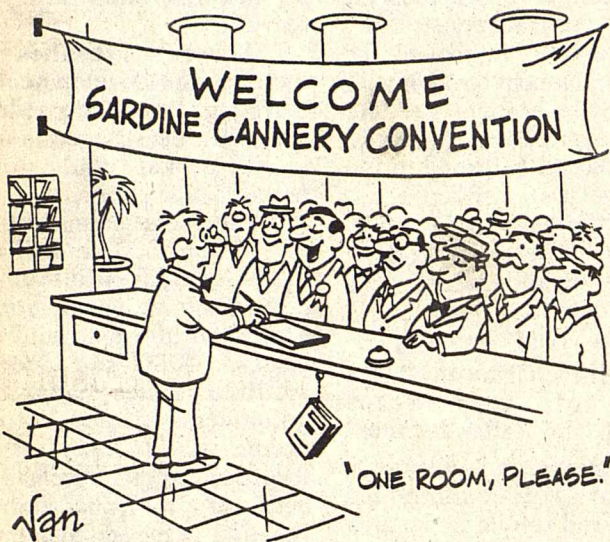

# WTU Changes Billing

To provide extra convenience and more account information to the people it serves, West Texas Utilities Company has improved the monthly bill it mails to customers.

Beginning May 14 the postcard-style bill customers have been receiving will change to a full-page, more detailed bill that will be mailed in an envelope. A return envelope will be enclosed for convenience when paying by mail.

The most obvious change in the bill will be its appearance. The letter-sized format will be noticeably larger, with a detachable bill portion at the top and a detailed statement below.

The top portion of the bill will be identified by WTU's logo and light blue color.

While the new bill is more attractive, its real purpose is to serve WTU customers more efficiently. The biggest change most customers will notice is how much more information the new bill provides about their accounts. "The new format has more space, so we can include additional information regarding each customer account," said Sonora, area manager, Robert Noriega. "You'll see exactly how your bill is calculated with meter reading usage, fuel, and other factors."

Now customers will see a detailed breakdown of their energy usage and rates, as well as how much they owe. The bill will also show more detailed information on other matters such as merchandise accounts.

WTU also is taking this opportunity to provide extra convenience to customers. In the past, customers have

expressed a strong wish for a return envelope to be provided with their bills. Now that bills will be mailed in envelopes, WTU will be able to provide this requested service.

The return envelope will have a window. The top portion of the bill you return to WTU, when placed correctly in the envelope, will position the address of your local WTU office in the window.

The full-page format fared well in selected customer testing early this year. WTU randomly chose 100 accounts company-wide to receive the new bill. Afterwards, each of the 100 customers was called personally and asked for reactions. Some of the features customers especially liked included:

- the new bill is easier to read;
- having the return envelope provided for them;
- the privacy of their account information going through the mail in a sealed envelope; and
- having more detailed information about their accounts.

The only change customers should notice is more information and added convenience. There won't be an increase in customers' bills to pay for the new features.

Although the return envelope is provided for customer convenience, those who prefer to pay their bill in person at their WTU local office may continue to do so. Your favorite WTU office personnel can still take your payment in person.

Any customer with a question or comment about the envelope billing may call his or her WTU area office for more information.

A fiddler's contest, washer pitching and an antique, hot rod and unusual car show will also be held during the festivities.

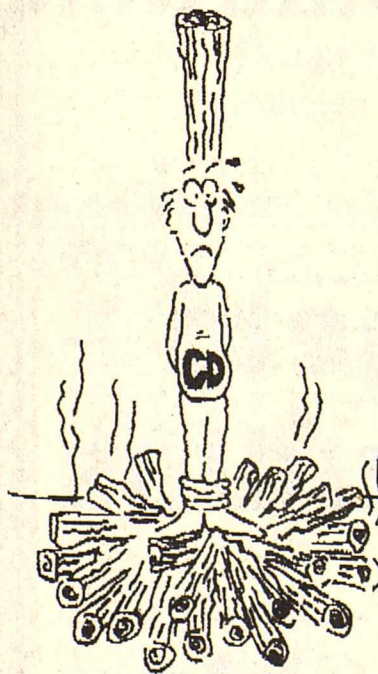

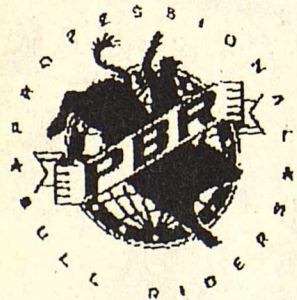

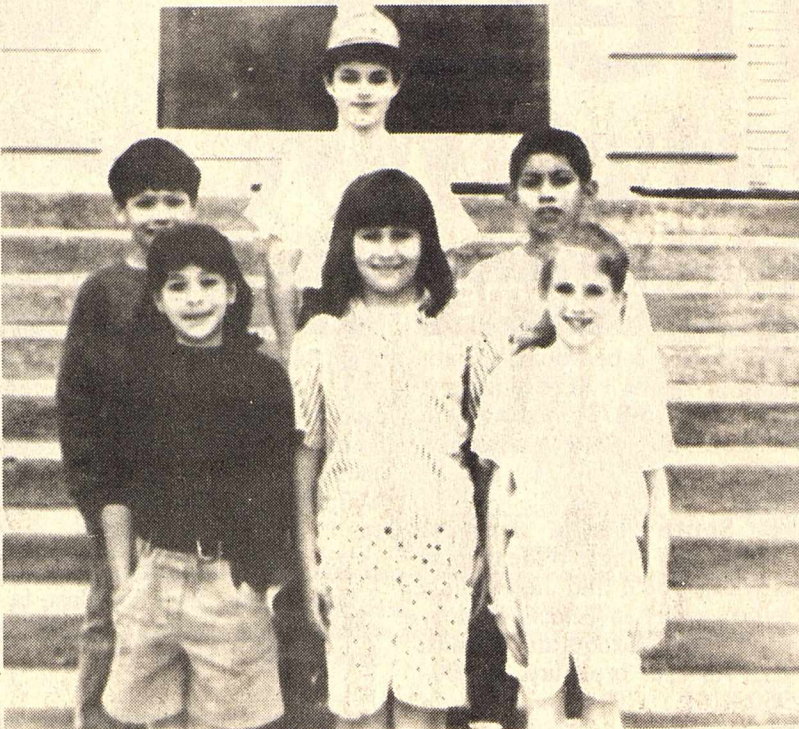
If you've lost or misplaced your card, contact Social Security for a

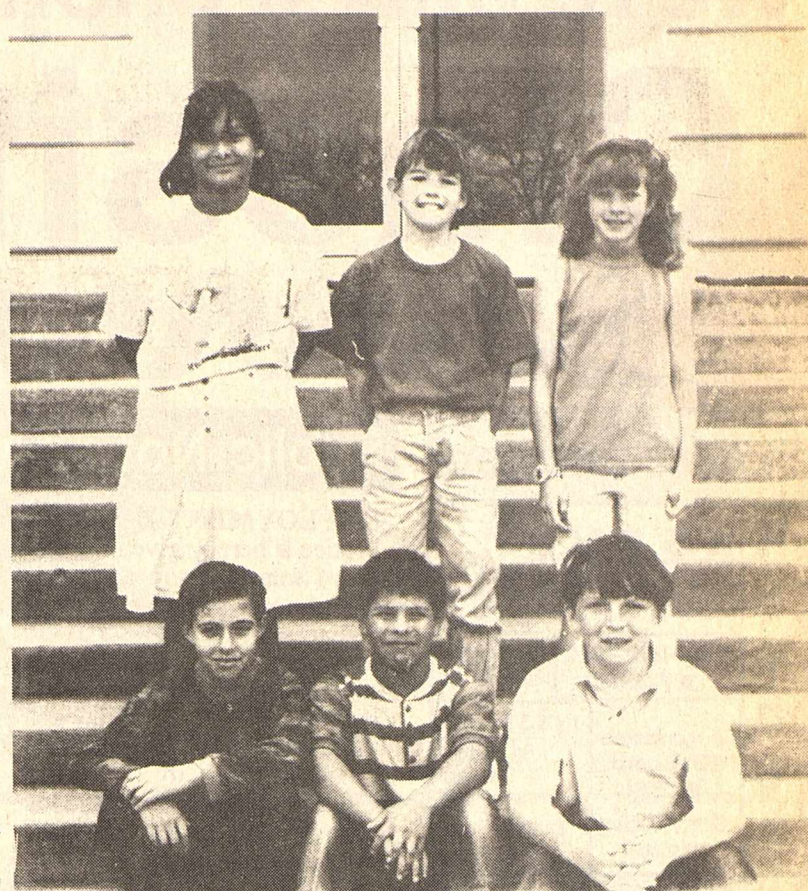
"Remember," stresses Upp, "your Social Security benefits will be based on the earnings posted to your Social Security record, so be sure you use the proper number."

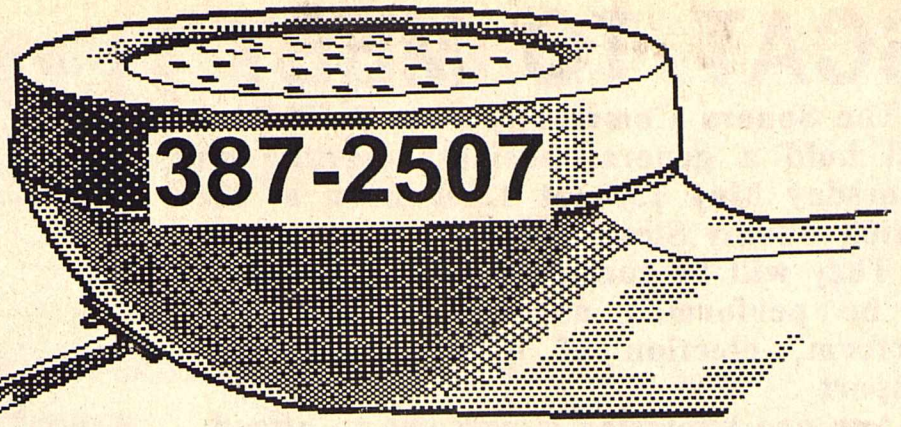
