### Fumigating to begin soon

## City adopts safer mosquito control program

During the month of May, the City of Sonora is inaugurating an improved mosquito control program throughout the community. The upgraded program should be safer, more effective, and provide greater coverage than ever before, according to Sonora City Manager John Pape.

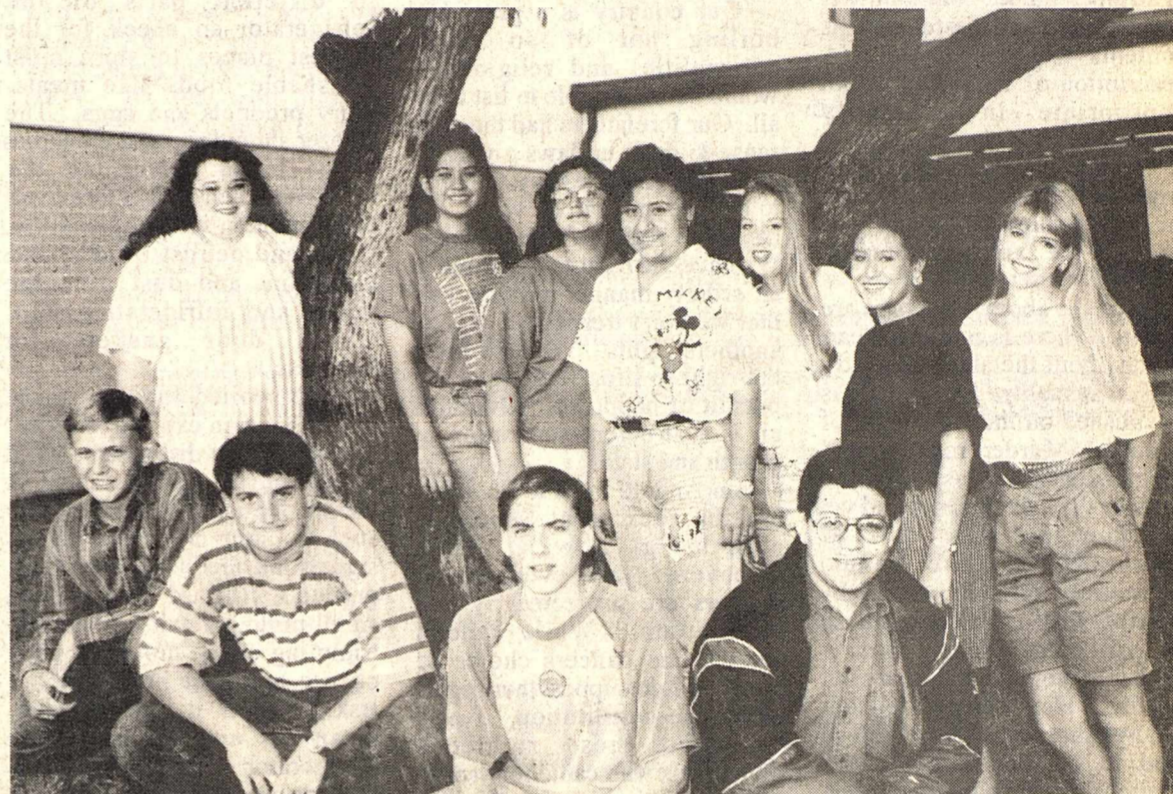
An ultra-low-volume (ULV) fogging unit has been purchased by the city, which will dispense the mosquito control agent in a very fine mist, Pape explained.

This mist will cover a larger area and will be more effective against the mosquitos. Additionally, draws and other potential breeding areas will be treated with larvicide to further reduce the mosquito population.

Pape also noted that mosquito control duties have been transferred from the fire department to the city's Department of Public Works. This will relieve the fire department of the additional workload at a time of year when

grass and brush fires tend to increase.

City employees received training in the new equipment last week, and have begun using the new system in the draws throughout the city. Once application in the draws has been completed, the crew will begin working residential areas. As in the past, any person who does not wish to have the area around their residence treated can contact Sonora City Hall during regular business hours.

## City Manager speaks in Winters

In an effort to stimulate their local economy, the City of Winters recently invited Sonora

City Manager John Pape to speak to citizens and local officials about Sonora's economic development strategy. Pape delivered his remarks during a noon luncheon meeting of the Winters Lions Club and the Winters Area Business and Industrial Corporation (WABIC).

In addressing the group, Pape explained that economic development is not merely an issue of growth, it is an issue of community survival. He also outlined the approach Sonora has taken to stabilize and expand the local economy, and encouraged the Winters officials to adopt reasonable goals and a realistic time-frame.

"You cannot reasonably expect to turn a community's economy

around in six months," Pape noted. "Change of this kind is a complex and delicate process, and your progress should be measured in years, not in weeks or months."

Sonora's economic development plan and "seven-step" strategy has been adopted by the City of Winters and the WABIC, and the community is currently in the process of implementing the plan.

## Two arrested for theft

Sheriff Bill Webster stated two local residents have been arrested for the burglary of eight storage units at Shurley Enterprises just South of Sonora.

Sheriff Webster stated the two Sonora residents, age 18 and 20 years of age, were arrested early Tuesday morning as they were seen leaving the storage units. Sutton County Deputy Sheriffs Ed Duncan and Tom Carter stopped the two suspects and found a quantity of items taken from the storage units.

Both subjects were placed in the Sutton County Jail and charged with burglary of a building. During the investigation, another burglary was cleared when one of the suspects admitted to breaking into the Rye Supply Company building which was reported to the Sheriffs' Office on May 8, 1993.

Both suspects were released from jail on \$10,000 bond.

You can not imagine my distress at having our sense of security destroyed recently when I discovered a poster with the men in various states of undress and in poses that can only be described as lewd placed in a public place (without the permission of the owner this poster was placed on a public bulletin board). ## Kelly's Column



### Spring cleaning... Don't forget the kitchen

When it's time for spring cleaning, an important room to keep in mind the kitchen where food is stored, prepared and eaten.

The kitchen needs to be kept clean and food must be stored safely. Start by checking the refrigerator and freezer to make sure safe temperatures are maintained for storing perishable foods. An appliance thermometer can be used. The refrigerator temperature needs to be between 34 degrees and 40 degrees Fahrenheit. The temperature will vary somewhat in different parts of the refrigerator so check for the coldest places to store most perishable foods like meats, dairy products and eggs. The freezer should register 0 degrees F. or lower. Keeping the refrigerator and freezer clean will help maintain safe temperatures. Clean and defrost insides, and clean lint and dust from the motor and refrigerating unit. Check door gaskets for tightness.

Any spoiled foods or those which have an expired "use-by" date should be discarded. Mold on any meats, soft or semi-soft cheese, fermented dairy products such as sour cream or yogurt signals the need to discard these products. If hard cheese has a small mold growth, substantial trimming of the mold from the cheese may not be worth the risk. Throw it away. Also, clean up any spills in the refrigerator. These encourage bacteria growth.

Check freezer foods. While frozen food stays safe for extended periods, the texture and flavor will suffer. Rotate frozen foods and, in general, use within six months to year. Date all items so rotation will be easier. Packages with frost inside or with freezer burn will probably show loss of quality.

Check the cabinets and pantry.

Ideally, foods should be stored in the coolest cabinets in the kitchen. Heat speeds up deterioration of foods.

Avoid storing foods near sources of heat such as the range, oven, dishwasher or hot water heater. Also, don't store foods under the kitchen sink where water and pipe connections encourage pest and rodent entry.

Check pantry items such as flour, spices, cereals and grains for signs of insect infestation. If you see little black bugs, throw the infested products away. Clean the storage area and sanitize. Store these types of goods in air-tight containers. Moldy breads should also be discarded and not eaten.

Check cans and jars for rust, dents, cracks, leaks or bulges. Don't taste any suspicious foods. Throw them away. Again check "use-by" dates. Set up a system of "first-in", "first-out" to ensure the use of oldest foods first. Generally, it's best to use canned goods within one year, especially home-canned items. Check for signs of pests or rodents and take proper measures of control.

Check appliances for cleanliness and proper operation. Now may be the time to replace those appliance parts or repair those you have been putting off. Cleanliness for appliances such as can openers, processors, slicers, blenders, etc. is important to help prevent cross-contamination of foods with disease-causing bacteria. Be sure you have a good supply of clean dish rags and sponges. These items harbor bacteria very well.

Spring may be a good time to do a thorough kitchen search and cleaning, but habits established on a regular basis to keep foods and the kitchen safe are one good way to maintain food quality and safety, and get the most from the food dollar.

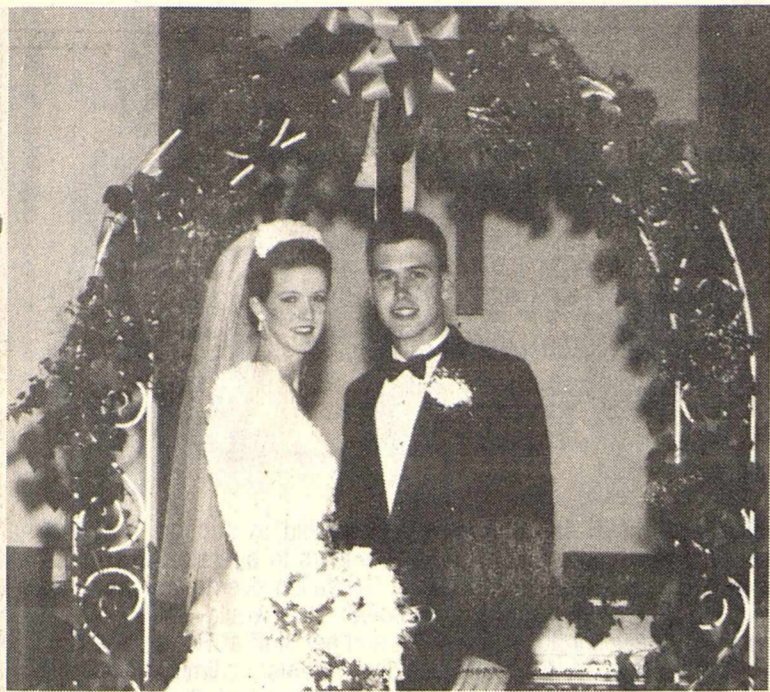

## Ask the Historical Society

Can you tell me where the Wall-Mittel School was located?

For the answer to this question we turn to the following article found in the Devil's River News of May 25, 1918:

The South Divide ranch people sold ice cream and cake for the benefit of the Red Cross at the Wall-Mittel School house 20 miles south of Sonora, Saturday night. Among the ladies to whom the success of the affair was due were Mrs. Wall, Mrs. Mittel, Mrs. Luckie, Mrs. Heflin, Mrs. Steen, Mrs. James Holland, Mrs. Henry Wilson, Mrs. McKee, Mrs. Arthur Stuart and Mrs. Bond. The Sonora Ice Company donated 300 pounds of ice. There was a large attendance from the neighboring ranches and a big crowd attended from town. The young people had a most enjoyable time with games and dancing. The night was ideal and the distance not far for motorists. The proceeds amounted to about \$85 besides several donations to the war fund. The cakes were made of other than wheat flour and were delicious.

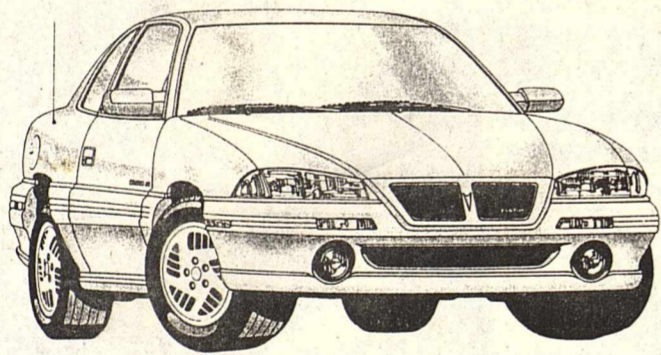

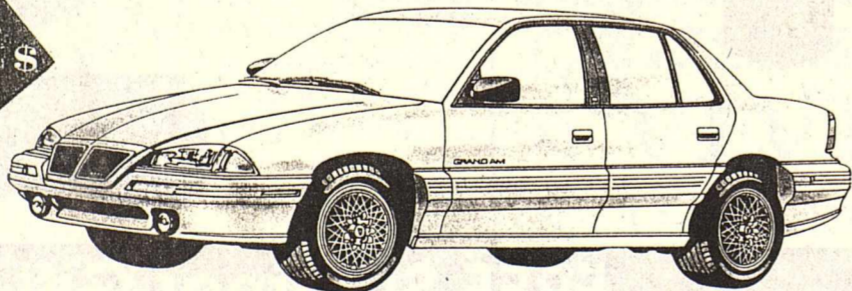

Congratulations to Jody Luttrell, and Eddie McReynolds for passing their state EMT exam in order to re-certify their licenses. Pat Campbell is to be congratulated for passing his instructors certification.

The new Type III ambulance, which was ordered in April, arrived last Friday. The entire EMS crew has been excitedly awaiting this day! The Type III is a modular unit with a walk-thru to the cab. It is larger inside, thus accommodating more equipment, as well as complying with new regulations by the state. It was quite an undertaking by several of the crew members to stock it with all the needed medical supplies, oxygen bottles, backboards, radios, etc. It's one Sonora can be proud of.

Some people have wondered why we need a third ambulance. Many times during the course of the year we've responded to wrecks in which there were multiple casualties, especially during icy conditions when we've had as many as three or more wrecks at nearly the same time. Our doctors and medical staff are very conscientious about trying to stagger the needed transfers, but head injuries, spinal injuries, internal injuries, as well as a number of other life threatening injuries simply won't wait for a transfer to a trauma center and to specialists, thus leaving the city and county "bare." This third and new ambulance should alleviate that problem.

On Friday, May 14th Lenora Pool gave a seminar to the entire 5th grade on inhalants. On numerous occasions Lenora and others have given talks, etc to different classes on health and drugs.

Did you know that in 23 states, including Texas, a woman's request not to be kept on life-support is invalidated if she's pregnant, no matter the stage of her pregnancy.

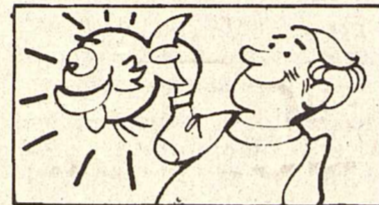

Inclusion on the list indicates the student earned a grade point average of at least 3.5--an 85 average--while taking between 8 and 14 hours of college credit.



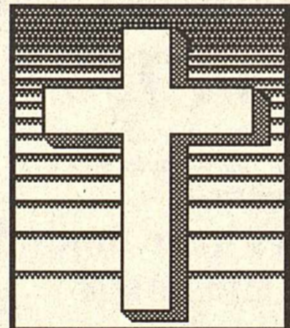

# School Board Minutes...

The Board of Trustees of the Sonora Independent School District met in regular session on Wednesday, May 12, 1993 at 6:00 p. m. in the Board Room of the Administration Building at 807 South Concho, Sonora, Texas.

Present: Michael Smith, President, Michelle Anderson, Jesse Bustamante, Gary Hardgrave, Sam David Hernandez, Gloria Lopez, Donald Patton and Charles Russell, Superintendent.

The meeting was called to order by President Michael Smith and the invocation was given by Superintendent Charles Russell.

No. 3, Oath of Office: Pursuant to Article XVI, Section I of the Constitution of the State of Texas, the elected board members—Michelle Anderson, At Large; Jesse Bustamante, Precinct 1; and Gary Hardgrave, Precinct 3—were administered the formal Oath of Office by Cynthia Keel, Notary Public.

No. 5, Approval of Minutes - President Smith announced that the reorganization of the board would be moved to the last item of the agenda before the executive session and that new officers would take their places at that time.

The minutes of April 13, April 29, and May 3, 1993 were unanimously approved as written after a motion by Donald Patton and a second by Sam David Hernandez.

No. 6, Comments from Visitors - President Michael Smith welcomed visitors to the meeting and commented that he would call first on Bob Brockman, who had requested time to speak to the Board. Mr.

Brockman, stated that, during the course of his campaign for school trustee, he had visited with many taxpayers who shared their concerns about what they felt was a lack of communication between the Board and them. He continued by stating that the Board was headed down a one way street to a lawsuit if they continued to be close minded and allowed administrators to make derogatory remarks to taxpayers.

Third grade teacher Melissa Carroll was recognized and spoke on behalf of eight teachers who had attended a recent conference. She commented that the meeting had been very beneficial and thanked the Board for allowing them to attend.

Third grade teacher Jane Lynch was recognized and said she was representing Intermediate School teachers. She commented that the administrators often do not receive the praise they deserve and proceeded to read a letter in support of Intermediate Principal Donna Hill. After reading the names of the signees, Mrs. Lynch invited the Board to visit Intermediate classes at any time. Dick Davis, an attorney from San Angelo, advised Mrs. Lynch to request that the letter be placed in Mrs. Hill's personnel folder and the Board so agreed.

Trustee Michelle Anderson commented that, as the newest board member, she had been reading and studying a great deal. She further stated that it was obvious from the large gathering of visitors that there were concerned citizens. She pointed out certain items in the Board Member Ethics Policy which she felt were important for all trustees to keep in mind, including encouraging free expression of opinion, communicating to other trustees and the Superintendent public reaction to school policies and programs, insuring that the Board remains responsive to the community, and remembering that the greatest concern should be the educational welfare of the students.

President Michael Smith commented that the Board definitely believed in following the chain of command in keeping communication open and working together with the community for continued improvement in the school district.

Trustee Sam David Hernandez stated that he had not been aware that citizens could not come to him with concerns and that no one had contacted him. Mr. Brockman replied that many people were afraid to do so because of repercussions.

P. E. instructor Martha Martin commented that Mrs. Hill had always been supportive of her

and had worked with her during the numerous times she needed to be away for athletic contests. Rande Fawcett questioned what the problem was concerning Mrs. Hill and President Smith stated that it was improper to discuss personnel in open session--the main reason being for the protection of the individual--and further stated that all administrators had been issued two year contracts.

Third grade teacher Nancy Brockman informed the Board that they were welcome to visit Intermediate School at any time and stated that Mrs. Hill had supported her staff 100%.

Trustee Gloria Lopez told the gathering that she was unaware of any communication problems, that no one had contacted her, that she was always available to hear their concerns, and that the lines of communication were always open.

Rande Fawcett and Sam Dillard both requested that an executive session be called at which concerned citizens could be present to discuss personnel problems. Once again, Mr. Smith stated that an executive session was for the protection of the individual, not in order to hide anything. He assured them that he would find out the legalities of having an executive session which the public could attend and would get back to them.

Third grade teacher Louise Dermody stated that Mrs. Hill had dedicated her life to helping children and had worked as both a teacher and an administrator to benefit the best interests of the children.

Dick Davis commented that he believed the Board was composed of a fine group of citizens who would not tolerate reprisals. He expressed his belief that there might be some administrative problems but that he was sure no reprisals would be permitted.

Superintendent Charles Russell asked Jane Lynch if she felt she would be reprimanded for reading a letter in support of Mrs. Hill and Mrs. Lynch commented in the negative.

Ramiro Perez asked if the Board always reconvened in open session after an executive session and the Board President informed him that it was illegal to take any action in closed session and the Board always reconvened in open session.

Joe David Ross stated that the visitors should remember that an executive session was necessary for the operation of any board and that they needed that time to feel free to discuss various matters and to iron out any problems. He continued by stating that opening up and executive session to the public would jeopardize its purpose and hurt the effectiveness of any board.

Some concern was expressed that the reconvening was not an agenda item. Once again, President Smith stated that the Board always reconvened in open session before taking any action and, if the reconvening needed to be an agenda item, measures would be taken to correct the problem. He remarked that nothing in the way of reprisals or hiding something had ever happened in his four years as a board member.

Special education teacher Virginia Kepler read comments expressing her appreciation to Mrs. Hill for both her consultative behavior and her support.

Monte Dillard commented that if there were problems, the citizens of Sonora had a right to know. He further stated that the gathering represented only a small portion of the citizens who were concerned that someone so highly thought of in the community was having career problems.

No. 7, Tax Assessor/Collector - there being no further comments, Mr. Smith moved to item 7 on the agenda. Chief Appraiser Rex Ann Friess reported that collections stood at 97.8% for the district and 98% for the CED, both approximately 1/2% down from the same time in 1992.

No. 8, Superintendent's Report - Superintendent Charles Russell gave brief reports over both the recent District Committee meeting and school finance. He stated that Mrs. Carol Pope had resigned that day--too late for the Board to accept her resignation until the next meeting--but he requested permission to begin advertising for a replacement. Permission was granted.

The Board appointed Michael Smith as their representative to distribute diplomas at graduation with the exception of one graduate of whom Jesse Bustamante will present the diploma.

The Superintendent continued by providing information about the Latch Key Program which the district hopes to implement for the 1993-94 school year. The program addresses At-Risk and low achieving students.

Mr. Russell continued his remarks by stating that Sonora Primary School had been named a Mentor School, the only elementary school to be honored in Region XV and 1 of only 33 in the state. He further stated that Sonora had the distinction of having 2 mentor schools, Junior High having achieved the same status in 1992. The Superintendent commented that Special Programs Coordinator Lori Solis was to be commended not only for her assistance in helping write the mentor application but also for developing the Early Childhood Program which contributed to Sonora's achieving mentor status.

The Board gave verbal approval to 2 waivers developed by the Junior High School. One waiver absorbs computer literacy into all academic classes while the other waiver addresses offering Algebra I to all 8th graders. The Board instructed the Superintendent to proceed with the waivers and send them to TEA for approval.

Enrollment figures were listed as follows: High School 280, Junior High School 252, Intermediate School 233 and Primary School 255, for a total of 1020.

No. 9, Curriculum Report - Yearbook advisor Kirk Macon presented proposals from three photography studios for the

1993-1994 school picture contract and commented that he had visited with representatives from each studio. Both Whitt Studios and Olan Mills offered similar packets including a 40% payment to the school for fall pictures (paid the day of shooting), a 30% payment for spring shooting, and other various items. Photo Ranch offered a 20% payment to the school plus furnishing photographs for the newspaper and for football programs.

Michael Smith commented that the school district had used Photo Ranch for several years and asked if they had been timely in the payment of their discount. Mr. Macon replied no. Mr. Smith asked Mr. Macon for his recommendation and was told that Whitt Studio offered the best total package.

Trustee Sam David Hernandez stated that he understood the importance of buying local services but that the comparison of a 20% discount to a 40% discount paid the day of service plus all the extras made him lean toward Whitt Studios.

Gloria Lopez suggested that the Board accept Mr. Macon's recommendation. Gary Hardgrave made the motion, seconded by Sam David Hernandez, to approve Whitt Studios as the 1993-94 school picture supplier. The motion carried unanimously.

No. 10, Payment of Current Bills - Current bills in the amount of \$178,494.01 were unanimously approved for payment after a motion by Gloria Lopez and a second by Donald Patton.

No. 11, Request for Saxon Math Books - President Smith introduced Math Coordinator Claudia Dempsey and first grade teacher Susie Moore who gave a detailed presentation about the Saxon Math Program. The program introduces new concepts as it continues to reteach and, thus, builds on past success for future success. Mrs. Moore stated that she had used the concepts of the program this year and that her students were developing an amazing number concept and higher level thinking skills. Both ladies stated that the program was being used in other school districts and was enjoying great success. Mrs. Dempsey stated that K-5 teachers were unanimous agreement that the program would be extremely successful for their students.

The Board commented that they would take the matter under consideration and they thanked both ladies for their excellent, informative presentation.

No. 12, School Calendar, 1993-1994 - After a discussion of the school calendar, the Board unanimously voted to approve the staff selection of Calendar A. Motion was made by Donald Patton and seconded by Jesse Bustamante. The calendar is attached to and made an integral part of these minutes.

No. 13, Budget Amendments, 1992-1993 & No. 14, Budget Proposals, 1993-1994 -

Business Manager Diane Jacoby went over the details of budget amendments for 1992-1993. The Board directed the Superintendent to purchase a rebuilt copy machine for the High School and to use the existing machine as a trade in. The Board and Business Manager continued with a discussion, line by line, of the budget proposals for 1993-1994. President Smith reminded the Board that they would have several opportunities to discuss the proposed budget before its final adoption in August.

Unanimous approval was given to budget amendments for 1992-1993 after a motion by Jesse Bustamante and a second by Gloria Lopez.

No. 15, Approve Summer Work for 1993 - Board members decided to table the approval of the summer work list until their representatives could tour facilities with Director of Maintenance Smith Neal.

No. 16, School Board Training Report - President Michael Smith reported on the hours of certified board member training that each trustee had accumulated for 1992-1993. The hours are as follows: Jesse Bustamante, 19.75; Gary Hardgrave, 8; Sam David Hernandez, 19; Gloria Lopez, 20; Donald Patton, 6; and Michael Smith, 6.

Trustee Michelle Anderson questioned if the reading of the training hours was done at the correct time and if the 3 hours she had received two evenings earlier would count toward her orientation. She was assured that her hours would count and that the reading of hours was done at the May meeting, as always.

Sam David Hernandez stated that he had received 3 more hours in March and that, if the administrative secretary did not have the information in his file, he would deliver documentation to her, thus raising his total hours to 22.

No. 17, TASB Convention--Appointment of Official Delegate - Michelle Anderson was unanimously appointed as the Board's official delegate to the TASB Convention. Motion was made by Gary Hardgrave and seconded by Sam David Hernandez. Other board members who wish to attend the convention were instructed to notify the administration office by Friday, May 14.

No. 18, Consideration of Audit Firm for 1993-1994: Ecker, Ingram, Tinkler, Oliphant, and Featherston were unanimously approved as the district's audit firm for 1993-1994. Motion was made by Donald Patton and seconded by Gary Hardgrave.

No. 19, Approve Region XV Service Center Media Agreement - The Board unanimously approved the Media Services Agreement for 1993-1994 with the Education Service Center, Region XV after a motion by Gary Hardgrave and a second by Gloria Lopez. The cost will be \$2.50 per ADA.

No. 20, Approval of Bus Routes, 1993-1994 - Bus routes for 1993-1994 were unanimously approved as presented after a motion by Sam David Hernandez and a second by Jesse Bustamante.

No. 21, Board Member Comments - Dorothy Cramer and Chandra Hughes were recognized by President Michael Smith. Each stated that they were parents of Intermediate children and also represented a

group of concerned parents who support the Board and Superintendent 100%. They stated that they had gone to the Superintendent when they felt all other avenues of communication were closed and that the Superintendent had listened to them and tried to resolve the problems they felt they and their children were experiencing with Intermediate School.

Michelle Anderson stated that communication problems were not confined to Intermediate School, that they existed on other campuses also, and that parents often feel frustrated.

Mrs. Cramer stated that she was disappointed in what the Superintendent was going through, since parents went to him because he was available to them and would listen. She continued by asking the Board if they had seen the results of the Intermediate School parent survey and they responded they had not.

Michelle Anderson stated that, in an effort to be informed, she had visited with all persons concerned--the Principal, the Superintendent, teachers, and parents because there were a lot of concerned citizens. She further stated that as far as she knew, she was the only trustee who had done so.

Other board members restated their belief that their lines of communication were always open and that they were always available to hear concerns. Board President Michael Smith concluded the comments by stating the Board's philosophy that their authority came in voting to hire a Superintendent and that the day to day administration of the school district was his responsibility.

Theater Arts Director Paula Rodriguez was welcomed to the meeting. The Board and Superintendent expressed their appreciation to her for all the honors she had brought to Sonora, including the first place win at the recent State One Act Play Contest and they thanked her for her dedication and hard work for the students of the district.

No. 4, Organization of Board - Motion was made by Gary Hardgrave, seconded by Sam David Hernandez, to unanimously elect Gloria Lopez as President of the Board. Motion carried.

Gloria Lopez made a motion, seconded by Gary Hardgrave, to elect Sam David Hernandez as President Pro Tempore. The motion carried unanimously.

Michelle Anderson was unanimously elected as Secretary after a motion by Donald Patton and a second by Gary Hardgrave.

No. 22, Executive Session - At this point in the meeting, Mrs. Lopez assumed chairmanship of the meeting and announced that the Board was going into executive session according to its rights under the provision of Article 6252-17 V. A. T. S., Sec. 2 (g) to discuss personnel matters and that no action would take place in closed session.

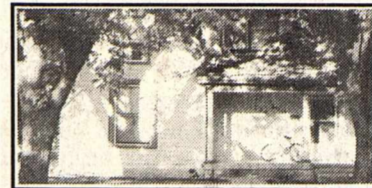

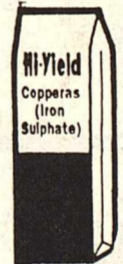
