A special City Council meeting will be held on Tuesday, June 1 to accept the resignation of Lopez.

Lopez stated that to do the job properly like he wanted to it would take away from his as owner of The Commercial

Restaurant business and he needed to spend more time there.

"I would like to thank the people of Sonora for all the courtesies and the confidence that they have had in me," said Lopez. "I hope that I have represented them with grace and dignity."

Lopez added, "One of the proudest things that I think has happened during the time that I was mayor, was the hiring of a fine person for city manager like John Pape."

US currency seized by Trooper Ortiz after routine stop on Interstate 10

On May 19th at approximately 4:30 p. m., Texas State Trooper Norbert Ortiz was on routine patrol 5 miles west of Sonora on IH 10. Trooper Ortiz clocked a 1993 Cadillac at a high rate of speed. Ortiz was able to stop the suspects vehicle. While interviewing the driver, who was identified as Robert James Evans, age 47, of Lakeland, Florida, Trooper Ortiz developed probable cause asked and received written consent to

search the Evans vehicle. Trooper Ortiz located, in a suitcase in the trunk, \$15,413 in U. S. currency. Trooper Ortiz believed that Evans was en route to purchase narcotics at an unknown location.

Also located in the suitcase was under two ounces of marijuana. Evans was arrested and booked into the Sutton County Jail for possession of

marijuana less than two ounces. Later on this date, Trooper Ortiz was notified by DEA Dallas that Evans was a wanted felon for possession of methamphetamine.

Trooper Ortiz filed forfeiture procedures with 112th District Attorney's Office May 20.

The forfeited currency will be put in an interest bearing account by the 112th District Attorney's Office.



Now's the time to plan your prescribed burn

Soil Conservation Service Believe it or not, this is the time of the year to begin planning for your prescribed burn. The burn season normally falls in the period of December-March, but the previous growing season may be one of the most critical times of the burning process.

The amount of fuel present is critical in determining how well a fire will perform and if it will achieve the intended goals. It is recommended that at least 1500 to 2000 pounds of fine fuels (mostly grasses) be available. If you are planning to burn and you do not have this amount, then deferment during the next growing season is necessary to produce the fuel required.

As part of the overall brush management goal, fire is a very

useful and inexpensive tool. When used properly, undesirable plants such as junipers and mesquite, pricklypear and tasajillo can be suppressed or controlled. Suppression of these plants over a period of years, and the development of a more open canopy where more desirable vegetation can grow will cut down the number of dollars spent on other, more expensive brush control measures.

There are two other advantages to prescribed burning. One is the improvement of forage quality. Plants such as tobosa grass become coarse and unpalatable after a short time. Periodic fires will maintain the palatability of this plant for a longer period and therefore increase utilization. The other benefit is the stimulation of resprouting of desirable browse plants such as liveoak and elbow bush. Most liveoak motts in this part of the state have very little or no resprouting because of the grazing by goats and deer, but with proper stocking in conjunction with a fire and deferment, desirable woody plants will come back and provide additional forage.

Prescribed burns are not wildfires. Prescribed burns are well planned and carried out under specific conditions. Proper planning before and adherance to the plan after the burn are essential. Deferment of pastures, proper grazing use and correct stock numbers are all part of the planning process. For more information or assistance, contact the local Soil Conservation Service. Programs offered by USDA-SCS are available to anyone without regard to race, color, creed, sex, age, handicap or national origin.

And as we stood quietly, listening to the sometimesimmense roar of the crowd (albeit not quite the anticipated crowd), I couldn't help but say a prayer for those young men "performing." I wonder what the career ladder (or is it a "career slide?") for nearly-nude male dancer looks like, and thinking that everyone who paid to see them was helping push them into that ever-moredifficult-to-climb-out-of abyss.

And as we pulled up stakes (really we just picked up our signs) and walked away, I wondered how those women would feel when they got home and looked into their mirrors? I hope and pray that there was at least a glimmer of a twinge in their consciences. But, perhaps, like those of old to whom Jeremiah spoke, "Were they ashamed, when they committed abomination? No, they were not at all ashamed; they did not know how to blush?" (Jeremiah 6:15)

What will come of that May evening? Did our quiet statement-by-our-presence keep some folk away? I hope so.

Did it cause some embarrassment for those in attendance? I think it must have, for most who entered would not

look me in the eye as they hurried past. Will it keep this from happening again? That's pretty much up to all of us. It depends on how willing we are to stand up and proclaim, in unity, that this is wrong for Sonora. Did you call, write, or talk to your City Council members and Mayor? If not, let them know. Even though they are our friends and neighbors, they are also politicians by choice, and they pay attention when enough voices are raised. If you know the owners of the club and the owners of the property, mention to them that you don't appreciate their lowering the standards of this community with this kind of trashy entertainment. If you know people who went, tell them that they are in your prayers, in the hope that they will reconsider their actions and their consequences for our

Carol Hunnicutt, native of Ozona, is working on her physicians assistant degree. She is currently working on her rural practice training under the direction of Dr. Charles Pajestka, local physician.

Carol has two very active children living in Dallas, a son age thirteen and a daughter age

Previously a paramedic, Carol decided to become a nurse anaesthetist. When she started her undergraduate work she found out through her professors about the Physicians Assistant (PA) program. Because it was an upcoming field and PA's were utilized everywhere, she decided being a PA was a better way to go. Physicians assistants are used in all 50 states, making the job market better than a nurse anaesthetist.

Carol is attending the PA program through the UT Southwestern Medical Center in Dallas, University of Texas School of Allied Health.

Carol has been at Dr. Pajestka's office for two weeks, and continues for four more weeks.

After completing her pre-studies she applied for the program and was chosen for an interview. Training for the PA program is a medical school type program that includes cadavers, neurosciences and physiologies. The students are required to work in a family practice at least 200 miles from Dallas, in a town with less 10,000. Carol, being from Ozona, wasted no time choosing Sonora to her preceptorship.

Once Carol has completed her PA's in the USA and rotation in Sonora she will go to approximately 1,200 in Texas.



before. Sharon Stone nude - big deal. The plot - Hitchcock's


