Broncos Face Lions 28-14

For the third week in a row, the Sonora Broncos out scored their opponent in the second half. Unfortunately for the locals, the game consisted of two halves.

The Broncos lost to the Ozona Lions by a score of 28 to 14. Sonora was in the game until the very end. The Lions were led by the running and passing of Senior quarterback Justin Castro. Ozona was able to take advantage of Castro's play and several Bronco mistakes to jump out to a 21 to 0 score at the half.

"We really played well in spots, but we just had too much to overcome," said Sonora head

coach Bob Bellard. "We played well enough to win, but we dug ourselves too big of a hole, a hole we could not get out of."

The Broncos entered the game with several preseason questions answered. Jason Morley has emerged as the starting quarterback. The defense is beginning to jell and the pre-district tune-ups are going to be very important for the Broncos, more important than anyone could have expected.

"What we must do is to maintain our confidence," said Bellard. "This is the time to get the kinks out, we have to play better in the first half."

The drive sheet tells the

story of the first half for the Broncos. The first drive ended with a punt; the next on an interception; the next two on fumbles and the final two drives of the half ended on failure to convert fourth down situations. The Broncos were unable to put together a string of more than four plays in the first half.

The first half belonged to the Lions. The first score came at the 3:27 mark of the first quarter. The touchdown was set up by an interception by Andres De La Garza which was returned to the ten. It took the Lions four plays to put the ball into the end zone. The score came on a fourth and 18, or was it a fifth and 18? The Lions missed on the first attempt at fourth then they were given another opportunity. The Lions had begun the play before the

More Bread In China Means More Markets For U.S. Beef

(NAPS)—Americans concerned about the country's economy as well as their own may be heartened to hear about opportunities for foreign trade that will increase employment at home.

One significant new market for an American product is the People's Republic of China. According to a recent study by the U.S. Meat Export Federation (USMEF), that country is looking more and more for outside sources of quality beef products. The USMEF is a national trade organization responsible for developing foreign markets for U.S. red meat products. Many of USMEF's foreign activities are funded by an industry checkoff program. This self-help program has made it possible for the American beef industry to make significant inroads into the Japanese and Mexican markets.

"The current economic boom and, more importantly, the growth in private enterprise and local autonomy have opened the doors for exporting countries to market beef directly into China," says Philip M. Seng, USMEF president and CEO.

The study also found:
• Demand for high quality beef in China's tourist hotel and restaurant sector will easily exceed the size of the Hong Kong and Taiwan market combined by the end of the decade, reaching as high as \$30 million in sales.

• Demand for U.S. variety meat products in China's general

market will create a major export target for U.S. suppliers. Seng estimates an initial market size of 200 million consumers in China for U.S. beef variety meats and sales of \$60-\$70 million in beef by the turn of the century.

During the 1980s, "Discretionary income [in China] was used largely to buy televisions, video recorders and basic home appliances," said Seng. "Today, incomes are channeled into purchases of gold, cosmetics and food."

The proliferation of supermarkets, fast food restaurants, family style restaurants, steak house chains and theme restaurants in the region are all expected to have a positive effect on U.S. beef sales in China.

National Stamp Month

October is National Stamp Collecting Month. To begin the activities the Concho Valley Stamp Club will host a Stamp Show on October 2nd and 3rd at the Holiday Inn, 441 Rio Concho Drive in San Angelo. The hours are 10:00 a.m. to 6:00 p.m. on Saturday and 10:00 a.m. to 4:00 p.m. on Sunday. Admission is free.

Stamp collecting is an enjoyable hobby for any age individual. You can collect stamps to suit your interests. It can be from a particular country, of one subject such as horses, cats or dogs, or just post cards with Christmas or Valentine messages on them.

Collecting can increase your knowledge of history and geography when you study why a particular stamp was issued or whose picture is on it. In the United States they will not issue a stamp commemorating a person until ten years after their death. Other countries do not have this restriction. The Stamp Show will have several dealers with material you can look at if you are not already a collector to decide if you want to start collecting. The Postal Service will have all of the current stamps for sale.

The Show theme is to honor the South Orient Railroad. An envelope with a drawing of the

Passenger Depot in San Angelo will be for sale by the Club and also the Post Office will have a special cancellation available using railroad tracks instead of the normal or wavy lines.

The Concho Valley Stamp Club meets at 7:00 p.m. the second Tuesday and fourth Thursday of the month. The Tuesday meeting is at the Main Post Office and the Thursday meeting is in the First National Bank of West Texas (formerly Central National). Visitors are always welcome.

Forlano Presents Lecture

Albert J. Forlano, R.Ph., Ph.D., Director of Medical Seminars and Consultant Services, of Eldorado, presented a lecture, "Antioxidants and the Prevention of Cardiovascular Disease" to the Texas Coastal Bend Section of the American Chemical Society in Victoria, Texas on Sept. 9, 1993. Dr. Forlano holds a doctorate in Biochemistry and Pharmacology from the Ohio State University. He lectures in the area of preventative medicine and disease reduction on a national basis in many large cities including Philadelphia, Pittsburgh, Chicago, Dallas, Los Angeles, Portland, Norfolk, and Lake Tahoe.

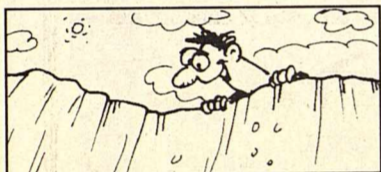
The meeting in Victoria was attended by chemists, physicians, nurses, and the general public. The program covered the nature of heart disease, risk factors for heart

disease, and most importantly, the factors that are involved in the reduction of the risks of heart disease. The reduction of the risks of cataracts and other eye diseases in diabetes was also covered.

The use of antioxidants in the prevention of disease is a modality that has been examined for the last 20 years by some of the world's most prominent physicians and researchers. The evidence is becoming more convincing so that many physicians and researchers are now making these recommendations to their patients. The use of these antioxidants may require some change in one's lifestyle and can be instituted by anyone wishing to decrease their risk of diseases, the ravages of aging, impaired immune function, and rheumatic disorders, in addition to heart disease.

Dr. Forlano will present the same lecture at the Shannon Southwest Clubhouse at 4141 S. College Hills Blvd. in San Angelo, on Sept. 30, 1993 at 7:00 p.m. In addition, a talk about the use of antioxidants in the reduction of risk of cancer and brain diseases will be presented on October 28 at 7:00 p.m. at the same location. The use of antioxidants includes the use of antioxidant supplementation as well as dietary modifications. Other modalities, other than dietary intervention, will also be covered.

While this talk is generally geared for the public, health professionals would also benefit from the information. Following the presentation, the audience will be given an opportunity to ask the speaker questions.

whistle to start had been blown and they were given another play. This time Castro was unable to connect with Chris Sanchez for the touchdown. The 20 yard play was followed with De La Garza's point after kick.

The next Lion score also followed a Sonora turnover. This time it was a fumble that led to the Lion tally. This drive was 60 yards and took 5 plays. This score was set up by an excellent throw from Castro to Jessie Garza. The touchdown came on a two yard run by J.J. Lozano. This time De La Garza's kick went wide right.

The Broncos fell victim yet again to the Lions and to the officials when on the ensuing kickoff, the Broncos kick returner was apparently down, but the officials ruled that the play was still live on a fumble. The fumble was caused by the Broncos contact with the ground, which can not by football rules cause a fumble. The Lions should be credited, though, with taking advantage of the situation. The 46 yard drive took 9 plays and ended with a one yard run by Castro at the 6:38 mark.

The Broncos got back into the ball game in the second half

when Joey Guerra capped an 80 yard drive with a two yard run.

Sonora got the ball following a quick kick. It looked as if Ozona was going to go for a first down on fourth and four at the 39 when Castro took the ball in the shotgun formation and kicked the ball into the end zone, giving the ball to Sonora at the 20.

The Bronco scoring drive was highlighted by some excellent blocking by the offensive line and running by Guerra and Gilbert Vara. Just as Sonora looked to be in position to press the Lions again they were hurt by a turnover. This time the Lions' Robert Bryson made the interception. The Lions moved the ball the 25 yards required on a 4 play drive that took less than two minutes. The score

came on a 2 yard run by Travis Davidson.

The final score of the evening came on a 31 yard streak pass from Morely to Louis Massey at the 8:40 mark. Though the Broncos were able to move the ball several more times they were unable to put the ball into the end zone.

In other action around the district, Reagan County continued their winning ways with a 27 to 3 victory over Lamesa. Crane lost to Pecos 23 to 6. Greenwood tied Denver City 21 to 21.

The Sonora Broncos will face the Breckenridge Buckaroos for the 1993 Homecoming game. The Buckaroos are coming in following a 34 to 24 loss to class 4-A Sweetwater. The Buckaroos fell behind 34 to 0 in the first half and then rallied for 24 second half points.

Breckenridge will be led by Will Mobley at quarterback and the Alvarez's-Patrick and Bobby. The three return from last year's team that beat the Broncos in Breckenridge.

"We are going to be ready," said Sonora head coach Bob Bellard. "This is a good team coming off a tough loss so we will have to be ready."

Hospital Auxiliary Meets

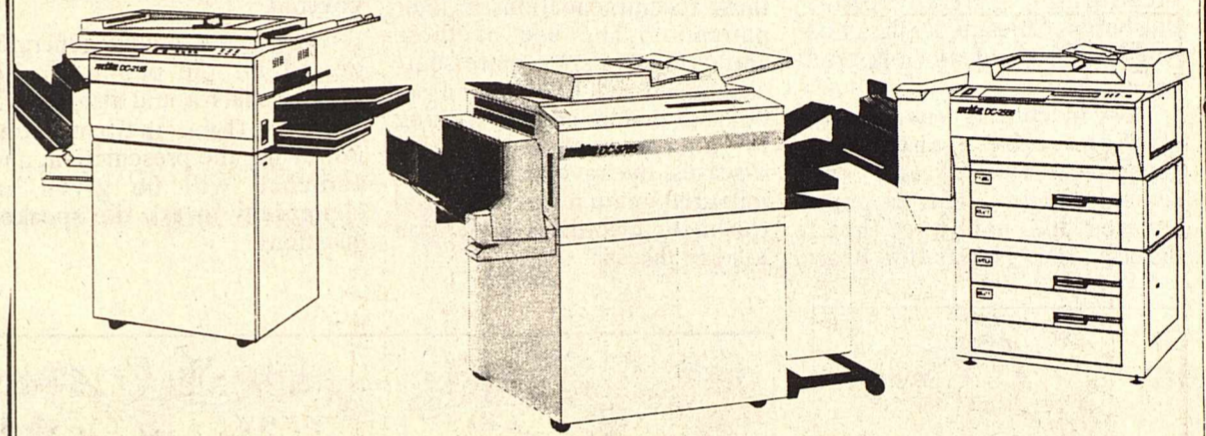

Sonora Unveils Adopt-A- Neighborhood

The City of Sonora has made it easier for citizens to report problems and concerns through an innovative new program called "Adopt-A-Neighborhood." Along with the new program, the city has installed a telephone "Action Line" for people to report problems that the city needs to address.

The new Action Line number is 387-5923, and it is answered automatically on a 24-hour basis, seven days a week. When a complaint is received, it is assigned to a city staff member to be handled.

If the reporting party leaves a name and contact number, they will be informed of what action the city has taken. Anonymous calls are also accepted and acted upon.

Loosely based on the Neighborhood Watch concept, Adopt-A-Neighborhood also encourages groups of neighbors, civic organizations, and service clubs to organize in order to improve the quality of life in

neighborhoods throughout Sonora. The Adopt-A-Neighborhood group helps to keep the city informed of problems within their area.

"The goal of this program is to make it as easy as possible for concerned citizens to bring their concerns to our attention," explained City Manager John Pape. "We are not asking people to do our job for us; we are just encouraging them to organize for the betterment of their neighborhood and then to let the city know what needs to be addressed."

Pape noted that virtually any type of problem can be reported. Examples include code enforcement problems, litter and trash, health concerns, street problems, or virtually anything of a non-emergency nature.

A brochure explaining the program is being mailed to all households with the next water bill. Brochures are also available at City Hall and through the Sonora Police Department.

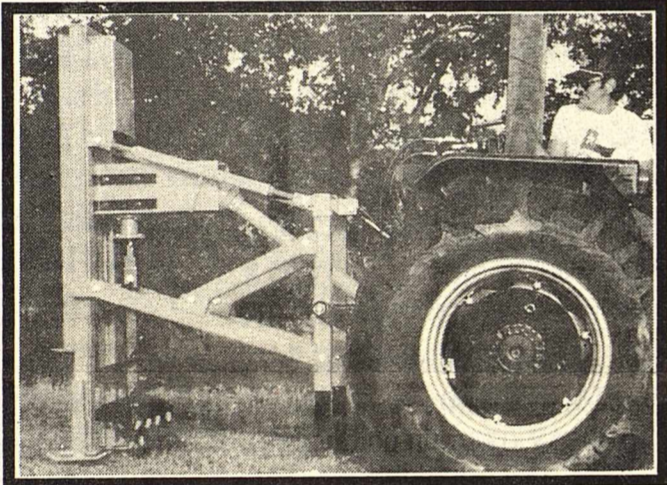

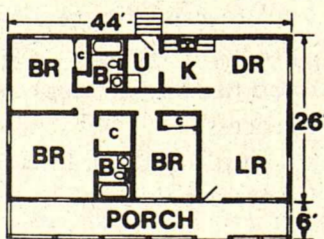

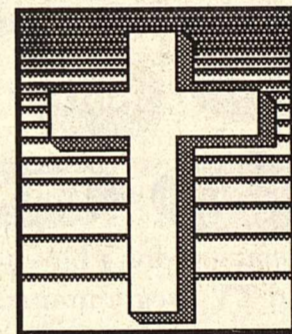

1902 Main Street Fire

Q. Do you have any information on the fire on Main Street in 1902?

A. We could not find a copy of Devil's River News for September 13, 1902 but found the following in the San Angelo Standard, Saturday, September 13, 1902:

A most disastrous fire swept over the little city of Sonora at an early hour yesterday morning, and as a result, one of the chief business blocks of the city is now a heap of wreck and ruin. The total loss to property is estimated all the way from \$75,000 to \$100,000.

The fire originated from an unknown cause in the store rooms of the Mayfield Mercantile Co., and was first discovered at 5:30 A.M. An alarm was immediately turned in and the fire boys responded as quickly as possible, but the flames were under such headway and the north wind blowing such a gale, that the entire block was wiped out.

The principal losses are as follows: Mayfield Mercantile

Co., loss in stock between \$25,000 and \$30,000, insurance \$18,000. E.R. Jackson loss in building, occupied by Mayfield Mercantile Co., \$5,000. First National Bank of Sonora, loss on office and fixtures, \$5,000, insurance \$2,000. The Maud S. Saloon, owned by Geo. W. Morris loss \$4,000, no insurance. W.W. Berry barber shop, owned by Geo. W. Morris, total loss. Ranch Saloon owned by A. J. Swearingen loss, \$8,000, no insurance. Mrs. Ben Keenon, restaurant, loss \$200. George Kirkland loss on building occupied by Mrs. Keenon \$500. R. W. Hill, butcher shop, loss about \$150. A.N. Galey, loss on building occupied by Mr. Hill \$200. J.F. Cannaday, boot and shoe shop, total loss. Mrs. James restaurant, loss \$200. A.N. Galey, fancy groceries, loss \$300. George S. Allison loss on building occupied by J. F. Cannaday, Mrs. James and A.N. Galey, \$4,000. Blacksmith shop owned by G.S. Allison, loss \$200 on building and \$300 in stock. San Angelo Telephone, phones and other fixtures, \$150.

A.A. DeBerry estate loss on residence \$600. John I. Word, loss on household goods \$200.

The DeBerry residence was occupied by Mr. Word and situated 800 yards south of the burning block and was set on fire by flying embers blown there either by the high north wind or sent flying through the air by the explosion of some coal oil tanks in the Mayfield building.

This explosion was terrific, and when it occurred, many of the firemen and bystanders were thrown to the ground, and

window glasses for blocks around were shattered to pieces. All the glasses in the Sutton County Court House were broken, and the glass fronts in some of the buildings across the street, including that of E.F. Vander Stucken Company were blown in.

The boys made a noble fight to save the block, but fate was against them. The fire was under such headway when the first alarm was given, and the wind was blowing so hard, that no company in the state could have checked the flames any sooner. A number of citizens were slightly injured in the fight, among them T.D. Newell, proprietor of Sonora Water Works, who was struck and knocked down with a ladder carried by an enthusiastic fireman and Guy Yankee who was also thrown to the ground and received a severe cut over the eye.

It was 8:30 yesterday morning when the fight was finished and the fire boys withdrew for breakfast, having battled fiercely for 3 hours against the flames.

Devil's River News of September 20, 1902 reported that James W. Keene, aged 35 years died from pneumonia and congestion of the stomach brought on by exposure and injuries received on the morning of the fire.

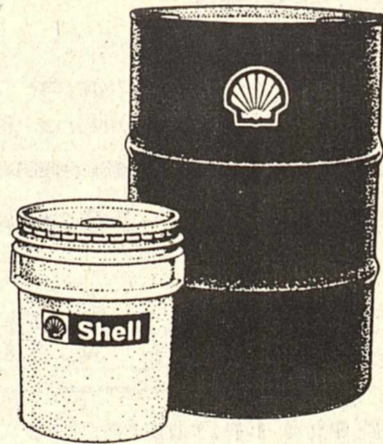

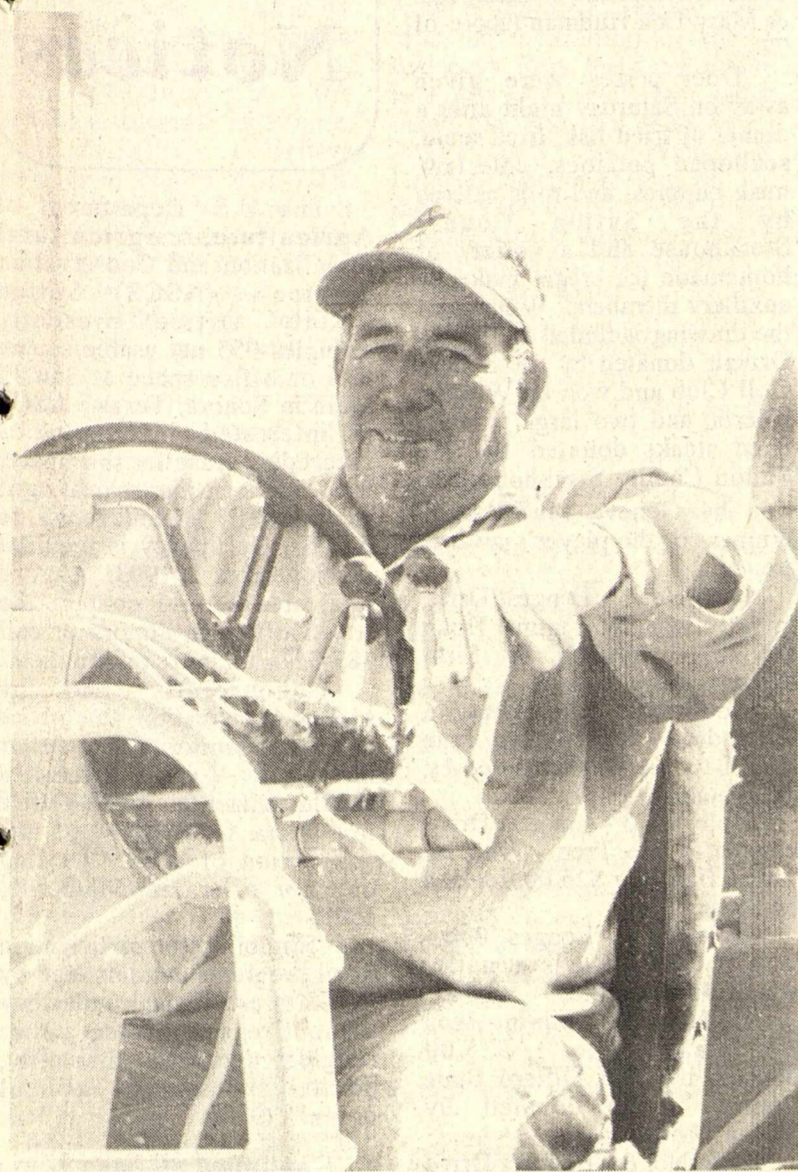

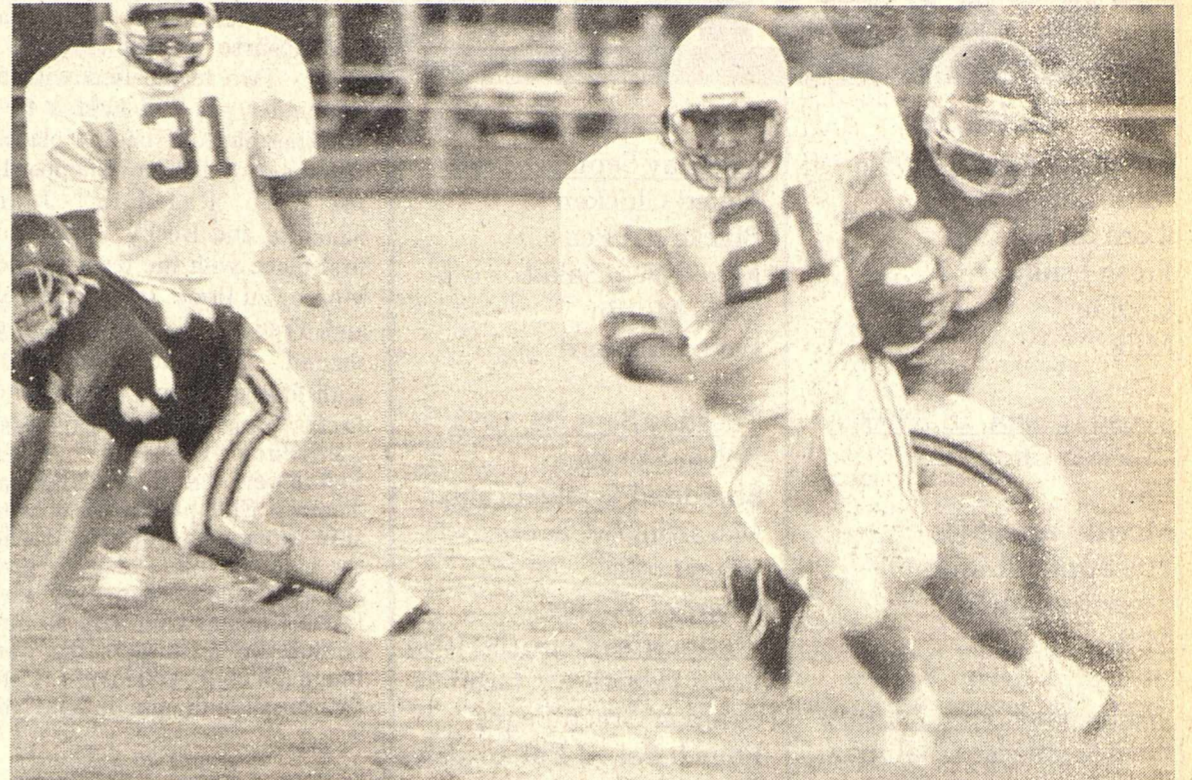

The Lion defense again did a good job of stopping the Broncos. After a fourth and 20 play which went for 15 yards the Lions regained the ball on downs at the 34.

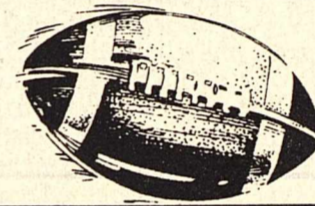

The Health Care Financing Administration (HCFA), which oversees the Medicare and Medicaid programs, estimates 15 million elderly and disabled beneficiaries will get the shots annually.
HCFA is an agency of the U.S. Department of Health and Human Services. Department Secretary Donna Shalala points out:
• Influenza is a viral infection that can lead to much more serious illness such as pneumonia or bronchitis. Thousands of people die each year in the United States from the flu or related complications.
• Those 65 and over who contract the flu are more likely than younger people to have serious complications.
• Flu shots can help you protect your friends and family. If you don't have the flu, they can't catch it from you.
• Flu symptoms include headache, fever, chills, weakness, aching muscles and red, watery eyes.
• The Public Health Service recommends everyone 65 or older get a flu shot every year.
• You can't get the flu from the shot.
The government will now pay to protect older Americans from influenza.
• Even with the shot, you may still get the flu, but in a milder form than otherwise.
• You can get the shot at your doctor's office, the health department or while you are in the hospital.
• Other ways to protect yourself include: frequent hand washing; a well-balanced diet that has plenty of fruit and juice; sufficient sleep, minimal stress, regular exercise, high indoor humidity and not smoking.

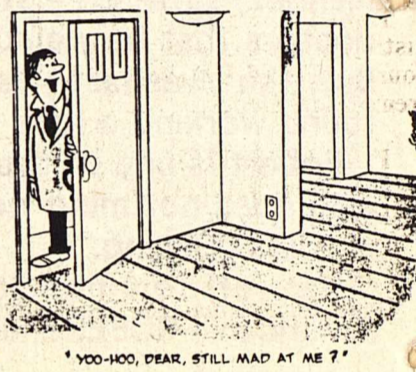

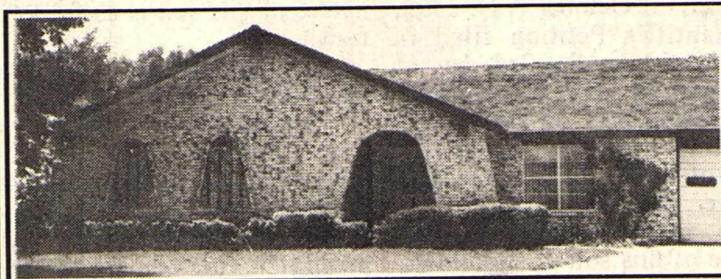

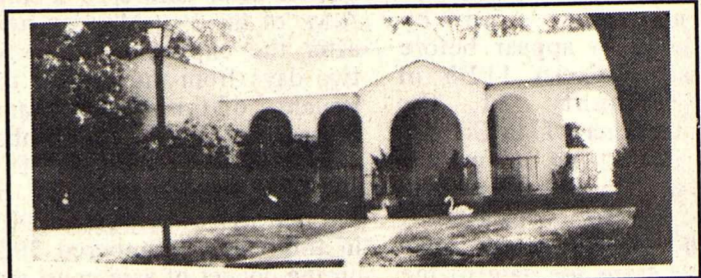

He and his wife reside in San Angelo now, and their daughter, Mrs. Sandra Thompson, is a teacher at Hamlin, Texas.



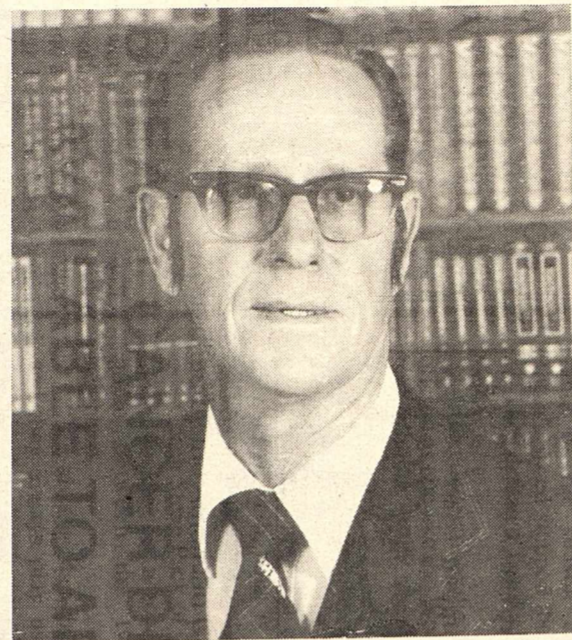
Rex W. & Edith Lowe

After leaving Sonora, he went to Irving where he has been for 33 years. He worked in education there as a teacher, supervisor of business education and special studies for 10 years, and a vice-principal for 12 years.

Mr. Morris had just retired, and he and his wife, Magdalene, live in Irving. Their son, John, graduated in August of '93 from Hardin Simmons with an English degree.
