## Sonora Broncos VS Reagan County Owls

It was all tricks and no treats for the Sonora Broncos as they were beaten 48 to 13 by the Owls of Reagan County. The Owls wrapped up their third consecutive District 6-3A championship in defeating the Broncos.

The Owls, ranked number 6 in the state by the Associated Press, showed that theirs was a deserved ranking in dominating every facet of the game, racking up 444 yards of total offense compared to Sonora's 249.

Sonora came out and smartly moved down the field only to have the turn-over bug to strike again. This time it was a fumble that came to end the Bronco success. It took the running of Jeremy Ellison and Joe Ramirez only five plays to move the Owls 63 yards to the first score of the evening.

On Sonora's next possession, again a fumble stopped the Broncos. This time on the first play following an excellent kickoff return by Joey Guerra, the ball was fumbled back to the Owls. On the second play from scrimmage Jeremy Ellison hit the 35 yard line and ran unmolested to another score. The score following the point after at the 7:23 mark of the first quarter was Reagan County 14 Sonora 0.

Reagan County would score on every possession of the first half and Jeremy

Ellison ran for 104 yards in the first quarter.

Jeremy Ellison would score again at the 9:22 mark of the half, taking a handoff from his twin brother and Reagan County Quarterback, Jeffery Ellison, and run 8 yards in for a 20 to 0 lead for the Owls. This ended a 10 play 78 yard drive.

Ramirez scored his second TD of the evening on the next Reagan County possession. The Owls kicked following the Ellison score into a stiff

north wind. The ball popped up and fell to the ground and was pounced on by the Owls' Jason Weatherby, giving the ball back to the powerful Big Lake offense. It took just 6 plays for the Owls to score again.

The final score of the half came on a Jeffery Ellison pass to Ronald Reyes with just 29 seconds left on the clock. The score at the half was Reagan County 34 Sonora 0.

The Owls would tack on two more scores in the third quarter. Again it was Jeremy

Ellison who would draw the Broncos blood on runs of 24 and 35 yards.

Sonora finally broke on to the score board at the 11:46 mark of the final quarter. A good Sonora drive was finished off by a one yard run by Gilbert Vara. The drive began following the last Reagan County score for the night After a good return by Vara, the Owls were hit with a 15 yard penalty for unsportsmanlike conduct, giving the ball to Sonora first and ten at the fifty. The Broncos moved the ball well against the first team Big Lake defense. Guerra had a 46 yard apparent touchdown called back on a holding call. Vara and Guerra combined with Gilbert Perez to move the ball to the goal and the score.

The final play of the game proved to be exciting for the fans who stayed in the cold night air to watch to the bitter end. With the clock down to 6 seconds Perez ran through a group of Reagan County defenders and ran 62 yards for a touchdown as the buzzer sounded ending the game.

The Broncos will end this season in Crane Friday evening at 7:30. Please come out to the game and support this fine group of men who have represented our community with class and courage this 1993 football season.

## Junior Livestock Show Holds Ewe Lamb Competition

The Sutton County Junior Livestock Show held its ewe lamb competition recently at the 4-H Center. The champion pair was exhibited by Amy Patton and the reserve Champion pair by Jason Jacoby. Other placings were: 3rd Shawna Faris; 4th Cody Renfro; 5th Anthony Renfro; 6th Tom Jacoby; 7th Jason Morley; 8th Justin Morley; 9th Graham Bloodworth; 10th Brandon Faris; 11th Bill Renfro; 12th Thomas Bloodworth; 13th

Kelly Blakeley; 14th Brandi Bible and 15th Ashley Bible.

Preston Faris, County Agent, stated that this, is the most educational class held at the show because it stresses commercial production factors. He further stressed that these classes impact not only the youth development program but actually help producers learn more about producing sheep which are profitable and meet the demands of a changing

industry.

The lambs are placed based on a weighted formula which places emphasis on subjective and objective measurements of traits important to the industry. These traits include mature size, fleece quality, staple length and visual appraisal of body structure.

The 4-Hers put the animals on feed in early June when they are weaned. They are fed until the show and receive

prize money for their placings. While financially not very profitable the project really teaches a great deal about production, management and economics.

Educational programs conducted by the Texas Agricultural Extension Service serve people of all ages regardless of socioeconomic level, race, color, sex, religion, handicap or national origin.

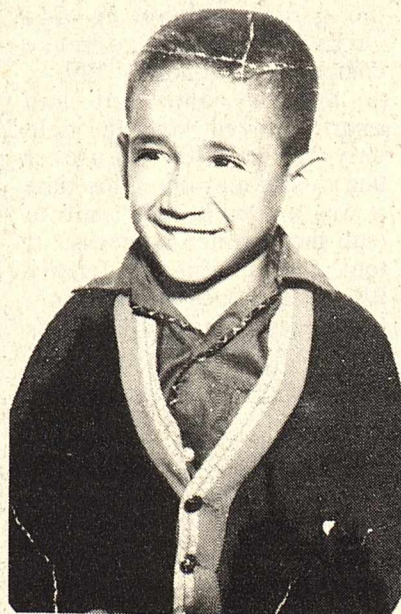

## TWC & TACB Merge

The Texas Water Commission and the Texas Air Control Board have merged to form a "super" environmental agency for Texas that will represent one of the most comprehensive state programs in the nation. The September 1, 1993 formation of the Texas Natural Resource Conservation Commission completes a consolidation that began last Spring to bring all of the state's major environmental protection programs for air, land and water under one organization.

Major priorities of the new agency include more aggressive response to citizen environmental issues, greater technical assistance to help Texas businesses meet new federal clean air mandates and other requirements, and expansion of programs that help Texas businesses and local governments reduce pollution and build recycling programs.

Agency chairman John Hall announced a series of initiatives the new agency will undertake:

- Quarterly roundtable meetings with representatives of state environmental groups to ensure the TNRCC is adequately addressing citizens environmental issues. The first meeting was Sept. 17 in Austin.
- Formation of TNRCC "strike teams" of technical staff that will be mobilized to conduct expedited inspections and investigations of air, land and water pollution in response to major community complaints.
- Statewide meetings to explore long-standing environmental issues. The first was held September 27 in Arlington regarding the burning of hazardous waste in cement kilns.
- A series of regional meetings over the next six months with community leaders to review the state of the environment and to develop regional action plans.
- Expansion of TNRCC technical assistance programs to help businesses, especially small businesses, meet new clean air mandates and to minimize the financial impact of compliance whenever possible.
- A review of TNRCC rules and regulations to determine what incentives may be given to cities and businesses that achieve pollution reductions beyond what is required.

Establishment of performance standards in TNRCC programs that the agency will meet in performing its job. Examples include schedules to be met in completing permitting or enforcement actions.

"We have made great strides in opening our doors to increased public input and better communication with those regulated," said TNRCC Commissioner Peggy Garner, who has just been appointed to another six-year term by Governor Richards. "Our philosophy is to provide maximum protection for the environment while fostering economic climate for Texas."

The TNRCC, as mandated by Senate Bill 2, will be governed by the three TWC Commissioners, Hall, Garner and Pam Reed. The legislation abolished the nine-member Texas Air Control Board effective September 1, 1993.

Expansion of Clean Texas 2000 will also be a priority for the TNRCC. Over 80 Texas industries and two dozen cities have joined the statewide pollution reduction program, announced last spring by Governor Richards. Participating industries have submitted plans to reduce the hazardous waste tons annually by the year 2000 and toxic emissions by 230 million pounds. These reductions are beyond what the law requires.

The Clean Texas program will award almost \$9 million in grants over the next year to help communities develop recycling programs. The programs for cities is focused on household and workplace recycling, collection programs for used oil, tires and household hazardous waste, and community composting of yard waste. Clean Texas 2000 is the most comprehensive state pollution reduction program in the nation.

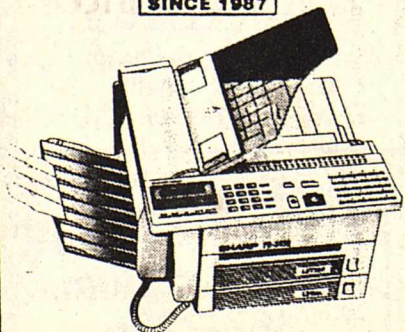

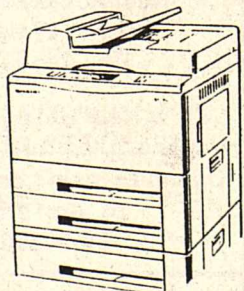

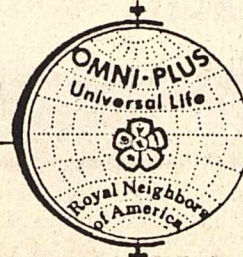

Sutton County Emergency Medical Service held a Mini First Aid Class October 19th & 20th from 7pm to 10pm.

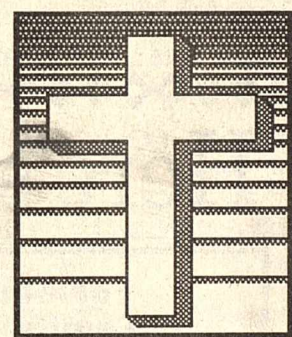
The six hour course covered medical illness and injuries and their treatment that may occur at home, at work, or while traveling.

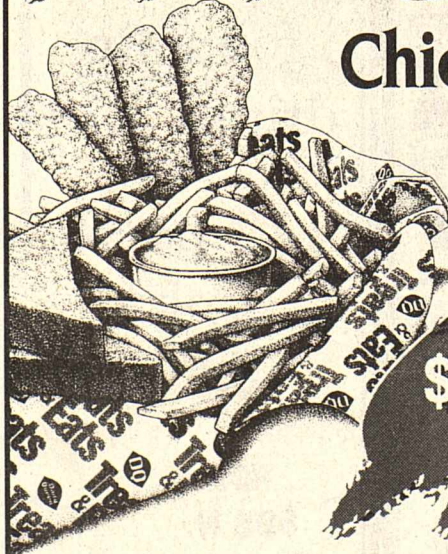

# JV Broncos - 6 & 2

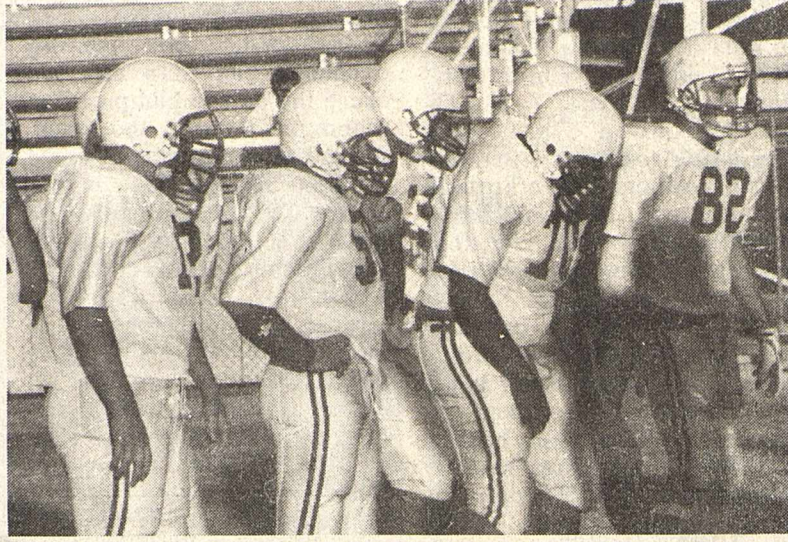

The Sonora Junior Varsity Broncos went to Reagan County and plucked the Owls 36 to 20 in a game that was never that close.

"We went into a very difficult place and came away with a victory. I am very proud of all of our kids," said John Creek, Sonora Junior Varsity coach. "We just played very well."

The JV jumped out to a 24 to 6 lead at the half and a lot of young people gained valuable playing time in the second half. "We got to play everyone. Some of our first, second, and third team kids really got some quality playing time. Walker Wallace, Ben Taylor, Pacer Holly, Chad Bruns, David Fisher, to name a few really did a good job when called on," said Creek.

The Bronco onslaught was led by Joey Gandar who gained 341 all-purpose yards, 241 rushing and 100 on returns. 80 of those return yards came on the opening kickoff for a touchdown. "That return was a thing of beauty," said Creek. "My, oh my, what a return!" It was a thing of beauty. The final score of the half came as a direct result of an action by Gandar again. This time it was a block thrown by Gandar that freed quarterback Barker to throw a beautiful pass to Thompson for the score. Score at the half was

In the second half Gandar again led the Broncos. His score in the second half came on a 26 yard run following a pitch from Andy Mirike. The score came following an interception by Joel Salazar.

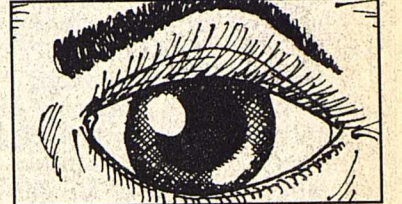

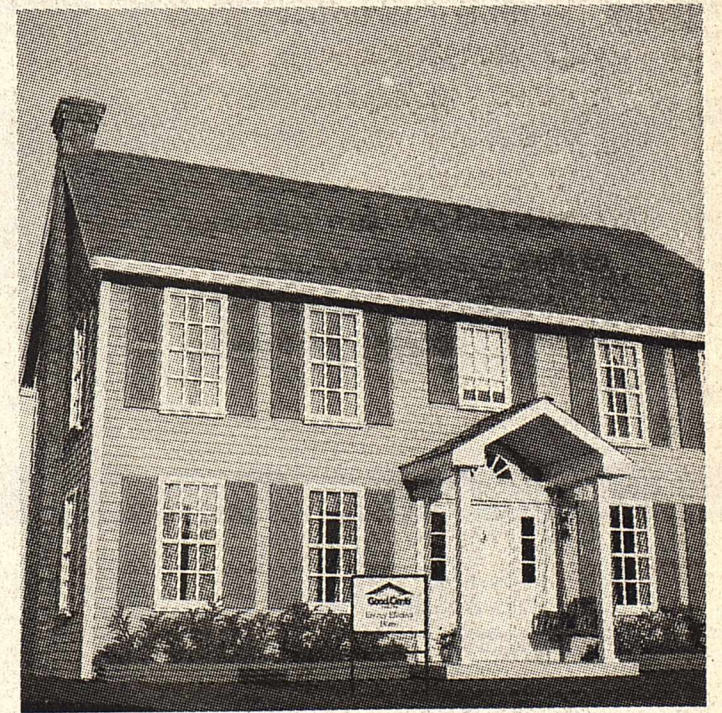

## Ask The Historical Society

Q. In your book "Bad Old Days" in And Around Sutton County 1889 - 1939, you have a story about a couple of runaway lovers from Valley Mills. Is the story real and do you have any pictures of the people involved?

A. The story of the runaway lovers was in the San Angelo Standard Times of May 22, 1921, in the Devil's River News and was picked up on the news wire all over the country.

I know it was in the Dallas and Waco papers. Two young people being chased across Texas by the girls angry parents and her brother and the death of the young lovers was a big story in those days. The young man was a veteran of WWI and the young lady a college student. Both came from very prominent families in Valley Mills and no one ever expected their little romance to end the way it did.

Several members of the historical society made a trip to Valley Mills and contacted several different members of Dorothy Harris' family who confirmed the story. They even supplied us with some pictures. We have the pictures on file. We were unable to locate members of the McNeil family that could help us. So to date we do not have a picture of Nelson McNeil.

Running with this story are two pictures. The group picture is taken in front of the McDonald Hotel and you can see the Devil's River News office in the background. From the left we have identified: #2 R. G. Nowlen; #4 Oma Rape Harris, Dorothy's mother; #5 Richard Harris, Dorothy's father; #6 L. W. Harris; #7 Fred Berger, undertaker; #8 O.D. Harris

and #14 H. S. Harris, Dorothy's brother. So three of the principle characters in the story, Oma Rape Harris, Richard Harris and H. S. Harris are in this picture. The picture of the young lady in the bathing costume is one of Dorothy Harris taken in 1920.

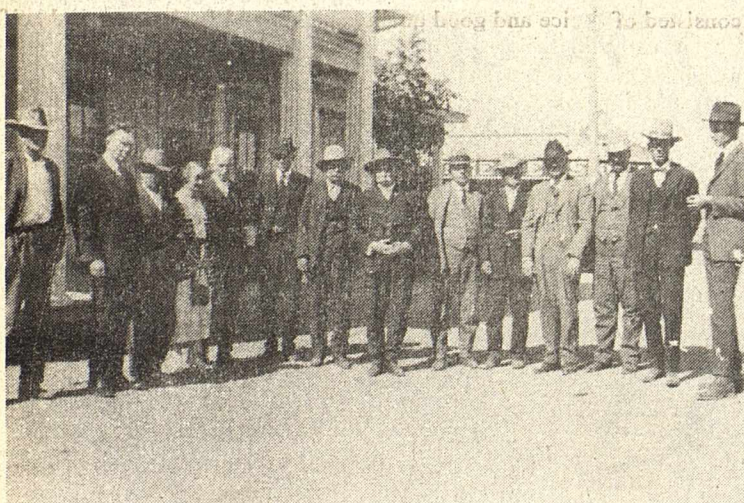
We have been told that the McNeil family had some relatives in this area and that there are several families in Sutton County who came from the Valley Mills area.

## EMS'ing Around

This is the time of year when most of us begin to get real busy; work, family school functions, and lots of upcoming holiday festivities. Silly season they call it. But, this is also flu season! This year they have a potentially dangerous strain, Type B or Bejing flu. Cases have already been documented in my homestate of Louisiana. The official flu season for this year runs from Oct. '93 to Mar. '94. Getting a flu shot now can enhance your bodies immune system and carry out that extra protection until the flu season ends. Getting a flu shot does not guarantee you won't get the flu, but it is a worthwhile preventative measure. This applies even more so for the elderly and persons with chronic illnesses such as diabetes and asthma, just to name a few.

On Sept. 25th, Dr. Gene W. Rogers and staff, administered flu vaccines to several of our EMT's at the EMS building. Thank you Dr. Rogers, we sure do appreciate your time, effort, and concern!!

On Sept. 26th & 27th Ada Castilleja's High School Medical Terminology class, instruction in CPR and choking. The instructors were Carla Garner and Donna Keese, Pat Campbell, Treva McReynolds, and myself assisted with the skills portion. It was nice to see 14 young, fresh faces around the EMS building. We certainly enjoyed having them for those two afternoons. We hope they don't stop with their training, but continue on to successful careers! Keep up the good work!

With the cold weather we've been having lately, (and boy was this weekend bitter!) I figured everyone has been

urging some type of heating system. So, I took the liberty to interview Sonora Volunteer Fire Dept., Fire Chief Carl Teaff. Chief Teaff recommended at the beginning of every winter season, owners of gas heaters of any type, need to have them serviced and checked for safety compliance. He suggested that "If the flames in your heaters are burning yellow, this is a warning signal. You should call your gas company provider, so they can adjust your heater properly. The flames should normally be blue. "If you own space heaters, your home should be well ventilated and should not have objects crowded around it. Fire, of course, is a great hazard, but there is also a silent killer: CARBON MONOXIDE POISONING!

Dysfunctional heaters burn up all of the oxygen in the house and give off carbon monoxide. When inhaled, carbon monoxide will prevent the normal transfer of oxygen by the body's red blood cells. Symptoms of carbon monoxide poisoning are as follows: repeated headaches, drowsiness, nausea, vomiting, coughing, shortness of breath, irritation to the mucous membranes, and ultimately unconsciousness, coma and death. Exposure even to a low level of carbon monoxide can cause a dramatic effect. Death occurs due to severe lack of oxygen in the body. This can all occur without recognition, because carbon monoxide is a colorless, tasteless, and odorless gas. That's what makes it a SILENT KILLER!

Three other possible hazards that should be considered, are central units, wood burning stoves, or using charcoal for indoor heating

and cooking. In central heating units that are a few years old, the heating exchange can burn out and cause the unit to pump carbon monoxide through the vents, instead of warm oxygen based air. Wood burning stoves sometimes do not have the pollutants that are given off during the burning process, adequately vented to the outside. Carbon monoxide is one of the pollutants. It is NEVER a good idea to burn charcoal indoors for any reason! Please take the time to protect your home and family. 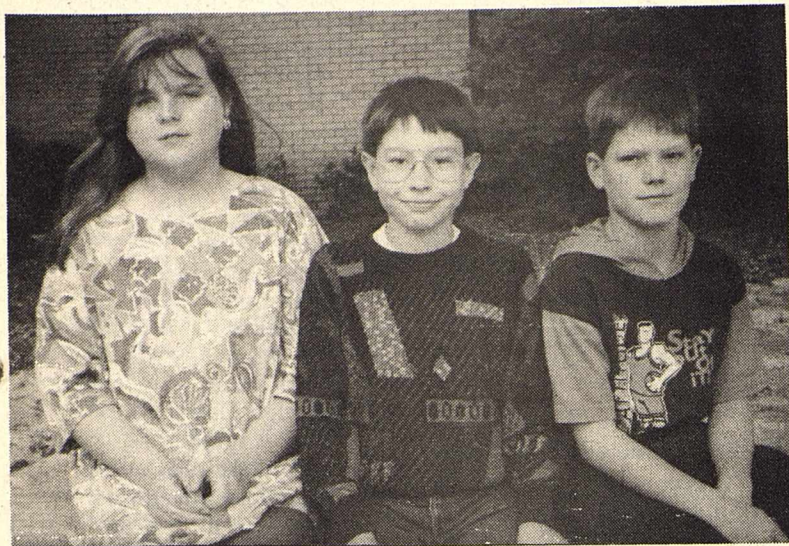

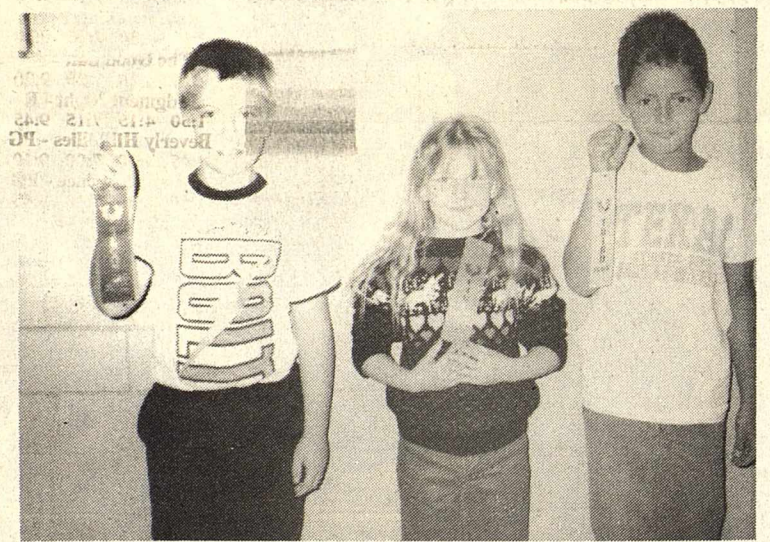

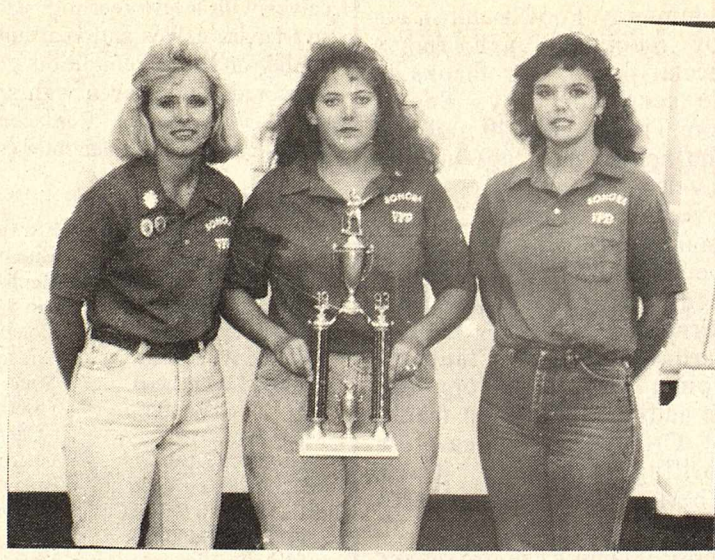

# Superstar From Sonora

Headed for the killer pen, the horse had one last chance and one last stop that might delay his execution; and only a prayer for a pardon.

Yellow Dog lives, and now he's killing the competition.

Yellow Dog is a short and stocky, golden-colored Quarter horse that belongs to Jimmy Powers of Sonora, TX. Powers bought the horse on that fateful day for little more than a handshake; and the 13 year old gelding has turned out to be the best horse he's ever owned.

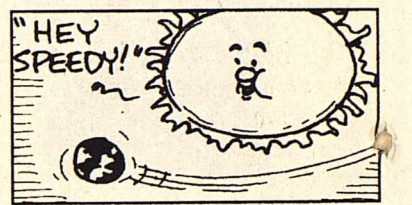

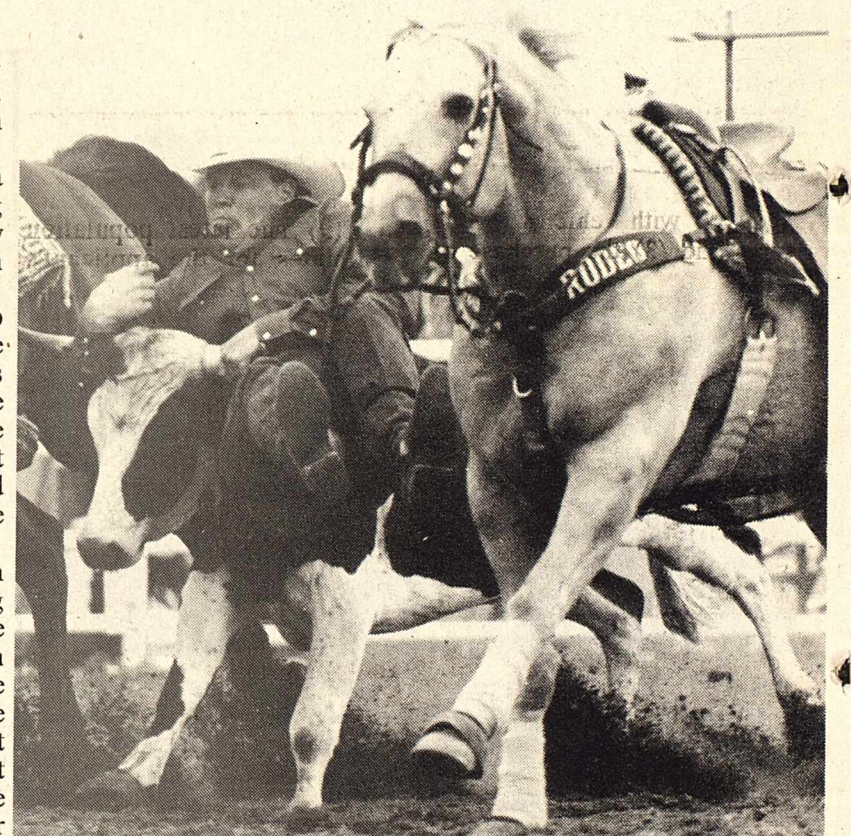

### ELDERLY AND/OR DISABLED GRANTS TO ASSIST WITH PUBLIC TRANSPORTATION

Pursuant to Title 49, United States Code, Section 1612 of the Federal Transit Act, the Texas Department of Transportation (TxDOT) issues this notice for solicitation of proposals and/or applications from private and public nonprofit organizations serving elderly and/or disabled persons to utilize funds available under the Section 16 grant program, administered by TxDOT.

**Notice of Invitation:** The Texas Department of Transportation (TxDOT) is issuing this request for applications for the Section 16 grant program. The Section 16 grant program provides capital assistance to nonprofit organizations which provide transportation services to elderly and/or disabled persons in Texas.

Funding for the Section 16 grant program is appropriated by the Federal government under the Federal Transit Act as described in FTA Circular 9070.1C, December 23, 1992. Fiscal year 1994 appropriations for Section 16 grant program are expected to be announced in October.

Eligible capital expenses under the Section 16 grant program include: (1) the replacement of vehicles such as buses, vans, trolleys, etc., currently used to transport elderly and/or disabled persons; and such auxiliary equipment as is normally acquired with vehicles of this type; (2) the purchase of vehicles for service expansions and new services to elderly and/or disabled persons; and such auxiliary equipment as is normally acquired with vehicles of this type; and (3) the purchase of radio equipment only, i.e. equipment that is not part of a vehicle allowed categories 1 and 2 of this paragraph. Section 16 funds must be used for transportation projects serving elderly and/or disabled persons.

Each project will be evaluated in the appropriate category in accordance with the stated selection criteria. However, TxDOT reserves the right to establish minimum required scores.

Projects must meet Federal funding criteria included in Circular 9070.1C and must also comply with property management standards set out in Title 43, Chapter 31.57 of the Texas Administrative Code, relative to the replacement of vehicles. To be eligible for consideration, each 16 proposal must include the following documents and information:

(1) Successful completion of the pre-application

interview and on-site visit with the District public transportation coordinator.

(2) A complete Section 16 grant application, copies of which are available at TxDOT District offices. Applicants requesting funds for multiple projects should group them within the application by funding category (replacement vehicles, expansion vehicles, new starts, and radios). The narrative should demonstrate the need for the equipment, the capability to maintain and operate the equipment, and the involvement of the applicant and the community in requesting funding for the equipment.

(3) A budget for each category of equipment which shows the unit cost of each item and total equipment costs. The federal dollars and local match dollars provided by the applicant should be noted.

(4) Compliance with the Americans with Disabilities Act to provide transportation services that are accessible to disabled persons.

(5) Provide proof of demonstrated coordination efforts with other transit systems within the applicant's immediate service area in the application.

(6) Proof of local match ability to pay a minimum of 20 percent of funding for said equipment. No federal dollars may be used as local match unless authorized by the federal agency that awards those monies.

(7) The latest annual one-way passenger trip figures for the applicant agency, with the source of the information shown (such as TxDOT reports, etc.).

(8) The latest annual administrative / operating budget for the transportation services provided by the applicant agency. Equipment costs should not be included.

(9) The latest population estimates for the applicant's authorized service area and agency clientele served, with source of the information shown.

Agencies requesting Section 16 funds for the purchase of vehicles (replacement or expansion) must also submit the following information:

(a) A complete inventory of the current vehicle fleet, with the following information provided for each vehicle:

- type (bus, van, etc.)
- license or serial number
- size (length)

- passenger capacity
- special equipment on board (radio, lift, ramps, etc.)
- model year
- odometer reading, date of odometer reading, and whether vehicle is a spare of is used regularly to provide service.

**Agency contact:** Questions concerning the request for proposals should be referred to the Public Transportation Coordinator with the local TxDOT District Office.

**Response date:** Written proposals must be received by the Public Transportation Coordinator, Mr. Tommy Robinson, Texas Department of Transportation, at 4502 Knickerbocker Road in San Angelo, on or before January 18, 1994.

**Selection criteria:** TxDOT will select projects for Section 16 funding on quantitative measures such as demonstrated coordination efforts, ability to operate present equipment on an annual basis where applicable, local match ability, ability to meet service needs of elderly and/or disabled persons based on passenger trips per vehicle per month in urban or rural areas, hours of services, ability to maintain equipment, average fleet mileage where applicable, and average fleet age where applicable. Only those measures appropriate to a specific funding category will be used in evaluating projects within that category.




