## In Memory Of Gene W. Rogers, M.D.

Hippocrates would have been proud.

He, of course, was the father of medicine who in the fourth century B.C. developed the concept that the physician should treat the whole of the person not just some specific problem.

He also developed a code of conduct and ethics that survives to this day.

He taught that physicians should put the interest of their patients first; that they should do no harm but always good.

Gene Rogers understood that.

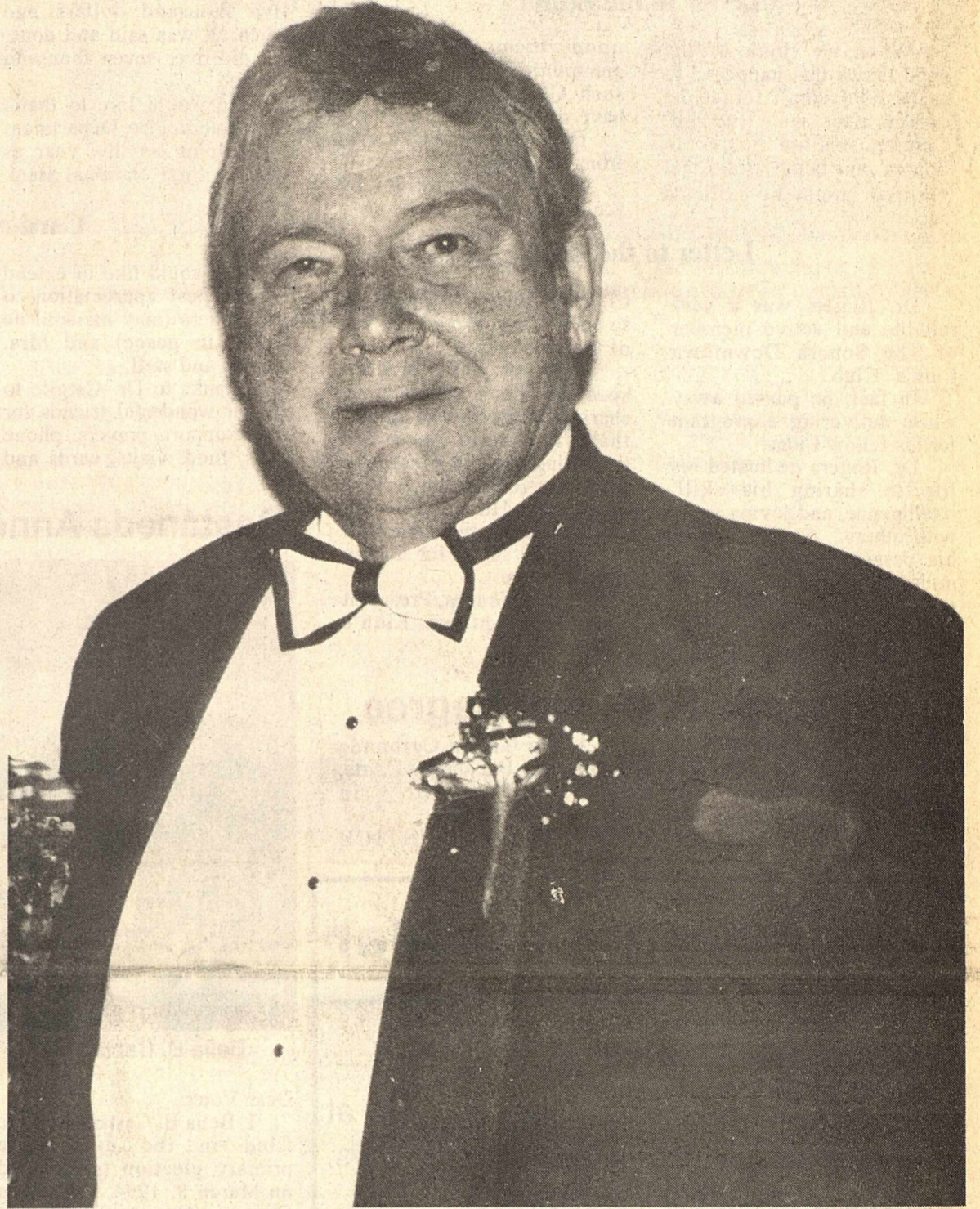
He came to our town two years ago after a successful career in Dallas. He could have coasted through and treated folks and gone home and rested. He had earned it. But that was not his style.

He and his lovely wife Brigitte worked very hard to make our community a better place. He always seemed to be every where at once. He practiced as much medicine on the streets as he did in the office.

He always had time to visit in the post office or the grocery store. "Oh bless your heart, come by the office and see me." "Aren't you a beautiful little girl," he would say to our daughter Julia. Ariel, our eight year old, told me more than once how special "nice Doctor Rogers," never just Doctor Rogers, made her feel. "He knows my name!" It made her proud that the "nice Doctor Rogers" knew who she was.

Doctor Rogers loved the elderly. He always had time for them. He would listen with genuine compassion and care. He always had a minute even when he did not. He never took folks for granted. He treated Hispanics and Anglos, rich and poor, young and old alike. He treated them as people of worth, of value.

No one ever heard him utter a bad word about another person. His staff

loved him and he loved them, yet he would vent his wrath (gentle as it was) only if they were engaging in the slightest bit of gossip. "If you can't say something nice don't say anything." He always said something nice.

Doctor Rogers was a skilled technician who did an excellent job. If that was all

that we lost when he died suddenly last Tuesday, our loss would be great. But we lost more, oh, we lost so much more than that. We needed Gene Rogers the physician. But we lost Gene Rogers the man, and that loss is much greater.

Hippocrates would have been proud to know that

2,300 years later there are still physicians like Doctor Gene Rogers who take their oaths of service as a sacred trust.

I am just proud that I had the chance to know Gene Rogers the man, my friend.

We are going to miss you Doctor Rogers.

If you have a small bear, you may want to put it in the trunk of your car and if you happen to come upon an accident where a child is involved, remember, teddy bears can help emotionally.

# Preventing Victimization

Education is the key to preventing victimization of older Texans at the hands of con artists. The first step in educating older Texans about consumer fraud is making them aware of the scams most commonly directed against them. This book and the presentations of all the speakers will assist you in this regard.

The second step in the educational process is teaching older Texans the actions to take in the face of fraud or suspected fraud. This information is obtained in this section. These strategies empower older Texans to safeguard their assets from preying con artists.

The concept of empowering older Texans is not unique. Likewise, it is our program's goal to persuade older Texans to:

- ...throw away "you-have-won" postcards
- ...hang up the phone on investment offers not known to you
- ...shut the door on

itinerant salespeople offering prices good "only for today"

These strategies of empowerment begin with convincing older Texans that our program will provide them with the tactics needed to thwart con artists. These prevention tips are empowerment tools.

### Basic Prevention Rules

For mail order, door-to-door and telemarketing sales, the first rule is to wait 24 hours before making a purchase. There is no need to rush. An offer from a reputable sales representative will remain available from one day to the next. A reputable sales representative will respect a person's wish to consider a purchase. If the sales representative does not, a person should not do business with him or her.

Consult with trusted people before making an important decision, especially when buying by mail or telephone or from a door-to-door sales representative. Get a second

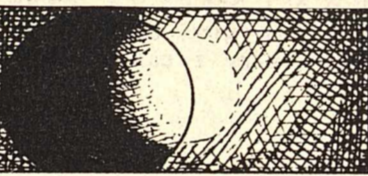
opinion. This provides time to carefully think about a purchase and to obtain a different perspective.

Look out for get-rich-quick schemes, "free" offers, "you-have-won" openings, and high-pressure tactics associated with these pitches. Offers that sound too good to be true, usually are.

Here are more specific preventive measures for older Texans to take to stop fraud.

### Door-to-Door Sales Representatives

1. If you are suspicious or not interested, tell the salesperson good-bye and shut the door.
2. Do not feel pressured to let anyone into your home whom you do not know.

Carla Garner was presented the Coordinator's Appreciation Award by Lenora Pool on Friday, December 17, at the annual Sutton County EMS Christmas Party. This award is presented to an EMT by Lenora Pool in appreciation for extra effort put forth in helping Rural EMS organizations be recognized.

Carla joined the Sutton County EMS in 1988 after receiving her ECA state

competition. In 1989, she earned her EMT license and then was certified as a Lecturer and Examiner in 1990. She is also a CPR Instructor for the American Heart Association.

Carla was appointed to the Texas Emergency Medical Services Advisory Council (TEMSAC) by the Texas Department of Health Chairman for a 6 year term starting in 1990. This committee of 18 reviews and promulgates all rules relating to emergency medical care in Texas. Carla served on a Trauma Advisory Committee called "Brainstorming" to learn how to get trauma messages out to the public. Carla was chosen to be a 3rd committee member by the Texas Department of Health to review 28 grant applications for major hospitals to establish Level I Trauma Center procedures to eventually be incorporated into all hospitals in Texas.

The Sutton County EMS congratulates Sutton County Judge and EMS crew member Carla Garner on receiving this award and is very proud to have her on their team.

Carla is married to Rusty Garner and has 3 children. Carla is the only County Judge in the state of Texas that is part of an EMS organization.

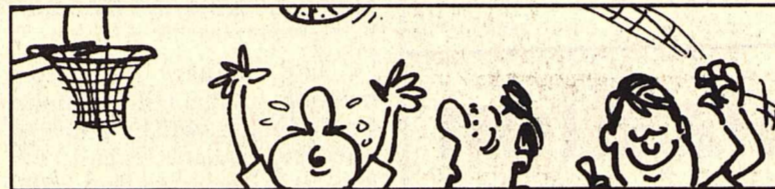

## A Tribute To Dr. Rogers

I am submitting this tribute to Dr. Gene Rogers on behalf of the Board of Trustees of the Sutton County Hospital District. We all admired and respected Dr. Rogers and his death is a tremendous loss to the hospital and to the community.

As I was mulling over what I wanted to say about Gene Rogers, I couldn't help but think of the articles in the Reader's Digest entitled "The Most Unforgettable Character I Ever Met." Gene was certainly not a character in the sense that he was a little different from most of us, but he was unforgettable.

I had the privilege of driving him to the Lion's Club meeting every Tuesday noon. During those drives, we talked and frequently we would park in front of his office and have long conversations. My part in these conversations consisted mainly of answering Gene's questions about the West Texas way of life. This was a whole different world to Gene since he was born and raised in a northern city. He was interested in every aspect of our lives. He wanted to be as knowledgeable as he could about everything. He wanted to know about ranching, about the goats, about the cattle, about the

guns we carry in our pick-ups and the black dogs that ride with us, about the rattlesnakes, the tarantulas, and about any other item that might have come up during the past week. He wanted to know details about work in the "oil patch" that I couldn't answer. He had an unrelenting quest for general knowledge, not necessarily related to medicine.

I detected that he might disapprove of some of the things we do. He thought we took too many risks in working with livestock and he thought that the gas field work was dangerous. In spite of my sensing that he disapproved, he was never critical nor judgmental.

Gene didn't like the fact that medical care is so expensive, but he did feel that we should not compromise the quality of care for the sake of change. He had his own ideas about how we might do better, but like the rest of us, he didn't know how to put them in place.

It was my responsibility to evaluate Gene when he was considering coming to Sonora. I called one of my friends in Dallas and inquired about Gene. My friend's response was, "I've known and worked with Gene for 16 years. I have so much confidence in his skill and

ability that I chose him to operate on two of my children and on my wife." A physician cannot get a better recommendation than this from a colleague.

I called another trusted friend who is the daughter of the founder of the Chester Clinic where Gene worked all of his adult life. Her response was, "Why would Gene Rogers, with his talent, his knowledge, and his ability want to move to a little town in West Texas?" She meant no disrespect to West Texas, but she thought he could better use his talents in a more populated area.

The end of this story is that Gene came to Sonora unknown and in the course of two years captured the respect of the community. He was a good doctor. He practiced a superior quality of medicine in an environment that does not offer the support and facilities that he had previously known. He was compassionate to all and he was genuinely interested in his patients.

Yes, Gene Rogers was a respected friend and in my mind he will remain an "Unforgettable Character".

## Thunderbird Rural Public Transportation CONSUMER BULLETIN

Because of the huge response to our advertised service in Sutton County, we think it would be helpful to our passengers to talk about how our transportation system works and what we must do to keep it running. Here are the basics:

**First**, we try to run as a bus service (high capacity and low cost). This means we must carry as many passengers as possible on each trip. Taxi cabs run at low capacity and charge high fares. If we operated our mini-bus like a taxi, we could not provide low-cost service.

**Second**, we are a demand-responsive system. This works best when passengers call for service well in advance of their required travel time so the driver can schedule as many passengers as possible during the same trip.

**Third**, as a public transportation service, we are similar to a city bus. **Everyone** has access to our service who is willing to pay a small fare: \$0.50 within the city, \$1.00 within the county, \$1.50 if leaving the county. We cannot reserve our vehicle for a specific group or event that would deny access to the public. In other words, we cannot provide private or charter services.

Here are the typical questions asked by Sutton County residents:

"I live near the Kimble County line. How can I get the van to come this far to take me into Sonora?" **Answer: We will schedule a trip anywhere within the county whenever there are enough passengers to make it feasible. The van capacity is ten. We would expect a minimum of seven or eight passengers.**

"I live on a ranch about 12 miles from Sonora. Can you bring me into town?" **Answer: Making a 24-mile round trip to transport one or two people is taxi-cab service. We do not provide that service. (However, see the previous question)**

"I was told that you have special days for passengers to do certain things in Sonora (like shopping). Can't I go where I want to go?" **Answer: Certainly. You tell us where you want to go, we don't tell you. (More questions, please see below.)**

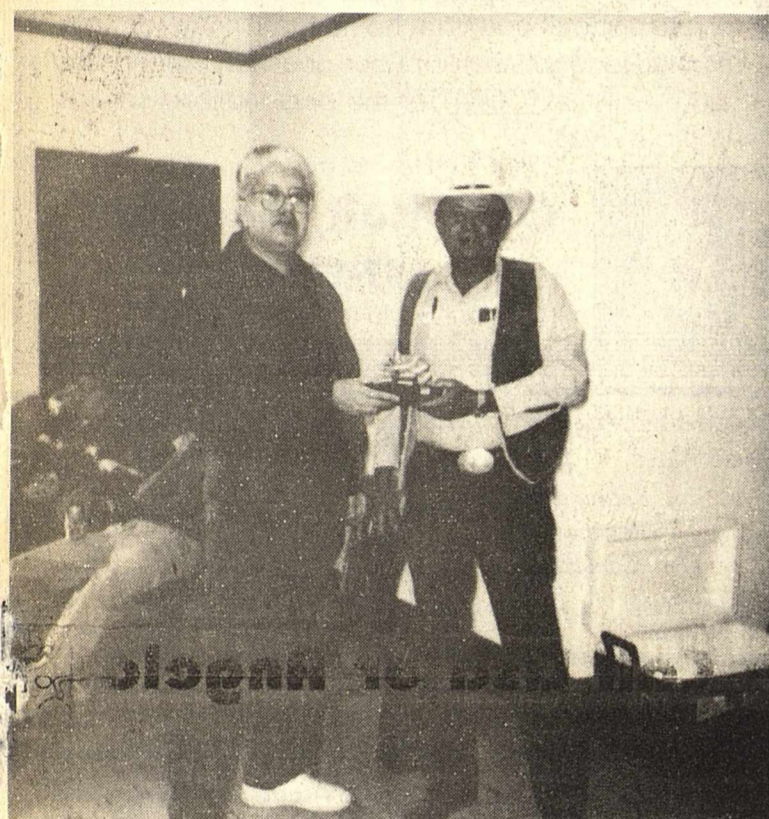

## Martinez Retires



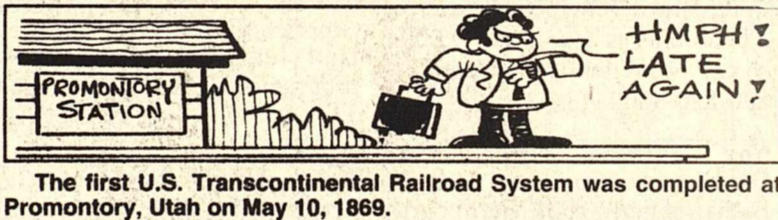
Lemuel Lopez is pictured here presenting a gold pocket watch to Refugio "Cuco" Martinez for his 13 years of service to the City of Sonora.
