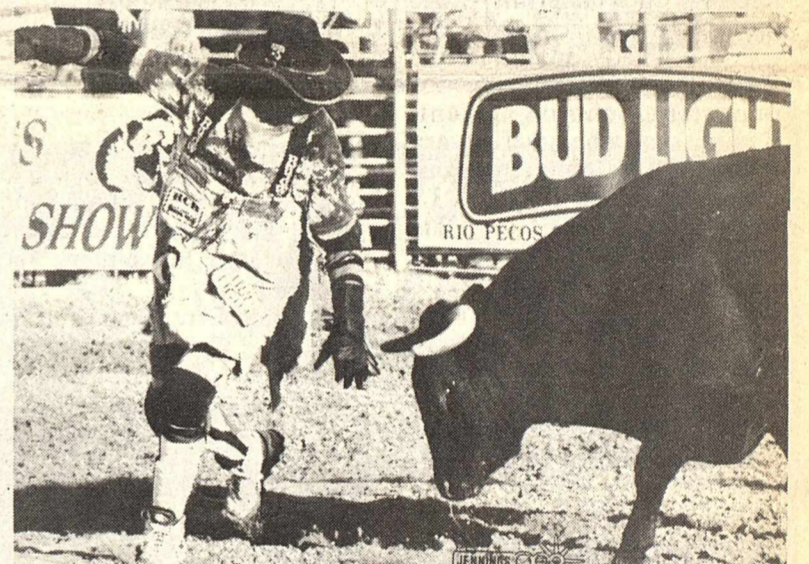
Friday and Saturday, August 26-27, 1994, Sonora will hold its annual Sutton County Days Festival in downtown Sonora on the Sutton County Courthouse lawn and the Outlaw Pro Rodeo at the Sutton County Fair Grounds.

The Outlaw Pro Rodeo will be Friday and Saturday nights at 8:00 p.m. boasting some of the major talent from the professional circuit. There will be an outdoor dance at the Fair Grounds each night; Friday's entertainment will be "Southern Image" from 9:00 p.m. to 12:00 a.m. and Saturday's entertainment will be "Prairie Fire" from 9:00 p.m. to 1:00 a.m.

## Intrasquad Scrimmage Held

Friday night's intrasquad scrimmage at Bronco Stadium was a clear indication that Bronco football is still as hard-hitting and aggressive as ever.

The defensive side, particularly the first team defensive unit, dominated the field when playing as a unit, and according to Head Coach Bob

Bellard the defense is playing "very good quality football right now, and could be playing championship quality football very soon."

After introductory remarks to parents by Bellard and Athletic Trainer Cory Turner, Coach Bellard invited the sizable crowd at Bronco Stadium down onto the field to enjoy the action. If the crowd came to see action, they left happy: the scrimmage was a display of a versatile Bronco offense attempting to break through an already-tough Bronco defense.

Parents and fans enjoyed the close-up look at Bronco football, and several remarked that the game looked very different from the field than from the stands.

The first team defense began the scrimmage with tremendous success, stopping the Bronco offense with sure tackling and two excellent penetration plays by defensive end Trini Banda. The defense continued to apply consistent pressure throughout the second series of play, holding the offense to a series of short gains until a well-executed sprint draw netted ten yards and slowed the penetrating Bronco defensive line.

The third series of plays, however, was the best example

of the new Bronco defense in action. The first two offensive plays, a dive left and a dive right, were stymied by a hard-nosed line backing corps, leading to a fumble in the backfield on 3rd down, and to a fourth and long for the offense. The offense elected to go for a 1st down, and the drop back pass was intercepted by Andy Mirike in a very fine play.

The Bronco offense attempted to vary play selection during the fourth series of downs, but the variations, while having some success, could not break the defense's hold on the scrimmage. The series featured a bruising hit by Adrian Mata leading to a fumble and another interception by the defensive secondary. The offense began to click as this series drew to an end, with the offensive backfield operating smoothly and the line blocking effectively to lead to two good gains, a ten-yard pickup on a sprint draw and a five-yard gain on an option left play.

The offense played well the remainder of the scrimmage, varying sprint out passes, sprint draws, and pitch plays to keep the defense off



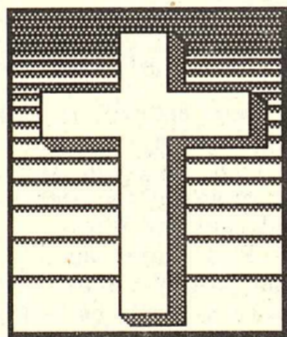

# Dempsey Earns Eagle Scout Award

Curt earned thirty-five merit badges, which include: Astronomy, Athletics, Camping, Citizenship in the Community, Citizenship in the Nation, Citizenship in the World, Communications, Computers, Cooking, Environmental Science, Family

Life, First Aid, Fishing, Geology, Home Repairs, Insect Study, Leatherwork, Lifesaving, Music, Nature, Orienteering, Personal Management, Pioneering, Reading, Reptile Study, Rifle Shooting, Rowing, Safety, Scholarship, Sports, Swimming, Weather and Whitewater.

Other awards earned by Curt are: God and Country, Arrow of Light, Order of the Arrow, Den Chief Service Award, Historical Trails Award, 50 Miler Award, World Conservation Award, BSA Lifeguard, BSA Snorkeling, Paul Bunyan Award, Totin' Chip, Fireman's Chit and Whittlin' Chip.

The Eagle Scout Award is presented to Boy Scouts who earn more than 21 merit badges and successfully complete a service project. Of any one hundred boys who become Scouts, only 2.5 will reach the rank of Eagle.

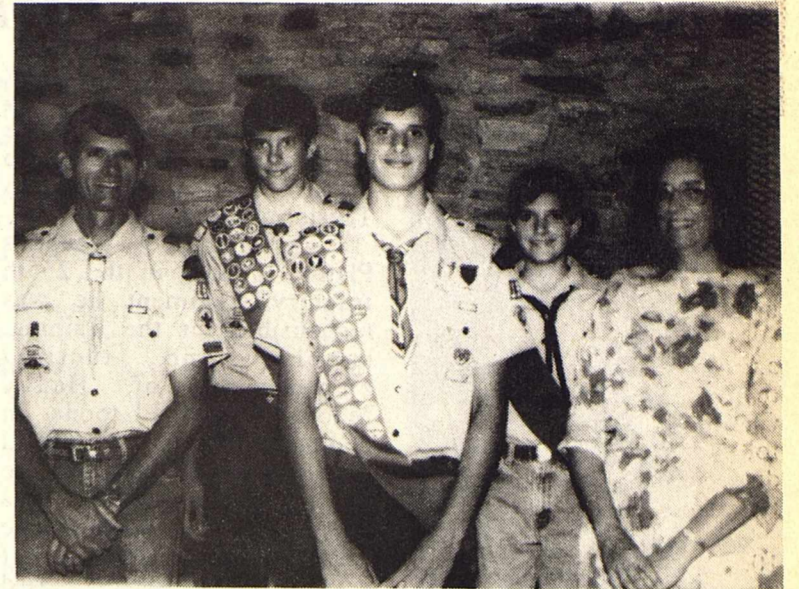

The fourth obligation of an Eagle Scout is to be cheerful. To remind the Eagle Scout to always wear a smile, the red, white and blue ribbon is attached to the scroll of the Second Class Scout award, which has its ends up in a smile.

The final responsibility of an Eagle Scout is service. The Eagle Scout extends a helping hand to those who still toil up Scouting's trail, just as others helped him in his climb to the Eagle. The performance of the daily Good Turn takes on a new meaning when he enters a more adult life of continuing service to others. The Eagle stands as protector of the weak and helpless. # Ask The Historical Society



O.L. Richardson, Jr.

## World War II Veteran O.L. Richardson, Jr.

O.L. Richardson Jr. was born in Sonora, Texas November 22, 1923. He graduated from Sonora High School, a member of the Class of 1941. He promptly enrolled in Texas A&M and with World War II in progress entered Field Artillery ROTC studies. This A&M group of 1,945 artillerymen remained together in school until as Juniors each had passed his 18th birthday and on which day as close as possible each voluntarily enlisted. The case of O.L., however, fell on December 12, 1942. The entire class was subsequently formally inducted into the Army at Camp Walters, Texas then shipped to Fort Sill, Oklahoma to train as artillerymen on the 105 mm Howitzer.

After one week of enrollment in Field Artillery Officers Candidate School the entire group of some 180 Aggies was switched to Fort Benning, Georgia for Infantry Basic Training along with their counter parts from other Universities among which were Duke, Cornell, University of Utah, and a few others, which like Texas A&M, had ROTC schools. Immediately upon completion of this basic training the entire group entered the Infantry School for Officer Training to become Infantry Unit Commanders and/or instructors.

Completing this training the individuals were sent to the four corners of WW II, O.L. being shipped to Ft McClellan, Alabama to join the 63rd Infantry (Blood and Fire) Division and become the First

Platoon Leader of Company M., 255th Regiment, a Heavy Weapons Company. The Division was preparing to embark for the European Theater of Operations.

As a Heavy Weapons Platoon Leader in the 255th Infantry Regiment he was responsible for the training, supply, and tactical employment of Heavy Machine Gun Platoons in combat, coordinated tactical employment with other units to provide supporting fire, was responsible for maintenance and operation of communication and transportation, selected and assigned firing positions and targets for heavy mortars and heavy machine guns, directed firing of weapons, was responsible for and directed the security of the platoons and security training in the use of M-1 rifle, carbines, pistols, submachine guns, hand grenades, trench knife and Browning Automatic Rifle.

The 63rd shipped out to the European Theatre of Operations on November 25, 1944 to join the Seventh Army in Alsace Lorraine, Southern France.

On February 15th in a subsequent action O.L. received three wounds from enemy fire in the course of the morning, and spent the next 15 months in Army Hospitals.

His awards and decorations include the Combat Infantryman Badge, the Bronze Star for meritorious service the Purple Heart, European Theater of Operations with one Bronze Service Star, the American Theater of Operation, the Good Conduct Medal, and the

Victory Medal. Other medals are for qualification with arms and include the Rifle, Carbine, and Heavy Machine Guns.

First Lieutenant O.L. Richardson, Jr. was discharged from active service August 4,

1946 but remained in the Army Reserve another 10 years.

I would like to extend a special thanks to O.L. Richardson. He did such a

wonderful job of compiling his information that all I had to do was type it into the computer exactly the way he wrote it.

**Q. I am looking for information on Henry Shirley. I am hoping that some of your readers might know how he died and some information of his family. Charlene Nelson, 6023 State Street, San Antonio, TX 78223-2932.**

A. The San Angelo Standard in a reprint from the Devil's River News had the following: Henry Shirley Dead Died at his ranch north of Sonora on July 13, 1892, Henry Shirley in his 63rd year. The deceased leaves a wife and large family. He was member of the Masons and they will conduct funeral ceremonies at the grave. The deceased was well known in San Angelo where his numerous friends will regret to hear of his death. Masonic records show that he affiliated with Hopkins Lodge #180 in Cumby, then McCulloch #273 in Mason on 10-9-1880, where he served as Junior Deacon in 1882. He

affiliated with Camp San Saba #555 on March 28, 1885 and served as Senior Deacon in 1885 and was affiliated with San Angelo #570 on March 5, 1892. Did Dee Ora Lodge bury him here or did San Angelo Lodge take him back there? I would appreciate any help the local lodges can give me on this one. We know that Henry Shirley was married to a Sarah Ann Blocker on December 24, 1854 in Pike Co., Arkansas. He was a Civil War veteran, having served 3 years with Griffins Battalion in the armies of the Confederacy. One son, William Henry Shirley married a Sarah Louisa Parker and other children we know of were Jonathon, Jesse B., Anna, and Isaac. 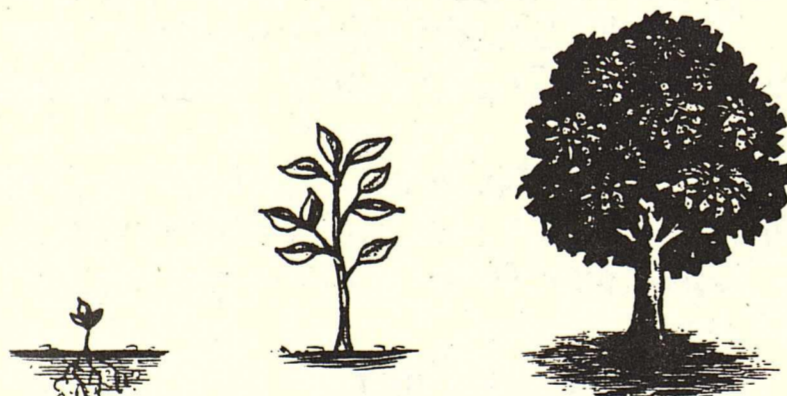

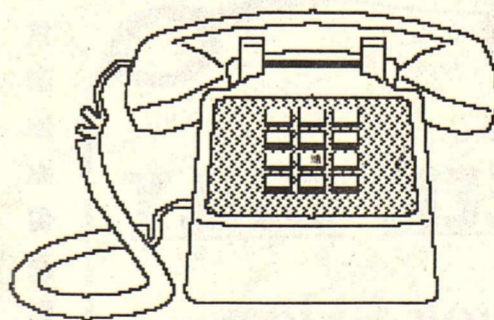

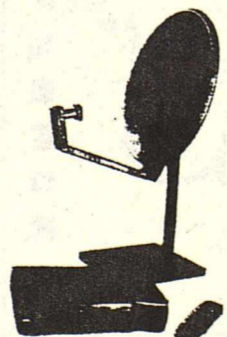

balance and having some success moving the ball. The last offensive series was especially effective, as the fullback, led by a great block by Cody Renfro, gained fifteen yards through traffic on an excellent run.

When asked about the dominance of the defense in the scrimmage until the last series, Coach Bob Bellard explained that he expects the defense to be farther ahead of the offense at this point in the season, Bellard did, however, identify several players who played well on offense: tight end, Jesse Capuchin, right guard, Cody Renfro, fullback, Mike House, and sophomore, Caleb Barker handled himself well at quarterback. Bellard expressed confidence in the development of the offense, stating that he believed he had quality depth at quarterback, tight end, and several other positions on offense.

Defensive coordinator Don Sessom singled out several defensive players from his aggressive unit for special praise, saying that Justin House played very well at safety, Marcus Montez and Trini Banda played well at defensive ends, and TJ Harris and Kelly Morrow at linebacker. Sessom and Bellard both complimented the

fine play of newcomer Raymond Hubble at defensive end, as well. The Bronco defense, according to Sessom, "focused very well on reading their keys and playing extremely solid base defense."

The Bronco defense has a new look this year, focusing more on penetration and disruption of the offense than on reading and flowing to the ball. If this scrimmage was any indication, the new defensive philosophy has a great deal of potential to dominate other offenses this year.

According to Bellard, other than some turnovers that need to be eliminated and some occasional inconsistency, the offense demonstrated potential as well, and this scrimmage was an exciting start to a promising season for the, Sonora Broncos. The Bronco Booster Club and Coach Bellard expressed their appreciation to the large crowd that watched the scrimmage from the field and the stands and stayed to eat flame-broiled hamburgers with the players after the scrimmage.

## Farmers/Ranchers Unite In Property Rights Battle

Farmers and ranchers from across the state, angered by government encroachment on their land and their livelihoods, are banding together like never before to defend their rights as property owners.

"A brush fire has started across Texas," said Agriculture Commissioner Rick Perry. "Property owners all over the state are standing up and saying enough is enough."

In meetings throughout the state, farmers and ranchers are united to discuss their options in the struggle against government intrusion and to pin down bureaucrats and elected officials on their intentions. A recent gathering in Llano drew some 800 property owners who grilled the state administrator for the U.S. Fish and Wildlife Service over the agency's proposal to tighten federal regulation of land use in Central Texas because of a songbird.

Yet while property owners have "recently scored a few victories, the war is still being waged," Perry said. "Now is a unique opportunity in our state's history to have an impact for future generations on the rights Texans have cherished since the days of the Republic."

The issue of private property rights -- and what small landowners can do to protect their liberties from government intrusion -- will be part of a day-long seminar during the annual convention of the Independent Cattlemen's Association (ICA) in San Antonio. The convention will be held August 18-20 at the San Antonio Wyndham Hotel.

The seminar, which kicks off at 9:15 a.m. August 19, will feature a series of presentations by property rights experts and elected

officials. They include Perry, Dr. Floy Lilley, a nationally renowned authority on property rights who holds the Clint W. Murchison Sr. Chair of Free Enterprise at the University of Texas at Austin, and U.S. Rep. Greg Laughlin of West Columbia, who will deliver the day's luncheon address.

Charles Carter, ICA executive director, said while the "property rights pendulum appears to be starting to swing in our favor, that can change in a blink of a politician's eye."

"The fight to protect and preserve the private property rights of agricultural producers is far from over," Carter said. "We absolutely must stick together and continue our crusade. That's why this seminar is so important."

Cost to attend the seminar, including the luncheon and afternoon reception, is \$30. However, because of the critical nature of the issue, the ICA is waiving the fee for individuals who would like to attend only the seminar, but skip the luncheon. In either case, attendees will have access to the convention trade show, which organizers say is the ICA's biggest ever.

To reserve a place at the property rights seminar, attendees should contact the ICA office in Austin at (512) 836-1321. Individuals who already have registered for the

convention will be able to attend the seminar as part of their registration.

The property rights fight was recently bolstered when Lt. Gov. Bob Bullock vowed to fight possible federal designation of 33 Central Texas counties as critical habitat for the golden-cheeked warbler. The Fish and Wildlife Service will decide later this year whether to seek the extra protection for the bird--a move that would further restrict the ability of Central Texas farmers and ranchers to work their land or build on it.

In a separate property rights battle, the Texas Natural Resources Conservation Commission recently dropped its effort to get federal protection for five Texas waterways, which would have meant federal regulation of the waters. Instead, the state will develop its own plans to protect South Bay, Christmas Bay, Barton Creek, Caddo Lake and the waters of Guadalupe Mountain National Park.

"Property rights are being treated like dirt," said Dr. Lilley, the UT scientist. "They are the forgotten Civil Right."

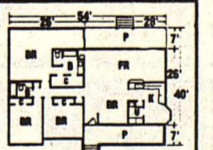

I would like to take this time and talk about an extraordinary person, Lenora Pool. In August of 1979, Lenora became a member of the Sutton County EMS. If you'll remember, at that time, the ambulance service was located at the Hudspeth Hospital, and the EMS were telephoned from their homes when needed. The crew consisted of a driver and an EMT in the back of the vehicle to

take care of a patient. In 1982, Lenora was hired by the Sutton County Commissioners to be the EMS Coordinator. This meant that she had to make sure students were taught the right procedures and were able to pass the State Exam distributed by the Texas Health Dept. in order to become an EMT. I am one of the people she worked and spent extra time with to help me do what I wanted to, which was to care for the people of this community. In 1984, the first EMS By-Laws for the organization were established. Lenora served as Coordinator/Treasurer for the first year. In 1985, the Gene West Memorial Award was established by Francis West in honor of her late husband. Lenora was granted the honor of receiving this award at the annual EMS Christmas party on December 13, 1985. This award is given to an EMT annually in recognition of their roles with the EMS. Lenora has since held many classes, and trained many people; some of which are today's EMT's and volunteer with the EMS here or in some other community. Lenora has

spent numerous hours attending classes and medical seminars, only to bring back her training to the EMS in Sonora so that we too may be trained in a professional manner for helping our community.

In 1992, Lenora was certified as an Advanced Trainer of Critical Incident Stress and Post Trauma Syndromes. She is a CPR Instructor with the American Heart Association, an Instructor/Examiner with the Texas Health Department, and the Coordinator of the Sutton County EMS. Lenora is married to Ben Pool, owner of American Sales and Service. Ben and Lenora have 5 children.

### Did you Know:

Each year in Texas, thousands of children sustain fire, scorching or scalding injuries. Many severely burned children die from these injuries. In 1992, burn injuries was the fourth leading cause of death among children in Texas, 1 to 19 years of age. The Texas Dept. of Health's "EMS for Children" program, suggests the following procedures to help prevent the burns of children:

1) Turn pot handles out of child's reach while cooking on the stove.

2) Use short appliance cords and do not let them dangle off the counter.

3) Make sure microwaveable foods are not too hot, especially on the inside.

4) While cooking, place young children in playpen or crib.

5) Adjust hot water temperatures to 120 degrees. Temperatures above 140 degrees can cause serious burn injuries.

6) When preparing a child's bath, run cold water first, then add warm water.

7) Cover unused electrical sockets with plastic plugs.

8) Keep children away from plugged in electrical cords. Biting into or chewing on an electrical cord could cause serious burns to the mouth, as well as electrocution.

## City Council Met

The City Council met on Tuesday, August 16, 1994 in the City Hall, Council Chambers.

The council approved the bid from Broncho Ford for a Ford 350, 1 ton truck with dump bed for the Street Department at a cost of \$18,975.00. Also approved was the Broncho Ford bid for the Ford Ranger, 1/2 ton pickup for the Parks Department at a cost of \$11,804.00.

The naming of the park adjacent to the Golf Course was approved and is now officially called "Will Carver Park".

The council accepted the

proposal that a portion of Water Street in front of the Court House be closed for Sutton County Days.

A resolution supporting the Texas Department of Transportation to pursue a "truck route" to relocate large truck traffic from R.M. 1691 to a location outside the City of Sonora was approved.

Council members approved the request to change Galindo Street to Mata Street.

During the Public Works Report, the members were also informed that the tearing down of the old swim pool would begin in approximately two weeks.

West Texas Utilities Company today announced it will file a petition with the Public Utility Commission of Texas (PUCT) to start a process to review WTU's revenues, rule on proposed rate changes and implement lower interim electric charges to customer by 3.25%.

The petition, to be filed around August 25, will request that a review of WTU's revenues be conducted by the PUCT to determine if WTU's revenues should be adjusted. The petition proposes interim rates until the PUCT can complete this review.

Until a final PUCT order is implemented, interim charges to customers will be reduced by 3.25%, effective October 1, 1994.

"The action to initiate this review process by WTU is quite

remarkable since some other electric utilities have recently increased rates," said Glenn Files, WTU president and chief executive officer.

WTU's customers have not experienced a base rate increase since 1987, even though the average overall cost of living has increased nearly 30% over that same period.

"WTU, however, has effectively managed the business and, as a result, we have remained financially strong. Our strong financial position has allowed us to be a key player with the communities we serve in economic development activities," Files said.

"The action we are announcing underscores our commitment to the growth and prosperity of the communities we serve," he added.

"Reasonable electric rates and rate options are important to our customers and to prospective customers. Therefore, WTU will use this process as an opportunity to introduce new rate options in response to market changes and modify or replace old rate options. These changes are necessary for WTU to continue to be responsive to the changing marketplace and to meet the needs of our customers," Files added.

"Our company has always had a commitment to ensuring that our rates are fair and that our customers are paying appropriate prices," he added.

"After reviewing our current and projected financial results and after discussions with the PUCT and others, we are announcing this action. The action will ensure that our customers benefit from activities that have resulted in efficiencies in our service to the customer," Files added.

"Also, as part of our commitment to ensure the benefits are passed to our customers in a timely manner, we are proposing to set the effective date for any revenue

adjustment and new rates implemented as October 1, 1994, regardless of when the PUCT issues its final order," Files added.

"It is not clear at this time what the total amount of the overall base revenue change may be or what impact this overall base revenue change will have on customer bills. Those determinations will be made during hearings before the PUCT after a careful review of our financial numbers, the proposed rate changes and some assumptions made by the PUCT staff," Files added.

"But the point is that the overall base revenue that WTU receives from its customers for the electricity could be lower than it is today," Files added.

In addition to the PUCT review of utility rates, a city may also review and analyze its electric utility rates under another formal proceeding.

"We are proud of the strong relationships that we have with the communities we serve. It is from these types of relationships that we have been able to work together to benefit our customers," Files added.

Catholic church. In his spare time, Meza enjoys fishing, playing baseball and other sports.


