## MARIJUANA SEIZED

Thirteen packages of cellophane wrapped marijuana were seized by local law enforcement officers Thursday, January 19, 1995. The estimated street value totals \$478,900. Four persons were arrested that same day. They were charged with aggravated possession of a controlled substance and possession of a controlled substance without a tax stamp. Two others were caught and arrested the following day.

DPS trooper, Norbert Ortiz, made the initial stop for traffic violations. Ortiz attempted to stop two vehicles simultaneously. While he had identified four occupants of one car, the other vehicle attempted to flee. A manhunt was ensued but called off at 10:30 p.m., without producing the two suspects.

The following day, Sutton County Deputy, Oscar Chavez, identified one of the suspects at the J.V. Mobile Home Park. Deputy Chavez made the arrest. The other suspect was caught and arrested later that day.

## BARTON WINS CASHMERE COMPETITION

For the third consecutive year, James Barton of Sonora has captured the National Cashmere Goat Shearing title. He also won a ribbon for the cleanest shorn goats. This is a new award added to competition this year. Mr. Barton stated when it was announced he had won this award, he assumed he didn't win the overall competition. He also stated this is his last year to compete but he plans to be involved in promoting the competition.

The competition is held annually at the National Western Stock Show in Denver Colorado in conjunction with the Cashmere Goat Show. Competitors are judged on time, absence of second cuts, fleece condition, body position and goat handling, appearance of shorn goats, and absence of cuts on goats.

Mary Beth Turney also of Sonora placed second, Kris McGuire of Laramie, Wyoming placed third, and Russ Nelson of Larkspur, Colorado placed fourth. Mrs. Turney is very active in the production of Cashmere in this area.

The competition is sponsored by Oster Professional Products Division.


## LIBRARY TO BE CLOSED TEMPORARILY

## SONORA MUNICIPAL SWIMMING POOL/RECREATIONAL AREA

After hearing many people express their concern about the cost and need for the new swimming pool, I decided to check into it and pass my findings along to our readers.

The first thing I feel should be expressed is that this is not just a swimming pool. The city council has done an excellent job of designing a recreational area that can be utilized by people of all ages. Included in this recreational area will be a basketball court, a sand volleyball court, tether ball, covered picnic area with grills, a large swimming pool, a wader pool for small children, a bathhouse with changing rooms, a concession area, and a waterpark-type slide.

This project began in January of 1993 when an application was submitted to the Texas Parks and Wildlife Department for a matching grant. The city received the grant for the amount of \$269,000. (Half of the \$538,000 proposed for the swimming pool/recreational area.) Since the city received this grant, they are obligated to spend at least \$538,000 on this project. The city's half of the money can come from the budget, grants, donations, in-kind labor, etc., as long as it totals at least \$269,000. (The city received \$7,500 from Meridian Oil and recently received a \$1,000 donation from an individual to go towards the cost of the swimming pool. The city welcomes and appreciates all donations, no matter what the amount.)

The old swimming pool was constructed in 1964 and required major repairs annually due to deterioration and leakage. Maintenance costs for the pool escalated to the point that it was no longer feasible to expend funds on the old, worn, and obsolete facility. (An average of \$3,600 in maintenance costs and 360 man hours were spent yearly for the past five years before the pool could be opened.) The pool also did not meet the current minimum standards for swimming pool design, and, as a result, safety and liability became a major concern for the city. The pool





## SONORA MUNICIPAL SWIMMING POOL/RECREATIONAL AREA

would have been forced to close within two years. The Sonora Municipal Swimming Pool is the only source of water-related outdoor recreation within our county, therefore it is very popular and heavily used during the summer. With all of this in mind, the city designed a swimming pool and a recreational area to serve not only swimmers, but also allow for other activities as well.

The new swimming pool will be 5670 square feet (compared to 3690 square feet for the old pool) and the wader pool will be 400 square feet (compared to 360 square for the old wader pool). The pool will hold 193,571 gallons of water, compared to 146,421 gallons of water for the old swimming pool. The new pool has been built with a sufficient circulatory system so that it can be filled one time and remain filled. The old pool had to be drained at the end of each season and refilled at the beginning of the next. In addition to the amount of water it took to fill up annually, the old pool lost millions of gallons of water yearly due

to leaks that could not be repaired. In 1991, 6.07 million gallons of water were used during the summer, in 1992, 4.5 million gallons, in 1993, 4.0 million gallons, and in 1994, 3.5 million gallons of water were used. (All figures include the initial fill-up).

Before beginning this project the city received letters of support from Sutton County, Sonora Independent School District, Lillian M. Hudspeth Memorial Hospital, the city auditor, Senator Bill Sims and the Texas Department of Health. In a Texas Cities Analysis and Planning Program Survey (sponsored by the Sonora Chamber of Commerce, the Texas Agricultural Extension Service and the City of Sonora) a swimming pool was the number one need expressed by those answering the survey.

During the January 17th city council meeting, the council approved the purchase of a 90 foot water slide. (The vote was a tie, with councilmembers Marie Barrera and Fred Perez voting for the slide and Bob Mooney and Jaye "Butch" Campbell voting against. Mayor Margaret Cascadden broke the tie by saying "I am voting for the kids - in favor of the slide.") Since the new

swimming pool will be larger than the old facility, more surface area will be provided, which will help alleviate the crowded conditions. With the addition of the water slide, the project provides the first recreational opportunity of this type within this area.

During a special meeting of the City Council on Tuesday, January 24th, the city voted on admission costs for the swimming pool/recreational area. A motion was made by councilmember Jaye "Butch" Campbell to raise the cost of admission to \$2.00 for the swimming pool/complex and \$1.00 for the use of the wader pool. The vote ended in a tie with Ms. Campbell and councilmember Bob Mooney voting for and councilmembers Marie Barrera and Fred Perez voting against. Mayor Margaret Cascadden voted against the raise, stating that the increase was too great. Ms. Barrera made a motion to raise the cost of admission to \$1.50 for everyone for the use of all facilities, including the wader pool, and to increase the cost of private parties from \$40 to \$50. The vote again ended in a tie, this time with Ms. Barrera and Mr. Perez voting in favor and Ms. Campbell and Mr. Mooney voting against. Mayor Cascadden voted in favor, breaking the tie.

This project proposal maximizes the use of funds in that the largest portion of monies expended will be used directly for providing basic recreational opportunities. A wheelchair lift into the pool provides innovative recreational opportunities for persons with disabilities in excess of legal requirements. The project also improves the recreational opportunities for low income, minority, and elderly citizens, many of whom live in the immediate vicinity of the project area.

The need exists for higher quality and a wider variety of outdoor recreation opportunities. The types of activity this recreational area will provide are projected to be some of the most popular in Region 10 and throughout Texas in 1995, particularly the water-related activities. With the help of the Texas Parks and Wildlife Department, the Sonora Municipal Swimming Pool project will fulfill these recreational needs, while remaining within the budget constraints of the community.

The swimming pool is scheduled to open for the 1995 regular season.

## Continuing Education

We believe that it is essential that we attend continuing education courses throughout each year in order to keep up with the latest developments in dentistry. Generally, we attend these courses at the dental school in San Antonio and we are only out of the office on Friday and Saturday.


Our most recent courses have been on Emergency Training and CPR, Cosmetic Dentistry, Dental Implants, and Temporomandibular Disorders.

Something that we are doing at a younger age are hard acrylic night guards on patients that have more than average wear on the biting surfaces of their teeth. We hope to prevent excessive wear of the teeth and maintain a more youthful and healthy appearance. Excessive wear can cause severe tooth pain and possible abscess and also can cause TMD problems.

Also, since many of our patients have had some recession, either from previous gingival surgery or from other causes, we are recommending the construction of an appliance that can hold fluoride and other medications in close contact with the root surfaces to reduce sensitivity, to prevent decay, and to help combat the bacteria that cause gum disease.

## Orthodontics

L.M. Pollard, D.D.S., is at our office to do orthodontics (braces) every other Thursday. Dr. Pollard does both adult and children patients. He also does interceptive orthodontic treatment on those children that would benefit from this type of treatment.



## Sterilization


All of us want to be sure that we are protected when we go to the dentist. We want our patients to know that we follow every guideline to make sure that your visit is safe. All our drills and instruments are sterilized after each use. We also have our autoclaves monitored each week to be sure that they are working properly. We also use many disposal items. These items are used on only one patient and then discarded. We want you to feel completely safe at our office.

## TMD

TMD (temporomandibular disorder) symptoms can include teeth, neck, ear, head and back pain. It can also include ringing in the ears, sinus problems, clicking and popping of the joint, grinding of teeth, locking of the jaw, and pain of opening the jaw or pain while eating. Many of us now believe that TMD is actually many different, but related disorders. Causes of TMD include joint disease like arthritis and trauma such as a severe blow to the head, malocclusion, stress, and grinding and clenching the teeth. It is true that most patients that suffer TMD are women. This may be because women have ligaments that are looser than men's and because women's joints are aligned slightly different than men's. I believe that the treatment for TMD should be conservative and reversible. I usually recommend a bite plane and the use of over the counter anti-inflammatory medications and the use of hot and/or cold packs, and a soft diet. Usually, this conservative treatment works for most patients.

## Advanced Technology

Advanced technology has come up with two new types of crowns (caps). One is the VITA In-Ceram all-ceramic crown. This new crown is the state-of-the-art, with high strength, biocompatibility, and excellent esthetics. It is especially useful for anterior crowns. This system is also used for high strength and accurate ceramic inlays and onlays. The other new system is the CAPTEC crown. This crown uses 22 carat gold and porcelain to produce exact fitting and very esthetics crowns. We are very happy to provide these services for our patients.

In the middle of the shampoo, the beautician discovered that she was out of a product that Patsy always used. Patsy had some at home, so she put a towel over her head and went home for the hair rinse. When she arrived home, she discovered that the door was unlocked. As she entered her home, she smelled freshly brewed coffee. She went in cautiously, and was surprised to see a woman sitting at her breakfast table drinking coffee and reading the newspaper.

"Who are you?" she gasped.  
"Just who are you?" the woman replied.  
"I live here. This is my house. Who are you and what are you doing here?" asked Patsy.  
"I found the door open, and I am having a cup of coffee," the very relaxed woman replied.  
Patsy noticed that the woman was drinking out of a cup that her husband usually uses. She had put some money in the cup for him, and she rushed to the cabinet to see if the money was still there. The money was safely on the shelf.

"We don't steal things", the woman said. "All I want is some coffee, some food, and a few minutes of rest. If you had stayed away all day, I would have eaten, bathed, and washed my clothes. If you will look, you will see that I washed your breakfast dishes, cleaned off your cabinets, and started cleaning your stove. I don't steal."

Patsy's shock gave way to curiosity, and she asked who the woman meant by "we".






