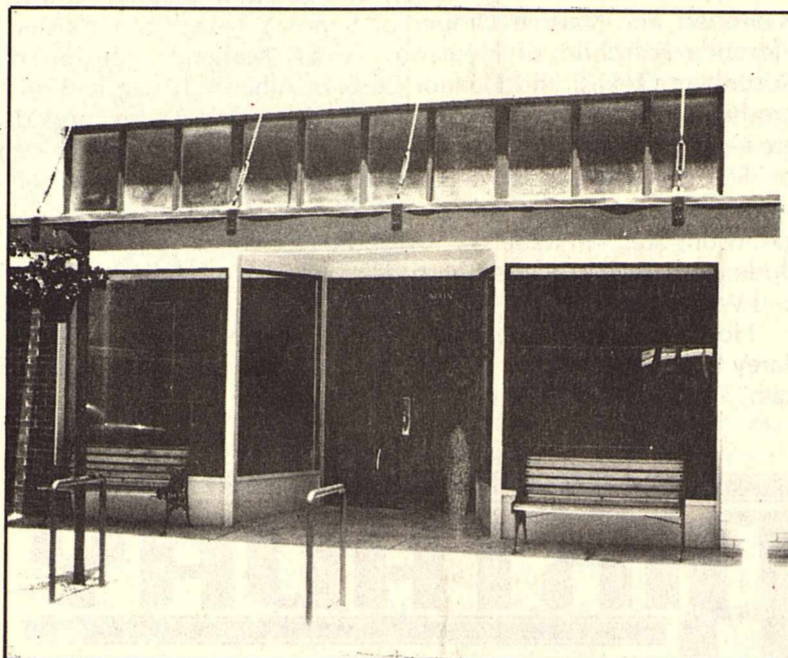

CITY HELD BUDGET HEARING

The City Council met Saturday, August 5 for a special budget hearing and briefing. The purpose of the meeting was to discuss revenue enhancements. City auditor, Phil Sagebiel with Sagebiel & Ravenburg, was present.

Mr. Sagebiel reviewed possible enhancements and suggested a number of options. To increase the general fund, assess a charge for non-emergency police calls, charge a year round fee for mosquito spraying, increase the swimming pool entrance fee from \$1.50 to \$2.00 per day, and increase inspection fees by 50%. The enterprise fund can be increased by raising water rates outside the city limits, charge interest on late utility bills, raise sanitation fees for customers outside city limits, and raise landfill user fees.

Mr. Sagebiel stated he was glad the council made the effort to get expenses down and consider revenue enhancements. Because of this effort, Mayor Pro-tem Butch Campbell, informed those present that at this time there will be no decrease in personnel.

City Manager, Kelly Carta, expressed that even though rates will be raised, the city did cut approximately \$200,000 from the budget. He feels that the meeting was successful.

A public hearing on the budget will be August 29.

Q. I am having trouble finding a date of birth for one of my ancestors. Census records show approximate year born but there are no birth certificates on file. Do you have any suggestions?

A. My first suggestion is to try to find out if anyone has a family Bible. Many times births, deaths, and marriages were entered into the family Bible. If you know the date of birth within a year or two you could check out the newspapers for that time frame. An example is the following: *Devil's River News*, January 31, 1891

Born to Mr. and Mrs. E.W. Wall, on January 29th, a son.

Check out death certificates for dates and places of birth and check cemetery records or the dates engraved on the stones. Sometimes these dates are not correct but they usually are fairly close. Look for military service records as they list date of birth. Another place to look are insurance policy applications, Masonic records, church records and possibly old medical records.

Just remember you are not the first person to have this problem. Many researchers have gone through what you are now experiencing. Some have never been able to locate the information. We wish you luck.

As long as we have the 1891 paper out let's see what else is going on around the area.

stockmen of western Texas at the office of the *Texas Stockman and Farmer* for the purpose of taking some action that would help secure the passage of a wolf-scalp bounty law. Among those present were P.H. Ross of Kerr County; L.B. Crouch, Captain John T. Lytle, John Little, David Little, of Frio County; N.T. Wilson of Val Verde County; Mr. McElroy of Kentucky; William Gerfers, Henry Fink, Richard Mecke, Mayer Half, R.R. Clarridge, C.P. Stafford, Jr., Voires P. Brown, E. Arnaud, of Bexar County and a number of others. It was suggested a fee of \$2 for coyotes and \$5 for loafer wolves and panthers be assessed.

The *Devil's River News* will shortly occupy its new office at the corner of Main Street and Concho Avenue.

A jolly hunting party left Sunday morning in a hack for the Mayer Ranch, fixed for a good time. They shot (at) a great deal of game and after a pleasant day with Sol Mayer came rolling home in the moon light. Max Mayer, Henry

cited as circumstantial evidence but must be supported by an explanation: land; tax; military; church, cemetery, and tombstone records; obituaries; and court records.

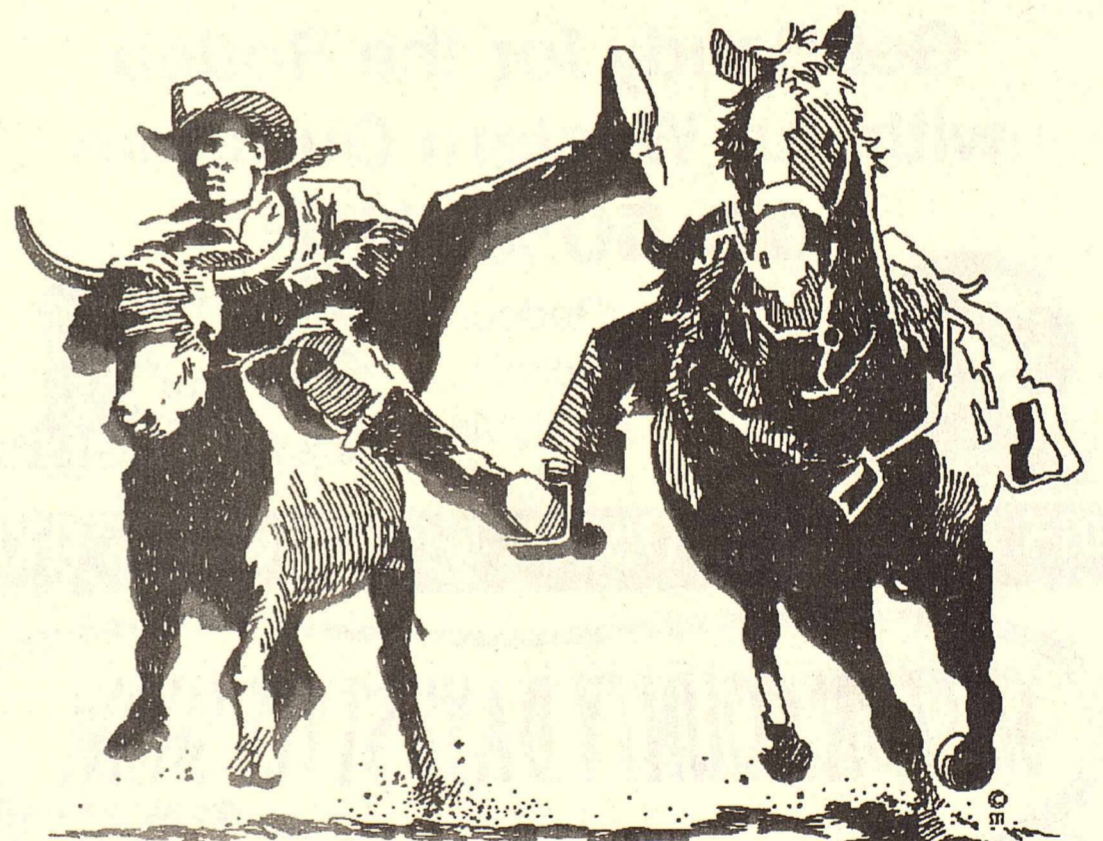

EMS NEEDS VOLUNTEERS

An ambulance is needed, you grab the phone and dial 911. When the Sheriff's office answers, you give the dispatcher all the information and within approximately four minutes the ambulance is speeding your way.

Let's backup and see what takes place during those first few minutes. When you hang up, the sheriff's office dispatcher sets the pagers off and all over town ambulance volunteers are alerted to the call. The three people on call drop whatever they're doing and quickly respond to the EMS building. Average daylight call out time is approximately three minutes. Not bad when you consider the volunteer could be at home in J&V Trailer Park, shopping with their children, mowing their lawn, baking a cake, working a regular job, or doing any number of the normal daily activities.

Calling these people volunteers can be misleading. All of them have spent long hours studying and many more hours practicing their skills. Nearly all started out with the 40 hour Emergency Care Attendant Course and most have gone on to earn their Emergency Medical Technician license. The members meet on Monday nights to schedule for that week. The first Monday of each month is also the business meeting for the Ambulance Organization and the third Monday is the training meeting where skills are practiced and kept up to date.

This particular ambulance crew was organized in a unique way over the last few years, from a struggling necessity to a fine asset. The system is set up on 12 hour shifts with two or three man crews. Shifts from 6:00 a.m. to 6:00 p.m. and 6:00 p.m. to 6:00 a.m. maintain constant service to Sutton County and Sonora. Each Monday evening a schedule is set, enabling each volunteer to work shifts convenient to them in most cases. This also enables personnel to hold other permanent jobs and still pursue the medical field. Sutton County has furnished each member with a pager to provide more efficient service. This enables everyone to go about their lives without having to stay at the EMS building when on call.

There is always a need for more people; to maintain a high level of service. We are in need of more volunteers. If this article has caught your attention, talk to some of these people and get a closer view, it might be right up your alley. Sutton County EMS is located at 211 E. 3rd, and our phone number is 387-5132.

Sutton County EMS will be holding an Emergency Care Attendant course this fall.

TEXAS SUPREME COURT CLARIFIES HUNTING LEASE WAIVERS

Landowners who lease their land for hunting often obtain waivers to minimize their liability. Recent rulings by the Texas Supreme Court have clarified what a waiver should contain.

"A waiver is defined as the intentional relinquishment of a known right," says Judon Fambrough, attorney with the Real Estate Center at Texas A&M University and author of *The Texas Deer Lease*.

"To be effective, the release provision must be based on an offer and acceptance where the parties have equal bargaining power," says Fambrough. "For example, parents cannot release in advance a minor's right to recover for personal injuries caused by the negligence of another."

Likewise, the agreement for release must be based on consideration, but it need not be monetary. An agreement not to sue in exchange for hunting rights may be sufficient.

Recently, the Texas Supreme Court added three requirements for an effective waiver agreement. First, there must be a statement in which the hunter expressly releases the landowner from any acts arising, "from the landowner's negligence."

Second, the written contract must give the hunter fair notice of the release provision. The fair-notice principle focuses on the appearance and placement of the provision, not its content.

"The fair-notice requirement is not necessary if the landowner can prove the hunter had actual notice or knowledge of the provision," says Fambrough.

Third, the release provisions must be conspicuous. The element of "consciousness" is tied to the "fair-notice" requirement.

"Basically, the release provision must be conspicuous enough to give the hunter fair notice of its existence," says Fambrough. "What is conspicuous? There's no real answer."

Fambrough suggests several ways to make a provision conspicuous. These include emphasizing entire paragraphs, not just a portion; placing provisions at the beginning or end of the contract on a separate sheet of paper; use of italicized headings and having hunters initial the waiver paragraph if it is part of the contract or to sign the page if it is a separate sheet.

FIRST FAMILIES OF TEXAS COMMEMORATIVE CERTIFICATES

Editor's note: The following is reprinted from the Texas State Genealogical Society Newsletter, May 1995, Volume 6, Number 1. Sutton County residents interested in applying who need assistance may contact Jo-Ann Palmer, secretary of Sutton County Historical Society. Mrs. Palmer will conduct Sutton County research only at \$10 an hour plus copying costs.

In commemoration of the 150th anniversary of Texas as a state in the United States of America, the Texas State Genealogical Society offers a First Families of Texas certificate. Anyone directly or collaterally descended from a Texas resident of February 19, 1846 or before, may apply for this certificate. Current Texas residency or TSGS membership is not necessary.

The applicant must prove descent from the ancestor (male or female) by an official record for each generation, including proof for the applicant. Proof that the ancestor was in Texas by this date should also be provided by an official document. Collateral descent must be through a brother or sister of the early Texan. Applications and photocopied proof of descent

should be sent along with a \$25 check or money order. A separate application must be completed for each Texas ancestor and the \$25 fee must be submitted for each ancestor.

Information that applicants provide as proof of lineage will be a valuable addition to the history of Texas and a source of information for future generations. All applications
