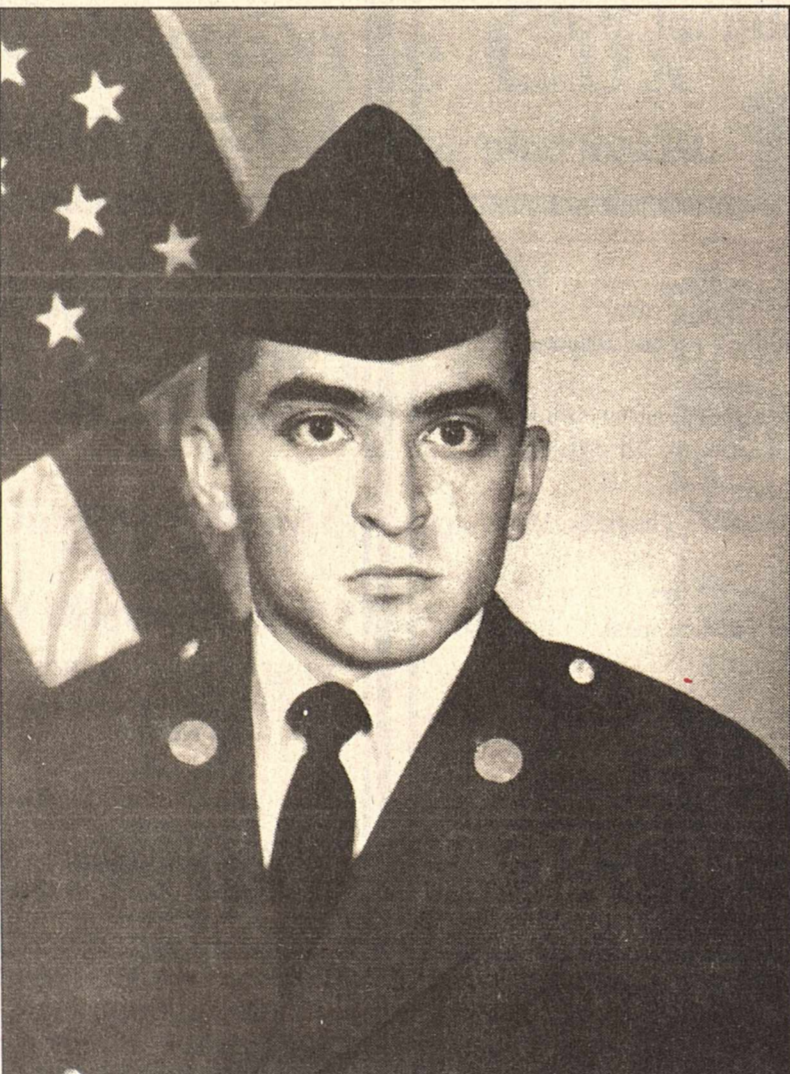
## Texas Folklife Festival: Silver Anniversary

## Balas Awarded \$10,000 Scholarship

Tonni M. Balas was awarded a \$10,000, four-year Houston Livestock Show and Rodeo FFA scholarship today in special ceremonies at the Texas State FFA Convention held in Houston.

Tonni, the daughter of Louis Balas of Sonora, was a member of the Sonora FFA chapter and plans to major in animal science at Texas A&M University. Tonni recently graduated seventh in her class at Sonora High School. She served as FFA chapter president, district president, area vice president, and District Miss FFA. Tonni received the Star Chapter and Star Lone Star Farmer degrees, was a state convention delegate, participated in horse, dairy and land judging, and was a member of the conducting and radio teams.

The Texas FFA is dedicated to making a positive difference in the lives of young people by developing their potential for leadership, personal growth, and career success through agriculture education.

"We take great pride in remaining the largest donor of scholarships to the Texas FFA, having provided almost 1,000 FFA members with scholarships at a commitment approaching \$8 million," said Jim Bloodworth, Houston Livestock Show and Rodeo President.

Recipients of the Show's FFA awards were chosen by members of the Texas Education Agency. The selected students all demonstrated academic excellence and strong leadership skills throughout their high school careers. All Houston Livestock Show and Rodeo FFA scholarship recipients must pursue a degree in agriculture or life sciences at a Texas college or university.

The Houston Livestock Show and Rodeo scholarship presentations were part of week-long activities at the 68th annual

Texas State FFA Convention, including workshops, seminars, and the election of new state FFA officers. Approximately 7,000 FFA members, teachers, parents, and friends were a part of this year's conference. Guest speakers included NASA astronaut Major Rick Husband and Texas Commissioner of Agriculture Rick Perry.

More than 61,000 young people are members of the Texas FFA, which represents approximately 14 percent of the national membership total.

The 50 scholarships present-

ed by the Show were funded through net proceeds from the 1995 Houston Livestock Show and Rodeo and are only a part of the \$2,470,000 in scholarships to 317 students awarded by the Show this year. In addition, the organization also gives graduate assistantships worth \$360,000, school art contest scholarships valued at \$70,000, more than \$150,000 in research grants and various other contributions to Texas colleges and universities. These contributions bring the Show's 1996-97 educational commitment to more than \$3.5 million.

# OPEN LETTER

July 17, 1996

Dear Editor:

It is a sad thing to watch vengeance served when justice is called for.

That is exactly what happened at the July 16th school board meeting. Three members of the school board denied SISD and the superintendent the right to defend against a TEA investigative report that was full of misinformation, false allegations, and downright lies. I have read this report, and some of these incidents go back over three years to when I served on the board. These findings no where near represent the truth.

Is the truth so damaging that it cannot be revealed lest a house of cards comes tumbling down?

How can anyone hold his head high when denying one of our most cherished freedoms-due process?

What is really sad is to think of the great number of our forebears who made the ultimate sacrifice in defense of these special freedoms, and them to watch this action by these board members' insolently thrown on their graves. To not give a man or an institution a chance for self-defense is indefensible.

I cannot believe anyone in his right mind would want the bureaucratic, socialistic tentacle of the TEA in our school. 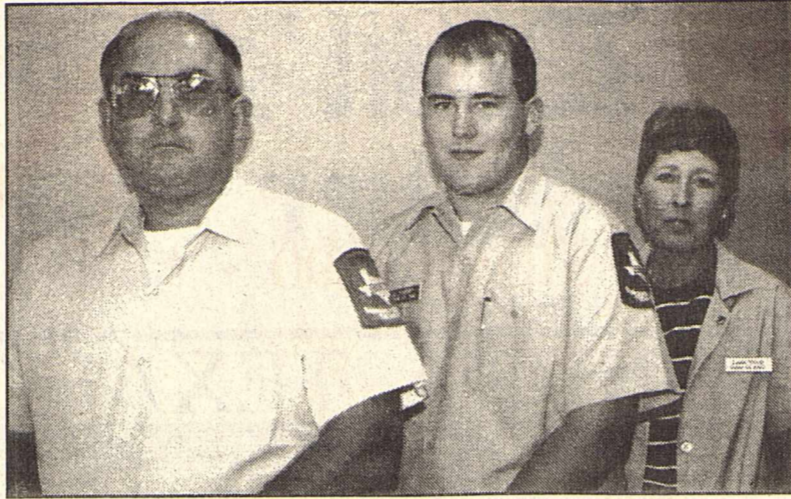

## A Family of "People Who Care"

When local residents mention our ambulance service, they should think of the Tim Thorp Family. Tim, Leslie, T.J., and Joni have lived in Sonora all of their lives. They operate Thorp's Laun-Dry and a ranch west of town. If you know the Thorps, then you may know what dedicated citizens they are to the Sutton County Emergency Medical Service.

In March 1982, the local ambulance service was moved from Hudspeth Memorial Hospital to the Sonora Volunteer Fire Department where it stayed until March 1983. When the ambulance was moved from the hospital, Tim Thorp, a fireman, took an Emergency Care Attendant Course (ECA) and began working with the ambulance service. By July 1984, Tim still helped on the ambulance, had completed an eighty hour Emergency Medical Technician course (EMT), had Leslie, his wife, enthusiastic enough to complete the training, and he became the first President for the Sutton County Emergency Medical Service Organization. Tim has served the local ambulance service in many capacities since 1983 and is still an active member of the organization.

Immediately after taking the forty hour Emergency Care Attendant Course, Leslie started going some on the ambulance and by the end of February 1986 became a certified Emergency Medical Technician. Leslie has

served in the organization as secretary (2), reporter (2), Vice-President (1), and is currently serving a second term as the president. Leslie has also been a CPR instructor and is an ECA/EMT Examiner.

T.J. Thorp started the Sutton County Emergency Medical Technician course in January 1996. He took the state EMT test for that course in April and received his EMT certification. Shortly after, he graduated from Sonora High School on May 24, 1996. Taking the course during the end of his senior year caused him to sacrifice many end of school activities, but he feels it was well worth it. He has now completed his rotation period with the organization and has become a full member of the Sutton County Emergency Medical Service Organization in July, 1996.

There is one more member of the immediate family, Joni, who will be a junior in high school this year. She is not yet of age to take one of the ambulance courses but has expressed an interest.

The Thorps are truly incredible with their dedication to the ambulance service, and the work goes on. Currently, Leslie and T.J. are completing an Emergency Medical Technician Intermediate Course that started in April and will finish in July. Sutton County should be grateful for VOLUNTEERS such as the Thorp family.

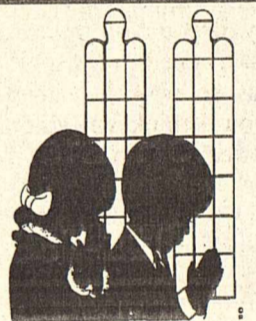

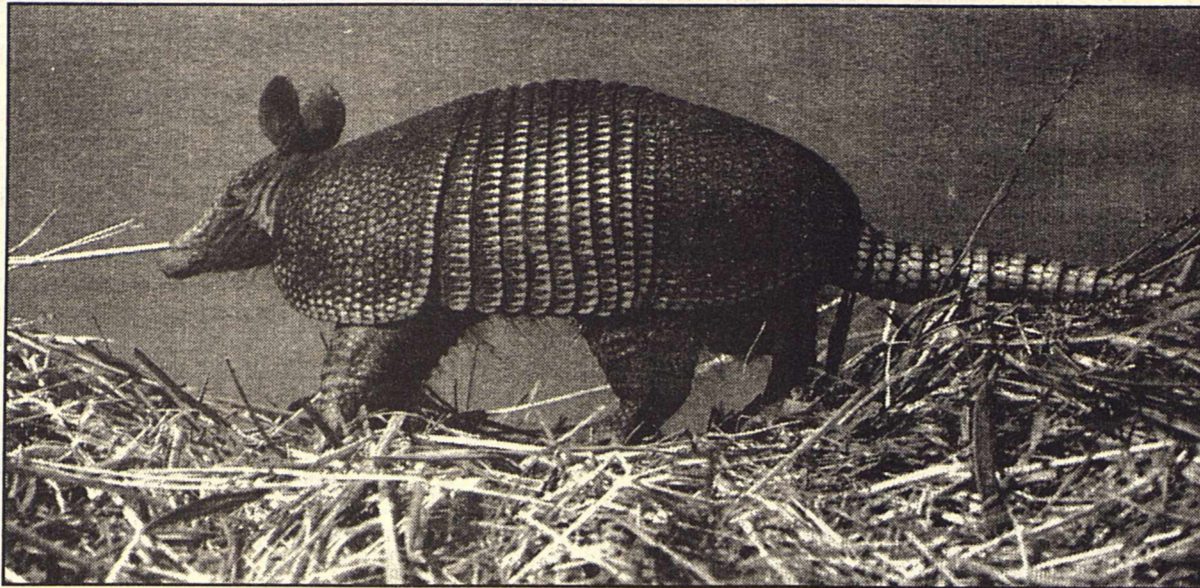
# The Historical Society

We must try each and every day to give a little of ourselves to make life a little better or a little easier for people. Our ancestors worked together to build this county, and we must continue their work, adding to it and enlarging on it. When we work together, a lot can be accomplished; but, if people don't help pull their share of the load, things will stagnate and cease to exist. Be a good citizen, help enforce the laws of our city and county, help your neighbors if you can, be involved, and work together to build a lasting monument to this town. Not through a special building or monument but by keeping alive the spirit of your ancestors, to make things better for future generations.

If you haven't been to the Covered Wagon Dinner Theater yet this year, you are really missing out on some good entertainment and wonderful meals prepared by our own Sutton County Steak House. Rick and I went to see Allan Wayne Damron with Biscuits O'Bryan and Ponti Bone with Tryon Fields and Armadillo Jim. Both nights were great, and it was so much cooler out at the Caverns of Sonora than here in town. We sat in the shade with gentle breezes blowing. It was a lot of fun, and you haven't experienced heaven until you have eaten one of Biscuits' campfire biscuits made from scratch and cooked in an iron pot in the coals from the fire. Allen Wayne Damron as usual was great. He has been performing at the theater since it opened, and everyone enjoys him.

Tryon Fields is a wonderful cowboy. If you closed your eyes and just listened to his spurs jingling as he walked around the area, you'd think you had been transported back to the old days. Tryon's outfit is perfect for showing the tourists the old west, especially when he fires off his six gun.



Ponti Bone with his Cajun music had everyone's feet tapping. Several visiting from Louisiana even got up and danced. What was really cute were the little children that were dancing around the grounds to his music. They made you wish you were young again and could throw away all your grownup inhibitions and prance around with them.

I have to say that Armadillo Jim really impressed me. I had never been to an armadillo race before. It is amazing to watch grown men and women crawling around on the race track, blowing on the armadillo's tails, trying to get theirs across the finish line first. Jim Schmidt had a beautiful red white and blue costume and took several of the armadillo out into the audience and let people pet and play with them. It was the first time this transplanted Yankee had ever seen one up close, and I was amazed at how docile they were. The funniest part of all was when Jim got out a set of fake armadillo ears and tail and had people imitate the armadillo wiggle. A woman from San Angelo, an Aggie, won the contest. See Aggies can do something. They can win an armadillo wiggle contest.

Armadillo Jim is a part of the "Put On Your Armor" Against Drugs Foundation. Their pet armadillos are under veterinary

care and licensed under the USDA Animal Welfare Act and fully insured. Their main purpose is "armoring" children against drugs, crime, and violence. ## EMT's Complete Advanced Skills Training

Fourteen Emergency Medical technician's from Sonora, Ozona, and Eldorado completed an Emergency Medical Technician Intermediate program held in Sonora. The program began April 30, 1996, and was completed July 18. This advanced skills program was sponsored by Howard College and Columbia Medical Center of San Angelo.

The program, held at the Sutton County Emergency Medical Service Training Facility, consisted of over 60

hours of classroom instruction and 100 hours of clinical rotations at Columbia Medical Center and the San Angelo Fire Department. The students were trained to establish intravenous access and manage fluid therapy; in addition, the students were trained to perform endotracheal intubation, nasotracheal intubation, and other advanced airway techniques. The program also included intraosseous fluid administration techniques, pneumatic anti-shock trousers, and pediatric I.V., and airway skills.

Mr. Keith L. Butler, EMT-P, Director of EMS Education for Columbia Medical Center and lead instructor for the program, stated, "This type of course requires a tremendous dedication on the part of the student, their family, and peers. The skills acquired by these students place them and their community one step closer to being able to provide pre-hospital advanced life support, a level of care which could greatly improve survivability from cardiac and traumatic events."

## County Commissioners Meeting Review

During the July 22 meeting of the County Commissioners, Judge Garner stated a decision must be made to complete the front entrance of the new library building. The Sutton County Public Library Committee stated that it would assume the responsibility of the design, supervision, and cost of all the finish out work for the grounds of the new Sutton County Public Library. The commissioners voted unanimously to accept this proposal. Construction is expected to begin immediately on the front entrance.

The commissioners voted to not charge an optional \$10 road and bridge fee for registered vehicles in Sutton County. This charge is optional and decided on each year by the commissioners.

A \$50 a day charge for the use of electricity at Allison Park is now required. This charge will recoup the cost to the county for the portable restrooms and electricity at the park.

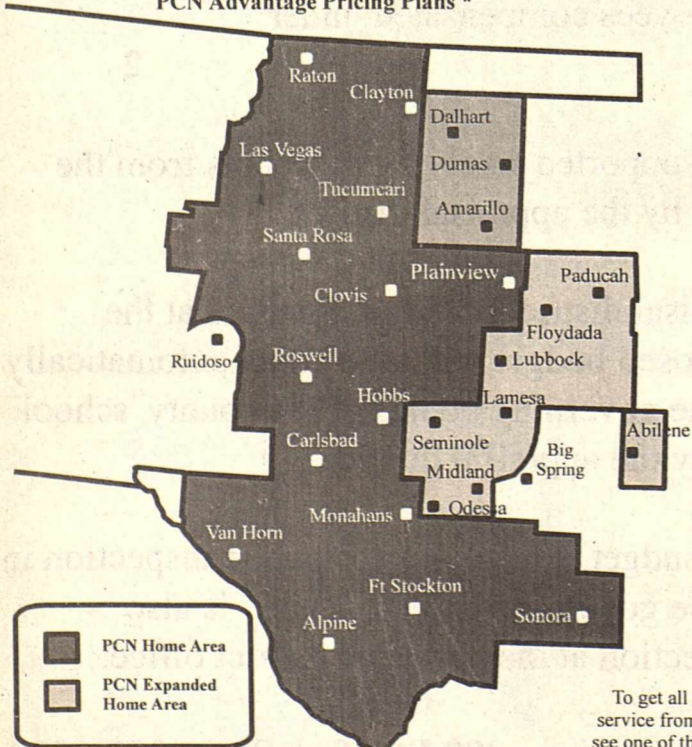

## Donors Needed Now To Avoid Emergency Later

United Blood Services of San Angelo is asking the community to show support this week by making an appointment to donate blood. UBS representatives say the situation is critical, and more donors must be drawn to avoid an emergency situation.

"There is a difference between a 'critical' stage and an emergency stage," said Cliff Liddell, UBS Executive Director. "The critical stage is what we experience before an emergency arises, and critical or even 'tenuous,' adequately describes our situation right now."

The blood supply is historically low during the summer

months, but this month the draw has dropped to a level that raises concern. Two end-of-week blood drives cancelled Wednesday that knock about 40 units off the projected draw.

"We're asking donors to call and make appointments to donate this Thursday and Friday," Liddell said. "I want to stress that this is not an emergency appeal, but the support of an extra 40 or 50 donors over the next few days could make the difference between an adequate supply and an emergency situation."

There will also be a blood drive held Saturday at the San Angelo Civic Theater from 10:00 a.m. until 1:00 p.m. that the public is invited to attend.

Blood types especially needed at this time are A positive, O positive, and O negative.

There is also a summer promotion for in-center donors. A donor will receive a token for a donation made in-center before August 5. If the donor donates a second time before September 30, he will receive a commemorative "I Donated During the Drought of 1996" T-shirt. There must be an eight week interval between donations.

"I'd like to thank all the businesses and organizations that are hosting blood drives this summer," Liddell said. "I'd also like to encourage those who've never donated to try it—it may be your only opportunity to help save someone's life!"

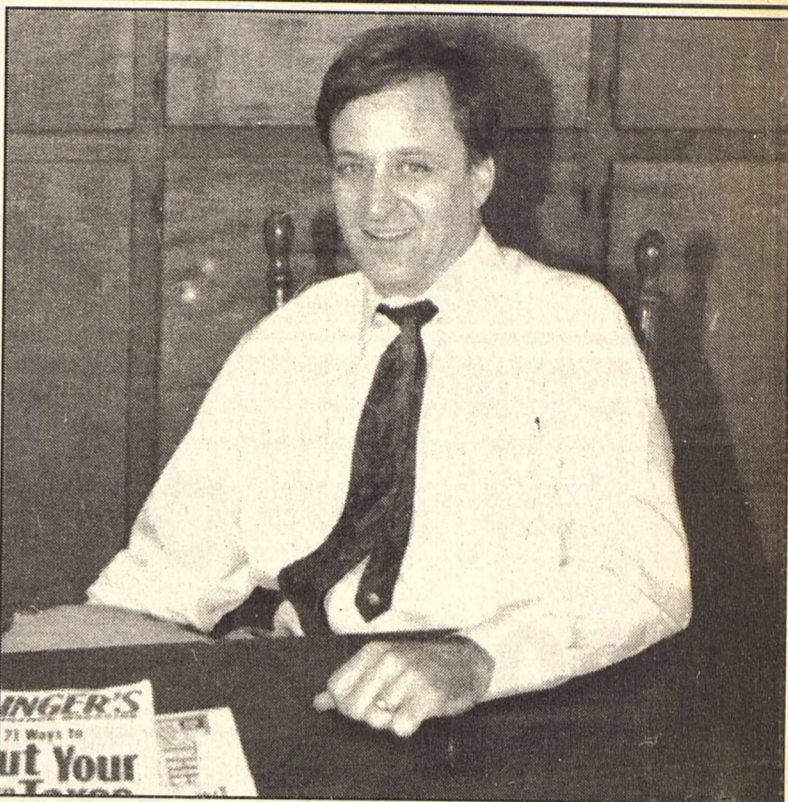
## Search Begins For 4-H Alumni

## News From the Sutton County Water District

by Mike Smith, manager of SCUWD

I attended a meeting in San Angelo, Texas, on July 16, 1996, to discuss current drought conditions. Texas Senators and House of Representative members have scheduled these meetings throughout the state. The meetings are to discuss what types of assistance and programs are available on local, state, and federal levels. Significantly below normal rainfall levels across the state have resulted in mild to severe drought conditions. The National Weather Service indicates high probabilities that drought conditions will continue for several months. Agriculture across the state has been severely impacted by these drought conditions. Some public water suppliers are beginning to report shortages or dry wells to the TNRCC.

During the last legislative session, Senate Bill 680 passed in regard to uncontested elections. Political subdivisions, such as water conservation districts, can cancel elections when candidates are unopposed. This could save our district approximately \$1,000 if a candidate is unopposed.

With the current draught conditions, we are re-submitting the following information:

Water plays a part in virtually every product we use and every activity we undertake. Each day we draw almost 150 million gallons of water from the Edwards Aquifer for drinking, irrigation, recreation, and industry. Learn to conserve water at home, in the yard, and on the job. Find new ways to use less water.

Inspect all pipes and faucets for leaks since hundreds of gallons a day could be dripping away.

Check toilets for hidden leaks. Tank-to-bowl leaks can waste about a quart of water with each flush. Place a few drops of food coloring in the tank. Wait fifteen minutes and see if the color appears in the

bowl. If so, you have a leak. Make necessary repairs immediately.

Install ultra low volume toilets and low-flow shower heads or fill a plastic, one quart bottle with water and place it in the toilet to reduce the amount of water used with each flush. To anchor the bottle, partially fill it with sand or small stones. Turn off the

tap while you shave or brush your teeth and take short showers.

Load the automatic dishwasher to capacity. Regardless of how many dishes are loaded, the dishwasher will use about 15 gallons, so get a run for your money.

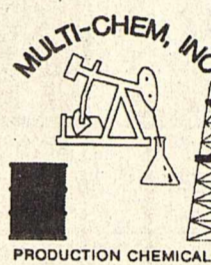

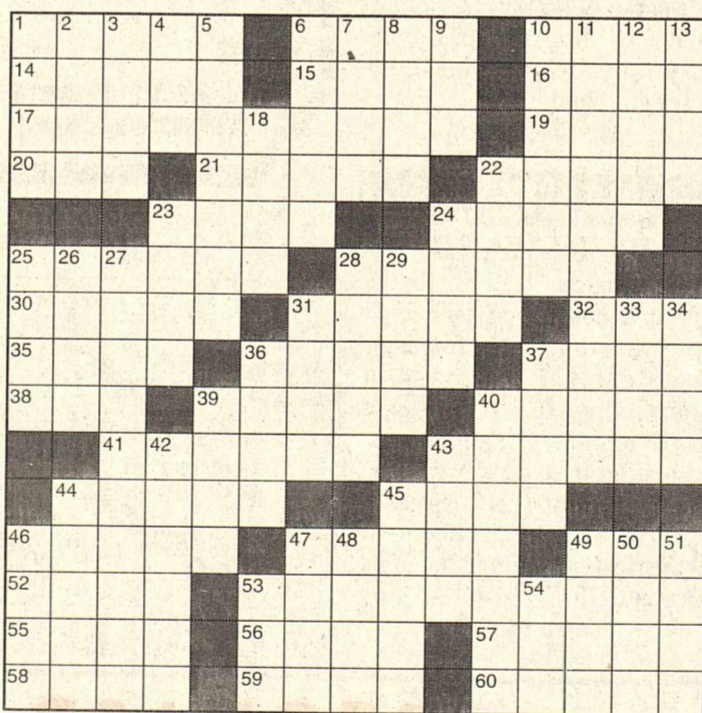


