## School Board Holds Regular Meeting

The Sonora I.S.D. School Board held its regular meeting on Sept. 14, 1998 at 6:30 p.m. After being called to order by Board President Jessie Bustamante, and the invocation given, the minutes from August 10th, 17th, 24th, and the 31st were all approved. Tax assessor/collector, Rex Ann Friess, reported that \$32,000 more than 1997 had been collected in taxes, thus putting the total at a 101% collection rate.

After a discussion over the possibility of paying some organizational dues, it was decided to research the matter further. More information is needed from the individuals requesting that dues be paid. Having made this decision it was approved to pay \$297,769 in current bills.

Superintendent Dr. William Harlan asked for approval from the board for early dismissal on Tuesday, October 13, 1998 for the Fall Festival, which is to be held downtown. The Festival involves several fund raising projects for the school. An early dismissal time of 2:30 p.m. was approved.

Next item for discussion was a presentation from Donnie Weaver. Weaver began with a technology update, informing the Board that all computers that were leased have been received and 110 are set up. Weaver explained that it was a slow process, but the teachers and students were doing great with the minimal training they had received. Weaver went on to say that by putting the new computers in the High School, it had allowed 50 computers to be moved to the Middle School and 25 to be moved

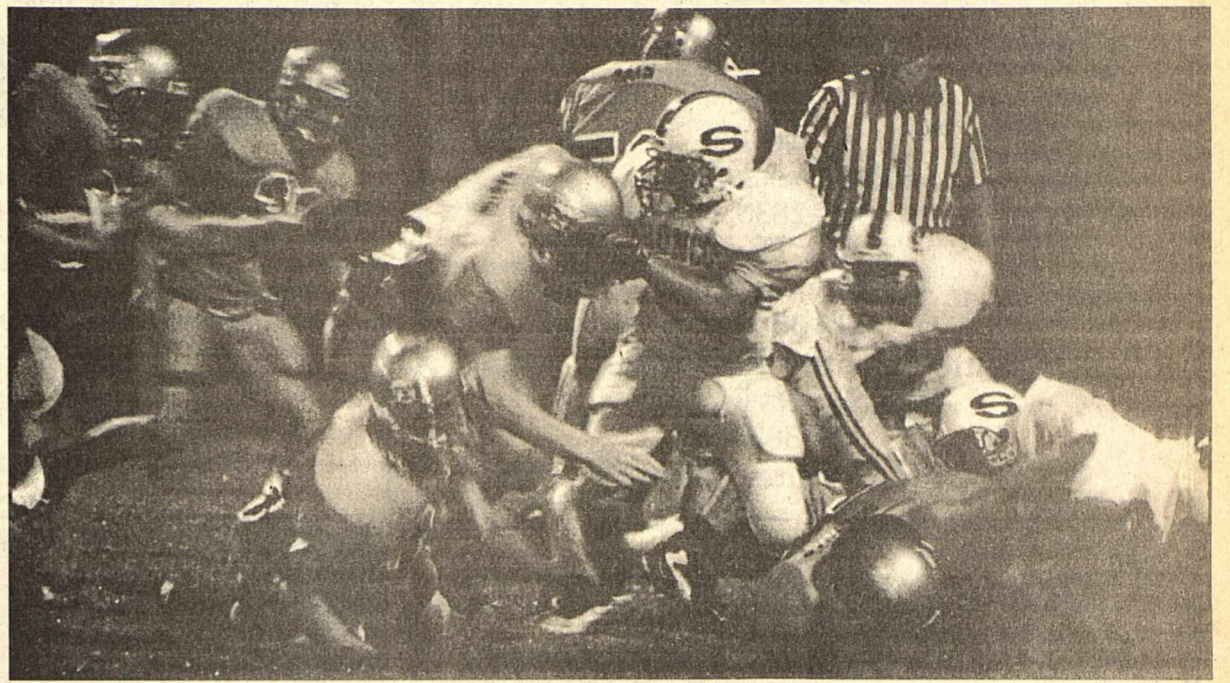
to the Elementary School, thus allowing for computer labs to be offered at the Pre-K - 2nd grade levels. Weaver also informed the Board that the new copiers had been installed and all seemed to be going well. This brought up the next item of business, the possible approval to sell the old copy machines. Weaver informed the board that he would like to advertise for bids to be taken on the old copy machines. It was approved for bids to be taken. Weaver's final subject of discussion was the possible approval to go ahead with the networking of the administration building. The cost of \$16,500 for the equipment, labor, and all other involvements has already been budgeted, so there was no reason to wait. It was approved to begin the networking process.

The next item for discussion was a presentation from Elementary School Principal Kelley Hirt & Vice Principal Louise Dermody, introducing the new character education program they are planning to implement in the Elementary. The program is called "Building Good Citizens for Texas" and involves a monthly focus on an honorable trait (examples: honesty, responsibility, etc.). The program will involve parent interaction and all materials necessary would be free of charge. The Board highly approved of the program. Hirt's presentation was followed by Dr. Harlan giving the Board information on the building use operational procedure. Dr. Harlan reminded the Board of the \$100.00 rental fee with the \$75.00 refundable deposit. This had been discussed and agreed upon at an

earlier date, so if there were any questions concerning the lease of the school properties everyone was now aware of the guidelines to be followed.

Dr. Harlan's Superintendent report consisted of informing the Board of current enrollment figures: 1013 total students; 498 at the Elementary, 203 at the Middle School, and 313 at the High School. It was agreed that these figures are very close to last years, about 9 down. Dr. Harlan informed of a representative from the State Energy Conservation in Austin, coming to look at the school's electricity and gas bills from the last 12 months. The representative is going to try to find a way to lower costs on these utilities. The severe roof leakage problem in the Middle School Library was also discussed. Kelley Hirt followed Dr. Harlan with a presentation on the upcoming plans for raising funds for possible revival of the E.L.K.S. program that was cut this year because of the loss of Government funding. Hirt explained how many parents and children were losing out because of the loss of this and she, and the other administrators working with her, felt that this was a much needed program. (See article on E.L.K.S.) Hirt also explained the importance of parent organizations and stressed that she was working to establish a working parent-teacher organization.

Having no comments from visitors or members, the Board went into executive session.

## Miscues spell defeat

This past Friday, the Broncos traveled to Brady to play a highly ranked 3A team. What ensued, I guess, could be blamed on Tropical Storm Francis. It never really rained hard, but a heavy drizzling mist greeted the Broncos upon their arrival and continued throughout the course of the ball game. If you could find any type of shelter, you might have stayed dry, but for the players and the fans, there was no escaping the relentless swirling mist. The Bronco offense turned the ball over 2 times, but what ultimately led to a 14 to 6 defeat, was the kicking game. On two consecutive possessions, the Broncos had to punt the football. On each of these possessions, the ball was snapped over the head of the Bronco punter and each time the Bulldogs were able to take possession of the pigskin inside the Bronco 40 yard line. Off of these two miscues, the Bulldogs were able to put the 14 points on the board, that were needed to gain the victory.

The game began with Sonora winning the coin toss and deferring to the second half. The Bulldogs received the opening kick-off and set up shop at their own 37 yard line, the much touted Bulldog offense took the field. However, an inspired Bronco defense led by Lupe Ramon, Brad Legan, and Anthony Renfro forced the Bulldogs to punt the ball after only 3 offensive downs. The Broncos, now had their first chance at a defense that had given up only minimal yardage the week before. Behind the blocking of Caleb Taylor, Anthony Sanchez, Greg Hughes, Brad Legan, Brady Lock, Dustin Patino, and Andy Sanchez, the Bronco running backs were able to move the ball down the field at a fairly good clip. At the 44 of the Bulldogs, the team dressed in all Gold began to stiffen. On a 3rd and 8, Bronco wingback, Crispin Lira was stopped short of the needed first down yardage. This brought about Miscue #1. With a 4th and 5 at the Brady 42 yard line, Brad Legan came on to do the punting chores. What ensued was a 16 yard loss as the ball sailed over Legan's head. Legan was able to pick the ball up, and return it for a few yards, but was tackled at the Sonora 42 yard line. With 4:49 on the play clock, the Bulldogs got their second chance. The Bulldogs only took 6 plays and 2 minutes to capitalize on the Bronco miscue. Finding tough going on the ground, Craig Tally, the Bulldog quarterback went to the air, finding Kasey King for a 34 yard gain, to the Bronco 6 yard line. After an encroachment call against the Broncos, the Bulldogs had a 3rd and 2 at the 2 yard line. Bulldog star runner, Michael Shipman, got the call and the first Bulldog score. Brent Raybion came on for the PAT and split the uprights. Making the score with 2 minutes 31 seconds left in the game: Sonora 0-Brady 7.

The Broncos, once again went on the offensive after Anthony Renfro returned the ensuing kick-off 15 yards to the Bronco 35 yard line. At this point, the Bulldogs began to show everyone why they are a top ranked defensive squad, as they held the Bronco power runners to no gain. On a 3rd and 11 from the Bronco 34, Bryce Williams rolled to

his left, being under great pressure and not finding an open receiver, Williams lofted the ball out of bounds. When the yellow flag came out, everyone thought it was a roughing the passer call-Wrong! The new rule this year is, if you throw the ball out of bounds and not in the direction of a receiver, then it is intentional grounding. The Broncos, now found themselves with a 4th and 30 at their own 19 yard line. Brad Legan, set up for the punt inside the Bronco 10 Miscue #2. Once again the snap sailed over Legan's head, Brad was able to capture the ball in the end-zone and somehow got the punt off, however, the Bulldogs took possession on the Bronco 19 yard line. With 44 seconds left in the first quarter, the Bulldogs kept the ball on the ground. Ernie Garcia, the Brady fullback did most of the damage gaining 10 yards on 3 plays. With a 1st and 7 at the Bronco 7 yard line, the first quarter buzzer sounded.

The Bulldogs opened the second quarter with Tally keeping the ball, and going around the right end for their second score of the evening. Raybion added the extra point to give the Bulldogs a 14 point lead with 11 minutes and 54 seconds left in the second quarter. On the Broncos next possession, Brady linbacker, Zeb Ferris, made his presence known, as he stopped Jacoby on two consecutive running plays and on a 3rd and 4, intercepted a Williams pass at the Bronco 35 yard line. With 10 minutes and 13 seconds left in the half, a defensive brawl began to emerge. The Broncos, with their backs to the wall made a statement: NO MORE!! Behind super defensive plays led by Greg Hughes, the Broncos showed that they are not all sugar and spice. The Bulldogs were able to move the ball to the Bronco 21, but here the drive stalled. On a 4th and 9, Raybion was called upon to try a 40 yard field goal. He just missed to the right. The Broncos had new life at the 20. But just as on the previous possession, the Bulldogs would have none of it, and after 3 plays the Bronco punting unit was back on the field. Once again, Legan found himself inside the Bronco 10 yard line. This time the snap reached him and he was able to get off a good 32 yard punt. Once again, Brady took possession inside the Bronco 50 yard line with 4 minutes 28 seconds left in the second quarter. The Broncos led by Tanner Fields, Brad Legan, Crispin Lira, and Anthony Sanchez held the Bulldogs to only 3 yards gained, and on a 4th and 7, the Bulldogs were forced to punt. Maybe it was providence or maybe turn about fair play, who knows, but the Brady deep snapper, snapped the ball over their punters head. Result-Broncos now have the ball on the Bulldog 32 yard line with 2 minutes and 42 seconds left to play in the half. The Bulldog defense not saying "NO MORE" but stating to "NEVER WILL" not only stopped the Broncos, but pushed them back for an 8 yard loss on 3 plays. With a 4th and 18 staring the Broncos in the face, the Broncos elected to try a fake punt, once again the snap was bad and the Broncos turned the ball over on downs. At the Brady 42 yard line, the Broncos dug in. Brad

Legan and Crispin Lira both broke up pass plays to force the Bulldogs to punt the ball after only 3 plays. With 22 seconds left in the half, the Broncos elected to run out the clock and go to the locker room to regroup.

Halftime Score: Sonora 0 - Brady 14

To open the second half of play, the Broncos put Anthony Renfro and Tanner Fields back deep to accept the kick-off. Anthony called for the ball at the Bronco 13 yard line. Renfro ran the ball straight up the middle into the wedge, at the 35 yard line everyone on the press box side of the field thought that he had been tackled. At the 35, Renfro broke toward the Bronco sideline and began to out-run the bulldog Kick-off team. 86 yards later, Renfro crossed the goal line for the Broncos only score of the evening. Not having time to catch his breath, Renfro had to don his kicking shoe and attempt the PAT. The snap was good, however, the kick was wide right. With 11 minutes and 41 seconds on the clock the score board read: Sonora 6- Brady 14.

For the next 6 minutes, neither team could generate any offense. The Bronco defense led by Greg Hughes, Lupe Ramon, Graham Bloodworth, Simon Murillo, Crispin Lira, and Brad Legan continually forced the Bulldogs into punting situations. On the other side of the coin, the Bulldog defense led by Zed Ferris, Andy Barton, and Jim Peel did much of the same. The Bronco defense did however, force a turnover with a little over 4 minutes left to play in the 3rd quarter. On a 3rd and 10 at the Bulldog 40, Tally called for a screen. Under a tremendous rush by the Bronco front 4, Tally threw the ball toward his receiver, Sonora's Lupe Ramon stepped in front of the intended receiver and intercepted the ball at the Bulldog 45 yard line. Ramon returned the interception to the Bulldog 25 before Shipman was able to drag him down. The return yardage was not to be, for there was a flag on the play. An illegal block below the waist was the call, this moved the ball back to the 50 yard line. For the remainder of the period and for the entire 4th quarter, each team either punted or turned the ball over on either an interception or a fumble. But not much offense was generated by either team, and the game ended in a classic defensive duel.

The Bronco defense played tremendously well throughout the ball game. The offense played well also, but could not ever sustain a drive, due to miscues. Much credit needs to be given to the team from Brady, their defense is probably one of the best that the Broncos will see this year. And hopefully, Tropical Storm Francis, got all of the miscues out of the Bronco's system. At least that is who this reporter blames it on!

This week the Broncos will entertain the Bucks from Alpine. This is also Homecoming week. This will be the Broncos first home game, with an 8:00 p.m. start time. Come out and show your support for the 1998 Sonora Bronco Football team.

## Bronco J.V. Loses Heartbreaker

The Sonora Bronco J.V. hosted the Brady Bulldogs J.V. last Thursday. For 39 minutes and 52 seconds, the Broncos, controlled the ball game. The running of Sean Fields and Bill Renfro, as well as the passing of Nick Lozano to Riley Crain kept the Broncos in firm control for all but the last 8 seconds of the game, and in the end it was the pass that proved to be the down fall of the young Broncos.

To open the game, the Broncos received the kick-off. Nick Lozano advanced the ball to the Bronco 27 yard line. However, on a 2nd and 1 from the 36, the Bulldogs intercepted a Lozano pass with 9 minutes and 11 seconds left in the first quarter. The Bulldogs took a little over 7 minutes off the first period clock in a relentless march towards the coveted goal line. Garcia did most of the work by gaining 36 of the 62 yards needed for a touchdown. The Bronco defense was led by Riley Crain, Chance Armke, Danny Solis, and Jarred Solis. But in the end, Ledezma the Brady quarterback, found Rogue in the end-zone for a 2 yard touchdown pass. Garcia got the call on the 2 point conversion try, and was successful. Brady 8 - Sonora 0.

On the kick-off, Sonora's Cameron Simms took the ball and returned it to the Bronco 20. At this point, the Bronco coaching staff alternated the ball carrying chores between Renfro and Fields. It was a well orchestrated ball control offense. It took the Broncos 11 plays and about 3 and half minutes to respond to the Brady touchdown. Renfro got the call on a 3 yard run to score the Broncos first touchdown of the day. On the try for two, Lozano was not able to link up with Crain, so with 8:46 left in the 2nd quarter, the Broncos were only down by 2 points: Brady 8 - Sonora 6.

Brady's next possession met with a great deal of resistance. The Bronco defense began to swarm the Bulldog runners. Thomas Schenkel, Riley Crain, and Bill Renfro led the charge and the Bulldogs were forced to punt the ball. The Broncos, set up shop at their own 29. Once again, it was a Renfro/Fields affair with a twist; Lozano found Crain twice for long pass gains. One for 34 yards and the

other for 22 yards, this one being the one that set up the go ahead touchdown for the Broncos. On a 2nd and 6 from the 6 yardline, Renfro took a quick pitch from Lozano and outraced the Brady defenders to the pylon. Renfro also got the call on the conversion attempt, which he converted. This made the score, with 1:28 left in the half, Brady 8 - Broncos 14. The Bulldogs, however, would not quit. On a long pass play from Ledezma to Grubbs and some very hard running by Garcia, the Bulldogs moved to the Bronco 28 yard line with 6 seconds to play in the half. This set up a 4th and 8 from the Bronco 28. Ledezma rolled to his right looking for a Bulldog receiver. What he found was Bronco pass defender Sean Fields at the ten, who intercepted the pass to run out the half time clock.

Brady Bulldogs 6 - Sonora Broncos 14.

The Bulldogs received the second half kick-off. They were unable to get anything going as the Sonora defense led by Chris Green and Jarred Solis limited them to only 3 positive yards. The Bulldog punt was caught by Lozano at the Brady 30 yard line and was returned to the Sonora 25 yard line for a 45 yard return. The Broncos struck quickly as Lozano found his favorite receiver, Riley Crain, on a 15 yard strike for the touchdown. The try for two failed. Bulldogs 8 - Broncos 20.

It began to look like the Broncos had the Bulldogs number as they were unable to get anything going on their next possession. Chance Armke sacked the quarterback for a 4 yard loss and newcomer David Martinez stopped Garcia for no gain to put the Bulldogs in a punting situation. The Broncos took possession on their own 20 with 2 minutes 23 seconds left in the 3rd quarter. On a 3rd and 10, Lozano found Crain for a 12 yard gain. However as Riley was being tackled, the ball was stripped and the Bulldogs recovered on the Bronco 48 yard line. This was the spark that the Bulldogs were looking for. Just as they had done in their opening drive, the Bulldogs used Garcia to drive the ball down the field, consuming nearly 6 and a one-half minutes in the process. On a 2nd and 9 from the 9, Garcia got the honors

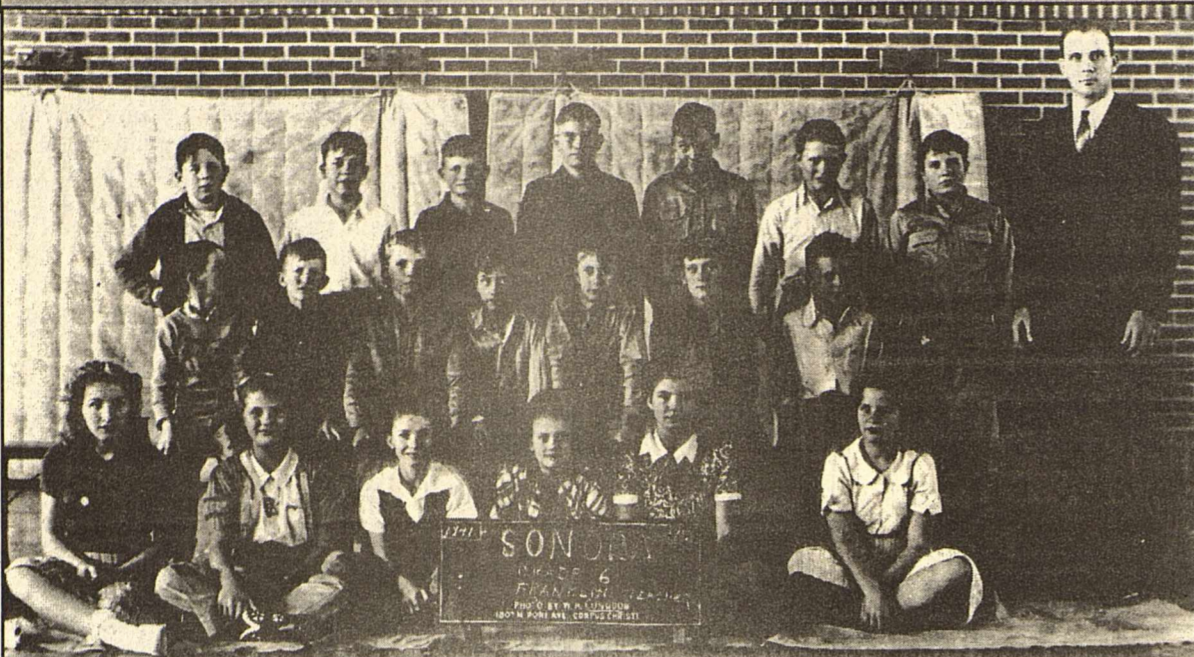

## Ask the Historical Society



Grade 6, 1941 - 1942. Mr. Franklin - Can anyone put names to the students?

Q. Who was on the 1937-1938 staff of "The Sonora Broncho"?

A. Devil's River News, May 6, 1938

Q. What was the name of the girl that Hix Hall and his wife adopted?

A. Devil's River News, September 30, 1938

A new Sonora resident is Cynthia Ann Hall, who returned with Mr. and Mrs. Hix Hall who were in Dallas during the week-end. Cynthia Ann is three and one-half months old and has been adopted by Mr. and Mrs. Hall.

In this edition we also found a picture that surprised us on the front page. The headline over it says Reichsfueher and the caption read: Pictured above is Chancellor Adolph Hitler of Germany whose name in the last few weeks has been

on the lips of more persons in the civilized countries of the world than any other man. Hitler is pictured standing, in his Nazi uniform.

Q. Why don't you scan some of the old pictures in the paper?

A. Many of them won't scan. They are too old and faded and others come out as dots and lines because of the technology used to print them. The only way to reproduce them is to photograph them and print the photo and my polaroid is not capable of this function.

In the same issue we found that lots of building was going on in Sonora. Miss Sally Wardlaw had torn down the old L. J. Wardlaw house that Troy White had been living in and was building two rock rental houses on the property across the street from what is now the Sonora Police Department building and Annex Building. These houses were five rooms and thirty-eight by thirty feet with a concrete porch on the front of each.

Dr. I. B. Boughton and W. H. Dameron were both building homes in the \$6,000 range. These were rock veneer homes with seven rooms Boughtons near the J. T. Penick home Dameron on a lot across from the Libb Wallace home. The contractors on the Wardlaw and Dameron house were Rutherford and Payne. Frank J. Von Rosenberg, builder of San Angelo, will do the Boughton residence. Also Mr. and Mrs. Clarence Valliant constructed a five room frame house for \$3,000 with K. C. Collier as builder.

Jim Caldwell is building a new residence at the Six-Mile Ranch of the Sawyer estate. Billy Penicks house was almost finished on the Junction Highway (Monica Du Russell's home) it was adjacent to

the new white stucco residence erected by H. V. Stokes.

St. Ann's Catholic Church had done \$2,500 worth of work on the residence house next to the church. It was enlarged from a four room house into an eight room house with an office, two bedrooms, an 18x28 screened porch, housekeepers room and bathroom being added. A basement was dug and the house was piped for gas.

Miguel Sanchez is expected to spend about \$500 converting an old house in to a gas station/grocery store. Antonio Garcia is operating a grocery store in his new frame building.

The Masonic Lodge was accepting bids from building contractors.

Granville Barker and his brother Bill have opened a new business called the Sanitary Barber Shop. It is a two chair shop and they have announced they will cater to the

business of children and ladies as well as offering a complete tonsorial service for men.

In an article entitled "Two Sonorans With Kinsmen Living in Troubled Nations" we find that Richard Vehle has a brother who is an aviator in Czecho-Slovakia and another man who is an airplane mechanic in that country's military. His mother is eighty years old and just learned how to wear a gas mask and attends drills regularly.

Joe Berger, who was born in Austria, has been an American Citizen since 1912. He has three sisters and one brother in his country of birth that has been taken over by Germany. He also has two sisters and a brother in Czecho-Slovakia. In case of conflict he would have brothers and nephews on each side.

R. A. Halbert purchased twenty sections of land owned by Virgil Powell for \$15.50 per acre.

In a note from Cedar Hill School it was reported that "pass tag" was the latest game being played. The boys liked it because the rules are somewhat similar to football. Mrs. Adams says however, "no tackling."

E. F. Vander Stucken Company Incorporated had a fifty-three piece Maroon dinner set for \$18.75, a six piece crystal glass set for \$1.95, one gallon size milk crocks for twenty-two cents, dried salt bacon for fourteen cents a pound and cured ham hocks for fifteen cents a pound. A one-hundred pound bag of Milo maize was ninety-nine cents and fruit cocktail was twelve cents a can.

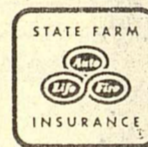

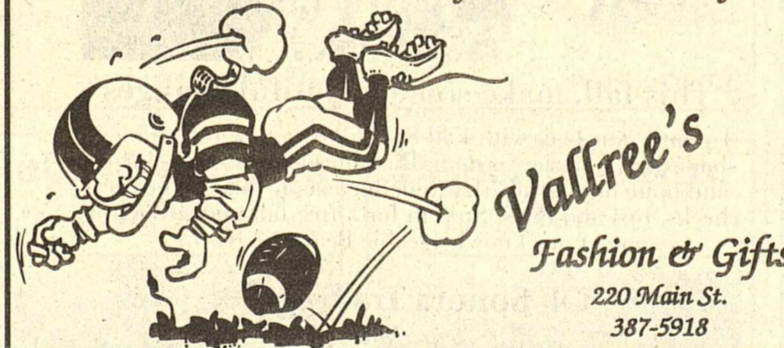

return it 46 yards for the go ahead touchdown. The try for two fails, but the damage is done. Bulldogs 26 - Broncos 20.

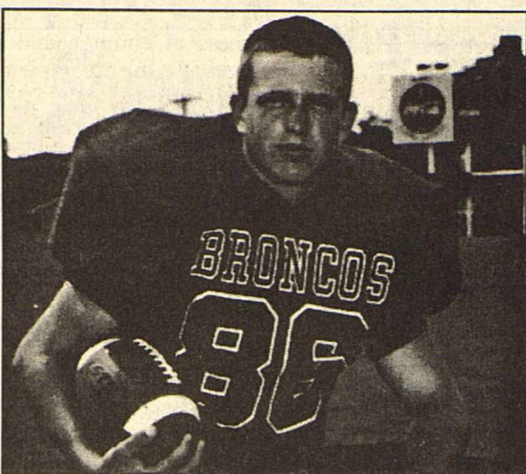

### Sharp notes new analysis of high-tech industries' contributions to Texas Economy

In the latest issue of his award-winning monthly publication, *Fiscal Notes*, State Comptroller John Sharp provides a new analysis that quantifies the contributions of the state's growing high-tech industry to the Texas economy.

"This report confirms what we have suspected for some time—that high technology has emerged as one of the primary sources for economic growth in the state," Sharp said.

The finding in this report were previously announced by Comptroller Sharp at a press conference held at the University of Texas at Dallas on August 24.

The report also describes programs that Texas companies and educational institutions have undertaken to train workers and recruit students in high-tech programs.

"All the computer power in Texas cannot match the brain power of our young people," Sharp said. "We have to do all we can to create a technically skilled workforce to meet industry's demand."

Sharp's recommendations on what the state can do to ensure an adequate workforce include:

- \* Appropriating \$20 million to the Texas Higher Education Coordinating Board to provide grants to Texas public universities' engineering and computer science programs.
- \* Appropriating \$5 million to the Coordinating Board to provide a similar grant program at public junior colleges and community col-

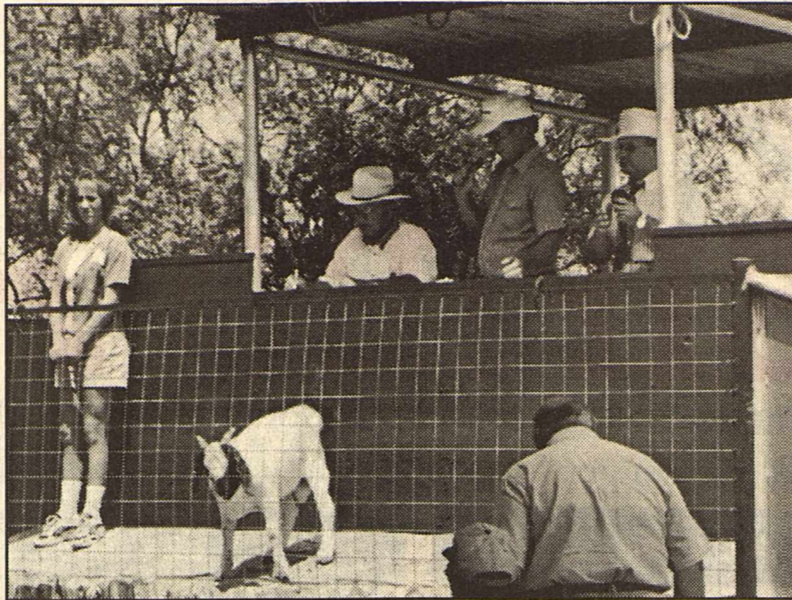
leges.

- \* Expanding the Skills Development Fund by appropriating an additional \$4 million in the 1999-2000 biennium specifically for high-tech training.
- \* Targeting \$5 million of existing Smart Jobs program grants to help businesses train workers for new jobs in the highest demand high-tech jobs.
- \* Dedicating \$1 million to the Texas Education Agency to provide competitive grants for public schools with limited resources that are working to increase the number of students in math and science programs.

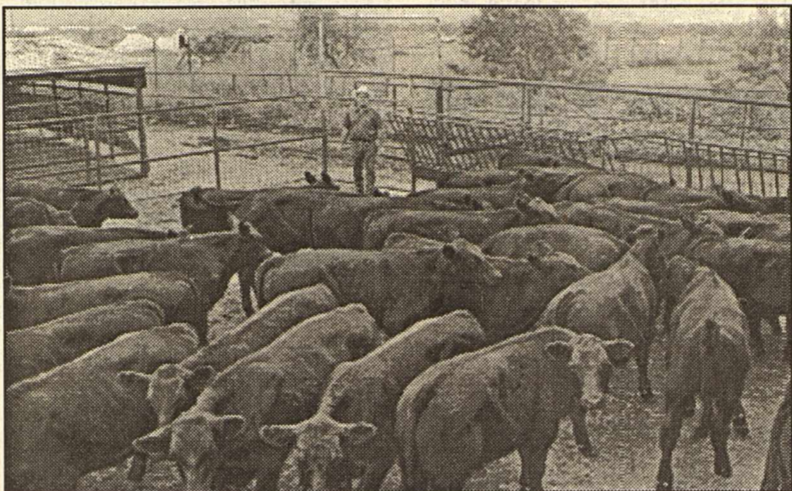
"Texas is poised to play as important a role in the knowledge-based economy of the future as the state has played in the natural resource-based economy of the past," Sharp said. "But for that to happen, we must take steps now to make sure our students are learning the skills they need to fill these jobs."
