

An End To The **Death Tax**



week, your Congress did just that. On June 6, 2002, the House of Representatives voted to end one of the most hated and unfair taxes on the books: the death tax. The specific date may fade from our memories, but the changes we made will forever be remem-

The death tax was a form of double taxation. The government taxes hard-working Americans throughout their lifetimes, and then at the time of death, they are assessed another tax on the value of their property. The last thing a family wants to see after a loved one passes-on is a bill from the Internal Revenue Service.

Bob McCan, a cattle rancher, said it best when speaking about how the death tax would affect him and his family: "Our ranch in Victoria, Texas, has been in my family for five generations, but it would have to be sold if I were to die today just to pay the estate taxes.'

And the death tax not only hurts ranchers and farmers, but urban and suburban small businesses. The death tax is wrong in principle. The government makes the death of a loved one a taxable event. Grieving family members are burdened with paying taxes as well as tending to funeral arrangements.


Currently, the death tax affects one-third of all small business owners. Their families are forced to pay rates as high as 55 to 60 percent on the value of their store, farm or ranch. This is

The death tax really takes a toll on the savings accumulated over a lifetime by farmers, ranchers and small businesses through their hard work. More than 70 percent of all small businesses do not survive into the second generation and even more don't even make it to the third generation.

Those opposed to the repeal of this unfair tax argue it is a tax break targeted to benefit a few wealthy individuals. But working Texans know better. Repeal of the death tax is about a father or grandfather having the ability to pass on to his children or grandchildren the family farm, family ranch, or family store.

by Jed Davenport, Director Adult/Juvenile Probation Services for Sutton/Crockett Counties A child who breaks the law in Texas may enter a complex world of procedures, places and people called the juvenile justice system. In Texas the ages of juvenile justice jurisdiction are 10 through 16. State law strictly regulates the handling of juveniles, but juvenile probation is locally administered at the county level.

Getting Caught

This year more than 130,000 Texas children picked up by law enforcement officers will enter the juvenile justice system.

For minor violations law enforcement may simply issue a warning to the child and parents. However, when further action is needed to protect the public or the child, or to prevent future offenses, the case is forwarded to local juvenile probation officials.

All juveniles with alleged delinquent offenses that are crimes punishable by jail for adults are fingerprinted and entered into a statewide central repository. Their criminal history record may then be accessed by law enforcement and juvenile justice agencies throughout

Intake - Front Door to the System

Children are taken into custody around the clock. They may be sick, intoxicated, injured, depressed or violent. Critical decisions must be made on the spot. Juvenile Probation Officers are skilled in crisis intervention, information gathering and assessment. They resolve some cases through counseling and refer others to more appropriate social agencies. If charges are to be filed in court, the juvenile probation officer makes the initial decision about where the child will stay pending judicial proceedings. Many are safely released to parents or guardians but others must be held in secure detention or in a shelter.

Who are these children?

Children who break the law come from all social, racial and economic groups. Nearly half are between 14-15 years of age, and about three-fourths are male. Many are charged with minor offenses or 'status offenses" such as truancy or running away from home. However, one-third or more are serious offenders who may have committed crimes such as burglary, assault or murder. Substance abuse, family violence and school problems are common.

In Detention Juvenile detention centers are short-term, secure facilities.



Ask the Historical Society

When was the Sutton County Jail opened?

The Sutton County Jail was accepted in September of 1891. The first major crime prisoner, John Denson, was placed in the jail in October of 1891.

John Denson Arrested

Detectives O'Meara and Van Roper yesterday arrested John Denson charged with the murder of a Mexican in Sonora, Sutton County.

The officers had received a description of Denson with a capias and having seen him often about town had little trouble taking him. He was placed in the county jail pending the arrival of a Sutton County official. Denson was with his father, who accompanied him to the court house. Just then, Deputy Sheriff Demos remembered that he had a capias for the elder Denson, on an uncollected gaming fine against him in Wilson County and the father and son were both jailed.

John Denson the man charged with murder, is 24 years of age and unmarried. His father lives on Mesquite Street, but the son has been in the city only a short time. He acknowledged being the man wanted, and in explaining the nature of the case said: " A difficulty arose between myself and a Mexican over the arrangement of a game. of cards, when the Mexican shamefully abused me by calling me various names. In return I struck him and he pulled a gun and shot me through my hand. Right through there," he said pointing to a scar in his hand.

"When he shot me I drew my pistol and killed him. I got a hearing before a magistrate and was discharged. I don't know why I have been arrested again, except that the grand jury may have taken up the case and found an indictment against me. I feel that I could give any amount of bail in that county."

Devil's River News -October 17, 1896 - The Pecos Killing

Last Saturday at Pecos, in Johnson & Beard's Saloon, the Miller Frazer feud was renewed, with the result that Bill Aerhart and John Denson are both dead, being instantly killed by Barney Riggs. The particulars as well as we can learn are about as follows:

Jesse Heard was standing behind the bar when Aerhart asked Denson up to drink. Riggs took a glass of whiskey in his left hand and when the others raised their glasses, poured the whiskey out and drank water. Then Denson proposed to treat. At this time, Riggs, who was. between them, walked around, to the end of the bar and when they raised their glasses to sip out of the glass and set it down, Aerhart drank his and walked up to Riggs and said, "I don't propose to get the worst of this" and at the same time dropped his hand on the handle of his six shooter. Riggs replied "What do you mean; didn't I drink with you?" and Aerhart said "yes and


I paid for it," at the same time slowly drawing his pistol. Just at this instant Denson gently laid his arm on Aerhart's arm, causing him to slightly turn his eyes from Riggs, when as quick as a flash Riggs drew and fired, and as Aerhart fell, jumped past him and fired at Denson, who then ran backward a few steps, when again Riggs fired. Then Denson made for the door and some say Riggs fired again. He ran just out the door and fell. Denson was shot in identically the same place as was Con Gibson, whom Denson killed at Eddy two years ago. Aerhart was shot just below the left eye, the ball passing back through the brain. Aerhart shot up the town the night before, and was very fussy and tried to raise a row with other parties, and it is claimed that he and Denson were dogging Riggs over town and always made it a point to get him between them when possible. Parties living at Eddy say that they saw a letter that Miller had written Denson telling him to come down and help work the election and they would get \$500 each. Riggs was very quiet and did not drink and while in Pecos he told several parties that he wished to avoid any trouble. It all grows out of Miller's having the gang at Pecos and it is reported that

more are going there. Affairs are in a bad condition in Pecos and if Miller imports more toughs there may be another "Lincoln" county trouble. Peaceful citizens are all scared but declare unless the toughs are subdued they will be compelled to act in self defense and take the law into their own hands. Unless more rangers are sent the blood will flow like water. The opinion of the public is that Aerhart and Denson intended to kill Riggs, so there is not much sorrow at their taking off. Riggs has four brothers, all men of grit and quick with a gun. Riggs' bond is \$1000 in the Aerhart case and \$3000 in the Denson case. - El

Paso Herald Mr. J.M. Denson received a telegram Monday announcing the death of his son John Denson who was killed last Saturday at Pecos. From a letter received later Mr. Denson learns that his son was shot by Barney Riggs. It seems that Riggs and a man named Aerhart were engaged in a row when young Denson interfered and was taking Airhart away when Riggs drew his pistol and shot Aerhart dead then firing two shots killing young Denson. It is said both the murdered men were unarmed. - Junction Citizen







Operated by either local juvenile probation departments or private companies, they are designed to protect the community and the child, and to assure the child's appearance in court. At intervals set by law, children in detention have detention hearings where a judge must be shown there is good cause to hold them. Children are not detained without due process of law. The more than 55 detention centers in Texas offer top quality custodial care, crisis intervention, counseling, education and many other services.

Waiting for Court

When charges are filed against a child, a probation officer initiates a court investiga-

After making a detailed assessment of the child's behavior, home, school and social relationships, the officer writes a social history report to assist the judge in deciding on a plan for the child's future.

Going to Court

In the court proceeding, called an adjudication hearing, the child, family and the child's attorney, appear before a judge or jury that will decide if the child committed a delinquent act or conduct indicating a need for supervision. If the child is adjudicated for the offense, the judge orders a "disposition" - a plan to protect the public and to redirect the child toward a lawabiding future.

Dispositions in most counties are based on "progressive sanctions" guidelines aiming to provide appropriate consequences and outcomes for juvenile offenders. The guidelines provide a continuum of progressive steps designed to balance public protection, offender accountability and rehabilita-

What Can The Juvenile Judge Decide

Juvenile court judges have many options from outright dismissal to long-term confinement in a correctional facility. For felony offenses, a youth 14 or older can be "certified" to stand trial in the adult courts.

For other serious offenders, the determinate sentencing law allows a juvenile to be confined up to 40 years, first in the Texas Youth Commission Facility, followed by an optional court transfer to prison.

For less serious offenders who require confinement, the judge may order an indeterminate commitment to the Texas Youth Commission where the child may be held until his or her 21st birthday.

In most cases, however, the judge orders some form of probation supervision in the community, or placement in a private, state or local residential

treatment facility.

A Second Chance

Some of the youngest, least serious offenders get a second chance to prove to the court that no further action is needed to prevent future illegal activity. Those who succeed in this sixmonth "deferred Prosecution" program avoid the adjudication process and continued involvement with authorities.

Probation - The Most **Used Option**

Of all the court's choices, probation supervision is most commonly used. Because children remain in their homes and schools, probation is the least costly, least disruptive course of

The court-ordered rules of probation demand school attendance, good conduct, curfews and participation in specified programs, including community service and financial restitution. Probation officers enforce these rules while they help the child and family achieve positive

Parents are expected to participate in their child's probation program. As the source of social, emotional and financial support, the family is key to a successful probation outcome. Family counseling, parent training and support groups help parents meet the challenge of rais-

ing teenagers today. Residential Placement

Some children must be removed from their homes due to uncontrolled behavior, drug addiction, mental illness or an inadequate home environment. children are removed from their homes only as a last resort to protect the public, to provide needed supervision and treatment to prevent future lawless conduct.

Starting over

The child who succeeds on probation, either at home or in an institution, gets a fresh start. The Texas juvenile justice system treats them with confidentiality and concern. Juvenile case records are not made pub-

Probation practitioners work hard to see that children leaving their care and custody are better equipped to build productive, law-abiding futures. Because all children have the potential for good, they deserve our best efforts in their behalf.

for the 21st Century (TEA 21). This federal designation makes the route eligible for federal funds. These funds are specifically designated for the coordinated planning, design, and construction of corridors of national significance, economic growth, and international or interregional trade. The Corridor will also connect to other high-priority corridors such as Highway 54, Highway 71, Interstate 25, and Interstate 80. Additionally, it connects to other major interstates such as I-10, I-20 and I-

The benefits of making investments along the Ports-to-Plains Trade Corridor are significant, and include economic growth, national security, intermodal connectivity, system connectivity, commercial vehicle compatibility, increased safety, and increased tourism.

In addition, Ports-to-Plains Trade Corridor will allow for the development of less-congested ports of entry along the Texas/Mexico border and will provide alternatives to other congested corridors that run through major metropolitan

Ports-to-Plains Coalition has many future goals and will need the cooperation and assistance of all the communities along the route. Tommy Arnwine and the Sonora Portsto-Plains Steering Committee have worked very hard on this project and continue to do so.




