County Submits Rent Bid For Proposed Office Space

Coke County Commissioners Court took another step Monday toward firming up plans to construct an auxiliary office building on the courthouse square at Robert Lee. The additional space is needed to alleviate crowded conditions in the Courthouse, and would be used to house the various federal agencies which now have offices in the Courthouse.

The County's governing body agreed on a proposed bid to cover rent for the use of the agencies involved. The rent proposal is for payment for the Soil Conservation Service, the Agricultural Stabilization and Conservation Service and

the Farmers Home Administration. The federal government ordinarily pays rent for housing these three agencies, even though space has been provided free by Coke County since the Courthouse was built.

Also to be housed in the proposed structure would be the offices of the County Extension Service agents. However, these agencies would not pay rent, as the county is required to furnish offices for them.

Another section of the building is proposed to house the Coke County Library, which has during its short life acquired over 9,000 volumes and outgrown the cramped quarters provided in the old jail building.

County Judge W.W. Thetford said the court decided the additional office space is badly needed, and present plans are to use some of the county's federal revenue mediate financing of the structure. He said the money derived from rent to be paid by the three federal agencies should eventually pay for the construction of the new building.

Some funds from Coke County Library are also available for use in the construction costs of that part of the building.

The commissioners also met Tuesday, July 5, attending to routine business and discussing the rent proposal bids.

Congressman **Bob Krueger** Reports

Decision Was Easy, Yet Difficult

As you no doubt by now know, I have made a decision to seek statwide office, a decision reached some time ago, and formalized this past week during a July 4 picnic at my home in New Braunfels, Tex.

The decision to make the race for the United States Senate was, in one respect, a natural and easy one.

In another respect, it was the most difficult decision of my life.

It was difficult because during the three years I have been in congress, I have known the greatest joy of my life, being privileged to serve the people with whom I grew up, the people who taught me life, the people who have had such enormous impact on what I believe, what I am.

In finalizing my decision to seek statewide office, I considered many factors, but foremost among those factors was my concern and affection for the people of the 21st District, those of you who sent me to Congress.

candid if I did not tell you that some loyal and good friends have told me they wish I would remain as their 21st District representative and, although my decision is now firm, it has been deeply gratifying that there are those who think I have served them well enough for them to want me to continue in that capacity.

However, what I have to believe, and what I ask you to understand is that the people of the 21st District will not be losing a congressman, should my endeavor be successful, as I think it will be, but they will be gaining a U.S. senator. The people of the 21st will not only not be forgotten, but will likely be better served by having a voice in the Senate. Hopefully, all of Texas will be better served.

To the other aspect of my decision, the easier part of my de-

The lesson I have perhaps learned best in Washington is that there exists a vital need for strong and courageous and intelligent leadership. Certainly, many of my colleagues in public life possesses these traits. Some do not.

But because Texas is at a crucial point in development, in growth, in potential, I believe it is essential that Texas be represented by a special kind of senator in Washington. Because the state is growing rapidly, the senator must know something about the complexities of growth. Because the state remains a major agricultural one, the senator must understand the uniqueness of an agricultural economy and the needs of rural America. I believe I possess that diversity and I believe I possess it because in serving the people of the 21st, I have been challenged by a congressional geographical makeup that is, indeed, diverse.

In spite of my confidence regarding the endeavor, I've also confronted the fact that this effort will require stamina, much

hard work, a new kind of growth, personal and professional. But I have announced early, allowing not only the people of Texas to examine my credentials, but allowing the people of the 21st District It would be less than substantial time to become acquainted with who might wish to succeed me as 21st District congressman, and by announcing early I hope to be able to explore every portion of this state with a vigor that will be good for me, and for Texas.

But most important, as I move about Texas, will be the constant

demand to rise to the challenge I have undertaken. As I do that, foremost in my mind will be what I have learned from you, the people of the 21st, because it is from you that my strength most surely will come.

Notes From The Oil Field

Andarko Production Co. will drill No. 1 State-Salmon Unit as a Rule 37 project in the Wendkirk (Cisco) Field in Coke County.

The planned 3,750foot venture is located six miles east of Robert Lee on a 20acre lease.

Site is 2,015 feet from the north and 160 feet from the southeast lines of E. Girke Survey 456, A-160.

The Meadow Creek (Canyon oil) field of Coke County gained its third producer and a location west extension with completion of Corpening Enterprises, Fort Worth, No. 1 I. A. Bird, nine miles northwest of Robert Lee, for 195 barrels of 42 gravity oil, no water, with gas-oil ratio of 179-1.

Production was through a 20-64-inch choke and perforations at 5,187-198 feet.

Scheduled also as a 7,000-foot wildcat, it was drilled to 5,266 feet where 4½-inch casing was set.

Location is 660 feet from the south and east lines of 320-1A-H&TC.






