Washington, Jan: 2.-Henri B. Varner of Lexington, N. C., president of the National Editorial Association, is here urging the Postoffice Department to postpone for six months the new ruling of the department denying publishers of the young men, for there are about after a specified term following the expiration of the subscription. on January 1, provides that here- mother who is very low and sudpapers can not carry subscribers in arrears more than one year; semiweeklies more than nine months; trizweeklies more than six months, and dailies more than three months. For every violation the publishers will be fined 1 cent for each four ounces. Since the average newspaper weigh four ounces, or less, each paper sent to a subscriber in arrears for a period longer than indicated will cost the publishers one cent fine.

#### Ticket Scalpers Tired.

San Antonio, Jan. 8 - The injunction law which was recently upheld by the Supreme Court of the United States, and following which decision a similar injune tion was issued by Judge Dwyer against the ticket scalpers here, has had the effect of putting the ticket scalpers out of business in San Antonio. The scalpers have agreed to go out of business if the railroads will drop the proceedings which have been instituted against them under the injunction.

An Indirect Responsibility. Texarkana, Tex., Jan. 4 .- William Jennings Bryan spoke at the railroad station in this city today for about 15 minutes, en route from Palestine to Mena, in which latter place he will make an address tonight. Washington, Jan. 7 .- Assistant Attorney General Goodwin. authority on the admissibility of matter to mail, today decided that Mrs. Elinor Glyn's book, "Three Weeks," is obscene. Postmasters can now refuse to deliver the book:

There is, just at this time, great deal of talk among the people, and much discussion in the public prints, of the financial problem, and alleged duty of legislative bodies, both State and Na. tional, to devise means and pass laws that will, in future, preclude the possibility of money strigen. cies. In the last two weeks Texas business men, of otherwise un questionable business judgement have been talking of the "apparent necessity" for Governor Campbell to call a special session of the Texas Legislature to pass some law that would assure the pople of the absolute saftey of financial institutions. A money stringency is to the larger financial concerns of the East, what a cold shap to a Texas wood hauler. 




