Koelzer Gets Service Pin

A Bovina resident was honored last night in annual award ceremonies of Pioneer Natural Gas Company.

A banquet honoring Amarillo area employees was held at the Country Squire Dinner Theatre of Amarillo. Daniel L. Koelzer, Bovina

serviceman for Pioneer Gas, was honored for 20 years service.

K. Bert "Tex" Watson, president of Pioneer Corporation, presented awards to 133 Amarillo area employees. In three banquets on the Pioneer system in West Texas this year a total of 247 awards will be presented representing 3,440 years of service.

Temperatures have ranged from the high sixties to the eighties for the high each day, with lows generally in the 40s or 50s.

The low on Sunday night did get down to the freezing mark in the area, as the official low on Monday morning at Friona's recording station was 32 degrees.

The harvest of the corn crop, the area's number one crop, has been virtually completed, marking one of the most orderly harvest seasons in several years. Yields, where the crops had not been damaged by hail, was much above average.

"In some cases, we have had reports of farmers, with good-sized acreages, who had yields of above 10,000 pounds to the acre," said Larry Webb, manager of Bovina Wheat Growers elevator.

Harvest of other crops, such as soybeans and sunflowers, also is well advanced, and completed in some cases. The sugar beet harvest in the area also is in its second week. The yield and sugar content for the beets has been called above average, which pretty well has been the case for most crops in the area.

The only crop whose harvest has not begun is cotton, which may have been helped by the light freeze of this week. Cotton observers had been saying that a light freeze would kill the tops of the plants, and allow for the maturing process to be completed.

Most cotton farmers have been hoping for a prolonged open season from the weather, which is just what they have received for the past month or two. And the forecast for the next several days appeared good if that is what farmers want, as the warm afternoons, and cool nights are expected to continue to be the bill of fare most of this week.



Texas Engineering Extension Service offers job training

COLLEGE STATION -Approximately 50,000 Texans employed in electric power, electronics, telecommunications and municipal services received job training through the Texas Engineering Extension Service last year.

So we have decided upon the following course of action to help our patients. From October 1, 1979 through December 31, 1979, the following policies will be in effect:


1. We will make available to our patients new, but discontinued, frames at a savings of 50 per cent. We have many current styles to choose

2. On second pairs of eyeglasses only, if the frame selected sells for \$20.00 or less, we will give our patients the second frame at no charge (free).

3. If the frame selected for a second pair sells for more than \$20.00, we will make the second frame available at a savings of 50 per cent. Many of our patients need a second pair as a "spare" or in prescription sunglasses.

4. We will make every effort to cut costs where we can without curtailing the high quality of professional visual care we continue to provide for our patients.

NOTE: If you have had your eyes examined anytime during the past year (at our office or elsewhere) and would like to have a "spare" pair of glasses or prescription sunglasses, you can take advantage of these savings.






