Whom it may Concern

The year is drawing to a close and your attention is called to the following sections of the Revised Statutes of New Mexico, concerning the working of public roads in your precincts. This notice is givthe law.

SEC. 1285: Revised Statutes, says: "Every ablebodied male inhabitant of the Territory, between the ages of 21 and 50 years, and of sound mind shall be required to work on the public roads, two days in every year, at such time as he may be called upon by the road supervisor of his precinct to do so. Every person owning a team of horses, mules or oxen, and who travels over the road with any kind of vehicle, shall be required to work one day with such team. Any person may ing to the road supervisor a road tax at the rate of one dollar and fifty cents for each team, and for every male so excused, \$1.00.

SEC. 1287: The road Supervisor shall apply all the money received by him as such to the purchase of necessary material or the necessary hiring of labor for the work. The action shall be in the name of the county and a certified copy of the order of the County Commissioners fixing the time for the working of the roads, together with proof of notice to the defendant of the road Supervisors and of his neglect or refusal to do so, as required by notice, shall be sufficient evidence to warrant a judgement in favor of the
