FIRST BALE TUESDAY

WILL RUSSELL, OF LOHN, MARKETS FIRST BALE.

Purchased by J. E. Bell at 11c.—Premium of \$45.—Strict Middling Grade.

McCulloch county's first bale of 1911 cotton was marketed at Brady Tuesday afternoon by Will Russell, of Lohn. There were 1575 pounds of seed cotton according to the gin scales, and A. Oliver, at the north side Perry gin, turned out an even 500-pound bale Wednesday. The bale classed strict middling, and was sold to J. E. Bell, at 11c per pound. A premium list of \$45 was made up, which, added to the price of the bale, netted Mr. Russell an even \$100.

Mr. Russell is a young man, and this is his first year at farming. He came here from San Saba county about three years ago, and up to this year had been employed with A. B. Reagan & Co. He reports having 63 acres of cotton. The cotton which produced the first bale was early cotton, having been planted in March.

The 1911 first bale is just a week earlier than the 1910 bale, the latter having been brought in Tuesday evening, August 7th, by D. B. Mayse, living three miles east of Brady.

FINE RAIN OVER COUNTY

CREEKS AND GULLIES RUNNING OVER.

Most General Rain in County for Three or Four Months Fell Wednesday Morning.

The McCulloch county farmers' smiles broaden with each successive rainfall, and as a result of the rain early Wednesday morning the smile is almost general over the county. Mail carriers from all the different directions report fine rains. From Waldrip to Cow Gap the finest rains in three years fell, and all the creeks and gullies were running over Wednesday morning. From Menard to six miles out of Brady rain was reported, while it rained splendidly from Fredonia to the river, and from Eden to six miles out of Brady. From Brownwood to Rochelle the rain was especially heavy. Reports from all over the county, by telephone and otherwise, are to the effect that the soaking has been general. At Onion Gap a big rain is reported; at Rochelle, a 3-inch rain; at Eden, 1½ inches in the town, while all the surrounding country was fairly flooded with a 5-inch downpour. Good rains also reported at Lohn, Stacy, Millersview, Mevin, Fife, Waldrip. At Mason the rain was not quite so good, ½ inch being reported, but coming this way the rain is said to have been better. At Lightner a fine rain fell, and the tank at Henderson ranch was filled for the first time since it was built.

In Brady and in the community immediately surrounding, the rainfall, as usual, was rather light. The government gauge showed .23 inches. Charter Oak stoves and ranges—the name is familiar to you. Broad Mercantile Co.

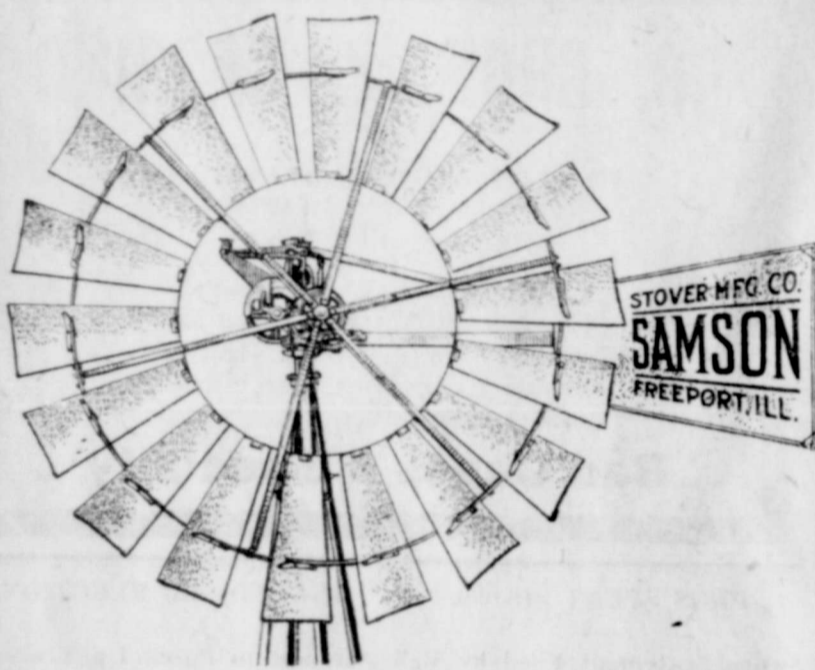

SANTA FE SCHEDULE

REGULAR SERVICE WILL BE DELAYED SOMEWHAT.

Latest Advice From G. P. A. Keenan Says Regular Schedule Only From Seliman.

W. D. Crothers is in receipt of further advice from G. P. A. W. S. Keenan, of the Santa Fe, regarding the installation of regular train service into Brady, in which he states that he regrets exceedingly to advise that their engineering department now is of the opinion that it will be impossible to operate trains between Sellman and Brady by August 12th, as he advised in his previous letter, on account of the present condition of the track, and the further reason that it would seriously interfere with construction work. Accordingly, the regular schedule to and from Brady has been postponed until construction work is further advanced.

However, he states that trains will be operated between Brady and Lometa on the four days of the San Saba Fair, upon the schedule previously announced. Commencing August 12th, regular service will be inaugurated between Sellman and Lometa.

Official Returns.

Commissioners court met in special session last Friday to canvass the returns in the recent election. They gave out the following official count of the vote in McCulloch county—For Prohibition, 877; Against Prohibition, 571. This official report does not include the Stacy box, returns on which were not made within the ten days required by law, and consequently the box was thrown out. Counting the unofficial returns from Stacy, there was an even 1500 votes cast in the county. Stacy voted 21 pros and 31 antis.

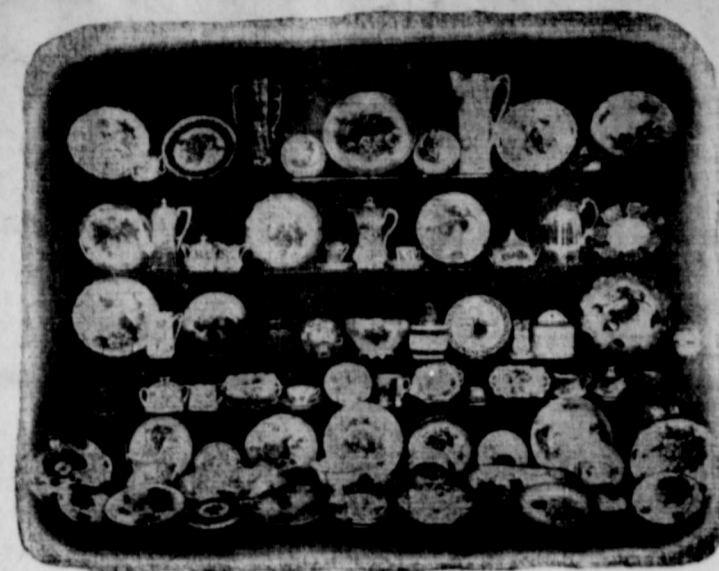

SURVEYING ROADS.

Engineer Gayle Reports Preliminary Surveys About Done.

Engineer Gayle reports having run the transit lines over seven of the principal roads in Road Precinct No. 1, viz: Brownwood, Coleman, Menard, London, Camp San Saba Voca and Rochelle roads, and is at present completing the preliminary surveys on the two remaining roads, the Eden and Whiteland roads. He estimates that somewhere between forty and fifty miles of roads have been gone over.

All that remains of the preliminary work is the running of the levels over the roads and making the estimates as to the cost of grading and road building to the commissioners court. Mr. Gayle has a crew of seven at work on the survey.

TEXAS INDUSTRIAL NOTES.

Greenville has voted an \$85,000 bond issue for the improvement of her city water works.

The total number of cases of mineral water shipped out from Mineral Wells for one month to various places were 12,330, or 153,996 bottles.

Coleman is to have one of the heaviest single spring clips in many years. It is estimated that the clip will run to something near 300,000 pounds.

The capital invested in manufacturing during the past five years shows an increase of 87 per cent; the cost of material shows an increase of 95 per cent and the horse power 94 per cent.

Dayton, Texas, which has only been incorporated two years, has just spent \$10,000 for a school building, \$110,000 on rice canals, \$85,000 on drainage and have just voted \$275,000 for good roads.

The first bale of cotton raised in the world, 1911, was produced at San Benito, and sold on the Houston market June 9th for over a thousand dollars. This beats the world record for early production, at least since the records have been kept.

Texas is making rapid progress in the development of her manufacturing industries, but looking on the other side of the ledger, we find the Texas farmer still hauling \$1,200,000 of raw material to the foreign factory per day. Texas needs more factories.

Intelligence and Texas real estate make a good combination and he who possesses them is well qualified for the battles of life. Every educated person wants a home in Texas, and everyone who is acquainted with Texas won't be happy until he gets it.

Uncle Sam has just completed an inspection of his pastures and he finds the Texas grass in better condition than that of and other agricultural state in the Union. Grass is the cheapest of all animal foods, and we have more pastures and better pastures than any other state in the Union.

The federal agricultural department announces that during the season 1911-12, as heretofore, semi-monthly reports of cotton ginned will be issued, and there will be four reports on the stocks and consumption of cotton. Every farmer in Texas should have copies of these reports, as the information will be valuable to the farmer in marketing his crops and can be secured free on application to the Bureau of Census, Washington, D. C.

Aid the farmer in building good roads, thereby assisting him in getting better schools and churches. Forty miles of good roads, leading out in different directions from a town, is worth more to a town than a big factory or a new railroad.

Uncle Sam has just announced the acreage of cotton harvested from the 1910 crop which shows a total of 32,403,000 acres in the United States and of this acreage, Texas has 10,060,000. The yield was 11,965,962 bales in the United States and 3,072,932 bales in Texas.

Uncle Sam has been inspecting the Texas cotton gins and he reports 4,057 ginneries, 13,461 gins and 928,820 saws. Of

these ginneries, 3,892 are run by steam power, 54 are run by water, 86 by gasoline, 12 by animals and 13 by electricity. Texas has the extremes in power, from the oxen to electricity, and we have a complete variety.

Acting Comptroller C. B. White has given out a statement in which he gives the increase in wealth in Texas during the last twelve months at more than \$70,000,000. More than 60 per cent of this amount is due directly to agricultural development. The comptroller makes the prediction that during the

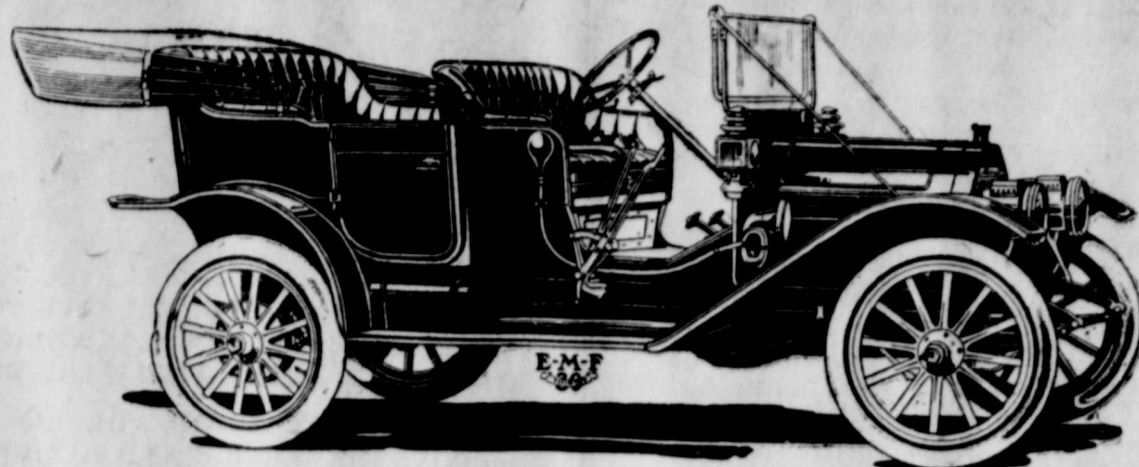
coming year the increase in wealth will pass the hundred million mark.

No one will deny the importance of cheap and quick transportation from ocean to ocean, from port to port, and from city to city. Is not cheap and quick transportation just as essential from the farm to the railway station or to the river landing? Does not the fact that transportation from the farm to the station is 30 times higher than from the station to the point of ultimate distribution appeal for remedy?

The June crop reporter, issued by the federal department of agriculture, reports 33,418,000 acres of cotton in the United States, and of this acreage, Texas is credited with 10,350,000. We have approximately one-third of the cotton area of the United States and 19 per cent of the world acreage. The cotton condition in Texas is reported at 105 per cent as compared with last year and the recent rains in the cotton belt districts of the state have bettered the condition of the plant.

To prepare for the oat crop

costs \$1.62 per acre; seeding, \$1.10; planting, 51 cents; harvesting, \$1.36; preparing for the market, \$1.78; miscellaneous, 46 cents; interest on land value, \$3.28; total of production, \$10.11 per acre. The crop sold for \$16.07 per acre, making a net profit of \$5.96 per acre. The average yield was 34.7 bushels per acre and sold for 46 cents per bushel. It cost 29 cents per bushel to produce the crop, leaving a net profit of 17 cents per bushel. The average value of oat land is placed at \$37.35 per acre and the average size of the oat field was 37.4 acres.

CITY COUNCIL.

Regular Semi-Monthly Meeting Held Tuesday Night.

The city council met Tuesday night in regular session, with all members present.

The most important matter to receive attention was the water bond issue. After considerable discussion, it was decided to have Mr. John B. Hawley, of Fort Worth, an eminent authority on such matters, to come to Brady and consult with the council as to the best method of procedure and also to act as the representative of the city in the appraisal of the property of the Brady Water & Light Co. in case the city decided to purchase their system.

The city secretary was instructed to order tax receipts for 1911.

The matter of telephone rates charged by the Brady Telephone Exchange also received attention of the council, and it was decided to request Mr. Vierling manager of the local exchange, to appear before the next meeting of the council.

It was also decided to employ Judge F. M. Newman to secure possession of the street machinery owned jointly by the city and the city of Ballinger. The contract between the two cities provides for the use of the machinery for a period of one year and it is then to be returned to the other city for a like period. Ballinger has had it for about two years and all demands made on them for the machinery thus far has been ignored entirely. Mayor Conley made a trip to Ballinger about ninety days ago to try to secure possession, but was told that they would be willing to ship it to Brady within thirty days, but have failed to do so.

ABILENE STORM.

Buildings and Streets Are Flooded—Hail Three Inches Deep

Abilene, Texas, July 31.—Abilene was visited by severe wind, rain and hailstorm this afternoon about 6 o'clock. The storm lasted over an hour. Hail is about three inches on the paved streets.

Every window light of northern and eastern exposure in the town was demolished, skylights were broken, stores and offices flooded and the streets are perfect rivers.

Both telephone offices are temporarily out of commission. No lives were lost and no houses demolished.

(Later) Abilene, Aug. 1.—In addition to enormous property damage, yesterday's storm resulted in one death, Richard Milner, aged 18 years, living near the epileptic colony. The young man went out to the barn to see about the horses when the structure blew down on him, crushing him to death. The house of John Cunningham, living near Lytle Lake, was blown down and Cunningham severely bruised.

In addition to John Cunningham reported injured, Mrs. Clifford Herter, living six miles north of this city, was perhaps fatally injured, her jawbone being broken.

IN THE WORLD OF SPORT

John Paul Jones, Cornell's Wonderful Mile Runner.

Probably the greatest performance which has been accredited to any man on any athletic field in the last two decades was shown recently by John Paul Jones at Cambridge, Mass., when he broke the record which stood for a mile for sixteen years. It was only by one-fifth of a second that Jones beat the mark which was made by Tommy Connett years ago, but it was enough time to give the Cornell boy a mark to his credit which is not likely to be broken in twice sixteen years unless it is done by Jones himself.

It is only once in a great while that a runner of the caliber of Jones is developed. He is one of those rare athletic prodigies which crop out once in maybe every twenty years.

It is claimed by experts that Jones has not yet reached the zenith of his career as a runner and that he will do even better for the mile.

Diving Rules Displeas.

The regulations for fancy diving suggested by the Olympic committee for the games of 1912 have been received by the Amateur Athletic union. They do not meet with the approval of Americans. Several of the most spectacular feats obtaining in this country have been excluded from the list of permissible dives altogether. The score card shows valuations not always in accord with American ideas, and the limit allowance of ten points is also criticised. It is probable that the matter will be thoroughly thrashed out by our authorities and suggestions for changes made according to their decision.

Schmidt Out of Game For Good.

It is believed here that Charley Schmidt has caught his last game of baseball for the Detroit club and that he never will catch a successful game for any other club. His arm has not improved one bit since he joined the team two months ago. He can hardly lob a ball to second base. He has had a good deal of experience at this year's game, having been at No. 7 in this year's boat, a member of the eight in his freshman year and for three years a member of the St. Paul school crews.

Pay \$15,000 For Stallion.

General H. 2047, was sold recently to A. W. Parish of Cleveland, O., acting on behalf of the Russian government. The famous trotting stallion was owned by W. M. Parslow and George Haas, and the price paid was \$15,000. According to Parish, he will be shipped to Russia at the end of the season.

Childs Yale Track Captain.

Clarence C. Childs, '12, Law, of Fremont, O., has been elected captain of the Yale track team. Childs got his "Y" in the football game against Harvard last fall as tackle and took third place in the hammer throw at the intercollegiate track meet at Cambridge.

Senator William Paul Dillingham, chairman of the special committee to investigate the fraud charges in the election of Senator William Lorimer of Illinois, is classed as a pro-Lorimer man. He is chairman of the senate committee on privileges and elections, but was not a member of the old sub-committee that conducted the previous inquiry into the Lorimer affair.

Messrs. Dillingham, Gamble, Johnston and Fletcher voted for Lorimer in the last session, and Mr. Jones voted against him. The three new members of the committee, Messrs. Kenyon, Lea and Kern, are all supposed to be anti-Lorimer. It will require all summer for this committee to get the facts and make its report.

A native of Vermont, Senator Dillingham is sixty-eight years old and has served in the upper house of congress since 1903, when he was elected to fill the unexpired term of the late Justin S. Morrill. Since then he has twice been re-elected for full terms. Before going to the senate he had served in the state legislature and was governor of Vermont from 1888 to 1890. He is a lawyer by profession and Montpelier is his home town.

A Missouri Investigator.

Congressman Courtney Walker Hamlin of Missouri, chairman of the committee on expenditures in the state department, is one of the busiest of investigators in Washington just now. In the fashion, no less than fifteen inquiries into public departments and their affairs being under way. Among the revelations to Mr. Hamlin's committee was an admission of Dr. Jacob H.

Hollander that he received money from both Santo Domingo and the United States while acting as special agent for the latter.

Mr. Hamlin is a native of North Carolina and is fifty-three years old. While still a lad his parents removed to Missouri, where the embryo statesman grew up on a farm. He was educated in the common schools, studied law and was admitted to the bar in 1882. Before election to the Fifty-eighth congress as a Democrat he had never held public office. He was not returned to the Fifty-ninth, but since then has been regularly re-elected.

DIFFERENCE SETTLED.

Between Frisco and Santa Fe Yesterday Afternoon.

Late last night The Standard was informed that the matter of the refusal of the Frisco to allow the Santa Fe to cross its tracks had been adjusted at 3 o'clock, and work on the laying of steel would be started again at once.

The Frisco has been censured by some who thought the action was taken by them to prevent the Santa Fe from building into Brady. Such, however, was not the case, the action being merely to determine the responsibility for maintenance of the crossing, and is similar to courses pursued by railroads wherever a like situation arises.

The Standard, with the citizens of Brady, is glad the trouble has been adjusted, and hopes to see the Santa Fe trains crossing Bridge street during the San Saba fair dates next week.

WORK ON S. F. STOPPED

RAILS LAID TO THE FRISCO CROSSING AT SELLMAN.

Frisko Refuses to Allow Santa Fe to Cross Till Agreement for Maintenance is Signed.

Quite a party of Brady citizens who chanced to go out to the Frisco crossing at Sellman shortly after dinner Wednesday to see how the work was progressing and to watch the laying of the steel on the Santa Fe, were treated to the rare sight of two great railroad systems locking horns. Just as the party reached the point of operation section foreman, Herring, of the Frisco, took up his position in the middle of the right-of-way and warned the Santa Fe track-layers not to attempt to cross the Frisco tracks. The steel had been laid up to the crossing and there remained nothing further for the Santa Fe track-layers to do but lay down their tools and quit work until the barrier is removed. Accordingly, the crew was called off and returned with the engine to Richland Springs. Work on stringing ties west of the crossing was continued as before.

The difficulty seems to have arisen over the failure of the Santa Fe to sign proper contracts providing for the installing and maintenance of the crossing, switch towers and interlocking devices. This is no small item, and it is said will approach in the neighborhood of \$500. Naturally this extra cost and expense falls upon the company desiring to cross another company's tracks, and while a verbal agreement had been reached between the officials of the two systems, the Santa Fe neglected signing the contracts. It is thought that this difficulty will be overcome in the next day or two and work will be resumed as before.

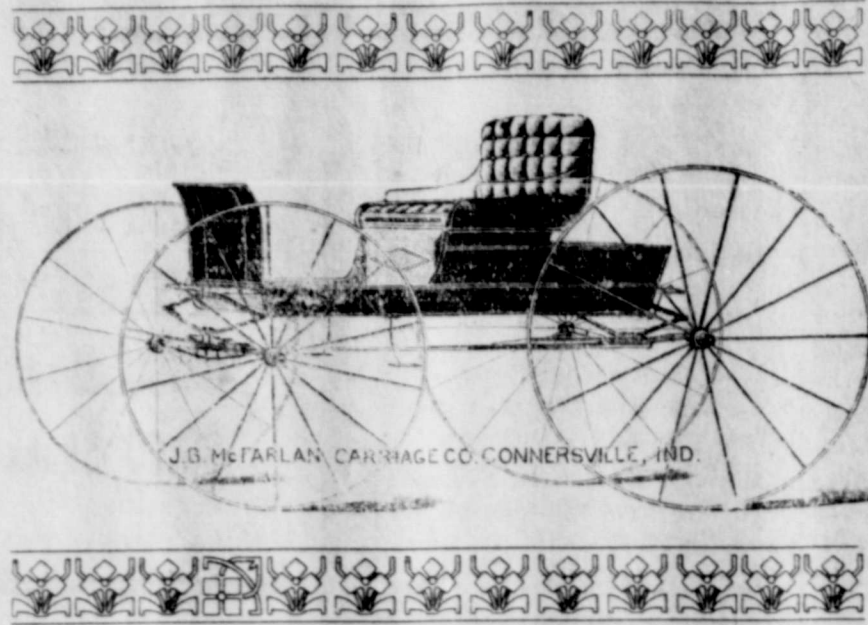
In consequence of the delay, and the unfinished condition of the track it is not at all unlikely that the Santa Fe will not attempt to run its trains to the San Saba fair from Brady, but will make the start from Sellman. Circulars just issued by the Santa Fe quote a rate of \$1.90 for the round trip from Sellman. Engineer Brewster reports that it will take two days to connect with the Frisco track, or the Santa Fe main line to Eden. If the trouble about the crossing can be settled immediately it is probable that the work will be completed this week yet.
