BETTER FIRE PROTECTION

WILL GREATLY REDUCE KEY RATE IN BRADY.

Letter From C. B. Roulet, Fire Insurance Actuary, Making Some Recommendations.

Through the courtesy of the Brady Land Co. the Brady Standard is enabled to publish the following letter from C. B. Roulet, state fire insurance actuary, of Dallas, setting forth recommendations for improvement in the fire protection of Brady, whereby the key rate of the city will be materially reduced. Mr. Roulet also sent a copy of the letter to Mayor F. M. Richards, urging favorable consideration of the city authorities of the corrections suggested for the defects enumerated in the list, and in which Mr. Roulet offers to furnish any additional information that may be desired.

The following is the list of improvements recommended by Mr. Roulet, following the inspection made January 6, 1913:

1.—WATER WORKS:

a. As you have but one boiler to furnish steam for two pumps and the proposed electric light plant, I strongly recommend the installation of an additional boiler.

b. In order to be prepared for an emergency such as the breakdown of fire pump, I recommend the installation of a duplicate fire pump of approved type, having a capacity of at least 500 gallons per minute. Upon installation, the present charge 1-(f) of .07 will be reduced to .04, securing a net reduction of .03.

c. Experience has demonstrated that metering of service connections is a very valuable asset to any city in the conservation of its water supply, and you have already 50 per cent of your service equipped. I suggest that you meter at least 25 per cent more, so that the present charge of .01 in your key rate for less than 75 per cent of services to consumers metered, may be removed.

d. The best engineering practice has proven conclusively that mains not less than 8 inches in diameter should be laid in mercantile districts, in order that the present charge of .10 for 100 per cent less than 8 inches in mercantile section. I recommend the replacing of all mains in mercantile district with 8 inch cast iron pipe.

e. By installing additional fire hydrants in residence section so none will be over 600 feet apart, the present charge of .03 for 25 per cent as above, will be removed.

f. An objectionable feature exists in the prevalence of dead end mains in your system as pressures at hydrants at these points are greatly reduced, hydrants become stopped up, water stagnant, etc., and, in addition, consumers in such localities receive a poor supply of water at low pressure, so that I strongly recommend that loop mains be made of all dead end mains.

g. When the building for the electric light plant is completed, approved labeled fire doors should be placed on both sides of openings in division wall to avoid a charge of .10 on your key rate for an additional occupant.

h. In order that engineer

may increase the pressure on mains at the sound of alarms of fire, I strongly recommend the installation of a telephone or fire signal at pumping station.

i. Under present conditions, the water level in elevated tank is not readily ascertainable to engineer at pumping station and, in order that the very apparent danger of allowing the tanks to get too near empty, I strongly recommend the installation of an altitude gauge.

j. Oily waste and rags are subject to spontaneous combustion and if not properly cared for are liable to cause disastrous fires. The means of removing this hazard is simple and consists in installing approved oily waste cans. Only one will be required in pumping station.

2.—FIRE DEPARTMENT:

To insure long life for your hose, I would submit for your consideration, the necessity of erecting hose rack for properly washing and drying hose.

3.—POLICE SYSTEM:

A city the size of Brady requires the services of four full paid policemen, so that by the employment of three additional men the present charge of .07 will be removed.

4.—BUILDING LAWS:

A copy of the standard building code may be secured upon request from the state insurance board, Austin, Texas. In order to obtain credit for adequate building laws, it will be necessary to adopt the code in toto, as well as complying with Section 69, page 42, as follows:

"Every building and the tops and sides of every dormer window thereon, within the city limits, shall be covered and roofed with tile, slate, tin, gravel composition or such other incombustible material as the building inspector may authorize. Nothing in this section shall be construed as prohibiting the repairing of any shingle roof, providing the repairs do not exceed twenty-five per cent of the cost of a new roof."

Credit of .05 will be allowed for the adoption and rigid enforcement of same by a competent, paid city building inspector.

5.—STREETS:

With reference to the conflagration hazard of your city, I suggest that you consider the advisability of paving or macadamizing all streets in the business portion, which, in addition to permitting the quick handling of fire apparatus, would also reduce your key rate .02.

JINX POLL TAX RECEIPTS.

1913 Receipts Number 1313—Exemptions, 13.

If the holder of poll tax receipt believes in hoodoos, he need not be alarmed, for the tax collector's office shows that he will have lots of company this year. Remarkable coincident as it may appear, there were an even 1313 poll tax receipts issued, and an even 13 exemption receipts, bringing the total up to 1326 receipts. This, as compared with 1713 poll tax receipts not including exemptions, paid last year up to February 1st.

Mercury is the only box that can boast of a gain over last year, the great falling off in payments being attributable to the fact that there will be no elections of importance this year. The following is the number paid at each box in the county, this list being subject to correction:

ENCOURAGING PROSPECTS.

Good Indications Encountered in Millersview Well.

The well at Millersview being drilled by Chas. Stewart is now down 1041 feet, with a fishing job on hand. In an attempt to shut off some water in the well, the casing had to be reset, and after four joints had been pulled, the string parted about thirteen joints down and fell back into the well. This has all been pulled, with the exception of one joint at the bottom.

The drillers announce that they expect to go as deep as the machinery will go. They have been greatly encouraged by the fact that every time they hit the sands oil and gas was found. They expect to strike the Lohn shallow sands at a depth of about 1100 feet, the Millersview well being twenty-three miles west of Lohn and the formation dipping in that direction. As soon as the casing can be reset, drilling operations will be resumed.

The well at Broadmoor was completed last week, the drilling being stopped in slate rock by the breaking of a sand drill. It is very likely that drilling would have been continued for some time but for this accident. Mr. F. C. Stewart of Tulsa, representing the Okla Oil Co., visited the well last week, and finding it had reached a depth of 1204 feet when the break occurred decided not to continue. The well was cased with 240 feet of 10 inch casing and 600 feet of 8 inch casing was in fine shape for going deeper, an eight inch hole having been maintained up to 1204 feet, and the company having a quantity of six inch and five inch casing on hand should it have been found necessary to reduce the size of the hole. At 975 feet a good showing of oil was found. Following Mr. Stewart's decision not to continue, all the casing was pulled and the machine gotten in shape for shipment.

At Fife the well was completed to a depth of over 1200 feet a couple of weeks ago by John Marks. This well was also abandoned, Mr. Marks returning to his home at Knightstown, Ind.

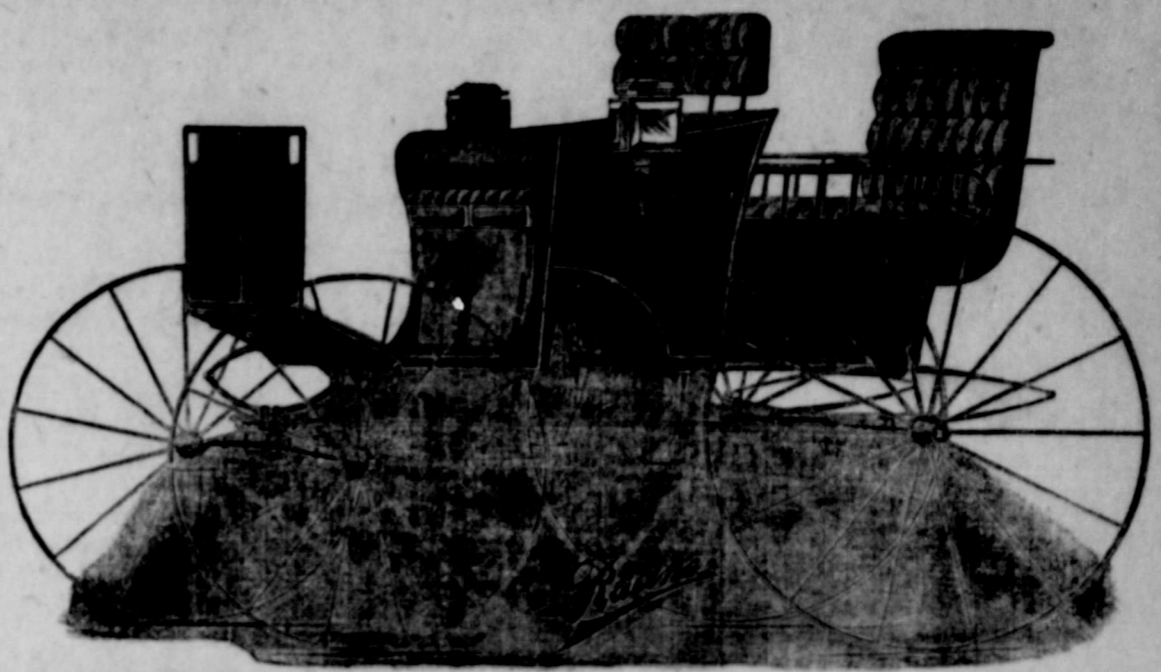
