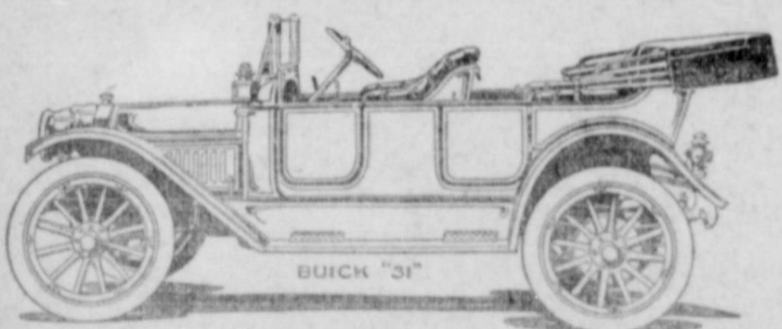



Buys Big Ranch.

WILL MEET MONDAY.

Civic League to Consider Important Matters.

At the regular meeting of the Civic league last Tuesday night, it was decided to change the time of meeting to next Monday afternoon at 3:30 o'clock in order to enable a better attendance of the business men and the ladies of the city as well.

It was decided to urge payment of membership dues at once, as the money is needed for the purchase of sanitary trash cans, and all members are requested to respond without further notice. The dues are but \$1.00 for each family, whether or not more than one in a family are members. Wire net cans have been decided upon, as they will permit of being washed and kept sanitary.

The duty of the overseer will be to look after the sanitary condition of his ward, and report all cases of neglect. Owners of such property will then be notified to clean up within a certain period of time, and failure to do so will result in the proper penalty being assessed.

The cleaning up of the cemetery was also brought up and, unless some better plan is presented, a clean-up day for the cemetery will be named.

These, and other matters will come up for further settlement at the meeting Monday afternoon, March 10th at 3:30 o'clock in the room in the rear of the Commercial National bank. The members, and citizens in general, are urged to attend.
