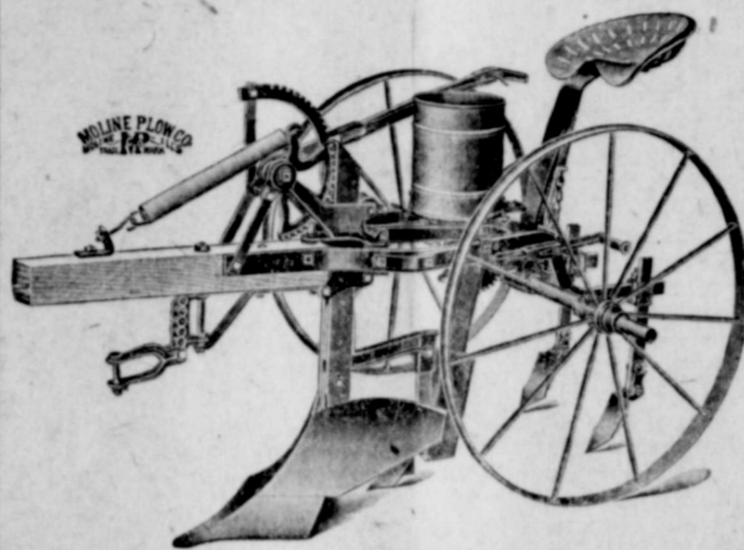

FROM A FORMER CITIZEN
 Yoakum, Texas, Feb. 11.
 Editor Brady Standard:

I have thought many times I would write to The Standard and would back off, but now here I come.

I like this country well, although there is more rainfall than is agreeable at times. Last year was a very good year for farming; cotton made one half to one bale per acre. Corn was good but the fall rains rotted most of the crops in the fields. Peaches, pears or plums do not do well here, but look out for the figs and grapes.

INDUSTRIAL CONGRESS.

To Hold Convention and Memorial For Col. Exall.

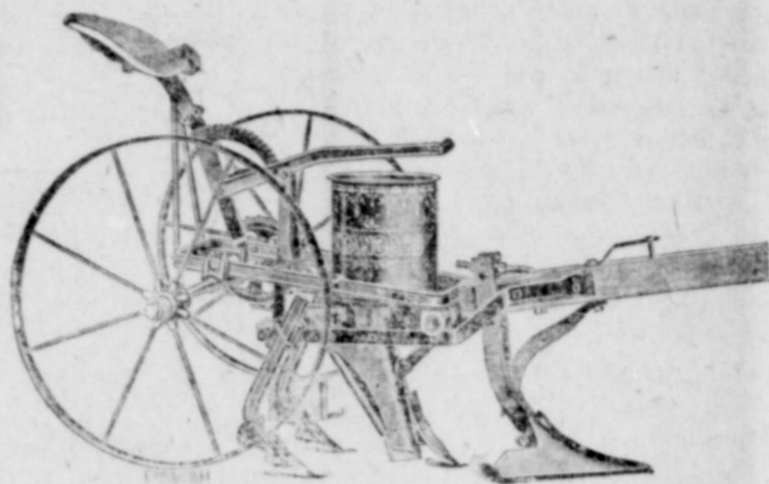
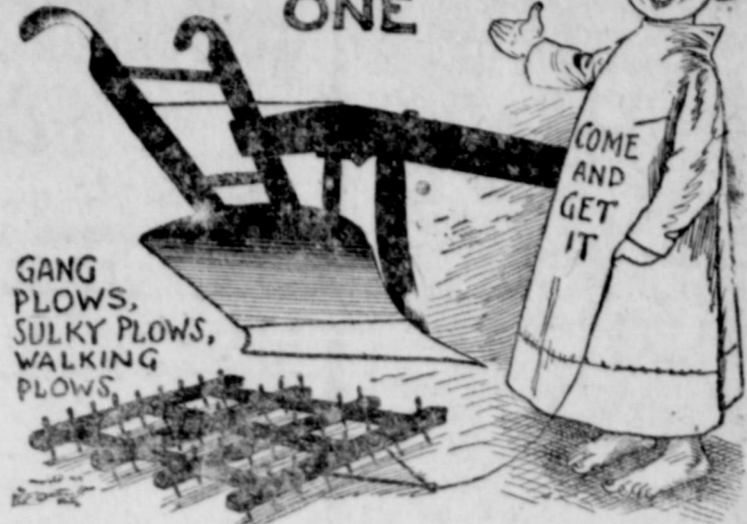
February 21st is Industrial Congress Day at the National Corn Exposition in Dallas, when the annual convention, deferred from December 13th, last, will be held, and the prize award of \$10,000 for the best profits in the 1913 crop contest distributed to the winners. A program of interest to farmers and those concerned in better farming will be carried out during the day, consisting of addresses as follows: "Some Things the Industrial Congress May Do," by Prof. C. P. Bull of St. Paul, Minn., Secretary-Manager of National Corn Exposition; "The Marketing of Agricultural Products," by Prof. Chas. B. Austin, of the University of Texas; "Use of Silo in Saving Drought Stricken Crops," by Prof. C. M. Evans, of A. & M. College; "Boys and Girls' Hog Clubs," by Messrs. C. C. French and John A. Stafford, of Fort Worth; "Baby Beef Clubs," by Hon. Ed R. Kone, Commissioner of Agriculture, and Mr. J. Boog-Scoot, of Coleman; "The Elimination of Waste in Marketing," by Hon. Clarence Ousley, of Fort Worth.

The memorial service at night, in the Fair park Coliseum, in charge of Hon. John H. Kirby, of Houston, will consist of the distribution, by Governor Colquit, of the prize awards, followed by a series of one, five, ten and fifteen minute tributes to Colonel Exall by prominent citizens.

Some suggestions have been made as to continuing the work of the Congress; one of these is to raise an endowment of \$500,000, the interest being used for prizes and expenses. Another suggestion is to charge contestants an entrance fee to provide the prize fund, and still another is to have a great Henry Exall Memorial Society, with a membership fee of \$2 open to every citizen in Texas, and to give the members in return for their subscription in 1914 a copy of the Henry Exall Farm Book and a memorial medallion; and in ensuing years the yearbooks and other publications of the Congress. The difference between the cost of the farm book and medallion and the membership fee will carry on the work if enough men can be found who love the memory of Colonel Exall and desire to perpetuate it in the way he would have chosen. Other plans, also, have been suggested and will be considered in connection with continuing Col. Exall's work.

Local Option Petition.

A petition to the commissioners' court praying for an election on the whiskey question in San Saba county is being circulated. It was circulated in town Saturday and, we understand, about 90 names were secured. The court is in session this week and the original intention was to present the petition to the court this week, tho it has not yet been handed to the court.

The law, we believe, requires the signature of 250 qualified voters to a local option petition and that notice of an election shall be given for not less than 20 days.

The last local option election held in this county was March 24, 1904, when the county went dry by a majority of 23 of a total vote of 1097 votes cast.

The antis are dissatisfied with the new liquor laws prohibiting the shipment of intoxicating liquors from wet into dry territory and some of the pros are rather courting an election for the reason that the county is now under the old law which made a sale a misdemeanor offense. They believe the county will remain dry and that a new election will place this county under the more recent law which makes its violation a felony offense. The pros also point to the fact that the antis in the legislature almost to a man voted for the Allison liquor law.

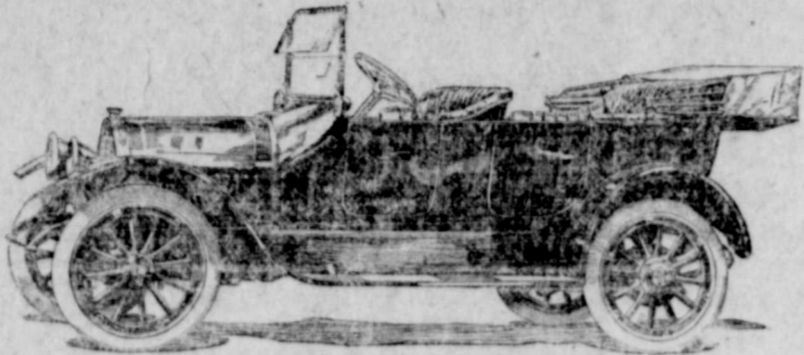

THE BRADY-MASON PIKE

This is the first installment of a series of articles on the Brady-Mason toll pike road, and should prove of interest to readers of The Standard. These articles are written by a man who is thoroughly familiar with the subject, having spent many years of his life as a citizen of the state of Tennessee, where these roads are to be found on every hand, and where their operation is a pronounced success. The Editor.

Turnpikes vs. Railroads.

Mason, and Mason county, have had many propositions for a railroad. Time after time our people have become enthused over the prospect; many have subscribed liberally; some have given away much in money and lands for right of way, and all have longed and hoped and cried in vain for the railroad as the only realization of our

fondest hopes. But all our cries and struggles have been in vain. Our hopes have bloomed but to die, and our railroad castles have melted away like ice palaces by a summer's sun. And why? We have staid our hearts and fixed our hopes on foreign syndicates, trusts and corporations that had no interest in us but for what they could get out of us, and our perpetual disappointment is the legitimate result of our misplaced confidence. That is of fixing our "star of hope" in a sky too foreign to our own sphere of operation. And yet our disappointment does not exceed by far that of many communities who have obtained a railroad. Brady itself is only a partial exception. Brady has indeed reaped the normal benefit from the coming of the railroad. But we find the note of disappointment there among those,

too, who were the active promoters in obtaining the same, and who laid liberal donations of cash at the feet of corporations who were to own and operate the road when built.

To the average town or community there is nothing more easily over estimated than the benefits to be derived from the coming of a railroad, and therefore the majority of towns and communities that succeed in obtaining them suffer much disappointment in that they are not so greatly benefitted as they had expected.

And doubtless such would be the case should the long proposed railroad be built from Brady through Mason. Some would be benefitted, and some greatly benefitted; some would be damaged, and some greatly damaged. And the average benefit accrues to the majority.

The Farm Pike Proposition is different. It is an even benefit to every man it touches. The merchant at Mason would receive his freight from Brady at 20 cents per hundred, which would be the same as railroad rates. Whereas now he pays 40 cents per 100 pounds. And the teamster would make vastly more hauling over a first-class turnpike at 20 cents per hundred than he now makes at the rate of 40 cents.

The Passenger Problem. The automobile would most admirably solve that. A twelve passenger car could run easily from Brady to Mason in one hour, if the road is held by private corporation, or in one hour and forty minutes if held by the counties. The legal rate of travel over county roads being 18 miles per hour.

The same car would make five round trips a day between the above towns, or deliver to and from either place sixty passengers. So the passenger fare could be reduced to railroad rates, and would never be more than five cents a mile. The life of an automobile would be increased three fold, and its repair bills would be many times less than now while running over our present rough roads.

And this mode of carrying passengers, when properly prepared

for, is far more satisfactory than the railroad, as there is no weary waiting at the depot, and no missing of connections. But the passengers may start and arrive any time they please.

Otherwise a good pair of horses could take twelve passengers to Mason and return the same day at five cents per mile. This would make eighteen dollars if loaded one way or thirty-six dollars if loaded both ways. At three cents per mile, railroad rates, he would get \$10.80 loaded one way or \$21.60 if loaded both ways, and his toll would only be \$1.50 for traveling over the pike. So you see that turnpike traffic can easily compete with railroad traffic in either freight or passenger traffic. And there are many other advantages of the turnpike over the railroad which will be discussed in the next issues.

Next week will be discussed "The Influence of the Turnpike on Real Estate."

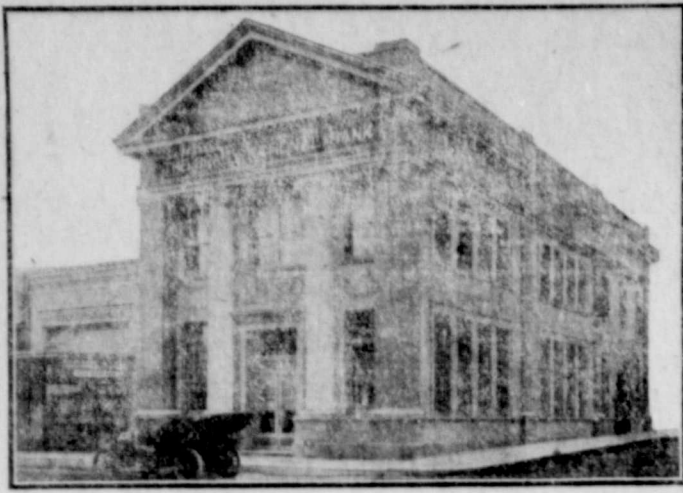
