

SOUTH SIDERS CONTRACT 201 FT. CEMENT WALKS ON SQUARE

DOUGLAS OIL CO. PAYS RENEWAL ON DRILLING LEASE

An item of considerable interest to investors in McCulloch county oil lands and acreage, is announcement of the payment of renewal rental on all of the leases held by the Douglas Oil Co., of Douglas, Neb., on its holdings about five miles northwest of Brady. The company's original holdings comprised 4,000 acres, most of which acreage they still retain. The Douglas Oil Co.'s test well on the A. G. Dahlberg land, Survey 1134, has been shut down since last fall with an 8-inch hole at 2290 ft. It is generally understood that the company expects to complete the hole to the 3500 ft. depth. Casing and equipment for a 3500 ft. hole is on hand, and the purchase and delivery at the well site of a brand new 3,500 ft. cable just prior to the closing down of the well, bear out this statement.

The Douglas Co. had 30 ft. of sand with a good showing of oil at 660 ft. and gas under the sand. At 860 ft. a second showing of oil was had.

SEEK RELEASE OF MEN. ACCUSED OF SWINDLING. BY HABEAS CORPUS TRIAL

Habeas corpus proceedings have been instituted by Judge Joe A. Adkins, representing H. Harris and S. L. Goodson, in an effort to secure their release from custody. The two men were arrested at Stacy the past week by Sheriff Wall on a charge of swindling, it being alleged that they sold spectacles to citizens under misrepresentation, and also that they raised a check given them by A. F. McCoy of the Nine community, from \$23 to \$25.

Sheriff Wall carried the two men to Coleman, where the habeas corpus trial will be had before District Judge J. L. Woodward today. The men have been confined in the local jail since their detention, having been unable to make the \$1,000 bond, each, set at their preliminary examination. Sheriff Wall states that since their arrest, two additional charges have been filed against them, one for stealing and another for swindling. It appears the men worked the Nine community, then made their way through the Rochelle, Mercury and Milburn communities into Brown county, and from Brown into Coleman county, then back into the Stacy section of McCulloch county. Several complaints, it is stated, would be filed against them in Coleman county. The second swindling charge and the theft charge come from the Mercury and Milburn communities, where it is alleged they raised a check, and also carried off with them the lenses to a pair of glasses belonging to an old lady.

BRADY COMPRESS TO CLOSE PRESS NEXT SATURDAY

The Brady Compress will make its final run for the 1919-20 season on next Saturday, April 10th, according to Wilbur Lee, compress superintendent, and will then close the second best season's run in its history. Something like 30,000 bales will have been pressed this season, with some 8,000 or 10,000 bales still out in the Brady territory. While the press will not operate after this week, the warehouse and platforms will be kept open for concentration purposes and for the accommodation of cotton men and shippers.

The best year in the history of the local compress was 1914, when 50,000 bales were pressed. The press this year was continued in operation longer than any previous time in its history.

"BONEHEAD" BY DRILLER RESULTS IN BIGGEST WELL IN STEVENS COUNTY

Ranger, Texas, March 26.—A bonehead pulled by a rig builder is said to be responsible for one of the best producers in Stevens county, according to information obtained here this week.

The well located by the Texas Venture Oil Company, and sold to the Montreal Oil & Refining Company on the J. L. Harris tract, 12 miles southeast of Breckenridge, brought in nearly two months ago, and is said to be now producing better than 6,000 barrels daily.

When the rig builder started to construct the rig for this well he was so "turned around" that he built the rig 100 feet south of a certain rock pile, made by the geologist who made the location, when it should have been constructed 200 feet north. The discrepancy in the location, although it was on the same lease, was not discovered until after the well had spudded in and was not changed. The pay sand was found at 3,100 feet, the well coming in for 4000 barrels. It was shot and increased the flow to 9000 barrels for a short time.

Joe Schuler, field superintendent of the Montreal Oil & Refining Company, is still well pleased with the bonehead pulled by the rig builder.

CITY ELECTION BEING HELD TODAY—NO OPPOSITION TICKET OFFERED

The city election, being held today, promises to be almost as quiet an affair as was the school trustee election held last Saturday. The printed ballot gives no opposition names to any of the candidates for office, which practically assures election of those offering by unanimous vote. No names are offered for the offices of city secretary and city marshal, these offices having been virtually abolished. The ticket reads: For Mayor, J. E. Shropshire; For Alderman (three to elect), G. B. Awalt, Henry Miller, Roy Wilkerson; For Recorder, N. G. Lyle.

BLOCK REGULATION CEMENT WALKS TO BE LAID ON SOUTH SIDE SQUARE

CONTRACT FOR BUILDING LET TO C. R. HORN—ASSEMBLING OF MATERIAL ALREADY IN PROGRESS—CITY EXPECTED TO CONSTRUCT CROSSINGS.

The much-heralded and much-desired block of cement walks on the south side of the Brady public square is to become a reality all the property owners having come to an agreement as to the building and the contract having already been let to C. R. Horn. Sand and gravel is already being placed on the ground, and the work is to be begun without delay and completed at the earliest possible date.

The new block of walks will be built in strict conformity with the city regulations, requiring walks in the downtown district to be of uniform 10-foot width, and the curb will be 18 inches above the level of the square. The stretch of walks will extend from the corner of J. F. Schaege's saddle shop to the corner of J. C. Wall's building, a distance of 201 ft. The city, it is understood, will furnish the connecting link between the string of new walks and the walks on the balance of the south side, and those on the west side, by building concrete crossings.

EASTER SPELL BRINGS FREEZING WEATHER

Easter Sunday brought one of the coldest and most disappointing spells of weather of the new year. Instead of the display of Easter finery, sure to be in evidence ordinarily, upon so momentous an occasion, last winter's furs were very much in evidence, and a warm fireside was much to be preferred to the customary Easter parade.

While the greater part of last week offered very pleasant weather, thereby stimulating trade and the purchase of much Spring merchandise, Saturday proved a most disagreeable day, a cold wind blowing from the west and bringing with it clouds of dust and sand. Towards evening the wind abated somewhat, and it appeared for a time that pretty weather was in store for the greatest day in church history. At seven o'clock, a fresh norther blew up increasing in intensity through the night, and causing the mercury to tumble, the thermometers registering below freezing.

The norther continued blowing until Sunday afternoon, the sun caused the weather to moderate considerably. Sunday night, however, the thermometer again registered below freezing, and, according to reports, it was three degrees colder than Saturday night, although the absence of the wind made it less apparent.

Much apprehension was occasioned by the late freeze on account of the fruit, which was well advanced and which, in the opinion of many citizens, has been killed. Others state that the fruit has not suffered material damage, even though ice was formed by the two successive freezes and much young vegetation was turned black by the cold.

B. A. HALLUN BUYS MELTON STRING OF RENT HOUSES

A real estate deal of considerable magnitude was closed Monday in the transfer to B. A. Hallum of the Melton string of rent houses located on Melton avenue, on the north side, and east of the Melton homestead. The purchase was made from H. R. Hannum of El Paso, who acquired the property from Mrs. W. T. Melton a few years ago, when Mrs. Melton purchased an irrigated farm and orchard near El Paso. Mr. Hannum was in the city Monday closing the deal.

The property includes five residences, all being well-built, one-story frame dwellings, ranging from four to six rooms. The terms of the deal were not announced. Mr. Hallum states that the purchase was made solely as an investment. The houses are all occupied, and their proximity to the business section makes the property of increasing value.

Mr. Hannum left this noon over the Santa Fe upon his return to El Paso. Another deal of interest to Brady citizens was the purchase by Otto Fahrenthold from S. W. Hughes of the Tidale homestead in the south part of town. The residence is a well-built 7-room structure, occupying a quarter block of land, well improved. The lot is well-located in a very desirable section of the city, and is a most valuable piece of property. The consideration is given as \$1,000.

A deal recently consummated, was the sale by S. W. Hughes to F. C. Foster, driller at the Thomas White-land well, of the Tidale house, located west of the Baptist church. The property consists of a lot 100x100 ft., and a three-room house with two galleries. The sale price was \$925.

ARREST MILBURN GREEN HERE FOR THEFT OF SEED COTTON IN ERATH COUNTY

Milburn Green was taken in charge here Saturday by Sheriff Wall on a charge of having stolen seed cotton near Stephenville in Erath county. The sheriff of Erath county arrived here Sunday morning, and took young Green back to that county with him for trial.

WHAT THE CENSUS SHOWS.

The 1920 census reveals the fact that the center of population has moved towards the east. For years there has been a steady movement in a westerly direction, but that is now changing and a reverse trend is noticeable. This population drift is indicative of some economic facts, and reasons on these facts. It shows that there has been a movement from the farm to the city; and this, owing to some special attraction which the city periodically has over the country. When wages are high in the industrial centers, labor leaves the more uncertain gain of the country and seeks the steady remuneration of the city. The past six years have been years of unexampled industrial prosperity; the calls have gone out for labor, and the answer is a drift of people to the east. Also many people have kept up the cultivation of farms while they themselves have moved to the city. This has been more practical in recent years because of automobile transportation. As distance is overcome by rapid transit, more people will seek the easy life of town, while drawing their revenues from agriculture.

Perhaps the most important factor in this eastward drift was the industrial boom developed by the war. The very high wages which the war brought about struck the cities first, and even when the increase did reach the country, wages were not so high there; this made young men, especially, leave the farms and seek the larger money. This is no freak or unaccounting thing. It rests on unaccounting laws and on traits of human nature. Long ago the Old Book said: "Where the carcass is there shall the eagles be gathered together." The circling flocks in the air are no surer sign of booty than the crowded trains. All seek the spoil to divide it.

It may be said, however, that the eastward drift is only temporary. Much that has moved east belongs west, and many who belong east will move west. Whenever hard times and industrial depression strike the country the city is the first place to feel it. Hard times strike the wage-earner first, and he moves in the path of least resistance. The course of empire is westward. There may be delays and eddies, but the stream flows in one direction. Until the human tide has found an economic level, this flow will continue. After that the movements will be more in the nature of oscillations; these oscillations becoming narrower as the world grows older. At last, there will be fixity and the end.—San Antonio Express.
