

Coke County Ships 12,000 Mutton

Floyd Modgling eestimates that approximately 12,000 fat mutton from Coke county have been shipped out to market this season. And we know no one who is better authority on the queskeeps close tab on the sheep movements in this part of West Texas.

Mr. Modgling estimates that the mutton averaged something like \$8,50 around, counting wool and the prices the mutton sold for on the market. This would make more than \$100,000 coming to the sheepmen of the county this season. A snug little bit of "terbacker" money, to say the least.






