

## School Bond Election Saturday in City Hall

Bronte voters will go to the polls tomorrow (Saturday) and vote on the question of whether or not the children of the elementary grades will have a new school building.

Three propositions are to be voted upon. The first one is for or against the issuance of bonds for the construction of the new building, and the other two are included in the polling to simplify the legal work necessary for issuing the bonds. The last two propositions are already in effect under the present tax set-up, but, according to school authorities, should be voted on again so as to make the preparation of the bonds simpler.

Proposition No. 2 calls for voting of a maintenance tax which, together with the bond retiring fund, shall never exceed \$1.00 per \$100 valuation on all taxable property in the school district. This same rate will still be in effect whether or not the bond issue carries.

Proposition No. 3 calls for the assumption of the bonded indebtedness of the school district, which has already been done, when various schools consolidated with the Bronte school.

Supt. J. L. Carroll said that actually proposition number one is the only issue to be decided since the other two have already been put into effect.

The proposed elementary building will contain ten classrooms, lunchroom, auditorium, two offices, storage vault, teacher room, first aid room and nurses room, rest rooms and janitors' room.

The list of questions and answers carried last week is being published again this week. It answers most anything a voter will care to know about the proposal.

School officials pointed out

that the present tax rate for this school district is one of the lowest found anywhere and that the new building can be financed without raising the rate. The large increase in valuations brought about by the oil industry, is the main cause of the financial wellbeing of the district.

Supt. Carroll urged all qualified voters to go to the polls tomorrow to cast their vote for or against this matter. It's the desire of the board and school officials to carry out the will of the people, he added.

Qualified voters are those who reside in this school district who have rendered property for taxation purposes this year, and who have paid their poll tax.

## One Killed: Two Hurt in Accident

A 23-year-old San Angelo woman, Mrs. Bobbie Aire Dickson, was killed and her husband and her brother were seriously injured in a highway crash about 6 a. m. Wednesday morning. The accident occurred about 8 miles south of Bronte on the San Angelo highway, between the Clark Glenn residence and Tennyson.

Injured were Pfc. James H. Dickson of Goodfellow Air Base in San Angelo and Tom Sales, 17, of Randlett, Oklahoma. The three were enroute to San Angelo from Burkburnett. Dickson's home, when their 1940 Dodge automobile crashed into a bridge.

The condition of the two injured men was considered serious Wednesday, although some improvement was noted.

The fatality was the third for Cooke County for 1952 and the 51st traffic victim of the San Angelo District of the Texas State Highway Patrol for 1952.

## Water Problem Getting More Critical Each Day

The water situation is becoming more critical by the day. Mayor H. O. Whitt said this week. Only a few more days supply is available unless something is done to alleviate the situation, and the old standby for water, the Colorado River, is just about dry.

### COOPERATION ASKED

Mayor Whitt said that he would like to ask residents of Bronte once more not to use water for irrigating and washing cars or any non-essential use.

He said that attention to this detail will mean having water a few more days. He stressed importance of conservation by saying that if people here do not comply with this request voluntarily,

it will become necessary for the city to pass an ordinance to fine those who use an excessive amount of water. Several persons have said this week that they will stop watering, but that they had not realized how serious the situation was.

### WILL TRY DRAGLINE

Some members of the city council went to the river Wednesday afternoon and decided to try using a dragline to clean out a hole in the river bed. It is hoped that enough water will accumulate in excavation to help supply the town.

### MAY BUY WATER AT R. LEE

Another angle that is being considered is buying water from Robert Lee and hauling it to Bronte. It would then be pumped into the mains and would be available to water users. The cost is the main drawback in obtaining water from this source. Mayor Whitt said that some tentative figuring showed that 2,000 gallons of water could be delivered to a Bronte water user for about \$10. The water would be brought in by trucks.

### SAMPLES BAD

To make a bad picture darker, Whitt also reported Wednesday that samples of city water and a sample from the Woullard well had been sent to the State Health

Department. Two of the samples sent from the city water supply were reported as having no harmful organisms, but the other sample from the city mains and the sample from the Woullard well were reported as containing harmful bacteria.

Whitt suggested that all who use water from the Woullard well should boil it before using it as drinking water.

J. H. Jackson, local trucker, added a new enterprise to the town this week by putting a tank on his truck and hauling water from Robert Lee. He sells to the Bronte residents who do not wish to drink water from the city mains.

In the meantime, work is progressing on the project which will relieve the scarcity of water in Bronte, the Oak Creek pipeline project. In addition to the line itself, the filter plant in the north side of town is now under construction. A large crew of workmen and quite a lot of machinery are being used on the plant and it is rapidly taking shape.

However, rain will have to fall on the Oak Creek water shed before Bronte can obtain water from the big lake which is being impounded northeast of here. The pipeline is being built by the Upper Colorado River Authority and the city is to retire the cost with no interest charges.

## SCS REPORTS ON CONDITIONS IN DROUTH AREA OF WEST TEXAS

Farmers in the still dry wind erosion belt of western Texas are standing ready to plant record acreages of wind-resisting grain sorghums and cover crops, the Soil Conservation Service reported today.

Many farmers in the area already were planning large plantings of grain sorghums and sudan grass for wind erosion control as well as for income, but dying stands of young cotton throughout the area will mean even more extensive acreages of these crops, SCS field men have reported to Regional Director Louis P. Merrill.

Supervisors of soil conservation districts in the area are teaming with PMA committeemen and other local leaders in plans for an all-out drive for wind erosion control. These leaders are urging the planting of wind-resisting sorghums and sudans to replace the cotton if moisture comes within the next few weeks. If no effective rain comes before August 1, they will recommend the planting of small grains such as rye for winter cover on land subject to blowing.

Merrill pointed out that the wind erosion in areas covering as much as seven counties in western Texas in the season just passed approached the worst conditions experienced farther to the north in the 1930's. Another winter of high winds on unprotected crop and range lands will mean damage that will take many years to repair, he warned.

The young cotton is dying rapidly in many areas which were hit hard by blowing through the winter. The crop is considered hopeless in Martin and Midland counties. A few plantings were still surviving in the northern part of Howard county which received a good rain in May.

In Cooke County even brush was reported dying. In the area of Sterling City to the west some grass was still green. Ranchers throughout the drier western Texas areas have already shipped most of their cattle and sheep to other areas.

Supervisors of the Dawson and Martin-Howard soil conservation districts are in the forefront of the drive in that district for sorghum and legume plantings. The two districts have purchased guar and cowpea seed for use by district cooperators. Guar is a summer-growing legume which may fit into conservation cropping systems in western Texas.

Production was natural through an 18/64-inch choke from perforations at 4,968-75 feet. Location is 330 feet from the south and 390 feet from the east lines of section 450-1A, H&TC.

Testing is underway this week on Humble No. 3 Olive May Kee-ney, Bronte Field test. It was tested in the Strawn last week and showed huge quantities of gas. The testing now is in the Goens.

Rig has been moved in on the location for Marlowe Oil Co. of Midland No. 1 Charles Copeland, northeastern Coke county wildcat. Location is 1,960 feet from the north and 660 feet from the west lines of section 282-1-A H&TC. Drillsite is 4 1/2 miles southwest of Blackwell.

Stanolind Oil & Gas Co. No. 8 Irene Morrow has been completed as a one-location south extension to the Fort Chadbourne field for a daily flow of 128.22 barrels of 45 gravity pipeline oil. Flow was from perforations between 5,374 and 5,427 feet.

Thos. D. Humphrey, Dallas independent, staked a wildcat in Runnels County one mile south of Maverick as No. 1 D. O. Lee.

It is slated to be drilled to 5,300 feet and is located 330 feet from the southeast and 3,470 feet from the north lines of Joseph Farwell Survey.

**HOUSE JOINT RESOLUTION  
NO. 38**

providing an amendment to Article III of the Constitution of the State of Texas by the addition of a new Section 50A, providing for the establishment of a State Medical Education Board and a State Medical Scholarship Fund from which grants, loans or scholarships may be made to students desiring to study medicine; providing that such students shall agree to practice in rural areas of this State; providing certain restrictions and limitations; providing for an election and the issuance of a proclamation therefor.

**BE IT RESOLVED BY THE  
LEGISLATURE OF THE STATE  
OF TEXAS:**

Section 1. That Article III of the Constitution of the State of Texas be amended by adding thereto a new section to be known as Section 50A which shall read as follows:

"Sec. 50A. The Legislature shall create a State Medical Education Board to be composed of not more than six (6) members whose qualifications, duties and terms of office shall be prescribed by law. The Legislature shall also establish a State Medical Education Fund and make adequate appropriations therefor to be used by the State Medical Education Board to provide grants, loans or scholarships to students desiring to study medicine and agreeing to practice in the rural areas of this State, upon such terms and conditions as shall be prescribed by law. The term 'rural areas' as used in this Section shall be defined by law.

Section 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this State at an election to be held on the first Tuesday after the first Monday in November, A. D. 1952, at which all ballots shall have printed thereon (or in counties using voting machines the machines shall provide for) the following:

"FOR the Constitutional Amendment providing for the establishment of a State Medical Education Fund from which grants, loans or scholarships may be made to students desiring to study medicine."

"AGAINST the Constitutional Amendment providing for the establishment of a State Medical Education Fund from which grants, loans or scholarships may be made to students desiring to study medicine."

Each voter shall mark out one of said clauses on the ballot, leaving the one expressing his vote on the proposed amendment; and if it shall appear from the returns of said election that a majority of the votes cast are in favor of said amendment, the same shall become a part of the Constitution of the State of Texas.

Sec. 3. The Governor shall issue the necessary proclamation for said election and have the same published as required by the Constitution and laws of this State. The expense of publication and election for such amendment shall be paid out of proper appropriation made by law.

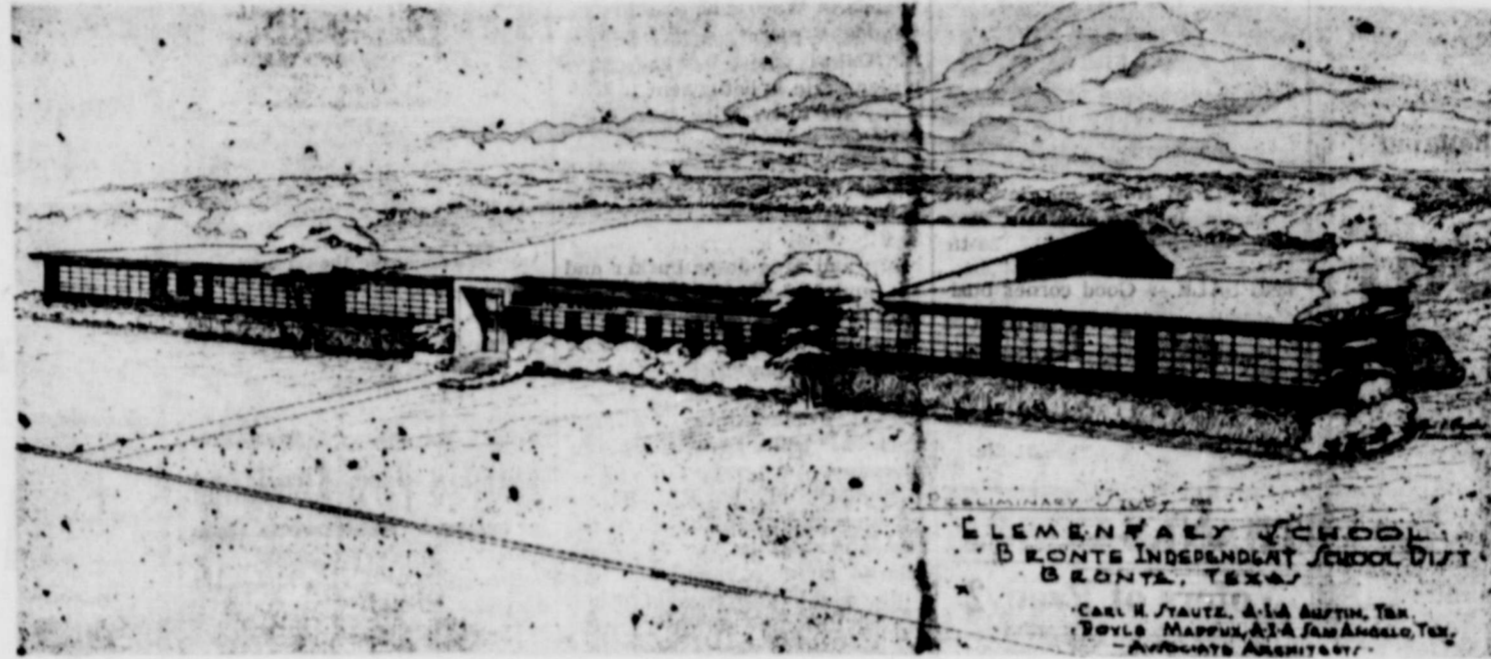

# Shall the Children of the Bronte School District Have the Advantages of Attending School In a Building Like This?



BELOW IS A GROUP OF QUESTIONS AND ANSWERS PERTAINING TO THE BUILDING OF A NEW ELEMENTARY SCHOOL AT BRONTE THIS LIST WAS PREPARED BY SUPT. J. L. CARROLL WITH THE HELP OF THE BOARD OF TRUSTEES.

(The following questions and answers are to inform you concerning the Bronte School and to help you understand the financial condition of the school.)

**QUESTION** — Shall the Bronte School District build a new elementary school building?

**ANSWER** — That will be for the qualified voters to decide.

**QUESTION** — Who are qualified to vote on a bond issue in the Bronte School District?

**ANSWER** — Anyone who lives in the Bronte School District and is otherwise eligible to vote provided he owns any kind of property in the district and has rendered the same for taxes in the Bronte School District.

**QUESTION** — What kind of property must one own to be eligible to vote in a bond election?

**ANSWER** — Any kind such as a dog, car, watch, household goods, house or farm, or anything that has value provided it is rendered for taxes but only tax-paying voters can vote in a bond election.

**QUESTION** — How long must a voter live in the district to be eligible to vote in a bond election?

**ANSWER** — He must have been living in the county where the school district is for six months prior to the election and must be a resident (not a visitor) in the school district at the time of the election.

**QUESTION** — Who calls a bond election?

**ANSWER** — The school board after they have been presented with a petition signed by twenty or more qualified voters asking for the election. In districts with fewer than twenty qualified voters a majority of the qualified voters must sign the petition.

**QUESTION** — What is the amount of the proposed bond?

**ANSWER** — \$260,000.00

**QUESTION** — What is the present bonded indebtedness?

**ANSWER** — \$28,000 which would make the total bonded indebtedness \$288,000.00.

**QUESTION** — What is the maximum amount the district could vote?

**ANSWER** — About \$420,000.00 is all this district can legally owe.

**QUESTION** — How much mon-

ey including principal and interest would have to be paid each year to take care of the bonded indebtedness if the new issue is passed?

**ANSWER** — The payments will run about \$18,000 each year becoming smaller toward the end of maturity.

**QUESTION** — What is the total amount of taxes to be collected locally each year?

**ANSWER** — The collections for 1951-52 will reach about \$45,000 and would be \$46,736 if they were all paid. If 90 percent of the taxes are paid for the 1952-53 the school should collect at least \$58,500.

**QUESTION** — What can the \$58,500 be spent for?

**ANSWER** — \$16,787.40 must be spent on current school program for 1952-53. One-half or \$29,250 may be spent to pay principal and interest on indebtedness and \$11,463 may be spent for any legal school expenses that meets the approval of the school board.

**QUESTION** — How much are the rendered values for school taxes in the district?

**ANSWER** — The assessed valuation for the 1951-52 school year was \$4,673,621 and is estimated to be at least \$6,000,000 this year.

**QUESTION** — Is the land in the district valued very high?

**ANSWER** — The assessed values on 25,073 acres, including improvements, from all parts of the district averaged \$4.82 per acre for school purposes. The highest valued land found in the survey was \$10.00 per acre while the lowest was \$3.33 per acre. According to the survey land is valued from one-eighth to one-tenth its present market value or one third to one-fourth the market value during the 30's. If the 300 square miles of land that is in the Bronte School District were valued at \$25 per acre and the city property were valued the same for school purposes as it is for city purpose, and if the oil and other properties were valued the same as it is now the valuation for school purpose would exceed \$10,000,000.

**QUESTION** — Who sets the values for independent school districts?

**ANSWER** — The values are

set by a board of equalization appointed each year by the school board. School board members cannot serve on the board of equalization.

**QUESTION** — What is the present tax rate for school purpose?

**ANSWER** — The present tax rate for the Bronte School District is \$1.00 on the \$100.00 valuation.

**QUESTION** — How does the tax rate for Bronte compare with the other schools?

**ANSWER** — Robert Lee has \$1.50 tax, Miles has \$1.40, Norton has \$1.50, Wingate has \$1.50, Balingier has \$1.50, Winters has \$1.50, Blackwell has \$1.50 and the Bronte district has \$1.00.

**QUESTION** — How much of the dollar rate would it take to pay the present bonded indebtedness?

**ANSWER** — About 10c.

**QUESTION** — How much of the dollar rate will it take to pay the indebtedness if the new issue is passed?

**ANSWER** — If the values for 1951-52 school year were used it would take about 40c and if the values for 1952-53 were used it would take about 35c.

**QUESTION** — If the issue does not pass what will the tax rate be?

**ANSWER** — The tax rate will remain the same as it is now which is \$1.00.

**QUESTION** — Suppose there becomes a surplus in the Interest and Sinking fund. What can be done with it?

**ANSWER** — All money collected to pay bonded indebtedness is placed in what is called the interest and sinking fund and can not be taken out for any other purpose until all bonded indebtedness is paid. It is kept to pay optional bonds ahead of maturity or it can be invested in government bonds and draw interest provided it meets the approval of the State Board of Education. When enough money is collected to pay all bonded indebtedness the trustees of the District can order the amount being collected to pay indebtedness to be collected into the maintenance fund.

**QUESTION** — What is the highest rate that can be collected for bonded indebtedness?

**ANSWER** — 50c on the \$100 valuation is the largest amount that can be collected for bonded indebtedness.

**QUESTION** — Where does the district get all the money to operate a school?

**ANSWER** — Using the figures for 1951-52 school year we find the following:  
Transportation paid by State—\$10,123  
Salary and operation paid by State—\$20,600  
Per capita paid by State—\$21,042  
Vocational Aid about—\$1,000  
Total Aid from State—\$52,765  
Collected from local school tax—\$45,000

We can give only the approximate taxes collected since there are some taxes not paid.

**QUESTION** — Where will the new school be located?

**ANSWER** — The School Board has secured an eight acre tract of land at the north end of Jefferson Street (Jefferson Street is the street that the present school is on) provided he bonds election carries.

**QUESTION** — Why did the School Board choose to place the building there?

**ANSWER** — That is the best available location that the school Board could find that could be purchased. It is well suited for a school site for small children because it is not near the highway, railroads, county road, and there are no industrial hazards near. It is also located where there is available land for the town to grow. It is not too far from the other school. Another factor considered is the fact that it is more than two miles from the Humble Camp. If it were nearer than two miles from the Humble Camp the school could not collect transportation aid from the State for the children who are transported from the Camp.

**QUESTION** — What will the new building consist of?

**ANSWER** — The plans for the new building call for 10 class rooms, lunchroom, auditorium, two offices, storage vault, teacher room first aid and nurses room, rest rooms for both boys and girls and a janitors room. There is also a concrete slab for tennis, volleyball, basketball and other

games that can be used in muddy weather (if there is such weather) for all types of play.

**QUESTION** — Who will occupy the new building?

**ANSWER** — It is planned that the first six grades should use the new building.

**QUESTION** — How many pupils will be in the first six grades?

**ANSWER** — There were 232 pupils enrolled in the first six grades at the close of the 1951-1952 school year.

**QUESTION** — How many class rooms will be occupied with the first six grades?

**ANSWER** — With the present enrollment the first six grades will occupy eight rooms.

**QUESTION** — What can the other two rooms be used for?

**ANSWER** — One of the other rooms can be used for a music room and the other can be used for a library.

**QUESTION** — What will be done with the existing building?

**ANSWER** — The existing building will be used to house the junior high school and senior high school students.

**QUESTION** — Will there be any other improvements made?

**ANSWER** — The school board plans to purchase new furniture for the old building and build an athletic house on the football field. They also plan to hard-surface the tennis courts if it is possible.

**QUESTION** — What advantage would the new building give the children?

**ANSWER** —

1. Children could be grouped for better instruction.

2. Children would have facilities adapted to the individual need.

3. Children could have more freedom and discipline would be much easier.

4. The health and safety condition of the children would be much improved.

5. The children in the Bronte Community would have equal opportunities with other children.

6. It lessens the danger of ever losing your school to some other community.

**QUESTION** — Can we get along without the new building?

**ANSWER** — We can get along without the new building but the children of our community could do much better with it.

**QUESTION** — When will the election be called?

**ANSWER** — The election will be called for Saturday, Aug. 2.

**QUESTION** — How many and what are the propositions in the election?

**ANSWER** — The three propositions in the election are: (1) To vote bonds for \$260,000 for improving old school, purchasing site, building new school and equipping new and old schools. (2) To establish and keep a uniform tax rate of \$1.00 throughout the school district. (3) To assume the present and new bonded indebtedness, to be paid from the above taxes, uniformly throughout the district.

**QUESTION** — Where is the election place?

**ANSWER** — In the City Hall in Bronte.

**QUESTION** — Are the voters in the consolidated district permitted to vote in this election?

**ANSWER** — They are not only permitted, but urged, to vote, whether they live in Coke or Runnels County.

**QUESTION** — Who will hold the election?

**ANSWER** — The presiding judge is Mrs. Frank Keeney. The election judge is Mrs. D. K. Glenn. The clerks are Mrs. O. H. Wilkoughby and Mrs. Otis Smith.

**QUESTION** — How will the ballots be written?

**ANSWER** — The ballots of said election shall be printed as follows:

PROPOSITION NO. 1  
"For the issuance of bonds and the levying of the tax in payment thereof."

PROPOSITION NO. 2  
"For maintenance tax."

PROPOSITION NO. 3  
"Against maintenance tax."

PROPOSITION NO. 3  
"For the assumption of indebtedness and levying of the tax in payment thereof."

"Against the assumption of indebtedness and levying of the tax in payment thereof."


