## Mail Deliveries Here Undergo Major Changes

A new mail route between San Angelo and Sweetwater began operation Saturday and has changed the mail schedules into and out of Bronte.

V. M. Curry of Abilene will drive the star routes, having submitted the successful bid for the period Jan. 10 through June 30, 1959, the remaining portion of the current four-year term. His bid was based on an annual rate of \$13,210, according to postmaster O. B. Fields of San Angelo.

The route will provide mail service previously furnished by Santa Fe trains discontinued on Nov. 1, and will replace a temporary mail route that has operated since discontinuance of the trains. The route will consist of two round trips each day from San Angelo to Sweetwater, one in the early morning and the other shortly after-noon.

Mail now comes into Bronte from Sweetwater and San Angelo at 5 a. m.; from San Angelo at 1:20 p. m.; and from Sweetwater again at 4:10 p. m. Mail from Ballinger will continue to come in at 9:30 a. m. and from Robert Lee at 4:10 p. m.

The staff of The Enterprise requests the cooperation of everyone in meeting the new deadlines. It is felt that the new date will be entirely satisfactory when everyone becomes accustomed to the new schedule. Many weekly papers carry Thursday rather than Friday date lines.

## School Census Being Taken In January

Supt. Garland Black said this week that the annual census for the Bronte School is being taken during January. He urged that all parents who do not have a child in school but who have one who will start next September to come by the school office and sign a census slip, or phone the school and let the fact be known.

Black pointed out the need of counting every child in the district. He said, "If your child will be six years of age before Sept. 1, 1959, the school will draw \$67.50 tuition from the State of Texas on this child, one year later."

## Pruitt's Store Selling Out and Quitting Business

After 13 years of operation in Bronte, Pruitt's Store is quitting business. The announcement is being made in this week's Enterprise in the firm's weekly ad.

Noah Pruitt, Sr., manager of the firm, said the business was more than they could handle since Noah Pruitt, Jr. accepted a position as postmaster in Bronte last year. The younger Mr. Pruitt has been a partner in the venture since it began operation here in 1945.

In addition to a large line of groceries and meats, the local firm also handles an extensive line of dry goods and other items.

Noah Pruitt, Sr. said it will take several weeks for the store to liquidate its stock. He said plans for the future are pretty indefinite as yet.

The Pruitts bought the store from Leroy Price of Lubbock, who had bought it only a few months previously from Brooks Browning. Prior to Browning's ownership, the store had been operated by the Price family for many years.

Matthew Caperton, county campaign chairman, announced this week that plans are taking shape for an all-out drive for the Coke County March of Dimes campaign. He said that just about all the workers are lined up and dates for special fund raising events have been set.

Caperton said the three cafes in Bronte have agreed to have a March of Dimes Coffee Day tomorrow, Saturday, Jan. 17. All money taken in that day for coffee will go to the drive. Participating are City Cafe, Coffee Shop Cafe and Cactus Cafe.

## Methodist Talent Program Yields More Than \$1100

Approximately three-fourths of the persons who were working on the Talent Program of the Methodist Church in Bronte turned in \$1142.37 last Sunday.

Rev. Jimmy Campbell, pastor of the church, said approximately 25 persons who took \$5 more than three months ago have not turned in their earnings. He said as best as he could determine 65 persons participated in the collection last Sunday.

Campbell said he was well pleased with the return on the money which was passed out in September to everyone who would take it. "We expect to almost triple our investment when all the money is in," he said.

Campbell said that several members of the church have not completed their projects and the money will be turned in at a later date. He urged, however, that everyone who has completed his work in the program to turn in the money as soon as possible.

Caperton said he will have advance ticket sales for the dance, with the tabs going on sale some time this weekend. Admission price will be \$1.50 per person.

Caperton reminded everybody in the area that the National Foundation for Infantile Paralysis, to which part of the money goes, has assumed the job of doing research on other diseases, birth defects, arthritis and rheumatism and other diseases which affect the central nervous system. Money will continue to be spent to help persons who have had polio, he said. Some of the funds will also be set aside for further research on the Salk polio vaccine. This will be the first year that March of Dimes money has been used for anything other than polio research and aid to polio victims.

Caperton said he had noticed that there are still plenty of vacant spaces in the March of Dimes cards set up in local business houses. He urged local residents to place their loose dimes in these containers. "We want to fill up every one of them," he said.

Cards, which will hold up to 60c in dimes, were distributed to local school children this week.

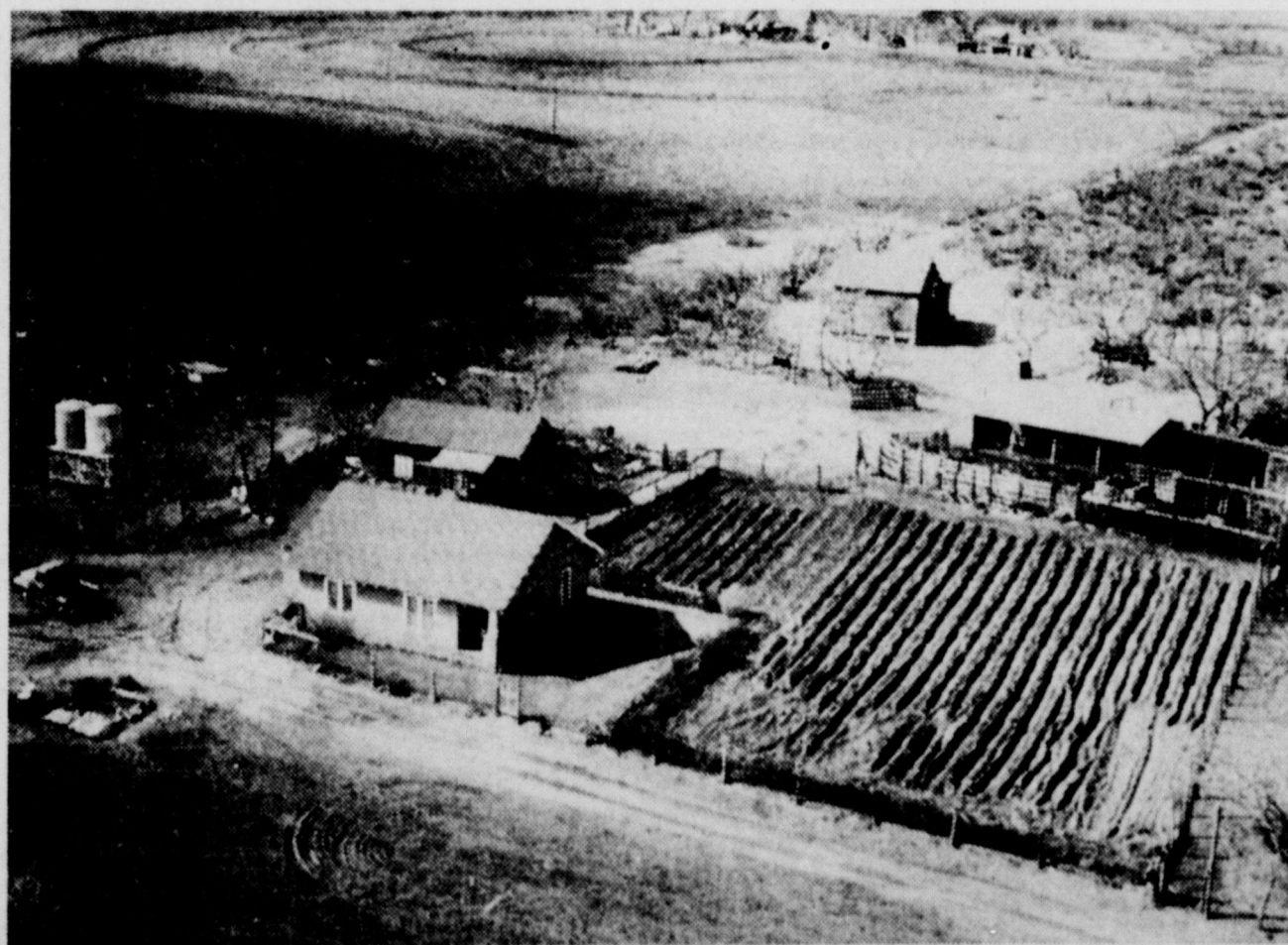
Burial was in Evergreen cemetery in Ballinger with Newby-Davis funeral home in charge of arrangements.

## Murders Trials Start Monday At Robert Lee

(From Robert Lee Observer)

Murder trials for two Negroes, charged with the robbery and slaying of a Gandy Creamery Co. truck driver last Oct. 24, will come up for trial next Monday in Robert Lee. Judge Joe L. Mays will preside over the session of 51st district court.

Killed early in the morning on Highway 87 between Water Valley and Sterling City was L. H. (Shorty) Canada, 58, who had started his route run from San Angelo a short time before. His assailants were Roosevelt Wiley, 26, and Willie McDade, both of Odessa.

A special panel of 72 men has been notified to appear at 10 a. m. Monday when the court is scheduled to open.

Wiley's trial will come up first and it is a foregone conclusion that the jury will be asked to give him the death penalty. He has a previous criminal record, having been free only ten days after serving more than one year of a 3-year penitentiary sentence for burglary.

McDade is said to have been under 17 when the crime was committed, birth certificate proof showing that he was not 17 years old until Nov. 26, 1958. State law provides that a person under 17 (a minor) cannot be assessed the death penalty.

Justin Kever, district attorney, says McDade's case will be taken up after the Wiley case has been disposed of. Kever will be assisted in the prosecution by his as-
